2.15.010 Establishment.

There is hereby established a First Street Public Space Design Committee comprised of no more than seven (7) members who are residents of the City. (Ord. 2007-M-22 § 2.)

2.15.020 Purpose.

The overall purpose of the First Street Public Space Design Committee shall be to solicit community input and recommend plans for the use of public space in accordance with the Redevelopment Agreement and Plans. (Ord. 2007-M-22 § 2.)

2.15.030 Members - appointment.

The Mayor, with the approval of the City Council, shall appoint seven (7) residents of the City as members of the Committee. In addition, the Mayor shall, with the approval of the City Council, appoint one of the members as Chairman of the Committee. In the event that there is a vacancy on the Committee, the Mayor shall appoint a replacement with the approval of the City Council. (Ord. 2007-M-22 § 2.)

2.15.040 Duties.

The St. Charles First Street Public Space Design Committee shall:

- A. Solicit input from the community regarding the design and use of public space in the First Street project ; and,
- B. Consider input from the community; and,
- C. Cause such studies and surveys as may be necessary; and,
- D. Request and obtain such cooperation, assistance and data from City departments and other public agencies as may be necessary to carry out its work; and,
- E. Contribute their judgment and expertise regarding the design and use of public space in the First Street project; and
- F. Report to the City Council at such time and manner as may be requested by the Mayor regarding the progress of the Committee; and,
- G. Make recommendations to the staff and City Council for the planning and use of public space on First Street; and
- H. Fulfill such other duties as may be assigned by the City Council from time-to-time.

2.15.050 Compensation and Conflicts of Interest.

FIRST STREET PUBLIC SPACE DESIGN COMMITTEE

No member shall receive compensation for serving as a member. No member shall be interested, either directly or indirectly, in the purchase of sale of services, supplies or as an employee except to the extent permitted under the statutes of the State of Illinois. (Ord. 2007-M-22 § 2.)

2.15.060 Meetings.

The Committee shall meet no less than once per month. The Members shall set the time and place for the meetings. Minutes shall be recorded for all meetings and transmitted to the City Council in accordance with Section 2.15.040(F) herein. The Committee may enact bylaws and such other rules as are deemed necessary for the orderly and efficient operation of the Committee. (Ord. 2007-M-22 § 2.)

2.15.070 Voting/Quorum.

Each member shall have one vote and all votes shall be decided by a majority of a quorum. A quorum shall consist of five or more members. (Ord. 2007-M-22 § 2.)

2.15.080 Renewal.

This Section 2.15.010 et. seq. shall expire one (1) year from the date of enactment of this ordinance, unless otherwise extended by the City Council. (Ord. 2007-M-22 § 2.)
