We're Doing More with Less

Remaining Responsible Stewards of Public Tax Dollars

There's no doubt the lingering effects of a sagging economy have been difficult for both individuals and organizations alike. Especially in times like these, local governments often hear how they need to operate more like the private sector and "do more with less." The City of St. Charles has in fact been operating leaner and would like residents to know how we are "doing more with less."

Between April 30, 2008, and

April 30, 2010, the City slashed \$5 million in expenditures from the General Fund, cutting back spending from \$42.7 million in 2008 to \$37.7 million in 2010. That's an 11.9% reduction. This



reduction was highlighted by a wage freeze that every employee of the City took during fiscal year 2009-2010. The result was more than \$1.2 million in savings for taxpayers. Other measures included suspension of the spring clean-up program, elimination of staff travel and training, deferral of vehicle replacement funding, and deferring or eliminating various capital and maintenance projects.

And the City's cost containment strategies are continuing. Expenditures in the General Fund for FY2011 were just under \$40 million--\$2.7 million lower than they were in 2008, a 6.30% reduction. Additionally, the City has decreased staff by an equivalent of 54 full-time positions, representing a 16% drop. Incidentally, this staffing reduction was achieved through attrition of positions and did not involve laying off any employees.

Projections for the current fiscal year ending April 30, 2012, show estimated expenditures of \$40.2 million, approximately 6% lower than FY2008. This would mark the fourth consecutive fiscal year in which expenditures would be lower than in FY2008. Additionally, this represents a slight 0.5% increase in expenditure levels over FY2011.

The City has managed its revenue sources in a similarly prudent manner. For calendar year 2012, the City is maintaining its operating property tax levy for the third straight year at approximately \$12 million. This means the City is not asking taxpayers to pay more in property taxes to the City for the third consecutive year. Many property owners actually have seen the City portion of their property tax bills decline.

Our fiscal responsibility was noted by Moody's ratings service which affirmed the City's Aa1 debt rating in September of 2011. Moody's cited "strong financial operations and solid reserve levels," as well as a "demonstrated history of reacting to budgetary challenges."

The City's guiding fiscal principle during these challenging economic times has been to "match our expenditure level to the level of our revenues."

Everyone has been impacted by the current economy. Recognizing and reacting to the situation in a timely manner has been essential to the City's ability to maintain its fiscal health. We have quietly and efficiently gone about the business of reducing expenditures to coincide with the level of revenues expected and continue to operate as responsible stewards of public tax dollars. This process has been so quiet and efficient, you may not even have been aware it was happening!

Important Winter Safety Reminders

Even though we're enjoying unseasonably mild weather so far this year, snow and cold weather could be just around the corner. Please keep these important winter safety tips from the St. Charles Police Department in mind.

Don't Leave Cars Running while Unattended

It is against state law to leave a vehicle "unattended without first stopping the engine, locking the ignition, and removing the key from the ignition." That means you may not warm engines or go into a store for a 'quick minute.' Not only is it not safe, but car thieves often target unattended, running vehicles.

City Snow Routes and Parking Restrictions

From Nov. 1 to April 30, it is unlawful for any vehicle to be parked on streets designated as snow routes when an accumulation of snow is two inches or more, until the street has been cleared. This allows for proper plowing of the streets.

You also may not park a vehicle on any public street or other public place for a period of longer than twenty-four (24) consecutive hours.

And, parking on a sidewalk is against the law (except between the hours of 10:00 p.m. and 7:00 a.m. when vehicles may be parked in residentially zoned districts on the portion of the sidewalk that connects the driveway to the driveway apron).

Also, please remember to keep fire lanes open at stores and schools! Emergency vehicles must be able to respond quickly during crisis situations.



Larger Recycling Cart Available

Veolia Environmental Services, refuse and recycling provider for the City of St. Charles, is offering residents an opportunity to rent larger, wheeled recycling carts, if they prefer.

For \$3 per month, residents can get a 65-gallon, rolling cart with a cover. The new recycling carts provide some definite advantages, according to John Lamb, environmental services manager for the City of St. Charles. "One wheeled recycle cart holds more than a current recycle bin and is easier to transport to the curb. The lid also will better contain material in the cart, even on blustery days."

The new cart rental program is a voluntary option. Residents do not have to participate and may choose to continue using their current recycling bin.

Veolia will send a flyer explaining the new cart rental program soon. Anyone interested in renting the new recycling carts must make arrangements directly with Veolia. More information will be included in the flyer.

Electronic Disposal and Recycling Update

On Jan. 1, a new state law went into effect prohibiting the disposal of electronics in regular trash for burial in landfills. This includes televisions, computers, monitors, printers, keyboards, DVRs, etc. Residents can no longer place refuse stickers on these items and place them at the curb for disposal from Veolia; electronic items placed at the curb will not be picked up.

These products typically contain many valuable metals that can be recycled. There are several options for City residents to recycle their electronics equipment. Kane County conducts electronics recycling the second Saturday of each month from 8 a.m. to 2 p.m. Best Buy stores in Geneva and South Elgin will accept electronics, along with Goodwill Retail Stores in St. Charles, Batavia and South Elgin.

St. Charles Industrial Sector Grows in 2011

In spite of an otherwise sluggish regional and national economy, 2011 has been a very prosperous year for industrial sector growth within the City of St. Charles. There are a number of reasons why industry continues to fare well in St. Charles. First, St. Charles enjoys ready access to regional transportation, including two expressways (I-90 and I-88), four state highways (Routes 25, 31, 38 and 64), the Union Pacific Rail Road, and neighboring DuPage Airport. The City also enjoys a local labor pool that includes a high percentage of professional and highly skilled persons. Finally, the City maintains public utility capacities that facilitate economic development, particularly in the industrial arena, including its own electric utility that offers low rates that very few, if any, communities presently can match.

National manufacturing interests also grew in 2011 with the expansion of RR Donnelley and Armour-Eckrich in St. Charles. RR Donnelley recently purchased the 500,000-sq. ft., former Pier 1 Imports building and expects to fully occupy it over the next 18-24 months. Phase 1 occupancy will employ some 175 employees, while creation of several hundred additional jobs is anticipated for the build-out. Food processing giant Armour-Eckrich has begun construction of a 13,000-sq. ft. expansion of its existing St. Charles facilities. To be completed next year, this addition will house eleven state-of-the-art drying chambers for cured meats.

In addition, within the St. Charles east side industrial area alone, the City has issued permits to expand light industrial development totaling more than 125,000 sq. ft. New businesses to St. Charles include Bema, Inc., an Elmhurst-based plastics packaging firm specializing in serving the food and medical equipment industries (60,000 sq. ft.); PDS Transportation Services, a full service transportation company serving all 48 contiguous states (31,000 sq. ft.); and IGM Resins, Inc, a Dutch-based chemical import, distribution and blending company specializing in inks and coatings (12,000 sq. ft.). Existing St. Charles businesses that have undertaken expansions to their facilities include Corrosion Monitoring Services, a unique company that assesses and repairs corroded tubular air heaters (19,000 sq. ft.) and Midwest Powder Coating, which provides powder coating finishes to a national customer base, catering to the demands of the motor sport enthusiast (7,500 sq.ft. addition).

With accessible local transportation, a highly skilled labor pool and city-owned electric utility that can offer power costs among the lowest in the state, it is easy to understand why St. Charles has long been recognized as a focal point for light manufacturing activity.

Register Your Phone Number with the Electric Outage Reporting System

Available for Residents Living within St. Charles City Limits Only

Last July, the City of St. Charles Electric Utility launched a new automated telephone notification system to streamline the reporting process when an electric outage occurs. The new system can:

- Handle heavy call volumes
- Relay outage information faster to reduce crew response times
- Use caller I.D. to identify an outage location
- Offer an optional call back feature to confirm power has been restored

Based on caller I.D. technology, the new system links customers' phone numbers to their accounts so the location of the outage can be identified automatically when they call to report an issue. It also allows customers to receive updates regarding the outage and a return call to confirm power restoration.

2012 IMUA Scholarship Program Applications Available

Four, \$500 Scholarships to be Awarded

The City of St. Charles, in partnership with the Illinois Municipal Utilities Association (IMUA), is offering four (4) \$500 scholarships to eligible high school students. To be eligible, applicants must be high school seniors whose parents or legal guardians are residential customers of City of St. Charles utilities. Eligible students must submit an application and essay of 500 words or less addressing their choice of one of three (3) utility-related questions.

The scholarship program seeks to promote and recognize scholastic achievement, as well as create greater awareness among young adults of the many issues facing consumers and public power municipalities.

“Today’s energy providers, including municipally-owned and operated utilities, face a myriad of economic, environmental and other challenges which warrant creative and innovative solutions,” said Glynn Amburgey, manager of Electric and Communication for the City of St. Charles. “Creating awareness of these issues among tomorrow’s leaders can be the first step in helping determine effective, long-term solutions, both now and into the future.”

This will be the 14th year IMUA has offered the program. A committee of municipal utility officials will select four (4) finalists, each of whom will receive a certificate and \$500 scholarship award. Winners will be announced in April. For more information, contact IMUA at 217-789-4632.
