## City “Walks the Walk” on Fiscal Responsibility

Throughout 2012, the City of St. Charles stayed committed to following a fiscally prudent path to keep a line on expenditures and tax levels. The success of these strategies is evident in our continued strong financial performance, which recently was recognized by Moody’s Investor Service with an Aa1 debt rating. In their report, Moody’s cited the City’s “strong financial operations and solid reserve levels.”

In fiscal year 2012, expenditure levels fell to \$38.58 million, 3.50% less than FY2011 and nearly 10% below 2008 levels. And these reductions have been made with no significant impact on the services and programs offered by the City of St. Charles.


Additionally, the City’s revenues continued their record of strong performance ending at \$38.65 million, resulting in a surplus of more than \$120,000 for the fiscal year. Sales and Use Tax revenues increased by 3.80% to \$14.6 million as the economy continued its slow but steady recovery.

These financial results were achieved while holding the City’s property tax levy at a consistent level. The 2012 levy that the City will collect during 2013 represents the fifth consecutive year that the City’s operating property tax levy remained at \$12 million.

General Fund reserves now stand at a level of approximately \$16.2 million, representing 42% of expenditure levels. This level of reserves is well in excess of the required 25% policy maintained by the City Council and provides an adequate cushion against future fluctuations in revenue levels.

In addition, taxpayers also will save more than \$2.4 million in interest costs between now and 2025, due to recent refinancing activity. That’s an average of almost \$190,000 annually.

## Electric Outage Reporting System

### Register Today



If you are a St. Charles Electric Utility customer, then be sure to register your phone number with the automated telephone notification system.

Based on caller I.D. technology, the system links customers' phone numbers to their accounts so the location of the outage can be identified automatically when they call to report an issue. It also allows customers to receive updates regarding the outage and a return call to confirm power restoration.

The system can handle heavy call volumes and quickly relays outage information, reducing crew response times.

## Substantial Building Improvement and Floodplain Management Standards

The National Flood Insurance Program requires that if the cost of improvements to a building or the cost to repair damages (from any cause) to a building exceeds 50% of the market value of the building (excluding land value), the entire building must be brought up to current floodplain management standards. Building improvement projects include exterior and interior remodeling, rehabilitation, additions, repairs, and reconstruction projects. Additionally, the cost of currently planned improvements will be added to the cost of previously made improvements and compared to the existing market value to determine if the improvements exceed 50% of the structure's value. All requests must have an approved parkway review before an order will be placed. Please do not send payment at this time. Once approved, residents will receive a confirmation letter, approved order form, and details on how to order a parkway tree.

## Guidelines

1. To begin the Approval Process, complete the form below and send it to the City of St. Charles Public Works Department, Attn: Public Services, 2 E. Main Street, St. Charles, IL 60174
2. Once we receive your completed pre-order form, a Public Services team member will conduct a parkway review to determine tree spacing, soil condition and existing underground utilities. All of these factors impact planting a new tree. Our team looks forward to helping you select the best tree for your parkway.
3. After the parkway review, a letter is sent detailing approval status. If your request has been approved, you also will receive an order form and instructions on where to send your order with payment.
4. If at any time you have questions, please contact Public Works at 630-377-4405.

*Pre-Order forms received as of March 1 will be considered for planting in the spring. Forms received by August 1 will be considered for planting in the fall.*

## Diversity is Important to a Healthy Tree Population

As many residents are sadly aware, the City has lost numerous parkway trees to the Emerald Ash Borer infestation. While the removal of infested ash trees will continue throughout 2013 and 2014, the City will replant new, healthy trees. The new parkway trees will reflect the City's move toward a diverse tree population or "urban forest."

One of the many benefits of having a variety of different parkway trees is the prevention of widespread, species-specific diseases and/or pestilence. For example, as the name indicates, the Emerald Ash Borer targets and destroys only ash trees. There are other diseases and pests that specifically impact certain other types of trees as well. By diversifying the City's parkway trees, our urban forest will be better protected against species-specific destruction and help prevent the mass-removal of trees.

Residents may soon enjoy some little known, yet beautiful trees including: bald cypress, coffeetree, and swamp white oak, to name a few. Soil conditions, power lines and other criteria are considered by the City when planting trees in parkways. We look forward to our healthy and varied urban forest!

## 2013 IMUA Scholarships Deadline for Applications is March 8

The City of St. Charles, in partnership with the Illinois Municipal Utilities Association (IMUA), is offering four, \$500 scholarships to eligible high school students. Applicants must be high school seniors whose parents or legal guardians are residential customers of City of St. Charles utilities. Students must submit an application and essay of 500 words or less addressing their choice of one of three utility-related questions. Applications are due March 8.

The scholarship program promotes and recognizes scholastic achievement, and creates awareness of the issues facing consumers and public power municipalities.

"Creating awareness among tomorrow's leaders can be the first step in helping determine effective, long-term solutions." This is the thirteenth year IMUA has offered the program.
