Audit Confirms \$1.46 Million City Surplus

The City of St. Charles continued its strong financial performance in 2013, reporting a surplus of \$1.46 million in the General Fund. According to the audit for fiscal year 2012-2013 performed by Sikich, LLC, FY13 revenues totaled \$39.5 million and expenditures \$38 million.

Apart from a small deficit in FY2011 at the height of the Great Recession, the City has posted a surplus in the General Fund from 2008 through 2013. This was achieved through:

- **Reductions:** Expenditures were cut 11.7% from FY2008 to FY2010.
- **Revenue:** The City instituted a 2% tax on alcohol sales. Also fees for services were adjusted for building permits, special events, towing, impounding of vehicles and arrest bookings.
- **Restraint:** Programs and services were maintained, while holding the City's portion of the property tax levy steady.



Chris Minick, Director of Finance, notes the same principles of responsible financial stewardship enacted during the Great Recession continue today at the City: "The expenditure reductions we established in fiscal years 2009 and 2010 during the economic downturn continue to benefit St. Charles citizens. FY2013 expenditures remain \$4.7 million lower than FY2008 levels and the City's tax levy has been held steady for five consecutive years."

City Retains Moody's Aa1 Rating

In related and equally encouraging news, Moody's Investor Service acknowledged the City's strong financial performance by reaffirming the City's Aa1 bond rating. Moody's noted several positive financial performance factors in its report stating: *'The City's financial operations remain sound following prudent and proactive management practices during the economic downturn. The City continues to be supported by solid operating reserves, a demonstrated history of reacting quickly to budgetary challenges...'*

Water Main Breaks are a Consequence of the Season

Water main breaks are common in the colder weather, especially with the extreme conditions we have experienced this season.

To report a water main break, please call the main Public Works Department number, 630.377.4405. If it is after hours, you will be prompted to leave a voice message in the appropriate mailbox. Include your phone number and address and the public works staff member on call will get back to you. If it is an emergency, please call 911 immediately. Also, please be reminded, that St. Charles Connect is not monitored after hours and should not be used to report an emergency situation.

If you notice rusty-colored water, simply turn on the cold water tap until the water runs clear. Rust-colored water is safe, but it may stain laundry. If this happens, keep clothes wet and treat them with stain remover. The City offers a stain remover at no cost to residents at the following locations:

Back by Popular Demand: Citizen Police Academy

Applications Due March 4

Ever wonder what it's like to be a part of the Law Enforcement profession? Sign up for the St. Charles Police Department Citizen Police Academy, March 5 - April 30, and you can find out.

This annual program gives participants a better understanding of how the Police Department operates. Some topics covered include:

- Criminal & narcotics investigations
- Arrest and search procedures
- Courts
- Traffic stops
- K-9 unit
- SWAT Team
- Crime scene processing

Both classroom instruction and outside demonstrations are used when possible. And CPA students may get an opportunity to participate in an activity, such as processing a "crime scene" for fingerprints or getting a radar reading on a moving vehicle.

The class meets Tuesdays and Thursdays, 7 to 9 p.m., for nine weeks. Most of the classes are held in the St. Charles Police Department

Deputy Chief Kintz Named VP of Kane County Chiefs Association

St. Charles Police Department Deputy Chief David Kintz recently was sworn in as Vice President of the Kane County Chiefs of Police Association. The appointment was made at the organization's January meeting. Deputy Chief Kintz previously served as Secretary and Sergeant-at-Arms.

The association is comprised of command officers from law enforcement agencies throughout Kane County. The group shares the latest information about legal and technology issues, as well as

management best practices.

Deputy Chief Kintz also chairs the Kane County Accident Reconstruction Team as well as the Awards Committee, which recognizes the top cop in the county each year.

The association provides funding for several task forces in the county, including the Major Crimes Task Force, Kane County Accident Reconstruction Team, and the Fire and Arson Task Force. It also awards college scholarships to children of officers in Kane County.

A Winter of Extremes...

From sub-zero temperatures and wind chills to 40° F highs--or freezing rain to frequent snowfall, this has been an interesting (and infamously record-setting) winter so far!

One of the most important winter responsibilities of Public Works is to clear the roads of snow and ice for safe travel. Most people see the plows out working, but may not realize there is an entire interdepartmental team collaborating "behind-the-scenes" to support snow/ice control efforts 24/7.

Before the Weather Hits

Winter preparations start long before the first snowflake falls. Heavy equipment is prepared; crews take practice runs; maps are reviewed and routes planned; shifts are coordinated and assigned; and supplies are ordered and stored.

The first line of defense against winter precipitation is the application of a salt-based brine solution. Used as a pre-wetting application, the solution aids snow/ice removal snow and acts as a de-icing agent. The City stores more than 7,000 tons of road salt and has an ample supply of brine solution.

Tracking the Storms

Staff watches the weather using a computer alert and forecasting system to help plan snow operations. City snow crews are scheduled around the clock when necessary. This winter, St. Charles snow crews have worked day and night--even on holidays--through more than 18 winter events.

Quick Response

Direct radio communications with crews on the road allow for quick response to reports of hazardous road conditions. Our Police Department, Tri-Comm and observant residents often are first to accurately report current conditions.

1. To begin the Approval Process, complete the form below and send it to the City of St. Charles Public Works Department, Attn: Public Services, 2 E. Main Street, St. Charles, IL 60174
2. Once we receive your completed pre-order form, a Public Services team member will conduct a parkway review to determine tree spacing, soil condition and existing underground utilities. All of these factors impact planting a new tree. Our team looks forward to helping you select the best tree for your parkway.
3. After the parkway review, a letter is sent detailing approval status. If your request has been approved, you also will receive an order form and instructions on where to send your order with payment.
4. If at any time you have questions, please contact Public Works at 630-377-4405.

Pre-Order forms received as of March 1 will be considered for planting in the spring. Forms received by August 1 will be considered for planting in the fall.

Tree Care: Right Tree in the Right Place

Proper tree selection and placement enhances property value, prevents costly maintenance trimming and lowers the risk of damage to your home and property, according to the International Society of Arboriculture.

Plan for Proper Planting

Planning before planting can help ensure the right tree is planted in the right place. The City of St. Charles arbor staff is dedicated to the planning process. As our arbor team prepares to plant new trees this spring, many aspects are considered. For each planting space the team reviews above and below ground planting space, local utilities present, existing plantings, soil type and wet/dry zones.

Trees and Utilities

Proper selection and placement of trees around overhead utilities can help eliminate power outages, reducing utility expenses. If tall growing trees are planted under utility lines, they require pruning to maintain clearance. Tree limbs making contact with the wires can result in service interruptions. In addition, utility pruning can result in the tree having an



unnatural appearance.

Much harder to recognize are problems involving underground utilities such as water, sewer, and natural gas. The root area of a tree is usually larger than the branch spread above ground. The City will determine the location of utility lines below ground before planting begins. In most cases, a distance of at least ten feet from any underground utility, including streetlights and driveway aprons, is required.



Report an Outage to 866.444.0016

St. Charles Electric Utility customers, be sure to register your phone number with the automated telephone notification system.

Based on caller I.D. technology, the system links customers' phone numbers to their accounts so the location of the outage can be identified automatically when they call to report an issue. It also allows customers to receive updates regarding the outage

and a return call to confirm power restoration. The system can handle heavy call volumes and quickly relays outage information, reducing crew response times.
