Sustainability Initiative Generates \$3 Million

In May 2010, the City initiated the St. Charles Sustainability Initiative to balance the budget and maintain strong financial footing during very difficult economic conditions. The initiative supports a main objective of the strategic plan: to maintain an optimal service delivery framework that balances resources with needs.

The City solicited suggestions from staff and community stakeholders. After reviewing and evaluating more than 130 ideas received, the Mayor and City Council approved implementation of 54 ideas in these five areas:

1. Capital Projects & Assets
2. City Services & Programs
3. Employee Compensation/Benefits
4. Support for External Agencies/Groups
5. Taxes and Fees

To date, 34 ideas have been implemented, resulting in more than \$3 million in either cost savings or revenue generation. Four large-scale ideas implemented (and their values) include:

- Voluntary separation incentive program for city employees, resulting in reductions in the workforce (\$900,000)
- Changes to the employee health insurance program (\$400,000)
- Reduction in front-line engine companies related to the termination of the relationship with fire protection district (\$750,000)
- Elimination of low-use vehicles in the city's fleet, or extension of the replacement schedule (\$800,000)

The outcomes have been extremely positive, and more is to come. Thirteen additional ideas are in the process of being implemented. ## It's Hot Out There! Please Remember Parkway Trees When Watering

Unusually hot, dry conditions are leaving many trees thirsty. Watering is one of the most important things you can do to care for your trees. And for newly planted trees, regular watering is essential.

Every new parkway tree the City plants receives a "gator bag" slow release watering bag. Normally, the City waters new trees about once a month from June through September. We have accelerated that schedule due to the excessively dry conditions. But if your parkway tree appears thirsty in between these waterings, you may want to refill the bag. The life of the tree may depend on it! Simply lift the white "Tregator" tag to expose the hole in the bag, insert the hose and fill the bag with water. ## Take Extra Care with Outdoor Fireplaces & Fire Pits

The St. Charles Fire Department would like to remind everyone of the guidelines for using outdoor fireplaces and fire pits. These regulations are especially important with the hot, dry weather we have been experiencing this summer. The City's Fire Prevention Code, Title 15, Chapter 15.28, allows these uses of outdoor fireplaces:

- The unit should be at least 15 ft. from any structure (house/garage/deck) and in an open lawn area. Recreational fires not contained in an outdoor fireplace, portable outdoor fireplace, barbeque grill or fire pit, should be 25 ft. from any structure or combustible material.
- Use only clean, well-seasoned wood—no leaves, compost, brush, waste materials of any kind or holiday decorations/trees.
- The fire should not burn for more than 2 hours and must be constantly attended until extinguished. The fire must be properly extinguished prior to leaving unattended.
- Some type of fire extinguisher must be available for immediate use (ex. garden hose).
- The fire must be 3 ft. or less in diameter and 2 ft. or less high or according to manufacturer's instructions.
- Open burning is prohibited when weather conditions or local circumstances make it hazardous. Be alert to wind speed/direction and courteous to neighbors.
- The City Fire Code Official may order any open burning be extinguished if it creates or adds to a hazardous or objectionable situation.



The City recommends following a "good neighbor" policy to minimize complaints. This allows the Fire Department to be available for emergencies. For more information, contact the Fire Department at 630-377-4458.

## Brush Pick Up Schedule

East Side	West Side

Brush (branches at least 3 ft. in length and less than 12" in diameter) must be placed on the parkway, cut ends facing the street before 7 a.m.

Do not tie bundles of brush with rope or wire. Brush must not be piled higher than 4 ft. and never piled in the street.

Brush also can be placed in paper yard waste bags for pick-up with regular refuse. Either bags with the City logo or generic bags can be used. Generic bags require one refuse sticker on each bag.

## BID Designation Considered for East Main Street Corridor

The City of St. Charles currently is studying the potential for creating a Business Improvement District (BID) along the Main Street commercial corridor on the east side, from 6th Avenue to the city's eastern border.

Communities in Illinois are permitted to designate a BID to revitalize, redevelop and remove blight from a particular area. By exploring a Business Improvement District designation, the City is taking a proactive approach to creating economic development opportunities to address underdeveloped, underutilized and/or declining commercial areas of the city.

According to state statute governing BID designation, communities are allowed to enact a sales tax and/or hotel tax of no less than 0.25%, and no greater than 1.0% in support of the district. All revenues generated from these taxes must be used only for activities that materially benefit properties located within the district boundaries, such as economic incentives, redevelopment programs and infrastructure.

An eligibility study was completed which determined the area does qualify as a BID. At its June 18 meeting, the City Council approved moving forward in preparing a District Redevelopment Plan, a prerequisite in considering formal BID designation.

## EAB Update

Since the Emerald Ash Borer (EAB) infestation was first detected in St. Charles, the Public Works Department has been actively inspecting the City's ash trees. Any ash trees in the public right-of-way (parkway) that have been confirmed with EAB are marked with a purple dot. If the confirmed EAB tree is selected for removal and replacement due to the severity of the infestation, it will be marked with a pink dot.



Homeowners adjacent to parkways will receive a letter notifying them if the parkway tree is confirmed with EAB. If it is determined that the tree must be removed, you will receive information about removal, along with a form outlining replacement options. It is important to return the form indicating your choice of a replacement tree within two weeks. If the form is not received, a selection will be made for you, consistent with the character of your neighborhood.

It may take more than a month before a tree marked for removal is taken out. After removal, the stump will be ground and the land restored, weather permitting.

Replacement trees will be planted either in the fall (October/November) or spring (April/May/June), depending on when the tree is removed and the species of replacement tree chosen. ## Electric Outage Reporting System

### Residents, Register Your Phone Number Today

If you are a St. Charles Electric Utility customer, then be sure to register your phone number with the automated telephone notification system.

Based on caller I.D. technology, the system links customers' phone numbers to their accounts so the location of the outage can be identified automatically when they call to report an issue. It also allows customers to receive updates regarding the outage and a return call to confirm power restoration.

The system can handle heavy call volumes and quickly relays outage information, reducing crew response times.

## Combating Pesky Mosquitoes

St. Charles has a robust program for combating mosquito outbreaks, which includes surveillance and monitoring, and larval and adult control. But you can help too. Here's how:

1. Discard buckets, bottles, or any water holding containers sitting outside.
2. Fill in or drain any low places in the yard.
3. Cover trash containers to keep out rainwater.
4. Repair leaky pipes and outside faucets.
5. Empty plastic wading pools at least once each week.
6. Make sure your backyard pool is properly cared for while on vacation.
7. Change the water in birdbaths and planters frequently.
8. Keep grass cut short and shrubbery well-trimmed around the house.
9. To prevent bites, the Illinois Department of Public Health encourages residents to use insect repellent, avoid being outdoors during dawn and dusk hours when mosquitoes are most active, and to wear long sleeves.

## Did You See Your Annual Water Quality Report?

The City of St. Charles is committed to providing a continuous supply of safe, reliable and economical water to its customers. Every year, the Water Division distributes a report that summarizes the quality of the City's drinking water. We are pleased to report that again this year, your tap water met all EPA drinking water health standards. The water is tested daily in accordance with strict EPA regulations, so you can be assured that your drinking water is safe and meets or exceeds all water quality standards as listed in the Safe Drinking Act.


### What Is a Water Quality Report?

A water quality report, also called a Consumer Confidence Report, lets you know what contaminants, if any, are in your drinking water and how they may affect your health. It lists all the regulated toxicants that were detected in your water over the preceding calendar year (2011).

### What Does a Water Quality Report Tell You?

- The source of the drinking water--river, lake, aquifer, etc.
- EPA regulations and health goals for drinking water contaminants.
- A list of all detected contaminants and their levels.
- Potential health effects of any contaminant detected at a level that violates EPA's health standard.
- Information about cryptosporidium and other microbial contaminants for people with weakened immune systems.

## New Lawn Watering Permits

A permit is required for watering newly installed sod or seeded lawns. The permit can be obtained at the Utility Billing Office at City Hall or the Public Works Facility at 200 Devereaux Way for \$10. This permit allows a resident to water a new lawn with a sprinkling device(s) for up to eight hours on the first day. The next consecutive nine days, watering is permitted between 12:00 a.m. and 9:00 a.m., and between 6:00 p.m. and 10:00 p.m. Following this 10-day period, the resident must comply with the water conservation schedule.



## Local Flood Hazard Awareness

The summer has been overly dry so far. And while St. Charles generally has not experienced wide spread damage due to flooding, there are local flood hazard areas throughout Kane County. Flooding from the Fox River, Ferson Creek, State Street Creek, 7th Avenue Creek, and Norton Creek usually can be forecast in advance. However flash flooding along these rivers and the numerous tributaries to these waterways may occur suddenly and unexpectedly.


