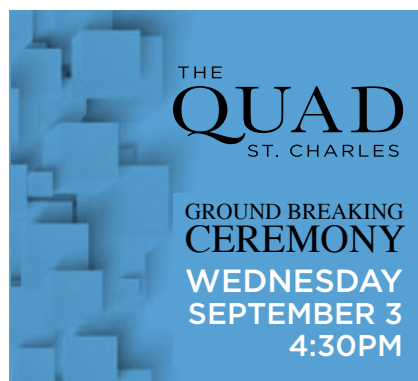

Final Resting Place: The Jones Law Office Building

Recently, the City moved the historic Jones Law Office Building from its location at 304 Cedar Avenue to a site in Langum Park along Rt. 25 near Devereaux Way. But that's not the first time the building has been moved.

According to the St. Charles Public Library, Steven Sandborn Jones was a lawyer who moved to St. Charles in 1838 from Vermont. He is credited with proposing the town change its name from its original Charleston to St. Charles after he learned another Illinois town already had the Charleston name.

During the Civil War, the small law office building served as a holding cell

for deserting soldiers. Evidence of the soldiers' presence is still apparent in the graffiti they left behind.

At one time, Jones' St. Charles law office was attached to the west side of the Minard House at 504 East Main Street. In 1988, the office was moved to its current location behind the Dunham-Hunt House at 304 Cedar Avenue. The City sold the Dunham-Hunt House property in 2013. St. Charles Police Department Again Receives National Accreditation

The St. Charles Police Department was granted its 8th Award of National Accreditation by the Commission on Accreditation for Law Enforcement Agencies (CALEA). The award was presented July 26 at the CALEA conference in Schaumburg, Ill. The department received the Meritorious Award, given to Agencies that have participated in CALEA for 15 years or more.

The accreditation came after a four-day, Gold Standard on-site inspection by a CALEA team of assessors in April. The assessors completed interviews with Department personnel and City officials, and also met with community leaders. Police Department policies, procedures and required reports were reviewed for compliance with 482 standards. The assessment team noted the St. Charles Police Department has dedicated, well-trained personnel, who have a good relationship with their citizens and business owners.

The St. Charles Police Department first achieved its accredited status in 1989, and was one of the first agencies in the State of Illinois to become nationally accredited. The reaccreditation period is three years, during which the agency must submit annual reports attesting to continued compliance to the standards. Maintenance on the City's Parking Garages is Underway

Most Parking Spaces will Remain Accessible throughout the Project

Concrete maintenance and repairs, sealant replacements and miscellaneous preventive maintenance work is underway on the City's two parking garages. Work is underway first on the westside parking deck at Illinois & 1st streets. Once finished there, maintenance to the eastside garage on 3rd & Walnut avenues will begin. Repairs are expected to be complete by October 17.

Both garages will remain open during the project. Temporary floor closures and the reservation of a limited number of parking spaces will be likely so crews are able to secure a work space. J. Gill & Company is the contractor on the project.

"We don't expect parking to be greatly impacted while the garage maintenance is underway," said Chris Adesso, Public Services Manager. "Most parking spaces will remain accessible throughout the project, with special consideration given to the dedicated electric vehicle charging station spaces in the 1st Street garage." 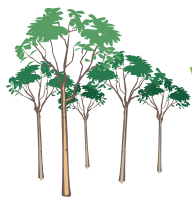
Do You Know about the Electric Outage Hotline?

Report an Outage to 866.444.0016

St. Charles Electric Utility customers be sure to register your phone number with the automated telephone notification system.

The system links customers' phone numbers to their accounts so the location of the outage can be identified automatically when they call to report an issue. It also allows customers to receive updates regarding the outage and a return call to confirm power restoration. The system can handle heavy call volumes and quickly relays outage information, reducing crew response times.

Fall Trees will be Planted Soon

Nearly 400 parkway trees were ordered last month as part of the 50/50 Parkway Tree Program. Planting will begin in early October. The contractor will begin marking white hash marks on the curbs indicating where the trees will be planted. Most newly planted trees will be fitted with a gator bag to provide a slow drip of water to the roots. In addition, the contractor has begun to remove the gator bags off any trees that were planted in the spring.



If the fall season is dry, place a hose at the end of the tree drip line, letting the water flow at a slow trickle for about 20 minutes. Watering once a month should be sufficient. **Note:** overwatering symptoms for trees are the same as those for under watering – leaves fall off, turn brown or appear wilted.

Hydrant Flushing Begins the Week of Sept. 29

Hydrant flushing improves water quality and minimizes mineral build-up in the water mains. It also ensures that hydrants are ready for emergency use.

Fall Hydrant Flushing Schedule

September 29 - October 3 - Hydrant flushing will begin on the west side of the Fox River south of the Timbers subdivision, continuing south to Gray Street and west to North/South 16th Street.



October 6 - October 10 - Hydrant flushing will begin on the east side of the Fox River south of Iroquois Avenue, continuing south to Division Street and east to North/South 14th Avenue.

Please watch for signs announcing hydrant flushing in specific areas. Also, for approximate dates in your neighborhood, visit the My Neighborhood section of the City website, www.stcharlesil.gov. Click [here](#) for a hydrant flushing map.

Water is safe to use and consume during hydrant flushing, however, residents may temporarily experience rusty-colored water. During hydrant flushing:

- If possible, limit water use.
- If water is rust-colored, wait until flushing has subsided, then turn on the cold water tap until water runs clear.
- Rust-colored water may stain laundry. Keep stained clothes wet and treat them with stain remover, available free of charge at **Public Works**, 1405 South 7th Ave.; **City Hall**, Reception Desk, 2 East Main St.; **Police Department**, 211 North Riverside Ave.

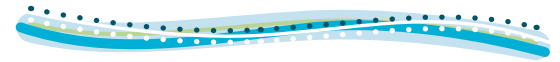

Guidelines for Draining a Swimming Pool



Your swimming pool is filled with chlorinated water. Chlorinated water discharged directly to surface water (wetlands, lakes, streams, and rivers), roadways or storm sewers has an adverse impact on local water quality. High concentrations of chlorine are toxic to wildlife and fish.

Safe pool draining recommendations:



- De-chlorinate the water in the pool before draining, either mechanically or chemically. These products are readily available at local stores.
- Or, drain the pool across your lawn over a period of several days using the following these guidelines:
 1. Allow pool water to sit at least 2 days while receiving a reasonable amount of sunlight, and without further addition of chlorine or bromine. It is recommended that the chlorine level be tested after 2 days to ensure that safe levels are met (below 0.1 mg/l).
 2. Pool discharge should be directed across your lawn, not down your driveway or into nearby storm sewer inlets. Our storm sewer system leads directly to wetlands, streams, lakes or rivers.

These recommendations are based on guidance from the Illinois Environmental Protection Agency. Please do your part to help promote cleaner wetlands, streams, lakes and rivers. Fire Pit Safety

Fire Pit Safety Tips from the St. Charles Fire Department:

- Outdoor fireplaces/fire pits shall be at least 15 feet from any structure or combustible material and in an open lawn area.
- Recreational fires not contained in an outdoor fireplace/fire pit must be at least 25 feet from any structure or combustible material and also in an open lawn area.
- Large outdoor fireplaces that are built on a foundation are allowed however, require a building permit from the City.
- Use only clean, well-seasoned wood – no leaves, compost, brush, waste materials of any kind or holiday decorations/trees.
- The fire must be constantly attended until extinguished.
- A fire extinguisher or garden hose must be available for immediate use.
- The fire must be no greater than 3 feet in diameter and 2 feet high.
- Open burning is prohibited when atmospheric conditions or local circumstances make such fires hazardous. Be alert to wind speed/direction. A City Fire Code Official may order the extinguishment of any open burning that creates or adds to a hazardous or objectionable situation.

2014 Leaf Pick Up Schedule

It's almost time to rake falling leaves again. Leaf pick up begins October 28 and runs through November 26. This year's schedule will follow an East/West schedule similar to the City's Brush Pick Up program. There will be a total of three pickups for the season.



As with brush pick up, all leaves need to be placed out on the parkway by 7:00 a.m. on your scheduled pickup date, even though it may take 3 to 4 days before your specific area is picked up. Once the crews move through an area, they will not return until the next scheduled pick up. Be sure to check the City's website www.stcharlesil.gov and click on the **Leaf Pick Up icon** on the home page or check the October issue of *The Den* for a complete schedule and pick up procedures.



Remember, leaves also make wonderful mulch in garden beds. Or, you can put them in yard waste bags for pick up through November 24. For more information, contact Public Works at pw@stcharlesil.gov or 630.377.4405.

Brush Pick Up Schedule

EAST SIDE	WEST SIDE
Sept. 15	Sept. 22

Brush (branches at least 3 feet in length and less than 12 inches in diameter) must be placed on the parkway, in front of your house (or along the frontage where refuse/recycling is collected), cut ends facing the street before 7 a.m. on Monday of the scheduled pick up (or Tuesday if Monday is a holiday). Please note: Pick up in your area may take 3 to 4 days to complete.

Do not tie bundles of brush with rope or wire. Piles should not be higher than 4 feet and never put in the street. Don't park in front of the piles. More is on our **Brush Pick Up page**.

Protect Your Property from Flood Damage

Reduce damages on property that is susceptible to flooding:

- Apply watertight seals to brick and block walls to protect against low level flooding. (less than 2 feet).
- Elevate furnaces, air conditioners, water heaters and major appliances on platforms or move them to higher floors.
- Sandbag and remove items from areas prone to flooding.
- Elevating or relocating the entire structure may also be a feasible option.
