Community officials who are authorized by local law or ordinance to provide floodplain management information, may also sign the certification. In the case of Zones AO and A (without a FEMA or community issued BFE), a building official, a property owner, or an owner's representative may also sign the certification.



COMMENTS: The Royal Fox subdivision is in part of Sections 13 and 24, Township 40 North, Range 8 East of the Third Principal Meridian.

Item 5 in Section B is a true statement, based upon protraction of the building site on the referenced FIRM. However, by the elevations measured around the constructed home, the building site is actually in Zone C.



The diagrams above illustrate the points at which the elevations should be measured in A Zones and V Zones. Elevations for all A Zones should be measured at the top of the reference level floor. Elevations for all V Zones should be measured at the bottom of the lowest horizontal structural member.
