Kathy Brens: "Good evening. I'm Kathy Brens and as I said last month, I'm a retired district 303 high school English and public speaking teacher. One of the techniques that we teach for both essays and speeches is the use of a comparison contrast format. Here there is a topic and two aspects which will be compared and contrasted. In my example, the topic is authoritarianism, and the comparison will be between Adolf Hitler and Donald J Trump. All entries must be factual and capable of being checked. Here we go, Hitler, followed by Trump. Hitler used racism to rise to power. Trump uses racism to rise to power and stoke fear. Hitler proposed to make Germany great again. Trump promises to make America great again. Hitler, an anti-Jew fascist. Trump anti Muslim fascist. Hitler blames the Jews for Germany's problems. Trump blames immigrants for America's problems. Hitler thought the Jews should wear special IDs. Trump thought Muslims should wear

special IDs and scapegoats' minorities. Hitler said the press was the enemy of the people Trump, the press is the enemy of the people. Hitler, the rule of law was suspended. Trump, the rule of law is ignored and obstructed. Hitler, secret police arrested enemies of the state Trump, masked agents arrest civilians protesting Hitler. Armed Forces invade opposition territories. Trump Armed Forces invade blue states, uninvited. Hitler. Jews are vermin and pests that must be exterminated. Trump says that we need to root out his political opponents that live like vermin within our country. Hitler contamination of the blood by an inferior race would lead to the fall of Germany. Trump immigrants are poisoning the blood of our country. Hitler, we must recognize the greater inner enemy. Trump says my political opponents within our country are far worse than the dictators of Russia and North Korea, Hitler sought to delegitimize democratic institutions. Trump delegitimizes institutions who do not serve his political goals, the courts, the electoral process, the certification of an election, democratic opposition, even branches of the administration that do not fall in line. Hitler called the media press of lies. Trump called mainstream news media fake news. Hitler cozied up to Mussolini. Trump cozies up to Putin Hitler. Signs were ignored. People were in disbelief Trump; too many people are ignoring Trump's worst impulses. Hitler took advantage of bad economic circumstances. Trump blames others. Dollars for the bad economics even almost a year into his second term. There are other points that could be made, but I want to get to our situation here in St. Charles, several of my fellow citizens spoke a few weeks ago stating about how much safer they felt from the danger of immigrants thanks to the presence of ICE, I would question if those fears existed a year ago or two, or whenever they arrived in St. Charles, or if the fears appeared along with the advent of the ICE squads and the fear and anxiety their actions engender. Speaking for myself, I am an 80 year old widow, and I am not afraid of the immigrant population in my hometown of the last 49 years, be they legal or undocumented, the vast, vast majority of people in this town, including the immigrant population, are hardworking, conscientious individuals, paying their taxes, raising their children and hoping for a good, productive life for their families. I am, as is true for virtually everyone in this room, with the possible exception of anyone of Native American heritage, I am a descendant of immigrants. Does the fact that a major branch of my family immigrated in 1640, almost 400 years ago, make me special, more worthy, more deserving of a larger portion of the American dream. Of course, not. Every immigrant in every age yearns and strives for the ideal set forth in the 18th century of life, liberty and the pursuit of happiness. So what am I afraid of? I'm afraid of Black Hawk helicopters landing near an apartment building in Chicago in the middle of the night, dragging out every resident, men, women and children, securing them with zip ties. What did that stunt cost us as taxpayers? And by the way, not one of those individuals was eventually arrested. I'm afraid when I see protesters and please reference the First Amendment, tear gassed a Congressional Representative pepper sprayed, a priest shot in the forehead with a pepper ball bullet, women thrown to the ground while

attempting to protect their neighbors, children separated from their parents or coming home to find them gone and on and on and on. I am terrified of losing my rights as an American citizen, especially freedom of speech, freedom of the press. This is a real fear, especially when we have a leader who refers to those who disagree with him or challenge him in any way or question any of his actions with crude and hurtful language, retarded, Piggy, ugly within and without, low IQ. Notice how Marjorie Taylor Greene has gone from a rising young star of the Republican Party to low IQ. Marjorie traitor Brown and these are just a small sample. I am afraid that the democracy I enjoyed growing up, raising my family, living in my adopted hometown, will be permanently harmed. Democracy itself in danger. Are we perfect? No, and never had been. But in general, I believe that we as a nation have been striving toward a more perfect union. I want that back again for whatever time I have left, and more importantly, for my children, grandchildren and generations to follow. I stated last month, paraphrasing the quote, evil thrives when good people say nothing. At the recommendation of my middle son, also an English teacher, I want to add, please let us listen to our better angels. One final personal note, the somewhat ugly, bulky sweater I am wearing belonged to my late husband, Jack Brenz. I wear it to honor his memory and to always remember one of his often repeated remarks the best: The best gift my folks ever gave to our family was moving us to St. Charles, I hope to continue feeling the same. Let's pass the proclamation, the city ordinance, or whatever it takes to get ICE out of our town and keep it out. Thank you."

Heather Herrera: "Good evening. I'm still Heather Herrera Ward five, the last time I was before you, I presented verified data from activity related to federal agents in St. Charles, and since that time, interactions observed by the community have only escalated. Before I begin, I will give you a quick rundown of my credentials, so it's clear I'm speaking from a well-informed perspective, one that honors the community, represents the many who are still too terrified to come forward. I have a formal education in political science, prelaw, Latin American Studies and Spanish. I have 20 years of experience in regulatory oversight, risk and compliance, with a specialty in cyber security and data integrity. I've been in the I've been a courtroom observer for nearly 30 years in DuPage in King County, and I have a lifetime of volunteer experience with a variety of organizations working to better the communities in which we live, work and enjoy. And the last part is exactly how I identify myself. I'm an advocate by nature. I bridge the gaps and look out for my community whenever I can. And one missed opportunity for me was when I saw you last week, on Wednesday at 711 Mayor Hull, the parking lot was frozen over. The snow flurries made it hard to see, and once I returned your Hello, I fought the instinct to respond with "Watch out. There's ice out there", because I wasn't sure if you'd receive them in sincere and it is the perfect analogy for how I view the city council and police department leadership when it comes to preparing for the dangers of our streets. I've been informing you since the beginning, and it would seem we have different interpretations of how to prepare for such conditions.

Despite the inherent risks. To date, there hasn't been acknowledgement or the desire to proactively protect the data of the residents, whether it be the city data flock cameras or drones currently being accessed by federal agents, there hasn't been a desire to take a formal stand on the illegal conduct of federal agents within the city limits, especially when they endanger the community, there hasn't been a commitment to ensure that those posing it as agents are even legitimate. So when we all stood and pledged our allegiance to the flag, know that only some of us truly meant the words with liberty and justice for all, because there are no caveats or Terms and Conditions on that belief, and when our actions don't match our words, my dad would have called that chin music. And as it stands, I've already implored you to take action, invited you to learn more in emails and multiple up with my multiple public comments, the fact that I've never received a response from my other person, Weber, Bessner, nor Chief Likens, tells me that I'm not the educated demographic worthy of your consideration. With that, I'll keep being the trusted advocate for my neighbors and still welcome any and all actions that serve the community you portend to value. Thank you for your time tonight, and please do watch out. There's definitely ice out there."

Linda Robertson: "Linda Robertson, St. Charles. I've lived in St. Charles for decades, and as some of you know, I have consulted all over the world, everywhere I was meant was there I was met with kindness and respect. Most people, no matter what the country, are largely the same. They want safety, stability and a better future for their children. And some moved to this country because of those same goals. I worked in places like Lebanon, Indonesia, China and Venezuela, countries labeled as dangerous or authoritarian, yet in all those places I never encountered masked secret police. That is why what is happening in the US today is so alarming. I have no issue with lawful immigrant enforcement, legal deportation hearings, due process, actions that follow the law are essential. What I do object to is people being taken by men with no badges, no identification, no visible warrants, faces hidden behind masks. Even the Gestapo didn't use masks. People are being detained or tear gassed simply for questioning authority, which is our right or for the color of their skin. US citizens, taxpayers, business owners, have been caught up in this. People in their last step to take the Oath of Citizenship have been pulled out of line. Nearby towns have taken steps to object to ICE activity on city owned property. They have chosen to protect their residents and their values. I do not want St. Charles to gain the reputation as a town that welcomes intimidation and fear. I do not want to live in or spend my money in a town that looks the other way while neighbors are being taken without due process or proper warrants. And I know I am not alone in that it affects our businesses. Council persons, please signal that St. Charles does not align with secret police. We are proud Americans. We are not good. 1930s Germans, Thank you."

Sue Broxham: "My name is Sue Braxham, and I live in Elgin Township, and Elgin is one of the cities that has taken steps to protect our public property and our neighbors, and I'd like to thank you all for your dedication to the safety and well-

being of our community. My husband and I raised our family in the Fox Valley and our two sons, now ages 31 and 33 graduated from d300 of three with a wellrounded education, equipped with the opportunity to pursue their place in the world, as all families hope their kids can do. This is in no small part attributed to the small to the solid reputation of the city of St. Charles, along with the other cities and villages in the Fox River Valley that work hard to create a secure environment of community minded, family friendly places where people come to live, attend school, dine, work, play, shop, worship and seek professional legal and medical services. It's obvious from the banners lining Main Street that St. Charles is a city of big hearts. We all want to live in safe neighborhoods where we can build relationships of trust with our neighbors and our city officials. As a member of we can lead change. I have witnessed the big hearts of the entire Fox Valley through the community outpouring for the monthly food drive that benefit families who are afraid to leave their homes to shop for groceries, and some even afraid to go to school, work and medical appointments. This past Saturday, in the freezing single digit temperatures. People came to drop off their donations, and I would ask them where they live and how they heard about the need for these food drives. One woman who lives in Geneva told me that she teaches kindergarten at St. Joseph's in Elgin. She said that she has five-year-olds who tell her that they're afraid of ICE. As she told this to me, her chin began to tremble and she had to stop talking, and she drove away. Later that same afternoon, when I was helping to organize the donations, I met a fellow volunteer who told me she works for an OBGYN office in Hoffman estates, and that they recently had a pregnant woman come for her monthly checkup who couldn't stop crying throughout the entire appointment because she was so afraid to be outside of her house due to the invasive violence abductions by federal agents taking place throughout our communities. I have recently come to learn that when families have a family member taken by federal agents, they often have to sell off everything they own in order to pay for the legal fees. This creates deep hardships for the entire community and affects our local economies. A week ago, last Saturday in Elgin, I was present for nearly four hours while more than 30 masked federal agents armed with Taser guns, tear gas canisters, pepper spray cans and long guns staged a violent standoff to arrest Luis Jesus Acosta Gutierrez, one man who was wrapped in a blanket crouched on a second story balcony of an apartment Building on Maple lane. There was no judicial warrant presented for his arrest. Just the night before I had visited the same street with friends at a home a half block away from the chaotic invasion the community that showed up in Elgin on Saturday, December 6, came together in solidarity to say, we do not want our streets blocked off by unmarked vehicles and staked out by armed masked agents with no regard for the rule of law and due process, as reported by the Chicago Tribune, 31 year old Acosta Gutierrez, like more than 95% of the targeted community who is being detained by federal agents had no criminal record. People came from miles around to help out these neighbors on Maple Lane by bringing supplies to help rinse out tear gas and pepper sprayed eyes and provide saline solutions, food, hand warmers and blankets. I saw my friend Wilma from Batavia, walking down the street with an arm load of blankets to hand out. She later told me that there was a young girl shivering who couldn't get to her own house because of the federal agents, and she was so grateful when Wilma, who is a retired nurse, wrapped her in one of the blankets she had brought from her home. We are counting on our city officials up and down the Fox Valley to take the courageous steps to protect the residents, which means abiding by and upholding the recently signed state of Illinois salt act, HB 1312 to safeguard targeted immigrant communities from these unjust federal actions. Our cities are safer and stronger when we can trust our local government to work with the community and do the right thing. Thank you."

Meghan Staskal-Bradt: "My name is Megan Staskal from St. Charles, and I speak to you this evening, excited and energized after meeting with you, Mayor Hull and Chief Liken, I appreciate the time that both of you took and the honest and productive conversation. And after speaking with you and listening to members from of community, members from St. Charles and the surrounding areas, I think we all feel it's time to do something first, it is important to listen to different perspectives and understand where people are coming from, but then it's time to do the hard work. And some naysayers will say that it's not possible that people are so incredibly set in their ways that it's not worth trying to work together. And of course, there are those situations, but I do know it is possible because I've seen it happen here in St. Charles through the work of our school district. Dr. Gordon facilitated listen, learn and return sessions at a time when our community was coming out of covid and upset with critical race theory. Those discussions were heated. They were emotional, but they were impactful, and the result was that people left with a better understanding of different perspectives and a common goal of making our schools better for our students. And perhaps that's one idea that we could model for the community. In addition to having community discussions, what else can we do? Well again, look at successful models. When people see their elected council members, firefighters and police officers at food drives, at pancake breakfasts, at the schools and shopping at all the businesses, it sets a precedent that all people. People are valuable and appreciated. And I recognize that this is hard work, because if it was easy, we would have already done it. However, I figure if we can all live through this weather, we can probably accomplish anything. Ronald Reagan said, All great change in America begins at the dinner table. As a community, let's bring our perspectives, our concerns and logical solutions for moving forward to the table and become a place where people, not only from St. Charles, but from the surrounding cities, feel valued, protected and safe. I look forward to our next meeting, and I'm excited to implement realistic and achievable goals that will encourage the people of the Fox Valley to maintain and build trust in the city council and the police department."

M. Kathryn Manning: "Hello. I'm Katheryn Manning. I'm a 37-year resident of Geneva and a 25-year member of the St. Charles Episcopal Church in St. Charles, and I'm here representing the racial justice committee of the church. I attended the December 1 meeting and heard community comments for and against an ordinance prohibiting ICE from using city property. I was appreciative when Alderperson Muenz stated her reasons for opposing an ordinance. She mentioned concerns about potential lawsuits, plus not wanting to give residents unrealistic expectations. I hope I'm stating that correctly, that's your point of view. Her comments piqued my interest, and I was sincerely interested in learning more about the outcomes of this type of ordinance. Internet and AI search have confirmed that, yes, cities with these ordinances have been sued. I learned that there are two main categories of plaintiffs, the US Department of Justice and the State's Attorneys. These lawsuit arguments centered around the Supremacy Act, which holds that federal laws supersede local laws in times of conflict. They also claim that this type of ordinance interferes with ICE operations. I also learned that there have been no DOJ victories against small cities similar to the size of St. Charles, that there's been no victories in small cities with that have ICE ordinances. Most have been dropped or dismissed based on the 10th amendment's anti commandeering doctrine, a constitutional principle that prevents the federal government from forcing states to enforce federal laws against their will. Courts also stated that not allowing ICE to use city property does not interfere or hinder their ability to perform operations as they are unencumbered to do so elsewhere and with their own resources. However, there is one type of lawsuit which has been consistently successful, that is when plaintiffs sue ICE DHS and sometimes local law enforcement for allowing ICE to unlawfully arrest them on or using city property and resources. My takeaway from this is that cities are at higher risk of being sued for allowing ICE to use city property versus making a clear statement banning them from doing so. And lawsuits by arrestees against cities may increase given Illinois just passed HB 1312 a sweeping law that bans civil immigration arrests near sensitive locations like courthouses, hospitals, colleges and daycare centers, and creates a new Illinois act that lets people sue immigration officers and get at least 10,000 in damages for unlawful civil arrests and civil rights violations. The new Illinois anti-ICE law 2025 represents a significant step in protecting immigrant rights and ensuring that communities feel safe from deportation fears, and I assume this new law will give residents stronger grounds for suing cities who allow ICE on city property or to use city resources resulting in unlawful arrests. An ordinance would be a statement from St. Charles that local police follow the TRUST Act, and what it would clarify that local police resources will not be used for any federal immigration enforcement, including more nuanced efforts, such as not honoring ICE detainers without judicial warrants. It would clarify that federal agents will continue to operate in our communities without any assistance, but without any assistance from local law enforcement and resources. Regarding the Alderperson's second concern giving residents unrealistic expectations about being protected by

this ordinance, I consistently found statistics supporting the positive impact on communities who know their Local police will not assist ICE and their city prohibits ICE from using city property. People are more likely to collaborate and cooperate with local police when there's a strong commitment to this, residents are then far more likely to contact the police for help or to report crimes. But if residents do not see this commitment, they may avoid contact or collaboration with local police. Given the new Illinois law, an increase in people unlawfully arrested bringing lawsuits against both ICE and cities, I think an ordinance would put St. Charles in a far less litigious position and send a very positive message to residents. I encourage St. Charles City Council to support a new Illinois and support the new Illinois anti-ICE law 2025 and commit to an ordinance I personally believe it would put St. Charles on the right side of history. Thank you for your attention."

Scott Powell: "Good evening. Yes, I'm Scott Powell, resident of St. Charles for over 20 years, and tonight, I stand before you to highlight a concept that has permeated all levels of our political discussion, the fallacy of both sides. On its surface, the idea sounds noble, reaching out, compromising, finding common ground, the perception is wonderful. It feels good. And those who seek balance on every issue, it validates their work. However, just as this approach aims to engage people on each side of an issue, we must recognize that there is another side to the concept itself. Both sides can be and have been used as a convenient cover for inaction, a way to avoid difficult choices in governance. Not every issue has two legitimate sides, and some have only two right and wrong. Searching for common ground between right and wrong is a fool's errand, or worse, an excuse for inaction. Seeking compromise does not apply to every issue before a council or Congress or any public body. Sometimes the choice is simply between right and wrong. The decision may be comfortable, but you are our elected representatives and leadership demands tough choices, choices that may not please everyone. The both-sides approach often works, but it should be reserved for local issues like tax levies, new development, service expansion or program reductions. In these cases, finding a prudent middle ground can lead to effective moderate governance without violent ideological swings. But these times do not call for both sides. Our country is in crisis. People in our community are being terrorized by our federal government. Federal sanctioned kidnappings are happening across our town, township and county. There is no other side to state imposed terror. No other side to mothers disappearing from school pickup lines, no both sides to tear gas deployed in neighborhoods less than 10 minutes from where we meet tonight, flash bangs and pepper spray aimed at peaceful protesters and rapid responders does not have two sides. This is political violence and political violence is always wrong. We implore you then to stand with our residents of our city, all of the residents of our city, so everyone feels safe, going to work, to the hospital, family gatherings, to court dates or the grocery store. Disappearing people from their families, trafficking them out of state and placing them in modern day concentration camps does not have two sides. It is wrong, full stop, wrong. You

cannot seriously sit and listen to both sides of this. One side stands for justice, human rights, due process and the promise of the American dream. The other argues for lawless terror, kidnapping and concentration camps. There is no middle ground between human rights and black site prisons. Tonight is not about finding a middle path. It's about affirming a fundamental truth when leadership recognizes there is no other legitimate side. Human Dignity is not two sided. We urge you to reflect on this distinction in your deliberations and let your actions demonstrate where this city stands. We ask not for compromise or sense sitting, but for clarity, courage, truth, telling and a clear stand for justice. Thank you."

Colonel Jake Wyatt: "I'm Jake Wyatt, Colonel US Army retired, and I'm from St. Charles. And actually, I grew up in St. Charles, graduated high school here in 1966 so I have a little bit of history about this town, and I love this town. That's why I live in this community. But I chose a profession to be a military, professional military officer. And certainly, I'm sitting here, I've heard your comments. I really appreciate all of them. All of you have very valid points. I've lived through some of these terrorists that you guys talk about, and I'm going to talk about those in just a minute. But all of you have a very valid point. I spent 25 years of my life defending the Constitution so you have the right to sit here and express your freedoms and your free speech, and I still support that today, and every veteran here in St. Charles and throughout the nation still supports that, because we took an oath to defend and support the Constitution and States. So, help me God. Just as you took an oath of office, when you took your office to sit up here, you took an oath to support and take care of the citizens of this community and support the state and federal laws. My challenge to you is that you review the laws. You've been a sitting judge and superior court judge and a Supreme Court judge. You know the laws, but what I ask you to do is to take a look at your oath, make sure that you understand, are we following the letter of the law? Don't deviate. Don't let political affiliations take it one way or the other. Political affiliation should have nothing to do with this. They should be what the law is saying and how are we going to support our work of office, especially our constituents sitting here? Just a little bit of background. My first time, I was involved in potentially riot procedure as a young Second Lieutenant back in 1970 OPERATION GARDEN PLOT. 600 of us boarded a train at Fort Eustis Virginia, and we went up to Washington, DC because of potential riots that weekend for the elections that were going to be taking place. Thank God we never had to get off the train. We went up there, 72 hours on the train and came back home. That was my first exposure of potentially being involved with young civilians in a potentially hostile environment. After that, I went off and I flew Black Hawk. I fly everything in the army owns. But I went to Vietnam firsthand. I saw the atrocities over there on both sides, our side and the Viet Cong side and South Vietnamese side. And as you know, history tells me what happened from there. I'm not going to go into history of that, but then I had the opportunity also to serve in the Philippines when President Marcos was overthrown. I was there and part of the operation when we took a dictator for over 25 years that suppressed his people

and made billions of dollars off of his own people. That's a true dictator he was. But he was unseated. I knew the people that were going to unseat him, because I worked with them for over a year and a half before the revolution took place. Next opportunity I had was in Panama, when we took down or handled them. I had the opportunity for 72 hours in Grenada on the tarmac there. And then I had the opportunity in the capstone of my career, Desert Storm. I was the deputy J for logistics to Norman Swartz golf. So, I've seen attorney good and the bad and so on. One of the ladies got up here talked about traveling to other countries and so on. Well, I tell you, I've traveled almost the entire world, and every time I got off the plane, there was armed people with Uzis or some type of weapon to meet you when you came off. I didn't care if it was Germany, Paris, France, Switzerland, Zurich, Switzerland and Middle East or in the southeast, and we didn't have that in our airports until 9/11 took place. When 9/11 took place, that's when we started having armed police officials in our transportation system. The bottom line is, City Councilman, Mayor, I challenge you, along with the first responders and those that protect this city, follow the letter of the law. Let it be your guide, your conscience of what you do and vote, how you vote and support it. Thank you."

Dan Tulley: "Good evening, everybody. My name is Dan Tulley. My town of residence is Carol Stream, Illinois. I am really grateful for this opportunity to speak before you today. I am an attorney. I used to work with Venezuelan migrants applying for Temporary Protected Status and work authorization permits, and now my current work involves a lot of activity in this community, reaching out to folks and going to their doors, calling them at their homes, knocking on knocking on doors of voters. And a lot of the messages that I'm receiving are messages of fear. People are afraid, and keep in mind that these are people who are US citizens, who are who can vote in elections. Why are people afraid? Because there's been a Supreme Court decision that allows ICE to stop people and detain people based on a couple characteristics, one, the color of their skin, if it's darker, then if they speak English with an accent, if they speak Spanish, or if they appear in areas where there are agricultural workers. Now, all these factors lead to people who meet any one of those characteristics American citizens thinking that they have to take their passports with them more and whenever they go out, even if they take their kids to school, they have to come up with contingency plans about what they would do if one they get detained, when their kids are trying to come home, or if their kids are even taken. There's a lot and lot of fear, and that's what I want to bring to you today. What I'm hearing from voters and from people in this community now we there's a lot of folks that say, well, that's already done. ICE has already moved on to North Carolina, but we only saw a couple miles up the road in Elgin two weeks ago, ICE came out in full force, looking for one person ended up tear gassing the entire residential neighborhood, including a state senator who got gassed. State senator Christina Castro got gassed, a pepper ball hit somebody in the face who was protesting this. Now people asking this, in this context of fear, what can you do against masked agents who act with anonymity, pulling up their cloth over their

face, thinking that they can act without impunity, with no consequences? Some people go to protests. Others go to Broadview. Others make signs and go to homes. People you know, in this type of context, individual action is important, but it's not enough. Our federal government is not helping to protect people. In fact, it's encouraging. It's cheering on, in many cases, this action from the executive branch. In this context, we look to you the leadership of the local elements of government. Kane County has already taken a stand. The Kane County Board already passed a resolution saying that ICE can't use county property for operations. Other municipalities have taken a stand. Elgin neighbor to North, they've already taken a stand. All throughout this area, cities are taking stands, villages are taking stands, staying not here. We will stand up for citizens. And I understand there's this question of whether or not these measures are legal. There's a concern on this board whether an ordinance or a resolution would be appropriate, but I asked, wouldn't you rather be on the side that tried to take an action in this unprecedented threat, to take unprecedented action. Wouldn't you rather be on the side that tried to stand up for your citizens? I know that each person on this board is a committed public servant. You wouldn't be here otherwise you want to do what's best for the community. I stand before you today just to bring it to your attention that people are afraid you had the opportunity to take action, and I hope that you do. Thank you very much."

Susan Sanders: "My name is Sue Sanders and I'm from St. Charles. I have lived here for over 40 years. Good evening, Mayor Hull and members of the City Council, I'm back tonight to speak briefly on an issue that remains deeply important to me. I want to begin by thanking the City Manager, the Mayor and the two council members, Miss Spellman and Mr. Gehm, for communicating with me about concerns related to ICE activity in our community as vice chair of the equity commission, this issue is central to the work we do and to the well-being of our residents. I also want to thank Heather McGuire for responding to my email about the possibility of hosting a Know Your Rights informational training, similar to what. Batavia hosted at a city council meeting. Training like this could bring together City Council members, the Business Alliance and residents, so everyone has access to the same accurate information. I sincerely hope the city will consider this while the equity commission plans to receive training. There are only seven of us, clearly not enough to be trained. Thank you as well to council members Bob Gehm and Vicki Spellman for being open to exploring ideas beyond simply posting information on the city website, also for conferring with the attorney over HB 1312 to make informed legal decisions. As many of you know, I am a member of "We can lead change". Fox Valley, since the inception of ICE operations earlier this year, in October, "We can lead change" has been working with community groups to fulfill residents' needs for supplying Know Your Rights information sessions for collecting food donations for those too afraid to leave their homes to shop. Thus far, we have collected more than 100 carloads of food and supplies that have been shared with hundreds of families this past weekend, "We can lead change", along with other

organizations, hosted a food and supply drive for families directly impacted by ICE activity. The St. Charles site was held at La Huerta grocery store, as we heard here last month, the owner, Laz, shared that his business was down 50% since ICE activity began. We believed encouraging donors to shop at La Huerta would support both families in crisis and the struggling local business. Thank you, Mayor Hull, for showing up on Saturday and shopping alongside community members. Your presence and generosity mattered and Bob Gehm, thank you for constantly showing up to support these food drives. These gestures are appreciated; however, they do not fully address the fear that continues to exist in our community. There is a targeted population that needs to feel safe simply to shop, go to school, attend church or walk down the street. And the targeted population, as you have probably read, is growing. Eventually, many of us could be included. We work with the police department, "We can make change" goes in three towns. We work with churches from all over the area. We train people from all over the county and the country, but our own town has not decided to stand up. Yet we will continue to do this work without the partnership of the elected representatives on this council, if necessary. 10 days ago, I witnessed an ICE operation in Elgin involving 30 to 40 masked and heavily armed agents without warrants or badges using tear gas, flash bang devices in a residential neighborhood. I never thought I would see this in America, let alone seven miles from my home. It would be naive to assume this could never happen in St. Charles. The mayor of Elgin made a public statement, standing up for his community and condemning ICE actions. I am asking our city leadership to continue brainstorming meaningful steps. Do not hide behind the website. We ask that you make a public statement and own it. Silence is unacceptable. Our residents deserve safety, clarity and proactive leadership. Thank you."

Executive Summary (if not budgeted, please explain):

After discussion at the December 15 Government Operations Committee, City Council gave direction to proceed with drafting the Ordinance to proceed with the Committee of the Whole structure in lieu of the standing committees.

These meetings will take place immediately following City Council meetings, generally on the First and Third Mondays each month. 2nd and 4th Mondays will be available for strategic workshops or additional meetings as directed by City Council.

After presentation at Government Operations, the following were implemented into the final ordinance for approval:

- 1. Section 2.04.020: Start time remains at 7:00 p.m.
- 2. Section 2.04.030: Special Meetings—Remains as three (3) council members to call a special meeting, per state statute
- 3. Section 2.04.090(A): Composition. The Mayor shall *not* be a member of the Committee of the Whole. Additionally, the Chair shall rotate with each Council member, in order by Ward, serving as Chair for 2 consecutive meetings. However, if a Council member is absent for a meeting in which they were designated to Chair, the rotation shall proceed to the next Council member without returning to the absent Council member in the rotation, regardless of whether it was the first or second meeting at which they were absent. Also included is language that no Council member can choose to forfeit their turn as Chair while attending the meeting. The rotation will begin at the first meeting in February with Ward 1.
- 4. The Mayor shall preside at all meetings of the City Council. The Mayor shall not vote on any ordinance, resolution or motion, except:

- A. Where the vote of the Alderpersons has resulted in a tie; or
- B. Where one-half (½) of the Alderpersons elected have voted in favor of an ordinance, resolution or motion, even though there is no tie vote; or
- C. Where a vote of greater than a majority of the corporate authorities is required by state statute to adopt an ordinance, resolution or motion.

In each instance specified, the Mayor shall vote. Nothing in this section shall deprive an acting Mayor or Mayor Pro Tem from voting in his or her capacity as alderperson, but he or she shall not be entitled to another vote in his or her capacity as acting Mayor or Mayor Pro Tem.

2.04.070 Ordinances, resolutions and motions—Approval—Veto.

All resolutions and motions which:

- A. Create any liability against a city; or
- B. Provide for the expenditure or appropriation of its money; or
- C. Sell any city property;

and all ordinances, passed by the City Council, shall be deposited with the City Clerk. If the Mayor approves of them, the Mayor shall sign them. Those of which the Mayor disapproves, the Mayor shall return to the City Council, with any written objections, at the next regular meeting of the City Council occurring not less than five (5) days after their passage. The Mayor may disapprove of any one or more sums appropriated in any ordinances, resolution, or motion making an appropriation, and if so, the remainder shall be effective. However, the Mayor may disapprove entirely of an ordinance, resolution, or motion making an appropriation. If the Mayor fails to return any ordinance or any specified resolution or motion with any written objections, within the designated time, it shall become effective despite the absence of the Mayor's signature.

2.04.080 Ordinances, resolutions and motions—Reconsideration—Passing over veto.

Every resolution and motion specified in Section 2.04.070, and every ordinance, which is returned to the City Council by the Mayor, shall be reconsidered by the City Council. If, after such reconsideration, two-thirds (2/3) of all the alderpersons elected to the City Council agree to pass an ordinance, resolution, or motion, notwithstanding the Mayor's refusal to approve it, then it shall be effective. The vote on the question of passage over the Mayor's veto shall be by yeas and nays and shall be recorded in the journal.

2.04.090 Standing committee - Committee of the Whole.

There shall be a standing committee of the City Council known as the Committee of the Whole.

- A. Composition. The Committee of the Whole shall be comprised of the Alderpersons who serve on the City Council. Each meeting of the Committee of the Whole shall be chaired by an Alderperson determined by a rotating list of Alderpersons as follows: Ward 1 shall begin the rotation, with the most senior Alderperson of each Ward serving as Chair for two (2) consecutive meetings, followed by the next Alderperson from that Ward. The rotation shall proceed by Ward in numerical order. If an Alderperson is absent for a meeting at which they were designated as Chair, they shall forfeit their turn as Chair, and the rotation shall proceed to the next Alderperson in the cycle. In no circumstance shall an Alderperson be permitted to relinquish their duty as Chair while attending a meeting.
- B. Purpose. The Committee of the Whole shall consider all business that comes before the City and shall make recommendations regarding such business to the City Council.
- C. Meetings. The Committee of the Whole shall meet immediately after each regular meeting of the City Council.
- D. Agendas. Agendas shall be prepared under the direction of the City Administrator. However, additional items can be added by the Mayor or Council as follows:
 - 1. Prior to a meeting: the Mayor or any four (4) Alderpersons may direct the City Administrator to place an item on the agenda for consideration if the request is timely made; or
 - 2. During a City Council/Committee Meeting: the Mayor or any member four (4) Alderpersons may propose an item be placed for discussion on an agenda at a future meeting.

2.04.095 Committee of the Whole - Special meetings.

Special meetings of the Committee of the Whole may be called by the Mayor, or a majority of the committee members; provided, that a written notice of such meeting shall be given to each member of the committee at least forty-eight (48) hours before the time set for the meeting, except in cases of emergency as determined by the committee; and provided further, that in case all of the members of the committee are present at any such special meeting, then the requirement of written notice to such committee members shall be unnecessary and shall be deemed waived.

The taking of such single or consent vote and such entries of the words "consent vote" in the journal shall be a sufficient compliance with the provisions of the St. Charles Municipal Code for all intents and purposes and with like effect as if the vote in each case had been taken separately by yeas and nays on the question of the passage of each ordinance, order, resolution and motion including in such omnibus group, and separately recorded in the journal. Likewise, the yeas and nays shall be taken upon the question of the passage of any other resolution or motion at the request of any Alderperson and shall be recorded in the journal.

A consent agenda shall be prepared under the direction of the City Administrator and shall include the approval of minutes of council meetings, bills to be approved, and such matters the Administrator shall determine are routine, but must be under \$25,000. Upon the request of the Mayor or any single Alderperson an item will be removed from the consent agenda and considered individually after all other items of business on the consent agenda.

1. Authority:

- 1.1. The Illinois Open Meetings Act provides that members of the public must be given an opportunity to address public officials at open meetings and provides that public comment may be subject to the rules established and recorded by the public body.
- 1.2. Members of the public may address the City Council, pursuant to the rules established and recorded in this section. Reference to "City Council" is to include its committees, commissions and any other subsidiary bodies for the purpose of the application of this section. Said rules shall be posted at the area where members of the public address the City Council at a City Council meeting.
- 1.3. Any person may be expelled from City Council Chambers for the remainder of a City Council meeting by the Mayor or a majority vote of the City Council if that person:
 - 1.3.1. Addresses or attempts to address the City Council at a City Council meeting except in conformance and compliance with the rules provided in this section; or
 - 1.3.2. Otherwise acts in a disorderly manner so as to disrupt the ability of the City Council to efficiently conduct its meeting, including but not limited to:
 - 1.3.2.1. Acting or appearing in a lewd or disgraceful manner;
 - 1.3.2.2. Using disparaging, obscene or insulting language;
 - 1.3.2.3. Personal attacks impugning character and/or integrity;
 - 1.3.2.4. Intimidation;

1.3.2.5. Disorderly conduct (as defined by state law).

2. Process:

- 2.1. It is requested that all persons who want to address the City Council at a City Council Meeting during the time designated for public comment shall state their name and the subject matter upon which they wish to speak for the record. No person shall address the City Council until being recognized by the Mayor. The decision of the Mayor to recognize or not recognize a person may be changed by order of the Council.
 - 2.1.1. The purpose of the public comment is to allow members of the public an opportunity to address the City Council on issues of concern to them which are not part of the agenda.

3. Limitations:

- 3.1. Groups of speakers should, whenever possible, consolidate their comments and avoid repetition through the use of representative speakers.
- 3.2. Except during public comment, speakers shall focus and limit their remarks directly to the matter then under discussion and should be as brief as possible and to the point.
- 3.3. Speakers shall address their remarks to the City Council as a whole, not to any individual City Council members, nor city staff.
- 3.4. Speakers shall not ask questions of individual City Council members or a member of the city staff. Public comment is not intended to require individual City Council members nor city staff to provide answers to the speaker or engage in debate.
- 3.5. Discussions between speakers and members of the audience are not allowed.
- 3.6. The Mayor, or majority of the City Council, may suspend the rules in order to provide more public comment, as deemed appropriate.
- 3.7. Speakers shall refrain from harassing or directing threats or personal attacks at City Council members, city staff, other speakers or members of the audience.
- 3.8. City Council members may, but need not, ask questions of speakers at the conclusion of their comments.
- 3.9. Members of the audience shall maintain decorum and refrain from noisy outbursts or other distracting actions such as applauding, cheering, booing, or use of signs or banners during or at the conclusion of any remarks made by any speaker, staff member, or City Council members.
- 3.10. Minutes are a summary of the meeting discussion and actions made by City Council. Requests by speakers to append or revise the minutes are not favored.

4. Petitioners:

- 4.1. Notwithstanding rules to the contrary in this section, petitioners, defined as persons or entities who initiated and have a direct financial or ownership interest concerning a particular agenda item as determined by the City Administrator, shall be called at the beginning of said agenda item and may address the City Council concerning their petition.
- 4.2. After members of the public have had an opportunity to address the City Council pursuant to the rules provided in this section, petitioners shall have the opportunity to reply to any comments or questions from members of the public or City Council members.
- 5. Public Hearings:

- 5.1. The purpose of a public hearing is to seek formal input as required by city ordinances, state statute or as deemed appropriate by the Mayor.
- 5.2 The Mayor will call the public hearing to order and announce the topic. During the public hearing, the Mayor will ask if there are any members of the public who would like to address the City Council about the item under consideration. Individuals wishing to speak should approach the microphone, state their name and if they represent an organization. The rules of conduct that apply to City Council and Committee meetings apply to public hearings. The Mayor, or a majority of the City Council, reserves the right to suspend these rules and allow more public comment, as deemed appropriate.

The committee discussed having the COW remain a council-only body and rotating the chair among all alderpersons on a meeting-by-meeting basis, with no opt-outs and a defined succession if the designated chair is absent.

Committee members discussed keeping staff responsible for assembling agendas while formalizing a process for council-initiated items. After discussion, consensus was reached to require four alderpersons to add an item to an agenda, with any removal handled through action at the meeting.

Committee members discussed having COW meetings include public comments at the beginning on agenda items and again at the end on any topic, while City Council meetings will keep public comment only at the end.

The group reviewed the Omnibus (consent agenda) spending limit and, to balance efficiency and transparency, lowered it to a \$25,000 threshold.

Staff recommended maintaining the current committee structure through January, with the COW structure expected to begin February 2026.

Key direction emphasized making the content clearer and more human-centered, adding FAQs, a plain-language Trust Act summary, links to external resources, and sharing the information prominently on the homepage and across multiple channels. The council also encouraged exploring ways to summarize data on police interactions with federal agents and to hold separate community conversations, possibly through the Equity & Inclusion Commission, while ensuring that any "Know Your Rights" training is carefully vetted. No formal vote was taken; staff was directed to follow up as appropriate.

c. Update from Lobbyist John Millner.

City Administrator McGuire introduced John Millner who serves as the City's state legislative lobbyist. Mr. Millner provided background and answered committee members' questions regarding key topics, including state-shared revenues, IMEA, lead service line replacement and EPA loans.

4. COMMUNITY & ECONOMIC DEVELOPMENT

a. Presentation of a Concept Plan for The Shops at Pheasant Run

Ellen Johnson, Planner II, presented the Executive Summary and materials posted in the meeting packet.

Derek Conley, Director of Economic Development, stated the applicant has also submitted an application for financial assistance. The project is in the Pheasant Run TIF district and it was always assumed that there would be some type of request with this property. The amount is \$3.3 million.

Peter Necastro, attorney for the applicant, presented the concept plan.

The applicant seeks to redevelop 34 acres and has submitted two site plans for a mixed-use development. The project includes a car dealership, daycare, medical facilities, and a gas station

among other general retail and commercial uses. The selection of a final proposal will depend on the applicant's assessment of market conditions and tenant demand.

The buildings will be designed for consistency with surrounding similar uses and will be constructed of high-quality materials to create an appealing entrance and gateway to that Route 64 commercial corridor.

Following the concept plan review, the applicant will be seeking a special use PUD. They believe this would be appropriate due the site's size complexity and its significance in St. Charles. The PUD process would afford them the certainty of entitlements as they actively seek financing and market the property to end users. They will also be seeking approval for the maximum number of drive-through uses to provide maximum flexibility as they market the site.

Mr. Necastro also noted they will be seeking TIF assistance due to the number of extraordinary costs related to the environmental remediation and infrastructure development.

Brett Duffy, Spaceco, stated the site would have between 12 and 15 lots. He discussed the access points into the facility. The first one will be off Kautz Road lining up with the Target entrance and then two additional cuts onto Main Street. There may also be one or two additional connections to Pheasant Run Dr. He briefly noted the pedestrian sidewalk connections.

Ald. Foulkes liked the car dealership and daycare/urgent care options. He expressed concerns about the number of drive-through facilities and the repetition of certain types of businesses in the area. He liked the idea of a small grocery store, fitness center, or an entertainment-based option to provide for some variety in that quadrant. He will not be able to support the incentive request if it's going to be used for a drive-through or car wash.

Ald. Silkaitis expressed concern about traffic flow with the number of drive-throughs in that area. He supported daycare and car dealership uses. He would like to see a bit more uniqueness with the architecture. He also asked about building ownership. Vequity owns some and they sell some.

Ald. Bongard noted the plan is fine but is it viable. Will it work or will there be lots of turnover? How will it keep from saturating what's two miles away? Will it complement what the city is trying to do with the mall site?

Mr. Conley stated the uses are in line with what he expects to see at this site. The mall provides for a different type of development opportunity.

Ald. Bongard asked if this was the most viable project that could get done.

Chris Ilekis, Vequity, said their business is based around national retail development. The clients they bring to this location are ones they have existing relationships with. He said there are a lot of new retail/restaurants coming to the market that this is a great fit for. He felt this would complement the Greco project down the street. They are concerned about the longevity of their projects and are critical of who they work with. They want the best quality. There currently isn't a market for a small grocer. Unanchored retail is a challenge which is why they are proposing a variety of uses. They are asking for flexibility for future leasing and salability of the site.

Ald. Gehm asked about the TIF request and what the costs would cover. How firm is that \$3.3 million estimate? Mr. Ilekis said the initial proposal was higher and they scaled it back. The costs center around soils and infrastructure.

Ald. Spellman asked if there would be any consistency with the design elements of the buildings or will that be left up to the individual businesses. Mr. Ilekis said it's going to be a little bit of both. They don't want a uniform look, but they do want consistency. Ald. Spellman said it would be great if there were sidewalks connecting all the buildings.

Chair Wirball expressed overall support of the proposal but noted he's not a fan of a gas station/truck stop use. He felt the access road needed some more thought and the drive-through options should be scaled back. He would like to get a firm number before having TIF discussions.

Ald. Pietryla supported the PUD but did not like the idea of a truck stop. Since this is a corridor, he hopes they will be sensitive to the kind of tenants they bring in. He also commented on the need for additional information on TIF costs.

Christopher Stark, Johnson Research Group, clarified that the TIF request is specific to horizontal infrastructure costs, excluding sales tax revenues. There would need to be substantial reconfiguration of the site. Due to the redesign of the project, the previous internal infrastructure is no longer viable for reuse.

Ald. Bessner asked for an estimate of the overall cost of the project. The total horizontal infrastructure cost is \$16+ million.

Ald. Weber would support a car dealership or truck stop use. He stated the drive-through options are needed to increase flexibility. He would like to see different heights with the monument signs or different elevations and asked if they might consider giving the city a little bit of space for a welcome sign.

Vice Chair Muenz asked for clarification as to where the four monument signs are going to be placed. Mr. Ilekis said they are proposing two multi-tenant signs and a decorative knee wall. She asked if they were considering adding signals at the intersection lining up with Target and how all the traffic is going to flow. Mr. Ilekis noted they had a traffic study done. They are not planning on having a signal there.

Vice Chair Muenz expressed concern over the safety of pedestrians who have to walk through the drive-through lane. Mr. Ilekis said they incorporate a view corridor for the buildings. They try to align parking and building visibility, but it is user specific. Vice Chair Muenz said the streetscape is nice, but it's not a place where people are spending a lot of time. She liked the car dealership use. Mr. Ilekis said the next rendition will show more connectivity between lots. The patio requirements aren't defined yet. She also felt the proposal was a bit repetitive with other retail businesses that they have at the eastern gateway. She is not supportive of banks, gas stations or car washes on the main street. She suggested exploring destination type venues that draw people to the city. She would support the TIF incentive for site conditions but not to subsidize standard uses.

Ald. Pietryla asked when the preliminary plan might be ready. They will be ready to resubmit a revised plan fairly quickly.

b. Recommendation to Approve a Resolution Authorizing the Execution of a professional service agreement with All Together for a Public Engagement Campaign for the Downtown River Front property

Derek Conley, Director of Economic Development, presented the Executive Summary and materials posted in the meeting packet.

Ald. Foulkes asked what they will use to present to the public. Mr. Conley said step one will be based on the feasibility study. They don't want to rule out anything at that point.

Ald. Spellman asked if the costs include any opportunities for mailings. Print materials are included.

Ald. Bongard said it is very important to get public engagement on this. How many responses is enough to move forward? He would like to see benchmarks put in place.

Chair Wirball expressed support in moving forward.

Motion by Ald. Weber, seconded by Ald. Spellman, to approve a Resolution Authorizing the Execution of a professional service agreement with All Together for a Public Engagement Campaign for the Downtown River Front property.

c. Discussion regarding Downtown Southeast Quadrant Public Improvement Proposal

Derek Conley, Director of Economic Development, presented the Executive Summary and materials posted in the meeting packet.

The goals of the improvements are to:

- Increase pedestrian safety
- Increase cyclist safety
- Create a cohesive connection of the Fox River Trail
- Maintain parking space count
- Evaluation of utility improvements

They are not looking to close off streets to create a plaza. It's a streetscape program. They would like to work with a consultant called Civil Tech. The City has used them for previous improvements.

Chair Wirball expressed support for the proposal and the use of the consultant. He asked if it would be paid for with TIF funds. The study itself would not be paid for with TIF funds, but the area is within a TIF district and future improvements could be funded with the TIF.

Ald. Weber suggested moving overhead power lines underground if they decide to rip up the streets. Mr. Conley noted doing so would be very expensive.

Ald. Bessner would like to see some focus on streetscaping. He asked how much consideration is being given to traffic in general. Mr. Conley said it will be considered.

d. Discussion regarding Permanent Supportive Housing Program Partnership with Lazarus House

Ellen Johnson, Planner II, presented the Executive Summary and materials posted in the meeting packet.

Ald. Weber asked how much was in the fund. It's about \$2.2 million. Some of those funds are earmarked for other programs and activities so there is about \$1 million available for this program.

Ald. Pietryla asked about the scope of inspections. Kristi Athas from Lazarus House said they take specific HUD training.

The Committee expressed support for moving forward with the program.

5. PUBLIC COMMENT

Steve Leffler commented on The Shops at Pheasant Run development proposal, expressing concerns about traffic and business competition.

6. ADDITIONAL ITEMS FROM MAYOR, COUNCIL OR STAFF

Ald. Spellman asked about the next steps for the Claibourne Farm project. Will the revised plan go back before the Committee? Mr. Colby said they do not expect it to be revised but the developer will provide responses to comments made at the Plan Commission. It is expected to be on a committee agenda in January.
