16	And we'll begin with our staff
17	summary. Helen?
18	MS. JOHNSON: All right. The subject
19	property is Lots 7 through 12 in the Oaks of St.
20	Charles townhome community located off Roosevelt
21	Street near Route 31. Last August, you'll recall,
22	the City approved a PD preliminary plan and
23	preliminary plat for this project to construct the
24	six town homes in two buildings. Now, final plat

1	of subdivision approval is required and the
2	projects under building permit review as well.
3	And so proposed is replating of the existing six
4	individual lots into one single lot. Replating is
5	necessary because the proposed units differ in
6	width than the existing lot lines. So then the
7	developer intends to parcelize, tax parcel each
8	for each unit, separate tax parcel, after the plat
9	is recorded.
10	Staff has requested the applicant
11	provide a letter from the HOA, the Oaks HOA,
12	regarding maintenance responsibility of a new
13	storm sewer that's needed for the new buildings.
14	And the applicant has intended they that they
15	will do so. There are no other outstanding staff
16	comments, and staff recommends approval.
17	CHAIRMAN VARGULICH: Okay. Any
18	questions or comments from Plan Commissioners?
19	I I just have one comment.
20	First of all, I like this project. I liked it
21	before, I still like it. And I would just
22	recommend that they remove tree number 44. It's a
23	mulberry. It's invasive. And it'd be nice not to
24	see more of them. So other than that
