#### 4. November 4th Presentation Discussion

Newman attended a meeting with Mayor Vitek, Heather McGuire, and Lisa Stricker to prepare for the City Council meeting on November 4. The group discussed the presentation details and noted the date change from October 21. Newman expressed appreciation to Stricker for being instrumental in the commission's success.

# 5. Subcommittee Reports/Newsletter Sign Ups

Culture & Religion:

Johnson provided guidelines for preparing items for the City newsletter; each subcommittee was asked to sign up for two months.

Macione shared that a resident had reached out to her regarding National Hindu Heritage Month. She recommended that a proclamation be drafted for the commission to review and see if the City would like to recognize this.

#### Physical Disability:

Bacigalupo provided details of a business approvement grant that the Economic Development Department will be proposing to City Council. The grant includes funding for more ADA focused projects that would go above and beyond code requirements.

Castro said that he had reviewed the council chamber renovation plans and noted he did not see any hearing loop system improvements included. He would like to know more information regarding RFPs (Request for Proposal). Strickler offered to research the RFP approval process for inclusionary items and will give an update to the group at the next meeting.

#### LGBTQIA+:

Newman provided information regarding an educational session that she would like to hold at the library in January or February.

# **Identifying Bias:**

Castro created a slide for the action plan that he would like to be included in the first quarter commission report. He noted that he had some feedback to address from Newman.

Castro stated he believes that there is a lack of diversity on commission appointments and a discussion ensued. Stricker cautioned the group to be very specific when asking about diversity.

#### 6. New Commissioner Discussion

The group reviewed the Equity &Inclusion Ordinance and discussed ways to communicate the vacant seat on the commission. Macione noted that she knew someone who had applied for the position and Stricker said she would follow up with the individual for an interview.

Sanders shared the positive feedback she had received regarding the Equity & Inclusion Commission while cleaning up after Scarecrow Weekend.
