JANUARY 13, 2026**

**1. Call to Order & Pledge of Allegiance.**

The meeting was convened at 7:00 p.m. by Chair. Nagy.

**2. Roll Call.**

**3. Minutes Review and Approval.**

Motion to approve and place into the public record the minutes of the December 9, 2025 Natural Resources Commission [NRC or Commission] meeting. Motion by Comm. Haggas, second by Comm. Mengler to approve the minutes. Voice vote: unanimous; nays – none. Motion carried at 7:01 p.m.

**4. New Business.**

A. **Arbor Day** – Chair. Nagy reported he met with St. Charles Park District staff, and the NRC and the St. Charles Park District will host a joint Arbor Day/Earth Day/Touch A Tree Truck event at Hickory Knolls Discovery Center. The event will be held on Saturday, April 25th from 11 a.m. to 3 p.m.

Chair. Nagy recommended presenting the Arbor Day Stewardship Award at the time the Arbor Day Proclamation is read by the Mayor during the April City Council meeting [in the past, the Stewardship Award had been presented during the annual Arbor Day event]; the Commissioners concurred. Recommendations for the recipient of the award will be discussed at the February NRC meeting. Chair. Nagy proposed former NRC Comm. Kathy Brens as a possibility.

The Commissioners reviewed a summary of past Arbor Day tree planting locations. A copy of the summary is attached to and made a part of these minutes. Thompson Middle School was selected as the 2026 location, with Richmond Intermediate School as an alternate. Arbor Day 2026 is on Friday, April 24th.

**5. Old Business.**

**6. Committee Reports.**

**A. Education and Outreach** – Comm. Provencher noted this is the last week for collecting holiday lights for recycling. Lights will be picked up from Public Works by Elgin Recycling on January 20th.

**B. Engagement** – None.

**C. Advisory** – None.

**D. Ad-Hoc** – Comm. Smith reported on the re-introduction of the NRC's single-use plastic bag fee initiative. Comm. Smith noted the City of Batavia implemented a \$0.10 per plastic bag fee in 2023 with the intent to reduce plastic waste, however, during 2023/2024 approximately 3.2 million plastic bags were purchased in Batavia. The Commissioners discussed the following considerations regarding the plastic bag fee initiative:

- If an ordinance was passed in St. Charles, the portion of the fees retained by the City could be used for environmental initiatives.
- Paper bags have a higher environmental impact during production versus plastic bags; plastic bags have a higher environmental impact during disposal/recycling.
- The State of Illinois may impose a single-use plastic bag fee and would collect the fees instead of St. Charles, unless the City passes an ordinance prior to the State of Illinois enacting plastic bag fee legislation.
- A possible escalating fee scale could be implemented to change shoppers' habits; the fee per bag could eventually be high enough to discourage shoppers from purchasing plastic bags altogether.
- The importance of a cultural shift in shoppers' habits was noted.
- In Seattle, Washington there are no plastic bags available to purchase from retailers and shoppers bring their own reusable bags.

**7. Communications. – Public Services Division Tree Activity Reports.**

Motion to approve and place on file the Public Services Division tree activity reports for December 2025. Motion by Comm. Smith, second by Comm. Haggas to approve the reports. Voice vote: unanimous; nays – none. Motion carried at 8:02 p.m.

**8. Additional Items.**

**A. Commissioners** – Chair. Nagy congratulated the Student Member(s) on their recent induction to the National Honor Society.

Comm. Smith noted input from City Council would be helpful to guide the NRC's initiatives.

**B. City Staff** – None.

- C. Visitor(s)** – Mr. Nelson expressed his support of the NRC’s single-use plastic bag fee initiative.

Mr. Pohrte suggested implementing an incentive-based program rather than a fee for using plastic bags. For example, if shoppers were to use a St. Charles re-usable bag, they could save money on their purchases at certain retailers in the City. Mr. Pohrte noted plastic bottles, not plastic bags, are the primary source of waste in the Fox River.

- 9. Adjournment.** – Motion to adjourn the meeting. Motion by Comm. Mengler, second by Comm. Haggas to adjourn the meeting. Voice vote: unanimous; nays – none. Motion carried at 8:17 p.m.
