Ald. Kalamaris asked about the benefits of paying off the TIF sooner than 23 years? And can we benefit from those tax dollars? Mr. McKenna explained that we can pay off the TIF earlier and there would be a benefit to City and taxing district.

Ald. Kalamaris asked about when do tax dollars start coming in? Mr. McKenna said the seven-year roll is in the statute to begin development within the seven years. Heather McGuire, City Administrator, responded there is revenue coming in from the existing tax base on the property. Any revenue that is generated from redevelopment that occurs from this point forward, that would be captured in a TIF increment.

Executive Summary (if not budgeted please explain):

On June 6, 2022 City Council approved a contract with consultant Berry Dunn, for the preparation of an updated Strategic Plan. The Strategic Plan serves as a road map, guiding decisions about the City's future. The Strategic Plan relies on feedback from the community and key stakeholders, to establish the City's vision, and align City goals, and priorities for the next five years.

For the past 6 months Berry Dunn has been conducting an extensive public engagement strategy to collect input via, one-on-one meetings with key stakeholders, public forums, group discussions, surveys, and a project website. The firm also reviewed several existing policy and program documents. After input was collected, Berry Dunn worked closely with City staff to prepare the Strategic Plan document. The plan includes an updated mission statement, vision statement, and guiding principles. The new plan also identifies 4 Strategic Priorities:

- 1. Balanced and Thoughtful Development
- 2. Community Engagement
- 3. Organizational Resiliency
- 4. Financial Wellness

Each Strategic Priority has Strategic Goals and Outcome Objectives. On December 5, 2022 the Government Operations Committee reviewed and unanimously voted to recommend approval to the full City Council. The content of the Strategic Plan for City Council consideration is identical to that shared at the Government Operations meeting, however, has been graphically designed to be a more presentable document.



 - Update the Water Utility Master Plan by the end of 2023.
 - Update the Sewer Utility Master Plan by the end of 2025.
 - Update the Electric Utility Master Plan by early 2024.
- Complete an Emergency Preparedness and Continuity of Operations Plan and adopted by the end of 2024.
- Conduct a Technology Risk Assessment and present the assessment to City Council by the end of 2024.
- Develop a Strategic Technology Plan by the end of 2025.
- Increase views of job postings and applications for jobs through the City's applicant tracking system.
- Reduce vacancy time for hard-to-fill positions.



FINANCIAL WELLNESS

Implement policies, practices, and procedures that manage long-term liabilities, increase understanding and awareness of the City's fiscal condition, and continue the efficient use of City resources to ensure ongoing financial strength and sustainability.

STRATEGIC GOALS

- Ascertain appropriate level of annual revenues needed to fund the City's core capital project programs with ongoing revenue sources.
- Evaluate and implement utility rates that provide the resources necessary to fund improvements to the City's water, sewer, and electric utility systems.
- Evaluate the City's charges for services for development-related items to better understand the costs and benefits of doing business in St. Charles.
- Identify ways to expand fiscal and budget transparency for the community to increase understanding of the City's finances.

- Implement and revise, if necessary, the City's Debt Policy by April 2023.
- Maintain good ongoing relations with bond rating agencies.

WHEREAS, the City previously passed Resolution No. 2018-84 "A Resolution Authorizing the Mayor and City Clerk of the City of St. Charles to Execute an Intergovernmental Agreement by and between the City of St. Charles and Kane County regarding St. Charles Housing Trust Fund Administration and Management Services", which established a partnership between the City and Kane County for services related to County administration and management of the Home Rehab and Accessibility Loan Program, the First-Time Homebuyer Loan Program, and the City's contributions into the Kane County Affordable Housing Fund; and

WHEREAS, said Resolution No. 2018-84 allocated \$416,000.00 from the St. Charles Housing Trust Fund to the Kane County Affordable Housing Fund to be utilized to finance projects under the Kane County Affordable Housing Fund located within the St. Charles corporate limits; and

WHEREAS, said Intergovernmental Agreement between the City of St. Charles and Kane County dated June 18, 2018 (the "IGA"), included Attachment B, "Budget for Housing Trust Fund Activities", which listed budgeted amounts from the St. Charles Housing Trust Fund for the Home Rehab and Accessibility Loan Program (plus 5% program delivery fee), First-Time Homebuyer Assistance Program (plus 5% program delivery fee), and Affordable Housing Development Program (plus 2.5% closing fees); and

WHEREAS, to date, a total of three (3) projects approved through the Kane County Affordable Housing Fund have been financed in part by the St. Charles Housing Trust Fund, as approved by the St. Charles Housing Commission, totaling \$153,911.89, for a remaining balance of \$262,088.11 from the initial City allocation of \$416,000.00; and

WHEREAS, Section 9 of the IGA grants the City sole discretion in amending the budget amounts specified in Attachment B with written notification to the County; and

WHEREAS, the City desires to contribute additional resources from the St. Charles Housing Trust Fund into the Kane County Affordable Housing Fund to be made available for Anthony Place II, a 60-unit senior affordable housing project located in St. Charles, in an amount not to exceed \$1,100,000.00, plus 2.5% closing fee paid to Kane County.

NOW THEREFORE, be it resolved by the City of St. Charles, Kane and DuPage Counties, Illinois, as follows:
