**Subject: Phase III Letter Notification for 2014 MFT
(Ohio Ave. Reconstruction – 3rd Ave to 6th Ave)**

Dear Resident:

The City of St Charles is pleased to inform you that we will be beginning Phase III work on the 2014 MFT beginning July 16, 2014.

This phase will consist of the removal and replacement of designated curb, roadway and driveway aprons. Designated times for construction operations including the startup of heavy equipment shall not begin before 7:00 AM Monday through Friday and 7:00 AM on Saturday. Construction operations including site cleanup, shall be completed before 7:00 PM Monday through Friday and 5:00 PM on Saturday. No work of any kind shall be done on Sundays or holidays observed in Illinois.

Driveway apron and curb removal and replacement.

During curb and driveway apron removal and replacement, residents will be required to temporarily move their vehicles from their garages and driveways that have Ohio Avenue frontage. A contractor representative will personally notify residents at this time. Curb and driveway aprons must not be driven or walked on for a minimum time period of 72 hours.

Concrete pavement removal and replacement.

During concrete pavement removal and replacement, residents will be required to temporarily move their vehicles from their garages and driveways that have Ohio Ave nue front age. A contractor representative will personally notify residents at this time. Concrete pavement must not be driven for a minimum time period of 7 days.

This will require you to park your vehicle(s) on the street or adjacent street during this time. The City of St Charles Police Department has been notified that residents of this area will be parking overnight on City streets. During the day, please park your vehicle(s) away from the construction area.

The contractors will return and remove any necessary formwork, barricades, and restore existing conditions and accessibility after the required concrete cure time. Residents may return to their garages and driveways after temporary driveway access ramps are installed.

All homeowners with sprinkler systems near the curb line should mark the sprinkler heads for easy identification by the contractor. Any other privately owned utilities or decorative items should also be marked or removed by owner until construction has been completed to help prevent damage. The City of St Charles will not repair any sprinkler systems or decorative items in the City right of way areas. Please take extra caution when driving and be aware of children who may be playing nearby and construction workers and equipment.
