Video Gaming Implications on Law Enforcement and City Finances

Basic Overview

- * The Video Gaming Act (230 ILCS 40) was signed into law July of 2009.
- * Allowed in:
 - * Licensed retail liquor establishments (draw, pour & mix- Class B, C, & D only)
 - * Truck Stops
 - Licensed Fraternal/Veteran Organizations
- * Sites and VGT machines must be monitored by adult supervision at all times (over age 21) and segregated away from other customers under the age of 21. Violations are investigated and cited by Illinois Gaming Board.
- * Hours of operation must coincide with legal hours of liquor consumption on the licensed premises.

Overview Continued

- * Each location is allowed up to 5 Video Gaming Terminals (VGTs).
- * Each connected by a central communications system (CCS) monitored by the Illinois Gaming Board (like an ATM machine).
- * Cannot be located within 1,000 ft. of a horse track betting facility or a licensed riverboat casino.
- * Cannot be located within 100 ft. of a school or house of worship.

Illinois State Gaming Board

- * Comprised of a 5-member board appointed by the Governor.
- * Administers a regulatory and tax collection system on VGTs.
- * Investigates misconduct.
- * Assures the integrity of VGTs by the licensing of manufacturers, distributors, suppliers, terminal operators, locations, and individuals that service VGTs.

Signage

- * Overseen by the Gaming Board. Joint responsibility between the terminal operator (amusement company) and the video gaming location.
- * Shall be placed in the video gaming area and be no less than 21" x 13".
- One Sign (Age 21 and Over Sign)
- * Second Sign must list the phone numbers for the following:
 - * Terminal operator
 - Illinois Gaming Board
 - * Gamblers Anonymous

Background Investigations

- Conducted by the Illinois State Police-Gaming Board Agents.
- * Site Locations.
- Business/Designated Video Gaming Manager
- Applicant Screening/Backgrounds.
- * Enforcement/Oversight.
- * Local police jurisdiction has some exposure to background responsibilities (local records checks, etc.). Document and Report any other violations once licensed.

On-Site (Gaming Machines)

- * All currency goes into the gaming machines.
- * Payouts are handled via a voucher and paid out by the ATM-type machine.
- * Local businesses usually do not pay out or handle currency*. Unlike lottery system (quick picks/scratch off games).
- * All transactions monitored by CCS and are recorded.
- * Movement from machine-to-machine has limitations.

Information to Date

- * 7,000 licenses issued to date (includes amusement companies, installers, etc.).
- * 5,000 establishments.
- * 20,000 machines installed (approximately 4 per location/average).
- * About 400 applicants have been denied a license.
- * Average waiting time from application to installation? Less than 6 months.

Transparency

- * State Gaming Board website is up-to-date and posts monthly financial reports in real time.
- * Local Social Service Agencies have not reported an increase in service levels since 2012 and VG.
- * Law Enforcement experience to date:
 - * Local police jurisdictions have reported no issues or increases in service levels associated with either crime or calls for service since the arrival of VG.

 - * Accessory Use (State issued liquor license location or a fraternal/veteran use).


Video Gaming Cafes

- Usually located near big box retailers.
- Main thoroughfares. County/State Routes.
- * Downtown locations? Bartlett has one such location pending an application. The other three Bartlett locations are on State/County Routes.
- * Stella's, Dotty's, Penny's.
- * Hours of Operations 11:00am-Midnight?
- * Food and Beverage Menu. Atmosphere is restaurant/deli in nature. Not a bar or tavern.
- * Owned and operated by corporate hospitality groups.

Revenues are based on amounts wagered per VGT. State levies taxes on "Net Terminal Income": which "means money put into a VGT minus credits paid out to players."

- * Mandated payout percentage of at least 80% over expected lifetime of VGT (per 230 ILCS 40/15 Section 15 (2)).
- * Tax Rate is 30% of Net Terminal Income
 - * 5/6^{ths} of tax income retained by the State
 - * 1/6th distributed to City

VGT Gross Revenue Distribution



Statewide, municipal share of tax income averages \$1,880 per VGT annually.

Based on state average, City income from video gaming would likely range between \$173,900 and \$695,600 per year.
