## Chief's Letter of Introduction

Thank you for taking the time to review the St. Charles Police Department's Annual Report for calendar year 2023. This information outlines the activities conducted by members of the St. Charles Police Department to inform you of the great work done on a daily basis by our employees. Our mission is to provide quality service with respect and a commitment to excellence. Included in this report is an overview of our services, crime rates, enforcement statistics, and other associated activities.

Accomplishments of this past calendar year include, but most certainly are not limited to the following: the additional hiring of new personnel; receiving over \$1.5 million in grant-funding to support the Department's new tactical training center, land improvements for the property north of our facility, body-worn cameras, and social worker funding; implementation of the provisions for the Safe-T-Act and Pre-trial Fairness Act with all internal policies and procedures; and work towards replacing and rotating several key command team members after several retirements – which included adding a new Detective Sergeant position to the organizational chart. In addition, the Department made great strides in securing a Narcan grant with the State of Illinois – which we now offer for free in our lobby, as well as becoming an authorized sharps collection facility.

As this remarkable progress proves, we, as an organization, remain committed to our citizens and the quality of the services we provide. Through quality training and organizational preparedness, we consider ourselves forever vigilant to respond to whatever emergency situation arises using the four tenets of our core values; *Service*, *Professionalism*, *Courage*, and *Dedication* (SCPD).
























### Records Division

Records Division staff members diligently follow state mandates, Illinois criminal and vehicle code statutes, local ordinances, and best practice protocols to

ensure the integrity of all records maintained by the department. Specialized tasks performed by the unit include, statistical reporting, FOIA processing, report dissemination, expungements, crime reporting to state and national information systems, and records database management.

## Special Services Unit (SSU)

The Special Services Unit is under the direction of Commander Tim Ocasek. The unit is responsible for overseeing all city-wide special events, traffic safety issues, crime prevention, school crossing guards, and the department's comfort dog. The unit falls under the direct supervision of the Deputy Chief of Administration.

The Special Services Unit (SSU) consists of the following members: 1- Commander, 1- Traffic Safety Officer, 1- Crime Prevention Officer, 1- Community Service Officer, 1-Community Restitution Coordinator/ Part-Time Community Service Officer, 12 Crossing Guards (both full and part-time), and 1- Facility/ Comfort Dog. The SSU works to enhance the quality of life for residents and visitors through the safe and efficient movement of traffic in the City. The SSU works in support of the Patrol Division by providing traffic studies and analyses, solving neighborhood traffic and parking problems, and working closely with organizers to plan safe and successful special events. In 2023, the unit assisted from beginning to end in dozens of events to include parades, festivals, fireworks, charity walks and runs, amongst other various special events.

#### **Special Services Unit (SSU) Specialties**

Commander Tim Ocasek, has been with the department for 11 years. He was promoted to the role of Commander in June of 2023 and has been running the Special Services Unit since. Before this, he served as a Patrol Sergeant for three years. Preceding his promotion to Sergeant, he was assigned to the Investigations Division for three years. In his career, Commander Ocasek was previously a member of the ILEAS Mobile Field Force team and has served as a Field Training Officer. Commander Ocasek also holds instructor positions for a variety of specialized trainings.

#### **Traffic Safety Officer**

**Traffic Safety Officer Kyle Popp**, has been a member of the department for over 2.5 years. Prior to being a St. Charles Police Officer, Officer Popp worked as an Evanston Police Officer for over 7 years. Over the course of Officer Popp's career, he has served as a Patrol Officer, Special Operations Group Detective, North Regional Major Crimes Burglary Task Force Investigator, Evidence Technician, EVOC instructor, and High-Risk Traffic Stop Instructor, amongst other specialties. Officer Popp became the department's Traffic Safety Officer in June of 2023.

The Traffic Safety Officer (TSO) is a sworn Police Officer specially trained in areas such as:

- Solving Neighborhood Traffic Problems
- Community Education
- Problem Oriented Policing

TSO Kyle Popp is assigned as a member of the City's Special Events Committee yet dedicates a large amount of his time to specific neighborhood concerns. In 2023, the following areas are just some of those where Ofc. Popp was assigned to analyze and address traffic and/or parking concerns:

#### **Crime Prevention Officer**

**Crime Prevention Officer Meghan Kramer** has been with the department for over eight years and has been the Crime Prevention Officer for the past two and a half years.

The Crime Prevention Officer (CPO) is a sworn Police Officer specially trained in a variety of educational areas and teaching for our youth. In addition, Officer Meghan Kramer is assigned the duties of crime prevention and crime analysis and facilitates the instruction for the *Too Good for Drugs Program* in our local schools. She coordinates the annual Citizens Police Academy (CPA), the Youth Academy, Spanish CPA, Elder Watch Program, St. Charles Youth Commission, Kane County Senior Services (Central Kane County-TRIAD), and the Kane County Hoarding Task Force. In addition, Officer Kramer produces publications both quarterly and annually with safety tips and other current event topics. Officer Kramer is also the primary handler for the department's facility/ comfort dog, Charlie, and was instrumental in helping the department acquire and train him. This year, Ofc. Kramer also started to implement new Crime Free Housing initiatives in the City of St. Charles.

The following two charts contain the top ten roadway and intersection crash locations for 2023. The third chart compares the difference between crash data from 2023 and 2022 as well as our overall enforcement efforts.

#### **Community Service Officer**

The St. Charles Police Department has one full-time Community Service Officer (CSO) and one parttime CSO. The CSO is a non-sworn member of the Department who performs a variety of tasks in support of all divisions of the Police Department. Those tasks include but are not limited to:

- Animal complaints
- Motorist assists
- Traffic control
- Parking enforcement
- Minor traffic trashes on private property
- Ordinance violations
- Assists with booking/processing of arrestees
- Responding to other non-criminal calls for service

- Daily transfer of documents between the department and agencies such as, the Kane County Circuit Clerk, the Kane County State's Attorney, and Tri Com Central Dispatch
- Child car seat checks
- Delivery of vehicles for maintenance and repair
- Transfer of evidence to and from state crime labs
- Evidence processing and property control.

Community Service Officer Ryan Beeter is in his 16th year of service to the City and continues to actively assist with evidentiary duties. He is also an active member of the Kane County Major Crimes Task Force Evidentiary Unit. CSO Beeter leads the department's Child Passenger Safety Seat Technicians group and works closely alongside our Patrol Division with day-today, non-criminal calls for service.

**Community Service Officer Francisco Fregoso** is in his seventh year of service to the City. Prior to 2023, CSO Fregoso's primary responsibility was managing the Community Restitution program. He continues to hold this position and, in the summer of 2023, took on additional duties as a part-time CSO.

#### **School Crossing Guards**

The Crossing Guards work each school day to safely cross children at nine different locations. There are nine primary guards assigned to the ten positions and there are an additional three substitute guards who fill in as needed throughout the year. An additional seven crossing locations are staffed by Community Unit School District #303. The Special Services Unit works closely with the school district to train crossing guards and plan safe routes to school. The Crossing Guards also help with pedestrian crossing locations during special events. All Crossing Guards attend an annual

training session and are outfitted with safety equipment provided by the Police Department.



#### **Facility/Comfort Dog - Charlie**

In 2021, the St. Charles Police Department, led by Officer Kramer, acquired and began training extensively with the department's first facility/comfort dog, Charlie. He is a German Shepherd and Golden Retriever mix who was donated

by a local family to an organization called Canines 4 Comfort. Following his initial extensive training, he was certified as the department's first facility/comfort dog. He is deployed routinely for a variety of events both public and in private situations where he assists families or those in need. In 2023, Charlie was deployed or utilized 82 times within the community and at outside events.





## Criminal Investigations

The Criminal Investigations Division serves in many roles with its primary responsibility to provide investigative support to the Patrol Division. Reported incidents are reviewed to identify cases which require additional follow-up efforts that would exceed the patrol division resources, are complex in nature, or have leads that expand beyond our jurisdiction. Solvability factors such as potential suspects, evidence, crime patterns, etc., are considered when determining when a case is assigned to a detective for additional follow-up work. These assignments include cases requiring multiple interviews, extensive crime scene work, or ongoing surveillance activities. These investigations can vary in duration before a case is successfully investigated or closed. A case is closed after all potential leads have been exhausted which may or may not result in an arrest.

The Criminal Investigations Division staffing consisted of the following personnel during 2023:

- Investigations Division Commander
- Detective Sergeant
- 4- General Assignment Detectives
- 2- High School Resource Officers; 1 each at St. Charles East and North High Schools
- 2- Middle School Resource Officers; 1 each at Wredling and Thompson Middle Schools
- Narcotics Inspector assigned to the North Central Narcotics Task Force/Illinois State Police
- Forensic Investigator/Property Custodian
- Civilian Administrative Assistant

General Assignment Detectives and School Resource Officers worked 436 cases in 2023, compared to the 386 cases in 2022. Of those, 279 cases were criminal in nature and solved, resulting in 103 arrests - 37% clearance rate. The overall criminal case clearance rate for 2022 was 35% with 87 arrests. Of those investigations, 27 cases assigned during 2022 remained in a "pending additional investigation" status at the end of the year and were followed up on in 2023. There

were 28 cases assigned in 2023 left pending and will carry over into 2024 for further follow up investigation.

### Attempted Homicide / Home Invasion Investigation

On January 14, 2023, at approximately 1937 hours, St. Charles officers were dispatched to the area of 135 Walnut Drive for reports of shots fired. Several callers to Tri-Com Central Dispatch reported hearing 5-8 shots coming from that location.

Upon officers' arrival to the scene, several people were reporting a person had been shot. As officers approached the rear door, they observed a male suspect holding an unconscious male just inside the apartment rear door. Officers observed an AK-style pistol in between the suspect and the unconscious male who he was dragging out of the apartment. Verbal commands were given to the suspect armed with the AK-style pistol and he was quickly taken into custody.

It was later learned that the suspect, along with two additional suspects, had entered the apartment through an unlocked patio door, wearing masks and armed with handguns. The suspects zip tied several victims inside the apartment and demanded money and drugs. During the incident, a male subject, who had received an open-line call from one of the victims, arrived and confronted the suspects. The suspects began to fire rounds at the male subject, who also returned fire, striking one of the suspects. The male subject was also struck in the abdomen and was taken to Delnor Hospital by his brother where he was treated. The suspect who was shot was pronounced dead. It was also learned that the third suspect had jumped out of a second story window and fled the scene.

Several officers and investigators, with the assistance of the North Central Narcotics Task Force, assisted in this investigation with processing the scene, conducting interviews, and identifying the third suspect. Charges were later filed against the suspect who was taken into custody on scene for Attempt Murder-1st Degree, Home Invasion with a Firearm/Great Bodily Harm, and Aggravated Unlawful Restraint. An arrest warrant was



obtained for the suspect that had escaped and fled the scene. In November of 2023, that subject was located and taken into custody.

The successful resolution of a homicide case requires exceptional investigative skills, relentless determination, and the ability to handle immense pressure. All of the officers involved in this investigation demonstrated all of these qualities throughout the investigation. Their dedication, professionalism, and tireless efforts played a pivotal role in ensuring the swift resolution of this heinous crime. Given the set of circumstances, the teamwork displayed by all officers was not only impressive, it helped bring this incident to a successful conclusion.

#### **Human Sex Trafficking Investigation**

On February 22, 2023, the St. Charles Police Department's Investigations Unit was informed through an anonymous source of a possible human trafficking/sex trafficking operation being run out of a residence in the 100 block of N. 15th St., St. Charles, IL. This anonymous source provided investigators with text messages and advertisements of women being offered for sex. The females observed in the photos appeared to be between 25-35 years of age and all of Hispanic descent. The anonymous source advised that the organization behind this operation utilizes Ring doorbell cameras at both entrances to the apartment mentioned above.

A joint investigation was initiated with Homeland Security Investigations (HSI). During the course of this investigation, there were countless hours of surveillance conducted and over 25 search warrants issued for several utility companies. This investigation resulted in locating brothels in St. Charles, Aurora, South Elgin, Elgin, and Palatine. Furthermore, this resulted in identifying five suspects that were involved in running the sex trafficking organization.

On July 19, 2023, a joint police operation was conducted with the assistance of Homeland Security Investigations, Elgin Police Department, Aurora Police Department, Cook County Sheriff, South Elgin Police Department, Attorney General's Office, Kane County State's Attorney's Office, and the Cook County State's Attorney's Office.

A total of nine search warrants were executed by law enforcement agencies on residences of five separate brothels and suspect residences. This resulted in eight women being rescued from this sex trafficking organization and five suspects were arrested. All five offenders were charged with a total of 23 felony counts related to human/sex trafficking.

The lead Investigator was nominated for the Kane County Officer of the Year Award as a result of his hard work on this case. The arrests made not only rescued victims from a life of unimaginable suffering, but also assisted Homeland Security Investigators with identifying over 45 sex trafficking locations across the nation.





## The following are other highlights of cases worked and related job functions performed by investigators in 2023:

- Execution of numerous search warrants and Grand Jury subpoenas for evidence property recovery and investigative case support, three of which were related to a reckless discharge of a firearm and an armed robbery.
- (16) Sexual assault and /or abuse investigations, compared to (9) in 2022.
- Ongoing compliance checks with home visits of registered sex offenders which resulted in three compliance violations.
- (2) Online sexual predator investigations; compared to (5) in 2022.
- (13) Death investigations non-criminal.
- (3) Armed robbery investigations; compared to (5) in 2022.
- (8) Motor vehicle thefts; the same as (8) in 2022.
- (25) Burglary from motor vehicles.
- (2) Residential burglary investigations; compared to (3) in 2022.
- (9) Burglary / Attempted burglary to commercial establishments; compared to (20) in 2022.
- (1) Attempted Homicide / Home Invasion; compared to (0) in 2022.
- Numerous City employment background investigations for probationary police officers, firefighter / paramedics, and dispatcher candidates.
- Liquor license, massage license, and business renewal applications; liquor/massage establishment site inspections and licensing background investigations.
- Numerous assists to outside agency investigations.
- Tobacco/alcohol establishment compliance checks were ongoing throughout the year. There were (3) citations issued for underage tobacco sales compared to (5) in 2022. (4) Businesses were cited for sale of alcohol to a minor compared to (7) in 2022. The St. Charles Police Department works closely with vendors to provide educational information and ensure continued compliance.
- Numerous investigations involving thefts, retail thefts, deceptive practices, credit card, identity thefts, and other assorted fraud- based offenses. (24%) of the cases investigated by detectives in 2023 were based on some form of theft, fraud or deceptive practice, compared to (32%) in 2022.

#### **Investigations Assignment and Duties**

Commander Drew Lamela is the current supervisor of the Investigations Unit. Prior to this role, Commander Lamela was a Patrol Sergeant for seven years. Commander Lamela spent 14 years as a general assignment detective and was a liaison with ICAC and a member of the Kane County Major Crimes Task Force. The Commander of Investigations is responsible for coordinating major incident response and investigation, liaison with agencies county-wide, and the supervision of the Investigations Unit detectives and their training.

Sergeant Rob Vicicondi was recently assigned as the new Detective Sergeant for the Investigations Unit. Detective Sergeant Vicicondi has been with the department for 11 years. Prior to being promoted to Patrol Sergeant in 2019, he was assigned as a general assignment detective for three years. Detective Sergeant Vicicondi assists with the supervision of general assignment detectives, as well as the Inspector assigned to the North Central Narcotics Task Force. Some of his duties include reviewing and assigning cases, assisting with FOID Card revocations, assisting with liquor and employment backgrounds, and acting as the on-call supervisor during his designated weekends.

Detective Ryan Carrigan and Detective Jose Jacobo are the two newest detectives assigned to the Investigations Unit. Detectives Ryan Carrigan and Jose Jacobo have been assigned to Investigations since the beginning of 2023. Detective Carrigan is certified in digital forensics analysis and serves as a representative for the Illinois Internet Crimes Against Children (ICAC) Task Force. Detective Jacobo serves on the Kane County Accident Reconstruction Team.

Detective Rick Murawski has been assigned to Investigations since the summer of 2020 and he oversees the sex offender registry database and compliance program. Detective Russ Haywood joined the Investigations unit at the beginning of 2021. All four detectives serve as members of the Kane County Major Crimes Task Force.

Members of the Criminal Investigations Division are assigned to the Kane County Major Crimes Task Force in both an investigative and evidence team capacity. The unit also participates in ongoing monthly intelligence and case briefings with several area Investigators Associations. St. Charles has led the Fox Valley Investigators Association monthly meetings for more than 20 years. Investigators from Kane County, as well as surrounding counties, municipalities and Chicago-based federal agencies, routinely attend these meetings at the St. Charles Police Department. The level of cooperation, collaboration, and resources generated by this partnership has provided tremendous benefits to this agency, as well as all involved in this partnership.



#### **School Resource Officers**

The D303 School District and St. Charles Police Department have had a partnership for several years and have School Resource Officers (SROs) in both middle schools and both high schools.



Detective Larsen has been the SRO for St. Charles East High School since 2020. During her tenure, Detective Larsen has become an essential figure amongst the student body and staff. Detective Larsen's work within the Student Support Services section of the school allows her to act as a

law enforcement liaison, counselor, mentor, and teacher. Detective Larsen's presence and activity continues to credit the efforts of the St. Charles East High School liaison program.



Detective Bryce Rentschler currently serves as the St. Charles North High School SRO since August of 2022. Detective Rentschler has spent time building relationships with students and staff, and updating safety procedures and policies. Detective Rentschler has made it his goal to

modernize juvenile operations within the department and become a subject matter expert within the juvenile field. Detective Rentschler helped revamp the Informal/Formal Station Adjustment Program by implementing the new Juvenile Justice Online program, which is shared among all Kane County agencies.



Detective Anson has been the SRO for Wredling Middle School since 2019. During his tenure, Detective Anson has developed excellent working relationships with teachers and support staff. He continues to build on these relationships and continues to promote open and honest

communication regarding the role of law enforcement at

Wredling Middle School. Detective Anson has fostered an environment that continues to make students more comfortable in speaking with law enforcement.



Detective Wold is the newest SRO at Thompson Middle School and began her tenure in the fall of 2023. Since becoming the Thompson Middle School's SRO, Detective Wold has fostered positive relationships with students, faculty, and staff. Detective Wold has demonstrated

approachability and willingness to engage with the school community.

The School Resource Officers oversee juvenile-based initiatives for the department to include referrals to the Juvenile Justice System and alternative programs, such as community restitution opportunities.

### North Central Narcotics Task Force (NCNTF)

The department continues to staff a full-time investigator with the North Central Narcotics Task Force. The unit was involved in numerous narcotics-related investigations throughout the region. These efforts resulted in (17) narcotics investigations, the execution of (4) search warrants, a total of (16) arrests, and the seizure of assorted narcotics, related drug equipment/paraphernalia, weapons, vehicles, and U.S. currency.

#### **Drug and Crime Tip Line**

The St. Charles Police Department maintains a telephone line which allows callers wanting to remain anonymous the ability to leave information regarding drug or criminal activity. The tip line rings directly into a voicemail where the caller can leave a message. An online submission form can also be filled out. These tips are reviewed upon receipt and assigned accordingly. Anyone can access the Tip Line on the City of St. Charles website, on the Police Department main page, under the Investigations Division link, or by simply calling 1-866-378-4267.





## Kane County Special Weapons & Tactics (SWAT)

The Multi-Jurisdictional Kane County SWAT (Special Weapons and Tactics) team completed another successful year in 2023. The Kane County SWAT team is comprised of nine different police agencies, two fire departments, and one independent physician.

St. Charles Police Officers Joe Gaske and Steve Mattas are assigned as members of the entry team. Officer Chuck Crumlett serves as an Assistant Team Leader.

The SWAT team was activated for service on multiple high-risk search warrants and arrest warrants in 2023.

The Kane County SWAT team continues to push itself during our bi-monthly training. This year the team trained on firearms proficiency, close quarters battle (CQB), hostage rescue, vehicle assaults, armored vehicle operation, rappelling, fire suppression, and tactical medicine. All Operators are required to pass a physical agility test twice a year. The SWAT team also conducted an aggressive week-long training course at Fort McCoy in Tomah, Wisconsin.



## ILEAS Mobile Field Force (3N) Activity 2023

The ILEAS Mobile Field Force Region 3 North team is comprised of officers/deputies from the Kane and McHenry County areas. Fortunately, 2023 was a calm year and allowed the members of ILEAS 3N to focus on training and recertification.

ILEAS conducted six training events focusing on civil disturbance/ riot control, crowd control, search and rescue, and dignitary protection.

ILEAS officials from Springfield and FEMA oversaw

the ILEAS 3N's recertification that ensured ILEAS 3N members were trained and certified to handle any activity throughout the United States.

The only activation for the team in 2023 was to assist with crowd control for the Nightmare on Chicago Street event in Elgin.

Looking ahead to 2024, the ILEAS MFF (3N) will begin tailoring its monthly trainings in preparation for the 2024 Democratic National Convention being held in Chicago.



## Evidence Submission and Storage






After evidence is collected by an Officer, it is packaged and information about the items are entered into a computer system and a barcode is generated. These barcodes stay with the evidence package throughout its lifetime and help keep track of its location. Once an item is packaged and barcoded, it gets locked into a "one way" evidence locker by the Officer (pictured above). The items stay secured in the locker until a property custodian checks them into the evidence vault and assigns a permanent storage location within the vault, keeping a chain of custody or "life history" for each item of evidence.

The property custodian maintains the integrity of all found items and submitted evidence and coordinates future investigative, crime lab submission or court related needs. A single fingerprint can be one of dozens or more items recovered during a case investigation. Using this as an example, this one recovered print will be handled by on-scene police personnel, an evidence custodian, a courier for transportation to a crime lab, processing by one or more lab personnel, and upon return, another courier, evidence custodian, etc. This all happens before it is to be handled by the States Attorney, possibly viewed by a defense attorney and accepted during trial by the court clerk. This one item has now been handled at least nine times and chain of custody documentation must be completed for each of these individual instances. A single case with 20 pieces of evidence now entails numerous man-hours of dedicated work and recordkeeping that regularly occurs out of the public's view.

Evidence storage requires high levels of organization, effective storage management and maximization of available space while considering health, safety and long-term preservation concerns. Our new evidence storage facility utilizes moveable high-density shelving units, large rack shelving for oversized items, refrigerators, freezers and a vault room in order to accomplish these goals.

An often-overlooked aspect of evidence storage involves our compliance with laws requiring items be maintained for long periods of time, potentially for dozens of years or forever. Quarterly audits insure that the integrity of our stored evidence is continuously maintained. Audit results are subject to not only internal command staff review but also that of outside agency inspectors via our on-going CALEA certification process. In 2023 we were able to legally purge 2,226 items of evidence from our storage facilities, while we accepted 2,300 new items during this same period.











#### **Evidence Processing**

Our police facility includes a spacious evidence processing area. This area is used by evidence technicians to employ more advanced processing techniques than what is often available at a crime scene. The processing area includes a cyanoacrylate (superglue) fuming chamber which can be used to reveal fingerprints which are not visible to the naked eye, a fingerprinting down draft table and a macro photography stand for taking close-up photos of developed latent evidence and trace evidence. The processing room also features bright LED task lighting and houses several alternate light sources (ALS) for revealing and photographing unseen evidence such as fingerprints or biological stains. The processing area is equipped with chemicals and dye stains which can be used in conjunction with the forensic ALS to aid in the recovery of evidence.

Casting materials, static electrical charges and gelatins are available for the recovery and/or enhancement of dust prints or other footwear impression evidence. Chemicals which provide presumptive confirmation testing of drugs and/or suspected blood evidence are also at our disposal.

#### **Digital Evidence**


No area in forensics is growing faster than digital forensics. Electronic devices are becoming more and more a part of our every day life. New devices are released and changes or updates happen at a whirlwind pace. Storage sizes on our devices continue to increase rapidly. Cell phones have storage capacities of hundreds of gigabytes up to one terabyte!

To help the Saint Charles Police Department cope with the ever-increasing demand to recover evidence in the digital age, our new facility is equipped with a dedicated digital forensics lab.

The digital lab has workstations to process information from cell phones, computers and vehicles. Security and privacy are key for this recovered digital data as it is treated the same as any other type of physical evidence. The digital lab contains a forensic server which holds all of the recovered data. The forensic server and its data are completely isolated from the Internet and even the City and Police Department networks.

#### **Major Crimes Task Force**

Our department continues to actively participate as members of the Kane County Major Crimes Task Force. Police agencies county-wide jointly share specialized/technical resources in order to maximize response to what can be complex criminal investigations. Task force participation is reciprocal in that should our community ever need additional manpower and/or specialized resources then these are only a phone call away. St. Charles PD assisted in 6 major task force calls for assistance in 2023.



#### **Prescription Drug Disposal**

In 2023 we were able to safely dispose of approximately 210 pounds of prescription drugs. Of this, 63 pounds were collected in partnership with Northwestern Medicine from the DEA's national prescription drug take back day. Our efforts continue to be a great feat, if one stops and considers where these drugs could

have gone otherwise if this program were not in place. We continue to promote this environmentally safe and controlled disposal of unwanted or unneeded drugs in order to reduce or eliminate any related drug-based catastrophes.



## Training & Accreditation

#### **Overview**

The St. Charles Police Department recognizes the importance of training and is continually striving to ensure sworn officers and civilian staff are provided with the knowledge and education to perform their service to the community in a professional and safe manner.

In 2023, St. Charles Police Department personnel received 14,120 hours of job-related training.

St. Charles police officers work a 10-hour workday. The 10-hour day allows for an overlap day once a week in which all officers are scheduled to work. This offers the flexibility to either augment the patrol shift or allow time for in-house training on each Thursday. All officers receive a minimum of one 10-hour training day each month of the year. This well exceeds our goal of providing each officer with at least 40 hours of inservice training per year.

Our annual training program addresses a variety of topics most of which are driven and required through the Illinois Police Training Act as well as our standards of accreditation through CALEA.

These topics include but are not limited to:

- De-Escalation
- Emergency Vehicle Operations
- Law Review
- Immediate Trauma Care
- Active Threat Response
- Use of Force
- Firearms training and qualification
- Less than Lethal Weapons
- Control Tactics
- · Bias-Free Policing
- CPF
- Mental Health Awareness
- Trauma Informed Response to Sexual Assault/ Abuse

- Constitutional and proper use of law enforcement authority
- Cultural Competency
- Civil Rights
- Human Rights
- Procedural justice
- Crisis Intervention training
- · Officer Wellness and Mental Health
- Firearms Restraining Order Act
- Reporting Child Abuse and Neglect

#### **Notable Training Courses Attended in 2023**

- Sergeant Runkle attended Staff & Command sponsored by Northwestern Illinois University.
- A few of the trainings Chief Keegan, Deputy Chief Mahan, and Deputy Chief Majewski attended included DISC Leadership Training, IPELRA Law Seminar, and the Illinois Association of Chiefs of Police (ILACP) Conference.
- Chief Keegan, Deputy Chief Mahan and Deputy Chief Majewski attended the Interest-Based Bargaining Training with members from both unions to prepare for the 2024 contract negotiations.
- Sergeant Kuttner; Officers Bennett, Kramer, and Godinho; and Detectives Carrigan, Larsen, and Haywood all attended a 40-hour Instructor Development course.
- Newly appointed as Master Firearms Instructor, Officer Mike Redmann attended several 40-hour courses to prepare him for this role.
- Commander Majewski attended the Illinois Homicide Investigators Conference.
- Sergeant Dony attended a 40-hour Vehicle System Forensics course.
- Detective Wold attended a 40-hour SRO (School Resource Officer) to prepare her for this new role at Thompson Middle School.



#### **School Resource Officers (SRO)**

All four officers assigned to work as SRO's in School District 303, Detective Anson (Wredling Middle School), Detective Wold (Thompson Middle School), Detective Larsen (St. Charles East High School), and Detective Rentschler (St. Charles North High School), attended training as certified School Resource Officers. To maintain this certification, each officer must attend at least one State-approved course in each of the following areas: Juvenile Law, Officer and Youth Interaction, and Active Threat Response.

#### **Accreditation**

Commission on Accreditation for Law Enforcement Agencies (CALEA)

St. Charles Police Department has been an Accredited agency through CALEA since 1989. Accreditation is awarded to police agencies that voluntarily demonstrate their commitment to excellence in law enforcement and continually improve their organization through self-evaluation and outside review.

Accredited agencies are required to continually meet over 400 standards set forth by major law enforcement associations, leading educational and training institutions, government agencies, and law enforcement executives internationally; all of which acknowledge CALEA's standards as the benchmark for today's law enforcement agency.

In 2023, SCPD was again found to be operating in compliance with CALEA standards. During that annual review an outside Professional Compliance Service Manager selected 100 of the 400 applicable standards. The Compliance Service Manager then reviewed Department policies, reports, and practices to ensure standards were met.









## Community Restitution Program

The Community Restitution Program is a non-profit work site which operates under the St. Charles Police Department. It works closely with the local court systems in Kane County and surrounding areas to coordinate community work for defendants referred to the program. The program has been in existence since 2012. The Restitution Program has shown to be an important contributing asset to the Police Department, the City of St. Charles, and its residents. Those assigned to the program are expected to complete specific hours of labor as restitution to the community.

#### **Participants In The Program**

Participants are assigned to work a number of hours by court order. The program accepts adults and juveniles who are charged with non-violent offenses. During 2023, 87 defendants participated in the program of which 50 have graduated, and the remainder continue to work towards completion. Defendants completed more than 2,000 hours in labor, resulting in a total monetary savings of nearly \$48,000. This figure is calculated using the average of the state minimum wage and an entry-level laborer for the City. The program continues to be a place of learning and growing, as well as a place where defendants are aided in finding counseling and other rehabilitation needs.



#### **Work And Responsibilities**

Rules and regulations are explained to each defendant prior to being accepted into the program. Each defendant is required to sign a contract stating that they agree to comply to the program's rules and regulations. Defendants are assigned to many different tasks including, but not limited to:

- · Pressure washing sidewalks and buildings.
- Collecting trash from over 53 roadways and emptying trash bins throughout the downtown area.
- Assisting with general maintenance of police department facilities.
- Removing snow from downtown area and public spaces.
- Washing, disinfecting, and detailing vehicles for the police department and public works.
- Assisting residents in need.
- Painting and removal of graffiti where needed.
- Mowing and general landscaping of City property as well as abandoned/foreclosed properties.
- Assisting with county recycling events.

The St. Charles Police Department continues to partner with A.I.D. (Association for Individual Development). There are currently several different case managers employed by A.I.D. and they have office hours at the Police Department five days a week. They work closely with officers on a multitude of different social services cases. The case managers have training and degrees in human services and are able to utilize their training in crisis intervention and de-escalation to work with members of the community experiencing hardships or trauma.

In fiscal year 2023, the case managers worked with 369 clients; 328 were St. Charles residents. The case managers take a sense of pride in working collaboratively with community agencies and the clients to help them reach goals and stabilize their situation.

The role of a police social worker is to liaison with the Police Department, the community, and the various social service agencies that serve our residents. A police social worker does not provide long-term

counseling, but rather assesses the quality of life issues brought to the attention of the Police Department, attempts to stabilize those issues, and provides the proper referrals necessary to bring the situation at hand to a successful conclusion or at least a manageable situation moving forward.

Examples of issues/situations in which a police social worker would be utilized:

- Mental health issues
- Chemical and/or substance abuse
- Victim advocacy
- Neighbor mediation/conflict resolution
- Hoarding
- Elderly services
- Youth services
- Domestic Violence/Orders of Protection
- City liaison with area social service agencies

#### **Crisis Intervention**

The St. Charles Police Department realizes that mental illness is an enormous challenge in our society today and consists of a broad spectrum of illnesses. It is vital that all sworn personnel are trained in CIT (Crisis Intervention Team) matters to effectively address the individuals suffering from these illnesses. The Department is working towards training all sworn officers in this essential training.

Currently, the Department has 46 sworn personnel who make up the Crisis Intervention Team. They are:

## Tri-Com Central Dispatch

During 2023, Tri-Com processed 145,228 inbound and outbound telephone calls; which resulted in 114,279 calls for service dispatched. Out of the total calls, 49,505 were calls received via the 9-1-1 emergency number. It should be noted that 80% of Tri-Com's 9-1-1 calls were received from wireless devices. Only 65 text to 911 messages were received with 31 of those being either test calls or accidental contacts.

Calls for service by community and contract agency in 2023 were:

- St. Charles 27.92%
- Batavia 16.64%
- Geneva 17.34%
- Tri-City Ambulance 8.35%
- Elburn and Elburn FPD 6.55%
- Sugar Grove and Sugar Grove FPD -7.24%
- North Aurora FPD 2,38%
- Waubonsee Campus Police 0.12%
- South Elgin Police 13.45%

#### **Staffing**

Tri-Com is authorized to maintain 18 full-time dispatchers, 3 supervisors, and one part-time QA/QI employee. We have two immediate openings in the full-time telecommunicator ranks. We continue to advertise and test prospective candidates as they apply. While hiring and retention continue to be a challenge in this industry, we have been succesful due to revisions made to our testing and training programs.

#### **Non-Union Compensation**


This year, we participated in a non-union compensation study contracted for by the City of Geneva. The data received led to changes in job classifications, job descriptions and pay ranges. The Board of Directors adopted a revised compensation plan and approved salary adjustments according to the plan. This process was highly collaborative and was very much appreciated by all of the non-union staff here.

#### **Budget**

We were fortunate to receive an additional supplementary surcharge check this year. The State NG 9-1-1 project expenses were lower than expected and the remaining monies were refunded to the ETSB's within the State. This money will be put to good use on several upcoming capital projects. As has been our previously adopted practice, we continued to apply for reimbursement of expenses for headsets, training and CAD maintenance. This year, we have greatly enhanced our cyber-security defences, made repairs to our microwave system and rewired our connections to our internal network.

#### **Fiscal Year 23/24 Projects**

Several significant capital projects were completed durning this fiscal year. The most noteworthy of these was the expansion and repaving of the parking lot. This completion of this project now allows for proper drainage of the surface and no longer do our member agencies need to park in the snow and mud when we have meetings. Adequate space is available for all. We have underaken the build out of our own fiber network, started the process for an automated fire station alerting system, updated the property lease, installed a geodiverse connection to the ESINET from Kane Com and much much more! We remain committed to continuous improvement and our progress has been exceptional!


