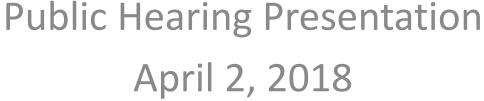

Highlights of 2018-2019 Budget:

** Budget proposes minimal use of reserves**

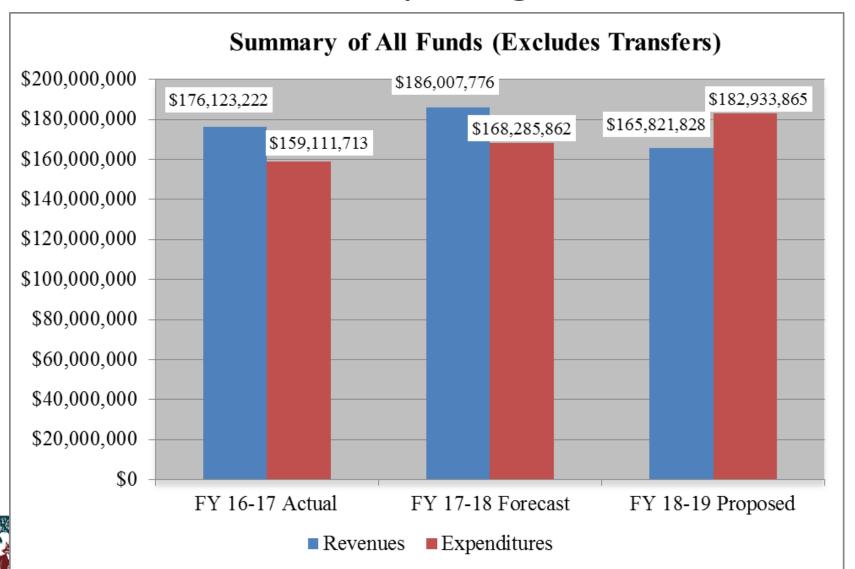
- \$212,000 to finance capital program
 No new taxes or tax increases proposed
 Municipal Gasoline Tax not included future implementation?
- Future Council consideration
 Minor utility rate adjustments proposed



Existing general revenue streams beginning to show stressors:

- State Revenue reduction \$450,000
 - LGDF (Income Tax: 10% reduction)
 - 2% Administrative Fee added to Home Rule Sales
 Tax
- Challenges of the "frozen" tax levy (9 years)
 - Taxes from growth and new property lower tax rate, they do not increase revenue
 - \$12 million levy in 2009 = \$13.8 million in 2017 if increased by CPI annually

Expenditures continue at low levels historically Outpacing revenues in future? – Capital



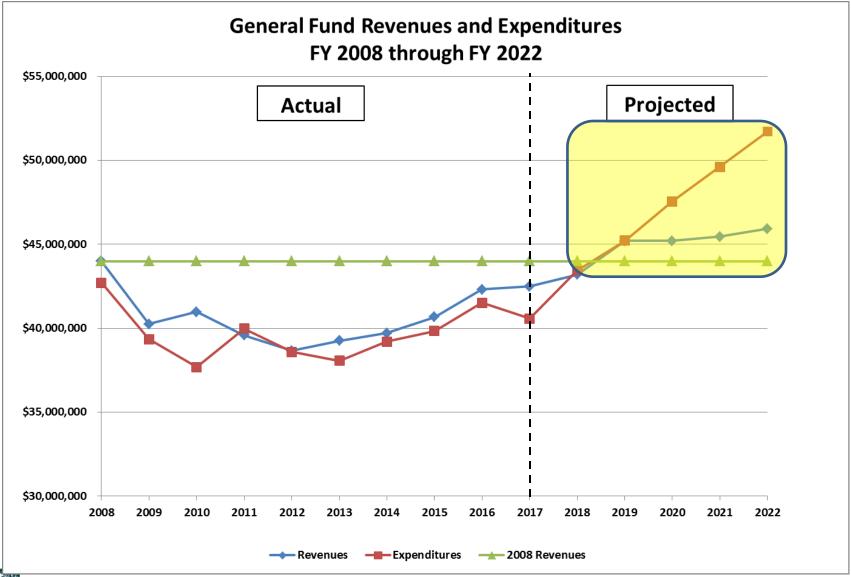

- Rate structure changes enacted over time
 - Operating deficits essentially eliminated
 - RESERVES IN POSITIVE POSITION ALL 3 UTILITIES
- 3.17% Combined Impact FY 2018-2019
- Lowest cost in Tri-Cities
- Rate Study Underway anticipated completion summer 2018
