Subject: Patricia Lane Base Reclamation Project – Construction Notification

Dear Resident:

The City of St. Charles is pleased to inform you that the street adjacent to your residence has been selected for major rehabilitation this summer.

The City will be utilizing a minimally disruptive pavement rehabilitation process known as base reclamation. The base reclamation process allows the contractor to remove only a portion of the pavement material, re-using the stone base and mixing it with cement. This process is both more economical than completely reconstructing the street and also less disruptive to residents. Complete project improvements will include utility repairs, sidewalk repairs, full curb and gutter replacement, driveway apron replacement, base reclamation, and a new asphalt roadway surface.

CONTRACTOR AND INSPECTOR:

The contract for this work has been awarded to J.A. Johnson Paving Company of Arlington Heights, IL as the general contractor. Chris Gottlieb, Civil Engineer II, will be the Project Manager for the City of St. Charles. The City has hired Justin McKuzes and Josh Schmitt from H.R. Green to be the on-site resident engineers. They will complete construction inspections for the work and be your personal construction liaisons. Justin will be the primary contact person regarding any construction activity. START DATES, COMPLETION DATES AND ROAD CLOSURES:

The contractor is scheduled to start work in mid-May. Work will begin with repairs to the City's water, storm, and sanitary sewer systems. Full replacement of the concrete curb, sidewalk repairs, and driveway apron replacements (from the sidewalk to the curb) will follow. All driveway aprons will be replaced in-kind. Base reclamation and paving work will then take place.

The road will remain open to local traffic for the majority of construction. Driveway access will be available during utility repairs but will be unavailable during curb and driveway apron replacement.

Roadway Closures:

Patricia Lane will require a roadway closure to perform the base reclamation process. This is anticipated to be completed in one day. Notification will be provided in advance of the road closure.

Parking During Times of Restricted Driveway Access and Road Closures:

Look for notifications to be placed on your front door in advance of any restricted driveway access or road closure. When driveway access is restricted due to construction operations, vehicles may be parked on Division Street or Via Veneto Drive during the day, and on Patricia Lane in front of your house on nights and weekends. Please utilize the enclosed parking passes when parking on adjacent streets. Additional parking passes are available at the Public Works office. Please call us at 630.377.4486 and we can drop them off for you.

Restrictions to On-Street Parking:

“NO PARKING” signs will be posted in the parkway during some phases of the project when vehicles cannot be parked on the street in the project area. During these phases, vehicles may be parked in your driveway or on adjacent streets.

Property Access Assistance:

If you should require assistance with special access or for an event such as a wedding or large party, please don't hesitate to ask. The City will do its best to accommodate all special requests. The sooner we are aware of the situation, the easier it will be for staff to accommodate you.

PUBLIC RIGHT-OF-WAY:

Please note that all work will be performed within the City right-of-way. If you have any type of existing features within the City right-of-way area (i.e. sprinkler system, landscape features, invisible fences, etc.) precautions should be taken by you, the property owner, to remove or store these items right away to assure they are not damaged. The City **will not** repair or replace private appurtenances left within the City right-of-way.
