Officer Belanger has submitted his resignation effective September 24, 2021. All Officers are performing well, went through field training and performing above standards. They will become a Master Patrol Officer, joined the collective bargaining unit and considered full time members of the Police Department.

- A motion was made to appoint Officer Monaco as a permanent Police Officer of the St. Charles Police Department by Tony Stancati and seconded by Geoff Pretkelis. The motion was passed by a unanimous voice vote of all members present.
- A motion was made to appoint Officer Belanger as a permanent Police Officer of the St. Charles Police Department by Tony Stancati and seconded by Geoff Pretkelis. The motion was passed by a unanimous voice vote of all members present.

- Chief Swanson discussed the results of the oral interviews for the new hire process. Given the fact that ten people did not pass the oral interview, which is almost 50% of those who interviewed. Chief Swanson would like to review and consider revising the Rules & Regulations regarding those standards.
