Mayor Vitek read the following statement:

Mayor Vitek and the Board,

Thank you for allowing my comments to be expressed prior to your vote.

My name is James Thom with WAMI GAMING and Western Automatic Music, Inc. We have been operating coin-operated amusement devices in St. Charles for almost two years. We hope to operate Video Gaming terminals in St. Charles in the very near future.

In the interest of time, I would simply like to ask the Board to reject the “PUSH TAX” idea. It is a bad idea now, it will be a bad idea in the future, and it could end up chasing players into businesses in neighboring municipalities that don't ask their players to pay a penny for every bet they make. Other municipalities were going to rush into passing the tax. But after learning about the difficulties it created and how unfair it was they decided it was a very bad idea and did not pass it.

I understand that on the first look the “PUSH TAX” seems like a great idea. It’s called a tax on the player. But who is the player? We are not allowed to track players. How will we collect this tax?

It sounds harmless, but the industry makes approximately 8 cents per push. A simple little penny turns out to be a 12.5% additional tax. That would give municipalities an increase from 5% to 17.5%...a 250% increase. That is excessive!

I don't believe St. Charles is anti-business. I've seen just the opposite over the two years I've worked there. Again, I ask you to vote No to this proposal. Help keep the businesses in St. Charles that depend upon their video gaming revenues strong. That way they can reinvest in their businesses, the community and employ citizens of your fine city.

Discussion:

- Heather McGuire explained that on October 27<sup>th</sup> there was an amendment added from the State of Illinois which requires the City of St. Charles to approve a push tax for video gaming by 12:00 am on October 31, 2021. She explained that we need to approve this now or would not be able to do so in the future. The intent of this tax is to be an end-user tax
- Mayor Vitek explained that the intent is not to impact businesses.
- Ald. Wirball asked about how much revenue will be collected.
- Ms. McGuire answered that it is hard to determine right now, will need to wait until after the tax is in effect.
- Ald. Weber said we need to have dialog with the businesses.
- Heather McGuire reiterated we will include businesses in the discussion.
- Ald. Lencioni asked how the tax would be collected?
- Heather McGuire said this is to be determined.
- Ald Lencioni said he supports currently but would like to allow businesses determine how to do this.
- Ald Paylietner asked in any other municipalities are implementing?
- Attorney Peppers responded that the numbers are low but tripled from Wednesday (4) to Friday. He also mentioned that the game commission is working on the software to track this tax, but it is a work in progress.
- Heather McGuire stated that she is available to discuss with any business owners and is always available.
