# II. Secretary's Report

# III. Treasurer's Report – Jayme Muenz

- A. Balance is \$3,236.27; the Youth Commission funded two requests in February: \$2,000 for the St. Charles East High School Hope Club and \$500 for the St. Charles East High School Post Prom.

  - A. Liaison Reports
  - i. D303 Patti Palagi
    - a. Kindergarten registration is in full force. Numbers are holding steady.
    - b. It is time to be super healthy in our schools with a focus on health basics such as hand washing and covering coughs.
    - c. Grades  $3^{rd} 12^{th}$  will begin testing in the spring.
    - d. The Haines building is looking great. Patti's department is moving there in August.
    - e. On March 19<sup>th</sup> from 6:30 8 in the Haines gym, they will present *Wake Up Call*. It walks you through an adolescent's bedroom to show creative ways kids hide contraband. This is part of the *Parent University* series.
  - ii. Park District Jennifer Bruggeman

- a. A new Teen Center supervisor has been hired Chris Holling. He is a WIU graduate who went to college for theater production and arts with a minor in parks and rec.
- b. Chris presented some information on the Teen Center which is at a pivotal point. Mission/Vision/Core Values and Rules were updated and the Teen Center also has a revamped logo.
- c. There is a new partnership with Fargo skateboarding, a group from Dekalb. This presents a great opportunity for seasoned veterans and those new to the sport to learn and practice.
- d. The Bob Ross painting party organized with the library was a success.
- e. Youth sports trips are going really well.

# iii. Police Department - Jim Burden

- a. Report of recent juvenile offenses
- b. Underage driving is becoming more common.

# iv. Library Programs - Nick Chaney

- a. The library staff is focusing on the upcoming move. Sunday, March 8 will be the last day the building is open as is.
- b. The library's temporary location at Haines is scheduled to open on April 6.
- c. Books can be returned to any library drop box or neighboring community libraries.

#### v. TriCity Family Services – Jules O'Neal

- a. TriCity's annual Gala is being held in March at the Q Center. Emerald City is the theme.
- b. The Wilderness Challenge Program kick off is coming soon for those in 9<sup>th</sup> grade and up. The program cost is \$75 for 8 days. TriCity does assist with financials or provide clothing if needed. There is enough space for 30 kids. TriCity has been doing this program for 31 years. The \$75 fee is refunded for those who fill out surveys throughout the year. The program is meant for at risk kids but is open to all; flyers will be available at next meeting
- c. TriCity has a lengthy waiting list and services are temporarily unavailable for adults.
- d. There is a shortage of people to hire in the mental health field.
- e. TriCity has partnered with Aurora University to present *Inside the World of Mental Illness: From Stigma to Acceptance* on March 24<sup>th</sup>.

# B. Outreach Sub-Committee Report

i. Commissioner Wiese has a call in for Lisa Garhan from the City of St. Charles. There is a future plan to work with the Youth Commission student consultants to come up with marketing plan / calendar of what to advertise and when.

#### C. Student Consultant Committee Report

- i. Commissioners Clavelli and Kristofer met with our three student consultants.
- ii. The group discussed how to disseminate info to schools and to youth in our community.
- iii. The Student Consultant Committee has a two-part focus. One, to bring in more student consultants and two, get info about the Youth Commission out to more clubs and groups in the community.
- iv. Bulletin boards are an option, but social media can also be better utilized. Twitter and Instagram are popular with high schoolers.
- v. National Honor Society was identified as a group that might be interested in working with Youth Commissioners to help with recruitment and information sharing.
