COMPLAINT OF VIOLATION

NOW COMES the Petitioner, James Keegan, Chief of Police of the City of St. Charles, Illinois and files this complaint before the Local Liquor Control Commission of the City of St. Charles, Illinois, and states as follows:

- 1. The Petitioner is the duly appointed Chief of Police of the City of St. Charles and as such is charged with the duty of enforcing the laws of the State of Illinois and the ordinances of the City of St. Charles.
- 2. That on or about March 15, 2016, at approximately 12:40 p.m., the Licensee, Best Massage, by and through its employees, officers and/or agents, committed the following violation of the St. Charles Massage Establishment Code:

OFFENSES

Violated Section 5.20.130(G) of the Massage Establishment Act which states:

"No person, knowingly, in a massage establishment, shall place his or her hands upon, to touch with any part of his or her body, to fondle in any manner, or to massage, a sexual or genital area of another person."

Violated Section 5.20.130(H) of the Massage Establishment Act which states:

"No massage therapist or employee shall perform or offer or agree to perform any act, whether or not for compensation of any form, which would require the touching of the patron's sexual or genital area."

Violated Section 5.20.180(B)(10) of the Massage Establishment Act which states:

"The license holder permits acts of prostitution or solicitations for acts of prostitution to be performed within the premises ..."

Violated Section 5.20.130(D) of the Massage Establishment Act which states:

"No person shall advertise, promote, or refer to himself or herself as a massage therapist as herein defined without being a massage therapist as provided in this chapter or Illinois statute."

Violated Section 5.20.110(A) of the Massage Establishment Act which states:

"Supervision. A licensee of a licensed massage establishment shall have the premises supervised at all times when open for business. Any business rendering massage services shall have at least one person who is a licensed massage therapist on the premises at all times while the establishment is open. The licensee shall personally supervise the business, or shall delegate such supervisory responsibility to a manager whose name is listed on the massage business license and shall not violate, or permit others to violate, any applicable provisions of the chapter. The violation of any provision of this chapter by any agent or employee of the licensee shall constitute a violation by the licensee."

- 3. On or about March 15, 2016, Best Massage was operating under a Massage License issued by the City of St. Charles.
- 4. That the acts detailed in Section 2 of this Complaint of Violation each are prohibited and are in violation of and contrary to Sections 5.20.130(G), 5.20.130(H), 5.20.180(B)(10) and 5.20.130(D) of the St. Charles Municipal Code.
- 5. That the Licensee, Best Massage, is responsible for the acts of its employees, officers and agents and is required to ensure that no violations of state law or ordinances of the City of St. Charles take place on said premises.

WHEREFORE, the Petitioner, James Keegan, Chief of Police requests pursuant to Section 5.20.150 of the St. Charles Municipal Code that the Local Liquor Control Commission, a/k/a the Massage Business Commission, hold a hearing on this matter and take such action against Best Massage as the Massage Business Commissioner shall deem appropriate under the circumstances.

On 03/15/2016, the St. Charles Police Department conducted a Massage Establishment Compliance Check at Best Massage, located at 2774 E. Main Street in St. Charles, Illinois. agreed to be the U/C to conduct this compliance check. 's assignment was to enter Best Massage and request a (1) hour massage and ensure / evaluate their legal compliance. was given \$70.00 (USC), which was photographed and recorded. Detective Ketelsen, Detective Bauwens and I conducted surveillance in the area of Best Massage.

At 1240 hours, I observed enter Best Massage. During this time, I did not observe anyone else enter or exit the business.

At 1325 hours, I observed exit Best Massage. approached me in the parking lot and advised that he paid a female Asian employee \$60 (1-\$50.00 bill & 1-\$10.00) and received a massage. informed that during the massage, the female Asian employee began touching his penis and testicles. stated that the female Asian employee agreed to perform a sexual act (hand to penis) on him for \$60. stated that after he agreed to receiving the sex act, he immediately got dressed and left the business. stated that there were (2) female Asians inside of the business and that the employee wearing a black shirt and black pants provided him with the massage. further advised that he gave the employee a \$10.00 tip.

Detective Ketelsen, Detective Bauwens, and I then entered the business. We were met by the female Asian employee now known as Xinnian Hu. Xinnian Hu was wearing all black clothing. The other female Asian was wearing a blue flowered shirt. immediately advised that Xinnian Hu was the employee who provided him with the massage and agreed to perform a sexual act on him. Xinnian Hu did not speak English and only spoke Mandarin Chinese. I asked the other female employee (unknown name) to contact the business owner and she made contact with the owner's daughter, who speaks English. I spoke with and informed her of this incident. I asked to translate to Xinnian that she was under arrest for prostitution. I asked if Xinnian was a licensed Massage Therapist and she stated that she was not. Xinnian that she was under arrest and stated that she would come to the police department to pick her up. Detective Ketelsen was paid for the massage and tip. (\$50.00 S/N: JK 20234457 A, \$10.00 S/N: ID 63241250 A, able to retrieve the \$70.00 that \$10.00 S/N: JA 53789127 A)

Xinnian was taken into custody and transported to the St. Charles Police Department. I contacted Language Line and I was informed that they did not have a Mandarin Chinese interpreter on duty. I was unable to interview Xinnian. Xinnian was processed and charged with Prostitution. I logged onto the Illinois Department of Financial & Professional Regulations. I ran Xinnian to check for a Massage Therapist License which came back "No Record". (See attached IDFPR Document) Xinnian was then charged with Violating the Massage Act / License Required. Xinnian posted \$150.00 bond and paid \$50.00 for the processing fee. Xinnian was issued a court date of 04/21/2016 at 0900 hours at the Kane County Branch Court. (See 's Supplementary Report and Detective Ketelsen's Supplementary Report) This case is cleared by adult arrest.
