Not Budgeted: **Executive Summary** *(if not budgeted please explain):*

Schramm Construction Corporation was retained to assist the City with receiving quotations for George's building clean-up/demolition (basement and 2 levels). Initial costs varied from approximately \$39,000 to \$55,000. Our scope of work was then refocused to what was necessary to understand the level of maintenance required to weather tighten the roof. Accordingly, Schramm provided a cost for clean-up/demolition including ceiling removal for only level 2. The "non-prevailing wage" cost for this completed work was \$17,640. The final cost for this work was \$31,693 based on using "prevailing wage" requirements. The City, for a Public Works project, is required to pay at the prevailing wage standard for clean-up/demolition.

Finally, the City advance this work based on our comfort with the proposal and our check for reasonableness based on other quotes received for the larger scope of work initially contemplated.

Second floor demolition at 109 east Main Street in St Charles, Illinois

Provide supervision, scaffold, equipment required to perform the following:

Remove the entire plaster ceiling beneath the roof including the lath. The ceiling and roof framing will be left intact and is not included in the cost to remove. Remove all of the interior non load bearing walls south of the wall demising the apartments from the rear portion of the building see attached sketch. Remove the wall framing and plaster on the south wall and the west wall south of the demising wall. (See the attached sketch for clarity.) Remove all flooring leaving the existing hardwood floor intact. Remove all materials from the site and legally dispose of the materials the second floor and stairwell will be left in a broom clean condition as it is now. The demo contractor will protect the wood flooring, stair railings, stair, and wood trim in the apartment area we understand the owner may want to salvage /restore the trim in the front area. We are not removing any of the plumbing fixtures or cabinets in the apartments. The plaster wall on the entire east wall will be left intact as is. The demolition contractor will do the best to not damage the hardwood flooring but cannot be responsible for damage such as dents, scratches.

Excluded from Work:

No permit or inspection fees/ no asbestos or lead paint abatement.


