Executive Summary (if not budgeted please explain):

The City was recently notified that we are eligible to purchase rock salt through the State of Illinois' Joint Purchasing Program. The State's 2016/2017 contract for clean rock salt was awarded to Compass Minerals America Inc. of Overland Park, Kansas at a price of \$65.39 per ton. As in prior years, we will have an obligation to purchase 80% of the order quantity and the supplier is obligated to sell the City a maximum 120% of our order.

Additionally, the City has desired to use a treated salt mixture that includes a liquid deicer. The cost for the treated salt is an additional \$15.00 per ton, for a total cost of \$80.39 per ton. This compares to last year's price of \$81.89 per ton.
