**Executive Summary** (*if not budgeted please explain*):

The Sanitary Sewer Manhole Rehabilitation Program is an ongoing Capacity, Management, Operations and Maintenance (CMOM) program to decrease the amount of inflow and infiltration. This program will repair several manholes, extending the service life of the structure within the sanitary system. The bid for manhole rehabilitation will cover the two service areas of SCO2 and WOR West Basins (see attached drainage area maps).

On May 3, 2019, the City opened (5) bid proposals. The City contracted with the engineering team of Engineering Enterprises Inc. (EEI) to prepare bid documents and to review the submitted bids. In reviewing the bid, Front Range Environmental conducted a couple math errors on their bid. The corrected bid amount should have been \$264,850. Front Range Environmental also proposed a product line that would not meet the performance standards of the bid and it was discovered that they are not qualified to install the specified liners. In addition, it was recently revealed they were unable to finish a job within a community.

Due to the concerns found with Front Range Environmental, EEI and City Staff recommends moving forward with the second lowest bidder, RMS Utility Services. RMS meets all the required reference checks and product specifications of the minimum bid requirements.

As planned, the work will proceed within the two CMOM basins, which is part of the Phase 3 approach. Maps of the two drainage areas are attached.
