# MINUTES CITY OF ST. CHARLES HISTORIC PRESERVATION COMMISSION THURSDAY, SEPTEMBER 20, 2023 – 7:00 P.M.

#### 1. Call to Order

Chairperson Malay called the meeting to order at 7:00 P.M.

#### 2. Roll Call

Ms. Hitzemann called roll with five members present. There was a quorum.

## 3. Approval of Agenda

A motion was made by Dr. Smunt and seconded by Mr. Kessler, with a unanimous voice vote to approve the agenda.

4. Presentation of minutes of the September 7<sup>th</sup>, 2023 meeting

A motion was made by Dr. Smunt and seconded by Mr. Kessler with a unanimous voice vote to approve the Minutes of September 7, 2023. Mr. Pretz and Ms. Rice abstained.

# 5. Certificate of Appropriateness (COA) applications

## a. 15 S 3rd St.

Ms. Hitzemann presented the application to remove current brick patio and replace with concrete patio.

A motion was made by Ms. Rice and seconded by Dr. Smunt with a unanimous voice vote to approve the COA as presented.

## b. 5 S 2<sup>nd</sup> Ave.

Mr. Joe Freeman, Owner, presented the application to remove and replace the wooden safety railing and ramp with a new black metal safety railing and ramp.

Commission discussed adding concrete in area surrounding ramp and area alongside the building that currently holds multiple trash containers for this and surrounding buildings.

A motion was made by Dr. Smunt to approve the proposed construction and authorization of staff to review and approve concrete permit to be submitted. Seconded by Mr. Kessler with a unanimous voice vote to approve the COA as presented and Staff approval of concrete permit to be submitted.

### c. 314 Walnut St.

Ms. Hitzemann presented the application to remove current asphalt driveway and install a paver walkway.

A motion was made by Mr. Kessler and seconded by Ms. Rice with a unanimous voice vote to approve the COA as presented.

# 7. Landmark Applications

# a. Public Hearing/ Landmark: 405 Prairie St.

Ms. Malay started the Public Hearing. No public was in attendance.

Dr. Smunt suggested using the historic property name of William and Martha Klinkey.

Dr. Smunt there is a significant failure on the jamb and head casings of the front and rear door entry doors are non-contributing.

Mr. Pretz made a motion to close the Public Hearing and seconded by Dr. Smunt with a unanimous vote.

Ms. Rice made a motion to approve the landmark application for 405 Prairie Street and was seconded by Dr. Smunt with a unanimous voice vote.

#### b. 720 Prairie St.

Mr. Pretz presented the recommendation for Landmark status for 720 Prairie Street.

Dr. Smunt commented the shutters on the home were incorrect size. Mr. Pretz advised he had a discussion with the homeowner of the property and homeowner would prefer to remove the shutters.

Dr. Smunt made a motion to move this property to a public hearing and carry over facts of discussion to the public hearing. Seconded by Mr. Kessler.

# d. 838 N. 5th Ave.

Mr. Pretz presented the recommendation for Landmark status for 838 N. 5<sup>th</sup> Ave.

The original owner had named the home Saxony Terrace. Commission felt Saxony Terrace Estate is the historic name, would be fitting, and should retain as name of property.

Commission discussed details of the house that should be added to the application.

Ms. Rice made a motion to move this property to a public hearing and carry over facts of discussion to the public hearing. Seconded by Mr. Kessler.

Ms. Hitzemann advised painting does not require a permit so would not come before the Historic Commission.
