NAY: 0 ABSENT: None MOTION CARRIED Mayor Rogina: I'd like to make a statement now that the budget has been adopted. On the record, I have agreed with Ald. Turner that a budget should not be underwritten with any reserves used. I stand by that statement today. I am supportive of using these reserve funds as a bridge to a discussion to the aforementioned gas tax that will take place in June. I'm supportive of this measure and hope the city council will analyze this issue carefully as a source of revenue. I further maintain that, per our previous conversations in the past few weeks, this budget year is a year to prepare for and seek new sources of revenue with a path for the next five years. I will debate anyone that we have been strong, competent, fiscal guardians, and particular as it pertains to expenditures. Staff has made it very clear as to what inflation adjustments revenues we have and what we've been working with over the past decade. Ald. Turner, in off line communication with me is exactly correct when he opines that the projects that we have started and would like to start, are bonding power, and ability to move the city forward rests with a realistic approach to sound fiscal management. I look forward to working with you, ladies and gentlemen of the council and with the staff and citizens to find the right approach to maintain a solid fiscal approach, not only for our 10% share, but property tax, and to maximize those sources from current or proposed, that will make fiscal sense and not create undo hardship on our residents. Our track record tells me we are up to that task. Thank you

Ald. Lemke: I too have voted to approve the budget and to go forward it is important we do have a supermajority approval but it does not mean that the expenses we have and proposed to incur need to be approved in the course of the year. The same goes for revenue as well. I think we need to continue to review how we manage revenue and expenses through the remainder of the fiscal year 2018/2019.

Ald. Turner: It was brought up once before that we need a comprehensive approach for not just a single year but for the next several. We used to have a 5 year budget plan and I think we should be planning at least 5 years ahead. When I came on to this council in 2005, there was really no fiscal issues that I had to face. I'm sure those who joined shortly thereafter say the same. I look back, Ald. Stellato, Ald. Lemke, Attn. McGuirk (at the time was on the council), and they did some really heavy lifting to maintain a responsible budget. There were some taxes put on, some growth and we took the revenue sources they proposed and coupled with the growth. This city was on a very smooth path and in three years, we're going to have a new mayor and maybe 3 or even 4 new aldermen, I really believe that and I don't think those people should be faced with a revenue crunch or a budget crunch. They are going to need their time to get their feet on the ground and learn what's going on and learn the quirks of their fellow aldermen. That's really hard to do if you have to worry about money right out of the shoot. As we go forward in this process, I think we ought to take a comprehensive approach, not just go from year to year to year, because we are constantly chasing out tail. It is not good for the city and not good for the residents. Thank you.
