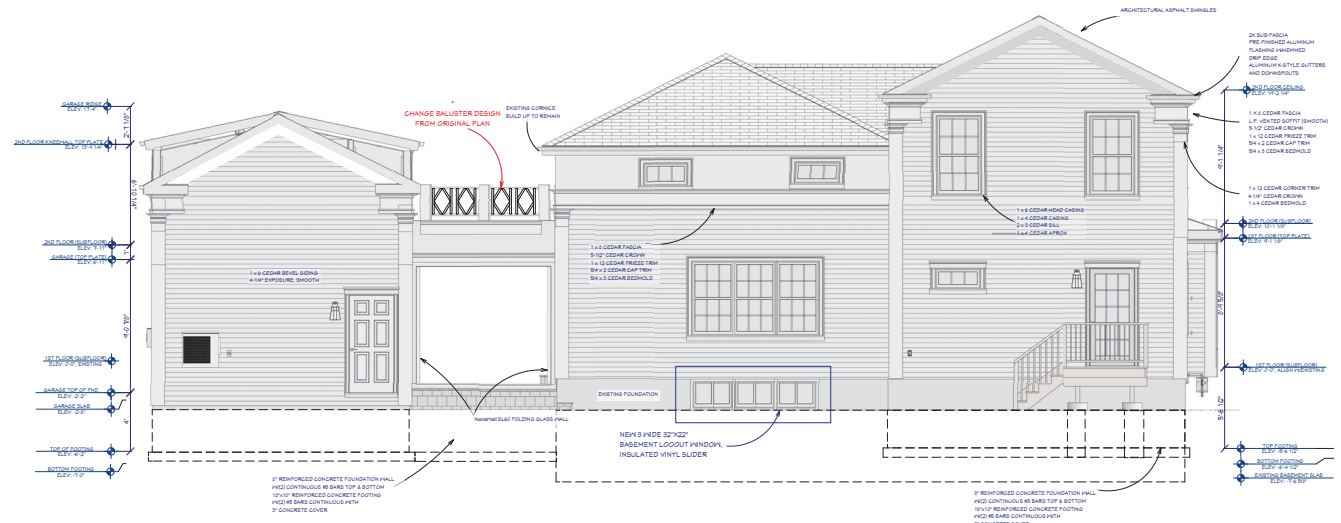
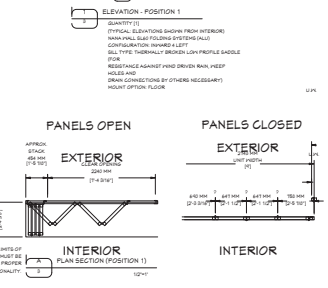
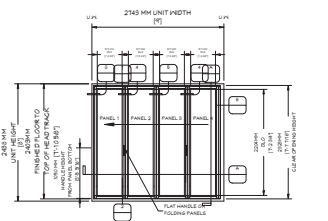


FRONT ELEVATION

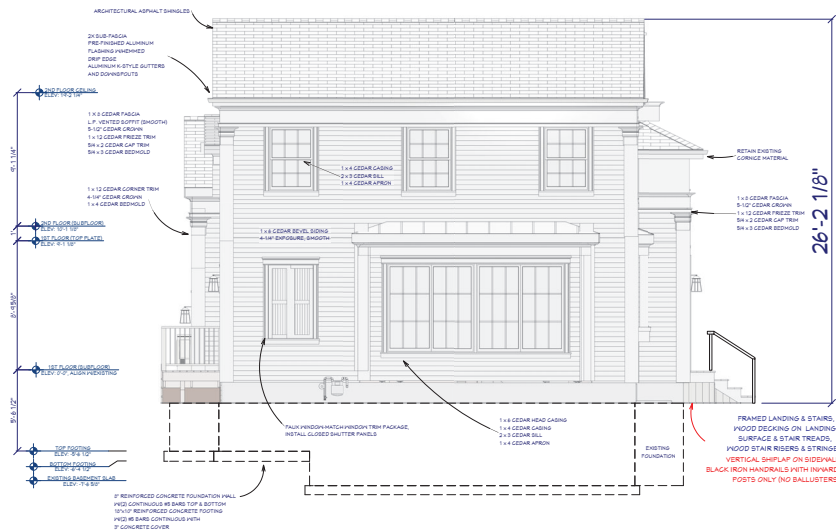

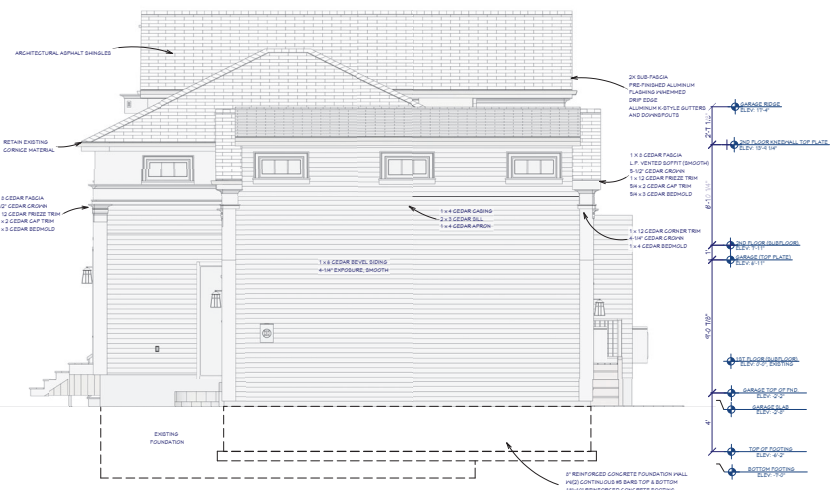

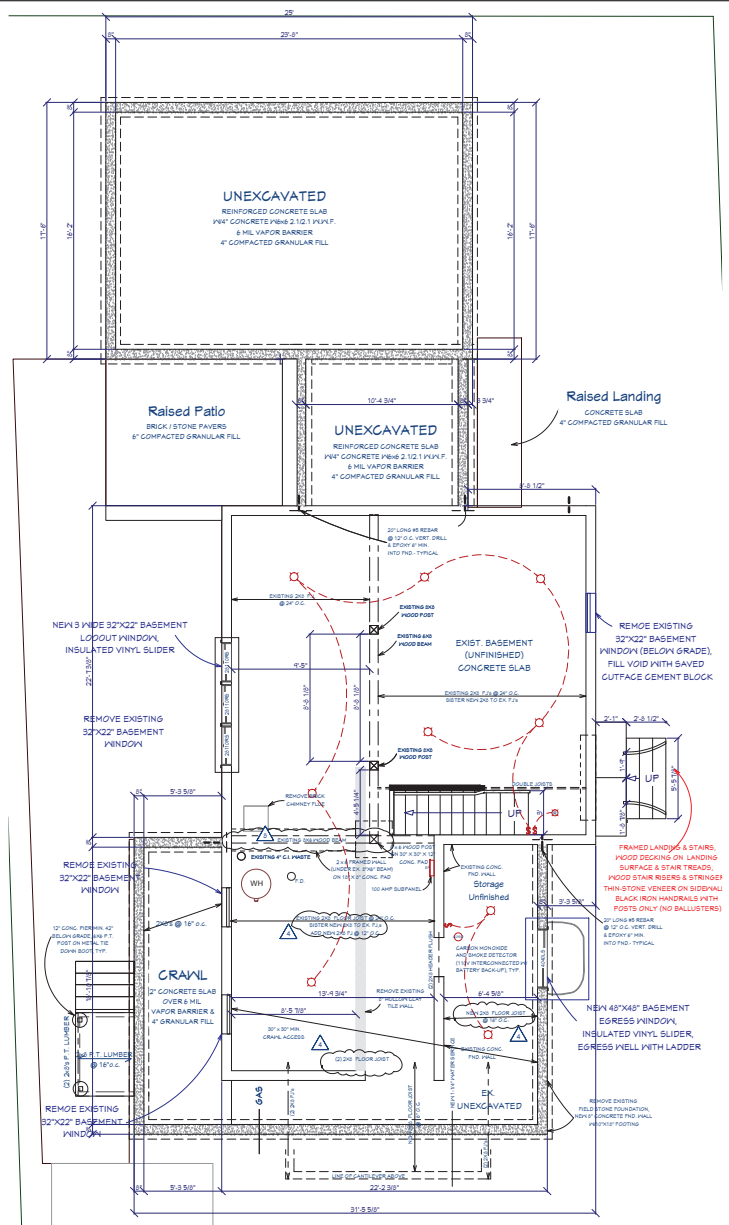
SOUTH ELEVATION
