7. Human Resources Department

a. Recommendation to approve an **Ordinance** Excluding the City of St. Charles as a Municipal Employer from Coverage Under the Paid Leave for All Workers Act and Amending the City Code to Require a Form of Paid Leave for City Employees.

Jenn McMahon reminded the committee that this Illinois law was passed in March 2023 and goes into effect in January 2024. The city management team's concerns about the law are:

- The absence of a request and approval provision, and
- The cost of offering the paid time off (estimated additional cost is between \$30,000-54,000)

The primary concern is the risk of impact on city operations. The administration of this leave, and supervisor efforts and recordkeeping, will be difficult. Because St. Charles is a Home Rule municipality, the city may approve an ordinance exempting employees from the benefits of this Act. The proposed ordinance also codifies the existing paid leave benefit for full time employees. It maintains the status quo regarding paid leave.

It is possible that SSA 21 may be phased out since this is the final year of bonded debt due. A public hearing will be conducted on these SSAs, along with the tax levy, on December 4, 2023.

Bill Hannah shard that the budget process started in October and departments are working on their proposed budgets. On January 22, a City Council Workshop is scheduled for discussion of the significant items included in the proposed FY 2024/2025 budget. On February 28, a draft budget is scheduled to be distributed to the City Council for consideration at the March 4 Government Operations Committee meeting. On April 1, a public hearing and City Council approval are scheduled. City Council is required to adopt a budget before the beginning of the fiscal year on May 1.

The City budget is concentrated in four funds.

- General Fund
- Electric Fund
- Water Fund
- Sewer Fund

Factors influencing budget development were reviewed. The January Workshop rough outline was covered and an opportunity to ask questions was provided.

It was requested to receive information about the grant process, including the number of applications submitted and the amount of grants received.
