A. Tree City USA

The City of St. Charles [City] was approved by the Arbor Day Foundation as a Tree City USA for the 26th year. Additionally, the City earned the Growth Award from the Arbor Day Foundation for going above and beyond the four standards of Tree City USA. Criteria for the Growth Award included the City's participation in continuing education for its certified arborists and forestry crew, tree inventory and plantings to removals ratio. Less than 15% of all Tree Cities earn the Growth Award.

Planning continued for the Arbor Day tree planting on Friday, April 26th at Davis Primary School at 1:30 pm. The specific site on school grounds for the location of the tree will be determined with School District 303 facilities and city staff members.

B. Bird City.

Comm. Myers reported City Council passed a Resolution for the City to become a Bird City. St. Charles will be recognized by Bird City Illinois during the May 8th meeting of the Kane County Audubon Society at 7:00 pm at Baker Community Center. Comm. Myers will invite Mayor Vitek to the meeting and encouraged all members of the NRC to attend.

Comm. Otto reported approximately 60 people attended the bird walk hosted by the NRC on April 6th at Norris Woods Park. Additional bird walks are scheduled in April and May.

Comm. Mengler reported he and Comm. Haggas attended the March 28th meeting of the Fox River Dam Joint Task Force ["Task Force"].
