### MINUTES CITY OF ST. CHARLES NATURAL RESOURCES COMMISSION MEETING RALPH GRATHOFF, CHAIRMAN AUGUST 9, 2018

#### 1. Call to Order & Pledge of Allegiance

The meeting was convened by Chair. Grathoff at 7:03 p.m.

#### 2. Minutes Review and Approval

Motion to approve and place into the public record the minutes of the July, 12 2018 Natural Resources Commission [NRC] meeting. Motion by Comm. Duerr, second by Comm. Goudreau to approve the minutes. Voice vote: unanimous; nays – none. Motion carried at 7:04 p.m.

#### 3. Old Business

#### A. Urban Forestry Management Plan

The Urban Forestry Management Plan [UFMP or the Plan] will be reviewed by the NRC and discussed at the September NRC meeting. Chair. Grathoff noted updates to the Plan will be made if necessary, rather than trying to pass an ordinance to affect change. Chair Grathoff inquired as to the process to amend the Plan. Mr. Adesso stated if there are substantive changes made to the Plan by the NRC, the amendments will likely have to be approved by City Council, but he will confirm this is correct.

Comm. Nagy inquired as to the audience for the UFMP [i.e. if the document is intended to be used by both the City and residents]. Comm. Nagy noted the acceptable species list appears to address only parkway trees, not trees appropriate for private planting such as Spruce. Mr. Adesso explained the Plan is intended for use by the City's Public Works Department. Comm. Duerr noted the UFMP is an educational document that provides recommendations for residents. Chair. Grathoff noted the general principles of the UFMP are applicable to both Public Works and residents, including pruning and planting techniques, and having the right tree for the right place. Chair. Grathoff suggested including City tree inventory data from Graf Tree Care to the UFMP. Comm. Nagy suggested including a link to species information on the Morton Arboretum website, which is updated continually. Mr. Adesso stated the NRC could further develop the Plan and possibly add a section/chapter for residents. Comm. Duerr suggested keeping City Council aware and involved with updates to the UFMP and the NRC's activities.

Commissioners will bring their comments/suggestions/updates to the UFMP to the September NRC meeting.

#### 4. New Business

#### A. Pumpkin Composting/Recycling

Comm. Goudreau informed the NRC of a pumpkin collection event initiated by SCARCE [School & Community Assistance for Recycling and Composting Education] the Saturday

after Halloween that offers an way to keep pumpkins out of landfills. Illinois is the country's number one grower of pumpkins. In 2017 thirty-one different sites/communities participated in pumpkin collections, and to date, ninety-three tons of pumpkins have been collected and kept out of landfills. The Kane County Recycling Office coordinated a pumpkin collection in 2017 that was held at Pushing the Envelope Farm near the Northern Illinois Food Bank in Geneva; approximately five gaylords of pumpkins were collected. The one-day collection events are generally held from 9:00 a.m. – 12:00 p.m. Comm. Otto noted the Park District previously held a pumpkin bowling event at Pottawatomie Park, then composted the pumpkins at the Park District's Bolcum Road location.

Comm. Goudreau explained hosting a pumpkin recycling event generally involves obtaining City approval, coordinating with the Kane County Recycling Office and getting a hauler, such as Lakeshore Recycling Systems to take to take the pumpkins to compost. Mr. Adesso explained the City no longer composts leaves or mulch. Comm. Otto noted the Park District's community garden plots are closed as of October 31st. Mr. Adesso stated the NRC could seek City Council approval to use City facilities for a pumpkin collection event, possibly at Public Works. Comm. Goudreau explained there is a toolkit for pumpkin recycling that includes small cards to hand out during trick-or-treating, among other resources.

Mr. Adesso will obtain information from the City's refuse/recycling service provider, Lakeshore Recycling Systems and follow up with the NRC. Comm. Goudreau offered to coordinate volunteers for the event. Mr. Adesso will seek approval from the City's Government Services Committee and City Council. Chair. Grathoff requested a motion by the NRC to approve pumpkin composting and recycling as proposed by Comm. Goudreau. Motion by Comm. Nagy, second by Comm. Otto to approve the pumpkin composting/ recycling event. Voice vote: unanimous; nays – none. Motion carried at 7:55 p.m.

#### **B.** Storm Drain Stenciling

Comm. Otto reported SCARCE received a grant to apply medallions to storm drains in DuPage County that state "No Dumping - Drains to River." Comm. Otto explained the America in Bloom judges suggested having storm drain medallions during their visit to the City. Comm. Duerr stated the City does, in fact, have medallions on some of its storm drains; and Comm. Otto confirmed she was aware of this. Mr. Adesso noted as of the late 1990s "No Dumping" was caste into the storm drains installed in the City. Comm. Otto noted she was aware that some of the storm drains do have stenciling. The stencils can be easily applied to storm drains, and Comm. Goudreau explained in DuPage County volunteer groups installed storm drain stencils; this may be a project of interest to an Eagle Scout group.

Mr. Adesso commented the River Corridor Foundation of St. Charles may be a resource for the NRC, and storm drain stencils may be close to the mission of the Foundation. Mr. Adesso explained a plan for storm drain stencils could be developed by the NRC and presented to City Council; he will report back to the NRC on the number of storm drains in the City. The City's GIS Department can track which drains have been stenciled should the NRC decide to pursue this initiative. Perhaps the NRC could set a one-year goal and/or partner with the River Corridor Foundation targeting the storm drains closest to the Fox River.

Mr. Adesso noted the manufacturer Berntsen makes medallions for storm drains. Comm. Goudreau will also obtain the source and cost of the medallions used in DuPage County; she will bring a sample medallion to the next NRC meeting. Mr. Adesso suggested the NRC may first want to address: what the stencils will look like, how big they will be, the locations of placement, etc.

Chair. Grathoff summarized the NRC can review the sample stencil and then decide if it will pursue a grant and consider making the project part of the NRC's mission.

### C. America in Bloom Summary

Comm. Otto informed the Commissioners that AIB's visit to St. Charles went well, and the City met many of the criteria in the categories judged. The AIB judges' results will be publicized at the end of September at AIB's symposium in Lexington, Kentucky.

### 5. Committee Reports

### A. Education Committee

In Comm. Myers absence, Ms. D'Argento reported the books for donation have been labeled with the NRC logo and letters to the schools prepared. Comm. Myers plans to distribute the books so the schools will have them before the 9-11 Patriot Day commemoration.

### **B. Langum Woods Clean-Up Committee**

Comm. Otto reported the St. Charles Breakfast Rotary Club and the St. Charles History Museum may have volunteers to participate in Langum Woods clean-up.





### 10.40.010 - Parking time limits

- A. City-owned, -leased, or -operated parking lots:
  - 1. It is unlawful for any person to cause, allow, or permit any vehicle to be parked in any Cityowned, -leased, or -operated parking lot for a period of time exceeding the time limits set forth in Exhibits A through WZ during the period of time between the hours set forth in Municipal Parking Lot Exhibits A through WZ.
  - It is unlawful for any person to cause, allow, or permit any vehicle to be parked in a parking space designated as a leased, permitted, or reserved parking space during the period of time between the hours set forth for leased, permitted, or reserved parking Lot Exhibits A through WZ. (Ord. 2005-M-2 § 1; Ord. 2004-M-17 § 1; Ord. 2003-M-26 § 1; Ord. 1998-M-21 § 1; Ord. 1998-M-14 § 1; Ord. 1997-M-41 § 1; Ord. 1996-M-28 § 1; Ord. 1995-M-35 § 1; Ord. 1991-M-54 § 1; Ord. 1987-M-61 § 1; Ord. 1987-M-29 § 1.)

### City of St. Charles, Illinois Ordinance No. 2018-M-\_\_\_\_

### An Ordinance Amending Title 10 "Vehicles and Traffic"; Chapter 10.40 "Stopping, Standing and Parking"; Section 10.40.010 "Parking Time Limits" of the St. Charles Municipal Code

**BE IT ORDAINED** by the City Council of the City of St. Charles, Kane and DuPage Counties, Illinois, as follows:

**SECTION ONE**: That Title 10, "Vehicles and Traffic," Chapter 10.40, "Stopping, Standing and Parking", Section 10.40.010, "Parking Time Limits", of the St. Charles Municipal Code, be and is hereby amended as follows:

A. City-owned, -leased, or -operated parking lots:

- 1. It is unlawful for any person to cause, allow, or permit any vehicle to be parked in any City-owned, -leased, or -operated parking lot for a period of time exceeding the time limits set forth in Exhibits A through Z during the period of time between the hours set forth in Municipal Parking Lot Exhibits A through Z.
- 2. It is unlawful for any person to cause, allow, or permit any vehicle to be parked in a parking space designated as a leased, permitted, or reserved parking space during the period of time between the hours set forth for leased, permitted, or reserved parking space in each City-owned, -leased, or -operated parking lot in Municipal Parking Lot Exhibits A through Z.

**SECTION TWO**: That Title 10, "Vehicles and Traffic," Chapter 10.40, "Stopping, Standing and Parking", Section 10.40.010, "Parking Time Limits", of the St. Charles Municipal Code, be and is hereby amended as follows:

**SECTION THREE:** That Title 10, "Vehicles and Traffic," Chapter 10.40, "Stopping, Standing and Parking", Section 10.40.010, "Parking Time Limits", of the St. Charles Municipal Code, be and is hereby amended as follows:

That Exhibit PL-I – Municipal Parking Lot I; Plaza building, first level be removed and replaced with the amended PL-I – Municipal Parking Lot I; Plaza building, first level.

**SECTION FOUR:** That Title 10, "Vehicles and Traffic," Chapter 10.40, "Stopping, Standing and Parking", Section 10.40.010, "Parking Time Limits", of the St. Charles Municipal Code, be and is hereby amended as follows:

However, as a slight variation from our original schedule, our team has been able to secure bids <u>early</u> for some of the Bid Package #3 work including Plumbing, Metal Panels, Fire Protection and Masonry. By getting approval of this work prior to October, it provides the contractor opportunities to expedite work faster giving the project a better chance to be weathertight by winter. Bid Package #3A is work proposed for September approval and Bid Package #3B is work proposed for October approval. We received several bids for each contract and in total were about \$140,250 <u>under</u> our cost estimate for this combined work.</li> <li>In addition to Bid Package #3A recommendations, the project team is asking for approval of Bid Package #2 scope changes (Attached Bulletin #1 &amp; #2) and allowances for the soil remediation costs for the foundation and retention pond excavation. 



weaker/low bearing soils or unsuitable soils, no lateral overexcavation will be necessary, but the excavation should be 1 foot wider than the footing (6 inches on each side).



Settlement of the conventional shallow foundations, designed in accordance with our recommendations presented in this report, is expected to be within tolerable limits for the proposed building. For footings, extending to estimated depths as indicated on the Preliminary Bearing Table placed on stiff to hard silty clay or properly compacted engineered fill and designed as discussed above, maximum total settlement is expected to be in the range of 1 inch or less. These settlement values are based on our engineering experience with the soil and the anticipated structural loading, and are to guide the structural engineer with his design.

#### Below Grade Walls

Permanent below grade walls should be designed to withstand lateral earth pressures and surcharge loads. The lateral earth pressures exerted on the walls will be a function of the stiffness and the rotation of the walls. The rotation of the wall controls the degree to which the internal strength of the soil is mobilized. If rotation or deflection of the walls will be less than that required to mobilize the active earth pressure condition due to stiffness, bracing or other mechanism (as is typical with basement walls), the "**at-rest**" earth pressure condition should be evaluated. For the at-rest earth pressure condition, below grade walls can be designed for a linearly increasing lateral earth pressure of 65 psf per vertical foot of wall above the long-term groundwater level and 100 psf/ft below the long-term groundwater level. These at rest lateral earth pressures assume that granular materials are used for wall backfill. The wall design should also account for any surcharge loads within a 45 degree slope from the base of the wall. For the at-rest earth pressure condition, a lateral earth pressure coefficient of 0.45 should be applied to surcharge loads.

We recommend the basement walls be provided with a perimeter drainage system, as described above, to reduce the potential for excess hydrostatic pressures to be exerted on the walls. This system may consist of perforated or porous wall, closed joint drain tiles located around the perimeter of the walls, slightly below the lower slab level. We recommend waterproofing and damp proofing of walls be considered for basement walls. Based on the groundwater level information obtained from the boring, damp proofing of the basement walls should be adequate. Waterproofing/damp proofing and waterstops measures should be installed in accordance with local building code requirements.

The space between the outside of the walls and the excavation should be backfilled with a granular fill. The ground surface adjacent to the below grade walls should be kept properly graded to prevent ponding of water adjacent to the below grade walls.

**Executive Summary** (*if not budgeted please explain*):

The Electric Utility has been asked to design and build and electric infrastructure improvement on Walnut Avenue to support an increased electrical service at the Arcada and George's Sports. PW Engineering designed a project to locate a new transformer in the City owned lot on the south side of Walnut Avenue, and bring pipes across Walnut for the new and increased electrical services.

Purchasing went out for bids and received three (3) bids. The bid package includes the civil work, roadway excavation, restoration of pavement and streetscape, transformer foundation, and pipe installations. Specifically, it includes installation of (6) - 4" conduits crossing Walnut Avenue for the purpose providing the Arcada with access to the new transformer and the ability to increase their electrical consumption by approximately eight times their current demand. Additionally, (3) - 4" pipes will be placed under Walnut to provide for the requested electrical service size to George's Sports. Archon met all bid requirements and took no exceptions.

This project was not anticipated or included in the FY19 Electric Budget. The \$127,000 total addition to the electric budget includes this contractor work and the estimated approximately \$54,000 in materials that City Line crews will take out of inventory to complete the work.

In 2014 the City entered into a 5-year agreement with Kramer Tree Specialists, Inc. for citywide brush and leaf collection services. In total, the City receives 8 monthly brush collections (April – November) and 3 leaf collection cycles, which typically take place in late October and concludes by early December. Over the course of the contract, the City has instructed Kramer to delay the initial leaf collection from the week before Halloween to the week of Halloween in order to maximize the volume of leaves dropped. This year's program will begin on October 31 <sup>st</sup> . Still, as the City and its residents have sought to maximize the diversity of the urban forest, we have found that some species of trees have a tendency to hang onto their leaves well into the late fall and even early winter season. This year, the City's new garbage contract with LRS has included a free leaf bag collection services for residents during the month of December to supplement the City's curbside collection program. At the conclusion of the leaf season, the City's contract with Kramer will be complete and staff will seek bids to perform leaf and brush collection work for the coming years.

This advertisement furnished three bids, of which Pedersen Company of St. Charles, IL was the lowest responsive, responsible bidder.

While inspections and removals are being performed on a daily basis throughout the year, it is anticipated that between 130 and 150 trees will be planted in each of the program seasons this fiscal year. Generally, all trees that are to be planted will replace those that were removed due to catastrophic decline as a result of disease, infestation, or significant trauma.

Staff has developed a planting list that will continue to improve the diversity of the City's urban forest, which will add an aesthetic diversity to the canopy, but will also help to minimize the impacts of diseases or infestations that affect a single species of tree more than another.

The unit price includes the cost of the tree, the installation, mulching, initial watering, as well as a twoyear warranty.

With all of the ash tree replacements occurring throughout the region, the market for 2.5" parkway trees has become very volatile over the last several years. Pederson's initial bid included a 9% increase for FY18 and a 13% increase for FY19. Last year, Pederson reviewed the market rates for the trees that the City has requested and reduced the increase to 2% to better reflect nursery pricing. This year, Pederson has again reviewed the market rates and has offered to hold their FY18 rates rather than implement the 13% rate increase indicated on their bid for the FY19 program.

#### PROJECT UNDERSTANDING AND APPROACH

The City of St. Charles is seeking bids to establish a contract for the provision and planting of specified varieties of quality parkway trees for the City of St. Charles in the fall of 2016 and the spring of 2017. As an option, the City is also seeking two additional one-year extensions to the contract, which could be exercised through the spring of 2019 at the City's sole discretion. This project will be overseen by St. Charles' Urban Forestry Consultant and/or City staff.

#### SPECIFICATIONS FOR PLANTING PARKWAY TREES

#### 1. GENERAL INFORMATION

Submitting Bid: Planting Contractor is requested to submit a price per unit for each tree type. This contract is a Unit-Cost contract. Some plantings may be removed from, or added to the supplied list prior to contract completion. Ample notice will be given to the Approved Planting Contractor if a site is to be removed from or added to the project. A total of 500 trees will be used to best estimate the overall cost of the project for both the fall and spring planting seasons, with approximately 250 trees anticipated to be planted per season. This is an estimate and shall not be interpreted as a minimum guaranteed quantity. The actual quantity will be determined based on bid pricing received, budgetary availability, and removals performed. Subcontractors may be utilized with the consent of City staff.

The timing of the award of this bid is anticipated as follows:

A purchase order will be issued upon City Council authorization and receipt of insurance documentation and bonds from the successful bidder.

Timing of planting: Timing of planting is critical to the success of this project. Timing of planting for the Fall of 2016 shall be between September 8, 2016 and November 15, 2016. The November 15 deadline may be extended (with the consent of the City) in the event of inclement weather conditions during the time of planting. Timing of the Spring planting shall be from the time the final frost has receded to June 1,2017.

Locations of Work: A list of addresses of parkway tree planting locations will be provided to the successful contractor prior to planting. The contractor will be responsible for calling J.U.L.I.E. at (800) 892-0123 to have underground utilities marked prior to planting. Individual tree planting locations will be provided by the Urban Forestry Consultant in the form of Excel Worklists, along with hardcopy, .pdf, and .kml maps for use on Google Earth. These lists and maps will not be routed. Routing of the lists will be the responsibility of the contractor. The Urban Forestry Consultant will be responsible for any alterations to the supplied plan.

**Hours of Work:** Work shall be performed from 7:00 am to 7:00 pm. Monday through F r i d a y , and 7:00 am to 5:00 pm Saturday. All weekend work must be approved in advance by City of St. Charles staff.

**Communications/Public Relations:** Contractor is required to notify the Public Services Division Manager one week in advance of beginning work and to check in weekly to reportprogress of work and any issues or problems. Contractor shall at all times maintain goodrelations with the public and respectfully answer questions from the public. Contractor will be required to direct inquiring residents to the Public Services Division Manager.

Water Source: Contractor will be permitted access to water at the St. Charles Wastewater Treatment

Facility for the purpose of filling tanks to water during initial planting of trees free of charge. Use of fire hydrants will be strictly prohibited.

**Safety:** The contractor shall exercise every precaution for the protection of persons and properties. The contractor shall provide their work crews with the necessary personal protective equipment to safely complete their work.

#### 2. ASSURANCES/SPECIFICATIONS

**Species:** The species selected for this project, and their specific locations, were determined bythe Urban Forestry Consultant using industry Best Management Practices (BMPs). If species that are called for in the attached Species List cannot be procured in full, substitution may be made by the Planting Contractor, but only at the discretion of the Urban Forestry Consultant and City staff.

**Inspection:** The Urban Forestry Consultant and/or City staff will visit the nursery with the Planting Contractor, and identify one or more trees for each species on the Species List that conform to health and aesthetic parameters set forth in the following section. This consultation will serve as a benchmark for what stock will be considered acceptable. Upon delivery of nursery stock by the Planting Contractor, the Urban Forestry Consultant will inspect all deliveredmaterial, and reserves the right to reject any item which is deemed to not meet specifications.

Any material deemed unacceptable will be replaced at no cost to the City. During and afterplanting, the Urban Forestry Consultant will inspect planting practices and end results, and retains the right to notify the Planting Contractor of noncompliance, at which point the nurserymust take corrective action at no charge to the City.

**Health and Aesthetic Parameters:** All stock shall be between 2.5" and 4" Balled and Burlapped (B&B) trees, unless otherwise approved. 2.5" caliper trees shall be the preferred size,but other sizes may be approved by consent of the Urban Forestry Consultant. Trees which have a multi-stem growth habit will be judged by adding the diameters of the individual stems, or byheight above the root collar. For trees judged by height above the root collar, a height of no lessthan 5' shall be considered acceptable. All stock shall be in good to excellent condition, and have good to excellent architecture for the species in question. No multiple leaders, cracked major branches, leans of greater than 15 degrees, dead major limbs, moderate to severewounding, diseased or infested stock, degraded root balls, or other such defect shall be accepted. Trees not in compliance with these guidelines will not be accepted.

**Planting:** The Planting Contractor's crew shall be comprised of experienced plantsmen with atleast one year of prior tree planting experience. Planting pits shall be hand dug by the approved planting contractor with sloped sides and flat bottoms. Sides will be gently roughed with ashovel or similar implement prior to installation. Excavated soil will be used as backfill. All trees shall be planted to the depth of the root collar. After backfilling, <u>excess soil shall be removed</u> before watering and mulching. See attached diagram for proper planting specifications.No wrapping, staking, or other modifications to the prescribed planting shall be performed by the Planting Contractor without the express prior consent of the Urban Forestry Consultant or City staff. Sec Attached Detail.

Mulch: All trees shall be mulched with no more than a 3" deep layer of shredded hardwood mulch after the initial watering. Mulch rings shall conform to attached specifications. Each site shall be cleared of all debris, excess soil, containers or tools before moving to the next planting site. If during post-planting inspection, mulch has been applied incorrectly, it will be identified and remedied at the Planting Contractor's cost.

Watering: The Approved Planting Contractor will provide a minimum of 5 gallons of water to each new planting immediately after planting (within 1 day preferred). Since some of the planting may occur during dormancy, continued watering may not be necessary.

Replacement Guarantee: The contract will guarantee all installed material for a period of no less than two (2) years after installation. Details of how the Replacement Guarantee will function must be established before this contract will be finalized and an order to proceed is issued. Replacement Guarantee details will depend on the Approved Planting Contractor's existing warranty specifications.

It is generally anticipated that the City of St. Charles will assume financial responsibility for replacement costs after the Approved Nursery's warranty period has ended. The Planting Contractor will not be responsible for replacing trees which did not survive due to any reason other than planting practice or vigor, such as (but not limited to) automobile accident, vandalism, gross homeowner neglect, or other such activities.

**Executive Summary** (*if not budgeted please explain*):

The Public Services Division recently issued a bid for the 2018 and 2019 storm sewer maintenance program. The scope of this program includes the cleaning and camera inspection of approximately 101,777 linear feet of storm sewer and 1,247 catch basins, inlets, manholes and box culverts. The cleaning work will help to ensure the reliability of the City's storm system, and the visual inspections will dictate the City's repair schedule for the next two years.

The City received four bids to perform this work with National Power Rodding Inc. of Chicago, Illinois being the lowest responsive, responsible bidder. United Septic has performed work for the City in the past and they have the experience, equipment and expertise to perform the work within guidelines of the bid.

Unit pricing was submitted for a two year contract to complete the work in Zones 1 and 6 in the northern portion of the City. While, the total bid came in over the City's budget amount for this fiscal year, the actual cost will be dependent on the necessity of heavy cleaning and catch basin cleaning. Therefore staff would like to utilize the unit pricing from this bid to complete work in both Zones 1 and 6 up to the budgeted amount of \$159,000. The remaining work that is not completed in these zones in the first year will be completed as part of next year's program. This is part of a 7 year maintenance cycle to clean and inspect all the storm sewers throughout the community.

## DESCRIPTION

The City of St. Charles is seeking a contractor to provide Storm Sewer Maintenance Services to help support our Storm Water Program. The contract includes the cleaning and inspection of catch basins and storm sewer within established zones in the City of St. Charles, as well as televising services of all areas cleaned. The two service zones identified in this program each contain up to 50,000 linear feet of storm sewer main, approximately 1,247 structures, 352 of which are Catch Basins. These numbers are further described on the attached Storm Water Infrastructure Report ("Exhibit C"). The City reserves the right to add or decrease the amount of sewer and structures to be cleaned, based on the bid prices received.

#### **DURATION OF WORK**

The base contract shall be for one year, the 2018/2019 fiscal year, May 1, 2018 – April 30, 2019. All regular maintenance as part of the base scope of this contract shall be performed in continuous business days and shall be completed and invoiced absolutely no later than April 30, 2019.

The City is also seeking pricing for an optional one-year contract extension. The extension may be granted at the sole discretion of the City. If granted, this extension year option will begin on May 1, 2019 – April 30, 2020.

#### LOCATION OF WORK

The base contract for the 2018/2019 fiscal year will be in Zones 1 and 6, located in the northwestern and northeastern quadrants of the City. Pipe sizes, lengths, and catch basin information can be found in "Exhibit C".

Supplemental work based on unit prices may be located in any zone within the City limits. Emergency work shall have no minimum mobilization required.

## **DEBRIS REMOVAL**

The City will dispose of all debris removed from City storm sewers as part of this program. The successful bidder shall dump all debris in a drying bed located within the City's corporate limits.

## BACKYARD STORMSEWER

The Contractor shall be responsible to make notification to all residents and businesses with backyard storm sewers/structures. Notifications shall be made no less than three (3) days and no more than two (2) weeks prior to starting the work. The notification should contain the estimated week/day of the work as well as the contact information for a foreman on the site.

Should the work have potential to damage a landscaped area, or should a resident request that no work be performed adjacent to his/her property, the contractor shall skip those properties and notify the Public Works Manager of all sections skipped. In the written report, skipped areas shall be noted with the reason that they were skipped.

#### **EMERGENCY RESPONSE**

Should an emergency situation require immediate storm sewer cleaning or maintenance services, the Contractor shall be required to mobilize on site within 2 and one-half hours of the callout.

## MINIMUM REQUIREMENTS

All contractors MUST meet the following minimum requirements to be considered for work:

- Minimum of 5 years of experience providing Storm Water Catch Basin Cleaning Services. If less than five years' experience, previous experience with the City will be considered.
- Provide adequate communications. All vehicles will need a 2-way radio with City frequency (provided by the City) and a Cell Phone.
- Ability to provide competent drivers/ operators that are capable of efficiently operating the equipment assigned and are able to read City supplied maps. Operator coding the data shall be PACP certified.
- Provide equipment that meets or exceeds the Department of Public Works equipment specifications. All equipment shall display the name of the contractor for identification.
- Meet or exceed all Liability Insurance Requirements as required by the City of St. Charles.

# STANDARD SPECIFICATIONS

The Standard Specifications governing the performance of the Work shall be deemed to include all revisions, amendments, and supplements in effect as of commencement of the Work, or subsequently enacted anytime during the progress of the Work. The Standard Specifications include the latest editions of the following:

- 1. "Standard Specifications for Road and Bridge Construction", adopted April 1, 2016, published by the Illinois Department of Transportation (IDOT).
- 2. "Bureau of Local Roads and Streets, Special Provisions and Specifications", published by IDOT.
- 3. "Interim Special Provisions", adopted subsequent to issuance of Supplemental Specifications and Recurring Special Provisions.
- 4. "Manual on Uniform Traffic Control Devices for Streets and Highways", adopted by IDOT.
- 5. "Standard Specifications for Water and Sewer Main Construction in Illinois". Seventh edition dated 2014.

### SUPPLEMENTS TO STANDARD SPECIFICATIONS

The following requirements supplement the "Standard Specifications for Road and Bridge Construction," adopted April 1st, 2016, (hereinafter referred to as the Standard Specifications); the latest edition of the "Illinois Manual on Uniform Traffic Control Devices for Streets and Highways" in effect on the date of request for bids; and the "Standard Specifications for Traffic Control Items," latest edition, (hereinafter referred to as the Traffic Specifications). In case of conflict with any part or parts of said Specifications, the Special Provisions shall be controlling.

Before submitting bids, bidders should visit the site of the proposed work, verify all site conditions and also conditions under which said work must be conducted.

Submission of a Bid implies that the bidder is fully conversant with all requirements of Minimum Requirements, Standard Specifications, Special Provisions, Standard Drawings, and site conditions. No claim for additional compensation will be considered or paid because of the CONTRACTOR'S negligence or failure to be so informed.

#### STORM SEWER AND CATCH BASIN CLEANING SPECIFICATIONS

The CONTRACTOR shall perform and provide:

- It shall be the responsibility of the Contractor to remove internal deposits from the catch basins or storm sewer structures, using accepted sewer cleaning techniques. The cleaning operation shall remove all garbage, solids, soil, sand, and pieces of broken pipe, bricks, grit, and other debris that would collect within the Storm Sewer Structure. Manholes, catch basins and Inlets, shall all be classified as storm sewer structures
- All material shall be removed at the downstream manhole of the section being cleaned. Passing material from one manhole section to another shall not be permitted. In the event that roots, sludge, dirt, sand, rocks, grease, encrustation and other solid or semisolid material or debris resulting from the cleaning operations are observed and/or detected by the Public Works Department as passing to downstream sewer segments(s), Contractor shall be responsible for cleaning such downstream sewer segment(s) at no additional cost to the City. All costs are incidental and shall be included in the unit bid price.
- Precautions shall be taken to ensure that the cleaning operation will not cause any damage or flooding to public and /or private property being served by the sewer line section involved. The Contractor shall bear full costs associated with any flooding or damage to basements or structures.
- The Contractor shall recognize that there are some conditions such as broken pipe and/or major blockages that can prevent cleaning from being accomplished or where damage could result if cleaning were attempted or continued. Perform a reverse set-up cleaning when a blockage in the sewer prevents completion of cleaning from the downstream manhole by moving equipment to the upstream manhole and attempting to complete the cleaning of the entire sewer. When such instances are encountered, the Public Works Manager shall be notified immediately.
- Attempt to remove a specific blockage in the sewer for at least 1 hour before advising the Public Works Department the blockage cannot be removed. The Public Works Department shall immediately be notified by the Contractor of any and all conditions, which in the opinion of Contractor warrant termination of cleaning activities. If Contractor's cleaning equipment becomes lodged in a sewer, it shall be removed by Contractor at his / her expense. This shall include excavation and repair of the sewer, underground utilities, backfilling, and surface restoration.
- When heavy sewer line cleaning is shown as a bid item on the bid, it shall be paid at an hourly rate and shall include the cost of all items necessary to complete the sewer cleaning and any bypass pumping/flow control which may be required. The cost for an additional set-up is incidental to the heavy cleaning bid. Heavy cleaning must be approved by the Public Works Department **prior to** its use or payment will be withheld.

- Acceptance of sewer cleaning work is contingent upon the successful completion of the Catch Basin Cleaning inspection. If Catch Basin inspection shows debris, solids, sand, roots, deposits remaining in the Structure, the cleaning will be considered unsatisfactory, and the Contractor shall repeat cleaning and cleaning of the Storm sewer structure, at no increased cost to the City until cleaning is acceptable to the Public Works Department.
- **CLEANING ITEMS:** The Contractor shall select the cleaning equipment for cleaning based on the age, the material and the probable condition of the sewer. The Contractor shall not damage the sewer or any manhole during cleaning.
- Storm Sewer Structures: Not all the structures on the map will need to be cleaned. It will be at the Contractors discretion if a structure has no debris to be removed from it. This will then be listed as a checked item only and not subject to cleaning and payment of such. A list of these items and structures shall be supplied to the City of St Charles at the time the section is invoiced.
- **INSPECTIONS:** The Contractor shall ensure that all structures submitted for payment will be free from debris upon completion of the cleaning work. A follow up inspection by the City will determine if the structures submitted will be acceptable for payment.
- **SUBMITTALS:** The Contractor shall:
  - a. Submit a spread sheet of all structures that were cleaned for payment with the appropriate city Identified numbers attached to the corresponding structure.
  - b. A spread sheet listing the structures with city ID's that were not cleaned.

## STORMSEWER TELEVISING SPECIFICATIONS

The contractor shall televise all sections of storm sewer cleaned under this contract. All televising footage shall be PACP coded, and a report of any defects provided to the City. Any critical or catastrophic failures of City infrastructure identified during this televising shall be brought to the attention of the Public Services Division Manager immediately.

Televising of storm sewer structures is NOT required as part of this scope of services. However, a structure condition report, completed on an iPad, provided by the City, shall be completed along with the mainline assessment.

Electronic copies of the televising footage shall be provided to the City on a CD or USB drive. All data shall be formatted to be PACP compliant. The City currently uses IT Pipes for their televising software. While not required, IT Pipes configured data would be seen as beneficial.

In addition to the video footage, the contractor shall provide a written report of each section cleaned, identifying defects in the pipe sections. The report shall be clear and concise.

Final payment will not be issued until televising footage and written report at delivered to and accepted by the City.

# **BASE BID/ FEE SCHEDULE**

Bidders will be required to submit costs for Storm Water Televising & Cleaning Services based on the following Fee Schedule. Bidders will be compensated based on Unit Prices identified for width and length of Storm Lines. Bidders will be awarded this procurement not necessarily based on least cost, but rather to the contractor whose bid best meets the requirements of this Bid. It is understood that the contractor will be required to perform and complete the proposed work in a thorough and professional manner. The contractor shall provide all necessary labor, tools, implements, equipment, materials, and supplies to complete the contracted work.

The bid shall include a detailed list of the equipment the contractor will have available including the following information:

- The Name and Type of Equipment
- Age of Equipment
- Condition of Equipment

Should there be a discrepancy between the gross sum bid amount and the bid amount calculated from the summation of quantities multiplied by their respective unit prices, the latter shall apply.

**Executive Summary** (if not budgeted please explain):

Over the past several months IHC, Trotter and Associates Engineering, and City staff has worked closely together to find cost-saving efficiencies and scope modifications on the Phosphorus and Digester Improvement Project. This joint effort has continued to ensure the City is receiving the most efficient and cost effective value during this construction project.

(Loan Contingency)

The team has closely reviewed the scope of work and collectively have been able to make some modifications to keep the project on track financially. These changes will not compromise the project, nor the overall product or services the city receives from the contractor. Instead, the construction project can proceed in a more cost effective and timely manner.

Staff recommends the following changes in the work scope :

- Repair holes in the I-beam as described in the monthly report \$13,077.77 •
- Change in base elevation by control building to improve drainage \$1,628.48
- Reroute new blower air lines for a cleaner install \$3,421.17
- Adjust pipe layout in digester room for operation improvement \$7,382.14
- Changing electrical meter and warning lights safety requirement \$14,426.97
- Change an area of grass to concrete sidewalk, less maintenance/durability \$1,127.48

In addition to the increases in the contract, the team also discovered some cost-efficient reductions in the scope of work. These proficiencies resulted in a cost reduction of (\$33,663.62).

Overall, the recommended balance of changes will increase the contract by \$7,400.36.

This is an EPA funded loan project; any change in the scope of work requires City approval.

# City of St. Charles, Illinois Temporary Construction Easement

#### **EASEMENT AGREEMENT**

THIS EEASEMENT AGREEMENT, made in the City of St. Charles, State of Illinois, by and Between Board of Education of St. Charles School District 303, Kane and DuPage County (hereinafter referred to as "GRANTOR") and the City of St. Charles, a Municipal Corporation, organized and existing under the law of the State of Illinois, of Kane and DuPage Counties, Illinois (hereinafter referred to as "GRANTEE").

#### Recitals:

WHEREAS, Grantor owns that certain real property located in the City of St. Charles, County of Kane, State of Illinois, and more particularly described in <u>Exhibit A</u> attached hereto and made a part hereof (the "Land");

WHEREAS, subject to the terms and conditions of this Agreement, Grantor desires to grant to Grantee, and Grantee desires to accept from Grantor, a non-exclusive public utility easement and right-of- way upon, over, across, under and through the portion of the Land, as described on **Exhibit B.** attached hereto (the "**Easement Area**"), and depicted on **Exhibit C**, attached hereto.

#### Agreement:


