To Whom It May Concern,

Good afternoon, and thank you in advance for hearing our request. Our names are Renee Boehm and Tracy Dockum. We are both literacy instructors at Wredling Middle School teaching co-taught classes together. Last year, you generously granted us \$500 to complete a service project which was an amazing success, and so we would love to be able to offer this opportunity to our students again! We have attached a few pictures to show you what a difference our students made thanks to your funding; we were so proud. Also, if you go to www.d303.org and locate the "video vault" and go to 2009-2010, you will see a video clip of our students in action. Last May, our students chose to serve: Friends of the Fox, Our St. Charles Park District, Brighton Gardens, Our St. Charles Public Library, and the Illinois Food Bank.

One change that we would like to make in our request is an increase in funding. Last year, we did not have enough money for buses to transport students to the variety of locations desired. Also, we realized we needed to hire two substitute teachers so that we could have at least one day coordinate with parents volunteers, teacher volunteers, and community organizations. For these reasons, we are requesting \$1000.00.

Our plan is again to identify and communicate with local non-profit organizations which would benefit from having middle-school volunteers. We will give a brief synopsis of each organization to the students, including the purpose and volunteer need of each. Students would then choose their top choice(s) and conduct further research on their chosen organizations. Students would gather information regarding the organization such as when/why it was founded, how it serves the community, who specifically is served, what volunteerism looks like, and contact information. After synthesizing this information, students will be grouped according to interest and will then use the contact information to schedule volunteer work to occur during the school day near the end of May. Our reasoning behind having students volunteer during the school day is that it allows every student the same opportunity, not dependent upon transportation, parents' working schedules, or weekend plans. Also, we are able to monitor communication.

Upon completion, students will reflect upon and share their experiences with one another in a variety of ways. Our ultimate goal is to have students experience an authentic and relevant research and service opportunity which will lead to increased community involvement and awareness. The research, writing and presenting of information all work to meet literacy learning standards while bringing their education to life.























About M.Y. Stage
