- Police Chief Jim Lamkin stated that the Police Department looked at the previous event and it was very well organized and in addition to our St. Charles officers they had adequate security. At this event each person who goes will get a wrist band, over 21 will have one color, under 21 would have another color. Chief Lamkin agrees to changing admission age based on two things, 1) wristbands 2) the amount of security people. He stated he is comfortable with the admission age of 18.
- Alder. Bessner asked if security will be able to see wristbands and be able to monitor the crowd. Chief Lamkin responded yes.
- Alder. Bessner stated he will be voting for this event but wanted to make sure that extra effort will be given to any avenue to monitor anyone under 21 who may try to seek out drinking. Chief Lamkin responded that the message is clear on the Police Department and the City Council parts to the event sponsors that if this is approved at over 18, we will continue to monitor the event closely and make sure age differences are respected.
- Mayor DeWitte asked how many police officers will be there. Chief Lamkin responded, two, but they will have 10 other security guards which many are off duty police officers from other agencies.
- Mayor DeWitte stated that he did not know about the wristbands and this makes him more comfortable about admitting people under 21 and it will be monitored very carefully.
- Alder Penny stated that if the event is held, it sounds like it will be well monitored.
- Alder. Turner said many of our members of the armed forces under the age of 21 would like to attend the event but can't. If they are willing to put their lives on the line for our country, we should let them attend the event.
