- Dave Kintz, Deputy Chief of Administration, presented information on the two vehicles needed. One is a supervisor vehicle the other is a canine vehicle. One is budgeted for this year, the other is not. The supervisory vehicle is being replaced due to mechanical issues. This vehicle is slated for replacement next year, but is being moved up. These vehicles have been approved by the Fleet Management Committee.
- Alder Carrignan appreciates the fact that the Fleet approved this. He then asked if other vehicles have been looked at with a smaller carbon footprint.
- Chief Kintz responded that the gas mileage was looked at compared with other vehicles and the Tahoe has a better rating. For the canine vehicle, the Tahoe sits lower so it is easier for the dog to get in and out of the vehicle.
- Alder Carrignan asked if Ford is getting out of the Police Car business.
- Chief Kintz responded that Ford is changing the vehicles and the one the Police Department would look at is not out yet.
- Alder Carrignan asked if the results of the hybrids in the fleet have been looked at.
- Chief Kintz responded that when the CSO vehicle was replaced some cost analysis on the hybrid versus the regular escape. Because of the hard use of the vehicle, it was determined that it was no benefit to us.
