The purpose of this memo is to document the background investigation of J.C. Sake pursuant to its application for a Class B-1 liquor license.

Applicant
Guoyang Shi (owner)



- Guoyang Shi is a naturalized citizen of the United States (May 3, 1997 – Garden City, NY). He does possess a valid Illinois driver's license . He has no contacts with this department.
- On May 31, I spoke with Guoyang Shi over the phone. Because of schedule conflicts I was not able to meet with Shi at the restaurant space. He stated he has taken over the space at 3843 E. Main St., and plans to open to open a Japanese/Chinese restaurant sometime in August, 2013. 

 He stated he was born in China, but was naturalized as a citizen in New York approximately 15 years ago. He stated he currently owns one other restaurant, Hibachi Grill, at 948 S. Barrington Road, Streamwood. He stated he does not possess a liquor license at that location as he does not serve alcohol there. Streamwood Police Department has no contacts at that location.
- Guoyang stated there may be some minor work completed inside, such as new paint and minor mechanical work, but he does not intend to seek a permit for any work. He stated he is unsure of the menu at this point, only to say the menu would contain both Japanese and Chinese food. He stated he guessed he would have approximately \$3,000 worth of alcohol on hand once he opened. Currently, there is no alcohol at the location.

- Guoyang stated he has completed his BASSET certification since completing the liquor license application, and he has provided that to the city. I advised him that any employees who he intends to have serve or dispense alcohol must be BASSET certified, and a copy of their certificates must be provided to the city. He stated he understood.
- A lease agreement is attached, as is a certificate of naturalization and certificate of liability insurance (Lead Ways Insurance – Bloomingdale).
- The criminal history of this applicant is pending receipt of conviction from the Illinois Bureau of Identification.


