Minutes

2013 Mid-Year City Council Retreat Held on Saturday, June 15, 2013 St. Charles Public Works Facility – Conference Room 2

Present: Mayor Rogina, Aldermen Stellato, Silkaitis, Payleitner, Lemke, Turner, Martin, Krieger,

Bessner, and Lewis

Absent: None

Others Present: Todd Bancroft, Brian Townsend

Mayor Rogina said that this is a special meeting of the St. Charles City Council and called the meeting to order. He also called the roll and stated that all members are present. He welcomed everyone to the retreat and thanked the members of the City Council for taking the time to get together and talk about important issues for the City.

1st Street Redevelopment Project

Townsend provided an overview of the discussion that occurred at the 2012 mid-year retreat and stated that the direction provided by the City Council at that time was:

- 1. The City will extend the project entitlements to May 7, 2013.
- 2. The City will not move to terminate the redevelopment agreement at this time.
- 3. The City will begin a process to identify other developers that may be interested in implementing the original vision for 1st Street.
- 4. The City will consider making some temporary improvements to the Phase 3 property and the SMN property to make it more attractive and useful.

Townsend said that those steps were completed and that it is now time to decide on the next steps. He distributed two diagrams that were presented by representatives of 1st Street Development LLC during a June 6th meeting with Mayor Rogina, Ald. Stellato, Ald. Turner, Aiston, and Townsend.

Ald. Martin asked about the status of 1^{st} Street Development LLC – is it still viable? Ald. Stellato said that it was, but that some of the partners are more involved than others at this point in time. He also said that Attorney McGuirk has been asked to study the issue from a legal standpoint to determine what options the City may have related to termination of the redevelopment agreement.

Ald. Turner said that he was comfortable giving 1st Street Development LLC 12 months to begin construction on Phase 3 or the City needs to move on with something else. He said that in exchange for the 12 months of time, 1st Street Development LLC should agree to walk away from the project, if the City wants to pursue other options.

Ald. Krieger asked about the potential to leave the Phase 3 property as open space and create a concert venue. She said that she would support a referendum on this subject to allow the voters to decide. Ald. Bessner said that he supports this idea and would like to obtain some additional open

space along the river. Ald. Silkaitis concurred and said that the City should try and get something unique on this property.

Mayor Rogina asked if the Council believes there is any obligation to the existing businesses that located there with the understanding that additional development was planned. There was an understanding that existing businesses could be impacted – positively or negatively – regarding changes in the plan for the Phase 3 property.

Townsend explained that the City has restructured the debt on the 1st Street project, but that it did not reduce the City's obligations – it deferred them to allow additional time for the development to occur. The restructuring did not contemplate a significant reduction in the size/scope of the project. As it stands today, there is approximately \$20 million in funding that will be needed from non-TIF sources to pay the debt.

Bancroft said that the City should obtain more details regarding the project, financing, etc. Ald. Stellato concurred and said it is still early and the concepts presented on June 6th were preliminary.

Ald. Bessner said that he would like to reduce the size of the development and provide additional open space. Mayor Rogina asked at what cost. Ald. Turner said that the 1st Street project was always planned to be an economic engine for the City, not open space.

Ald. Martin said that he was comfortable with the revised concept and said the City should proceed to work with 1st Street Development LLC on it. He said that a park/open space is not realistic given the prior decisions and the economic consequences.

Bancroft said that he believes the concept is a nice fit for the site and is not too dense. Ald. Payleitner agreed.

Ald. Lewis asked about the former Manor Restaurant site. Ald. Stellato explained that this property is owned by a separate development group, SMN Development. He said that this may be an opportunity for the City to acquire some additional open space for the project, if that is a desire. Ald. Lewis asked about the cost of doing this. Ald. Stellato said that it would need to be studied further.

Mayor Rogina indicated that the consensus of the group is to proceed as follows:

- 1. Obtain the legal opinion from Attorney McGuirk regarding the City's legal obligations to 1st Street Development LLC and SMN Development
- 2. Work with 1st Street Development LLC to refine the concept
- 3. Ask 1st Street Development LLC to make a presentation at the Planning & Development Committee before August 20th

Economic Development Director/Downtown St. Charles Partnership

Mayor Rogina said that Chris Aiston is planning to retire at the end of July and the Council needs to determine what to do with the position, once the vacancy is created.

Ald. Bessner asked if Mr. Aiston's decision was voluntary. Townsend indicated that Mr. Aiston has expressed disappointment regarding certain aspects of his position previously and that he is eligible to retire at age 55.

Ald. Silkaitis asked what Mr. Aiston's current salary is. Townsend said that he does not have the exact number, but it is approximately \$125,000.

Townsend said that there was discussion about the economic development function in 2009. He provided an overview of the materials that were presented to the City Council at that time and called attention to the ten main functions/responsibilities of the Economic Development Department. He also summarized the four different approaches that were considered before the City Council decided to re-establish an Economic Development Department and an Economic Development Director position.

Mayor Rogina stated that the City provides a significant amount of funding to the Downtown St. Charles Partnership and the Convention & Visitors Bureau. He asked if the City was well-served by the current approach regarding these outside entities.

Mayor Rogina mentioned the percentage of businesses that are members of the DSCP is lower than what he believes it should be. Ald. Payleitner said that membership may not be a fair way to judge engagement. She said that businesses need not be members to participate and many cannot afford to be members. She also said that the DSCP uses the terms "investors" and "participants" and not "sponsors" and "members."

Ald. Stellato said that he was concerned about a recent event hosted by the DSCP that was supposed to be about leasing, but turned into a discussion that was critical of the city. He was disappointed to hear that the DSCP allowed this to occur.

Ald. Martin said that the DSCP is getting better with new board members and Lynne Schwartz. Townsend agreed that things appear to be improving and on the right track.

Ald. Martin said that he believes the City needs an Economic Development Director. He said that he believes the position is necessary.

Ald. Lewis said that she is concerned about the City not knowing about stores coming in or going out. She said that she understood this was difficult to track because the City does not have a business license requirement. Townsend said that it was unrealistic for the City to know about all such occurrences because stores don't need to tell the City and that is probably a low priority for them, given everything else that may be going on.

Townsend said that the City will need to decide what the priorities are for Economic Development and what the position profile will include as points of emphasis. This will be critical to the City's success in finding the right candidate and the success of the selected candidate.

Ald. Stellato asked that the City consider an incentive-based bonus program for the new Director.

The consensus position is to proceed with the hiring of an Economic Development Director to replace the vacancy created by the retirement of Chris Aiston.

A break was taken at 10:30 am. The group reconvened at 10:40 am.

Charlestowne Mall/East Main Street Business District

Mayor Rogina provided a summary of a meeting that Ald. Payleitner, Ald. Stellato, Chris Aiston, Brian Townsend, and he hosted with representatives of Mark Goodman & Associates on Friday, May 3rd. He said that Goodman is the person who currently has a contract to purchase the mall. Townsend added to that by indicating that Goodman reportedly put down \$500,000 in earnest money last week and that the deal could close as early as mid-September.

Ald. Stellato and Ald. Payleitner commented on the meeting with Goodman et al and a summary of the concept that he is considering. This includes additional out lots, redeveloping the current food court area, and demolition of the former Sears space to create new building pad(s).

Mayor Rogina said that there has been no formal discussion or request of incentives, but that the City will almost certainly be asked for something and referenced the East Main Street Business District.

Ald. Stellato said that Dennis Alf from St. Charles Toyota is strongly opposed to the concept. He said that Mr. Alf has suggested the City only do a sales tax rebate for the mall.

Ald. Lemke asked about the City's sales tax and if the City is limited to rebating the 1% home rule tax. Townsend said that the City receives 2% on the sale of general merchandise and that any or all of that could be used to support the redevelopment.

Mayor Rogina asked about the Council's interest in considering the Business District proposal. Townsend said that there was discussion about the Business District at the December, 2012 Planning & Development Committee meeting. He provided an overview of the materials that were presented at that time and called attention to the ability to bifurcate the establishment of the district and the imposition of any new taxes.

Ald. Krieger stated strongly that she believes the Business District should wait until after the IL 64 construction is complete. Ald. Martin concurred and said that he is opposed to any new taxes. He also requested a summary of the outreach that has been done with the area businesses and what the feedback has been.

Ald. Bessner agreed with deferring the consideration of the Business District and said that it should be tied to redevelopment of the mall.

Ald. Payleitner said that incentives for redevelopment should be considered on an individual basis and not as a district.

Ald. Lemke said that additional taxes on businesses working with thin margins will not be good for them.

Bancroft asked if it was appropriate for the City to be reactive here. He said that the City may want to consider being more proactive with a program, rather than waiting for individual properties or stores to come forward.

Ald. Stellato said that he is comfortable with the proposed boundaries of the Business District, but would prefer to defer consideration for 6 months.

The consensus of the City Council was to defer the consideration of the East Main Street Business District for at least 6 months.

A break was taken at 11:10 am. The group reconvened at 11:20 am.

Knowledge-Based Incentive Pilot Program

Mayor Rogina indicated that the City has been approached by a business that would like to relocate to St. Charles. It is currently located in Roselle & Schaumburg and the business would like to consolidate its offices and research & development activities at a St. Charles location.

Townsend provided a summary of the business, its current proposal to relocate, and a proposed incentive program to assist the business. He said that the State of Illinois is also offering incentives to the business and that the City retained Northern Illinois University (NIU) to study the proposed economic impact of the relocation.

Townsend said that the City's proposed pilot program is called Knowledge-based Employment Incentive Pilot Program and is proposed to support a business that wants to bring a significant number of good paying positions to St. Charles. In this case, the business proposes to bring 71 current jobs and create 15 new jobs over the next 2 years. In addition, there are about 100 summer/seasonal positions that the company hires.

The program proposes to provide a direct payment to the company for creating employment in St. Charles, establishing the following:

- 1. A value for each of the jobs (full-time equivalent) with an annual salary of \$50,000 or greater at the St. Charles facility;
- 2. A bonus value for each of the above described jobs that is filled by a person residing within a given geographic boundary in or around St. Charles

- 3. An additional bonus value for each of the above described jobs that is filled by a person that resides within the St. Charles corporate boundary;
- 4. A bonus value for each internship filled by a City of St. Charles resident attending, in good standing, high school or college; and
- 5. A maximum amount to be paid to the company in employment incentives on an annual basis and over the entire five year period.

The maximum amount of money the City of St. Charles shall pay the company under this incentive pilot program over the five-year term is \$275,000.

In addition, the company would need to make a commitment to stay in St. Charles for no less than twelve (12) years. Failure to meet this condition shall result in the company, or its successor, having to repay the City all disbursements paid to the company under this incentive pilot program.

Mayor Rogina said that the City has also requested that the company work with St. Charles School District #303 to explore opportunities to provide some other educational experiences for our high school students.

Townsend said that we are only proposing a pilot program now to see how it works and to evaluate its success. He said it could be expanded to other businesses that meet certain criteria, such as:

- Will bring 75 or more jobs to St. Charles
- Average salary of \$50,000 or more
- Will occupy more than 20,000 square feet of space

Ald. Lewis asked where the money to pay for the incentive will come from. Townsend said that the City will need to budget the funds each year.

Ald. Lewis asked if the City had approached Kane County about helping with this incentive. Townsend said that Chris Aiston did reach out to Kane County, but was told there were no programs available to assist.

Ald. Lewis asked how we came up with this program. Townsend said that it was based on something similar that the City of Elgin did for an accounting firm in 2012. He also said that it was based on the company's request and a desire to create something that would generate employment for St. Charles.

Ald. Martin said that he believes the company is a good one and he supports the proposal.

Ald. Silkaitis asked about the economic impact study conducted by NIU – will the proposal yield positive results. Townsend said that it will.

Ald. Stellato asked about the EAV of the building today and the possible increase after renovations are made. Townsend said he would research this further.

Mayor Rogina stated that it was the consensus of the City Council to proceed with the proposed Knowledge-Based Incentive Pilot Program.

A break was taken at 11:45 am. The group reconvened at 11:50 am.

Other items:

Mayor Rogina discussed his interest in relocating the podium from the center of the Council Chambers to the east side of the room. The group agreed that it can sometimes be difficult for persons at the podium to address the Council and the audience simultaneously.

It was the consensus of the group to implement a relocation of the podium for a trial period to see how it works.

Mayor Rogina presented an idea to rotate the order of voting for aldermen on a monthly basis.

It was the consensus of the group to rotate the order of voting for aldermen on a monthly basis beginning in July, 2013. Ward 1 will be in July, Ward 2 in August, Ward 3 in September, Ward 4 in October, Ward 5 in November, etc.

Ald. Lewis asked if it would be possible to have an office space with a computer, desk, and phone established for aldermen to use while they are in City Hall. She said that when she is at City Hall, there is no workspace for her to use. Most aldermen said that they are able to serve their constituents without it and did not believe this was needed. Townsend said that such situations could be accommodated on a case-by-case basis, as needed.

Mayor Rogina reported that the US Supreme Court is considering a legal challenge related to prayer as part of government meetings. He said that the ruling may prohibit the City from continuing its invocation prior to City Council meetings. The ruling may also decide that the invocation can continue. It could also allow the invocation, but establish guidance for changing the practice. Mayor Rogina said that the City's current practice will continue until the US Supreme Court issues its decision in the next few weeks.

Townsend concluded the retreat by thanking everyone for dedicating the time to participate.

A motion to adjourn was made by Ald. Turner, seconded by Ald. Bessner. All ayes. Motion carried.

The retreat concluded at 12:15 pm.

Mayor Rogina: At the P&D meeting last week, Dr. Lyle Clarke gave the City on overview of Clarke Mosquito as part of a proposed Pilot Knowledge-Base Incentive Program. A newspaper article and subsequent inquiries made mention of Council's lack of questions related to Clarke Mosquito's specific R&D program. Mr. Aiston is here to introduce Dr. Clarke and allow him to make a presentation to the Council.

Chris Aiston: There has been some inquiries to the operations and activities associated with the research and development that will soon be in place at 675 Sidwell Court location. Since that time I've had the opportunity to talk with Dr. Clarke and he will be making a presentation with respect to those activities and will be available for questions thereafter. If it's the Council desire and consideration after his presentation that their questions have been answered to your satisfaction, we would then ask for a vote to approve the terms of the incentive that was presented last week and then staff will work with the City attorney to create the pilot program and incentive agreement for execution by Council and Dr. Clarke.

Dr. Lyle Clarke: I thought I would show you some pictures of what the lab is and what goes on in this research and development environment. Preceded to show slides of:

- Lab Work Only field trials and manufacturing will be done out of St. Charles

- Regulated by EPA
- Track Record awards

The lab is about 11,000 sq ft. which is similar to a university biology lab strictly for screening products for the next generation of mosquito control products.

Ald. Silkatis: Have you ever had any problems with IEPA such as being cited for anything?

Dr. Clarke: No.

Ald. Lemke: What is the total square footage of the building?

Dr. Clark: 28,000 square feet.

Ald. Lemke: How much of the lab space would you guess is analytical as opposed to research per se?

Dr. Clarke: It's one lab space maybe 2,000 sq. ft.

Ald. Lewis: You are expanding right? You already have two labs elsewhere in the country and this will be the third one you are going to open?

Dr. Clarke: We are consolidating. We have two lab facilities in Schaumburg which we are relocating here.

Mayor Rogina: I know you are proposing in the summertime there is the probability of about 100 interns at your facility and if they are East or North graduates there would be an incentive which we would like. Could you comment on what these interns will be doing?

Dr. Clarke: There are some field operations. We treat most of the streets' open catch basins. Within St. Charles there are 2,000 – 3,000 of the grated catch basins and they are the one of the number on breeding places for West Nile carrying mosquitoes. We found the most efficient way to treat these is by bicycle. We are 50% more efficient doing this with bicycles than with trucks. We've eliminated eight trucks and reduced our carbon footprint. It used to be the worst summer job in our company but now is the most indemand job. So we'll base that out of this location. The picture I showed of Erin in the presentation – she started as an intern and is now today running our laboratory. We have about ten Science interns all the time.

Mike Raehl, 610 Steeple Chase Road, St. Charles: Looking at your operation in Roselle you have kind of a mixing/distribution operation that includes a helicopter pad and a spilled containment capability. Do you envision any kind of that operation being done in St. Charles? Second question, if you are hiring the interns, will they be picking up and distributing from your facility here in St. Charles?

Dr. Clarke: First question is our Roselle facility is our manufacturing facility. We run our services operation there and many years ago, because of this, we were able to get a helicopter pad there. None of that will come here. This is strictly corporate and R&D. All of our manufacturing will stay at our manufacturing facilities. Second, there is no distribution of products for sale at this location.

Mr. Rauile: To be more clear on that, the distribution that the bicyclist would use.

Dr. Clarke: There would be products there that the bicyclists would use. This would be a satellite operation to service the Fox Valley for bicycle riders and our inspectors. The product we use for these catch basins are our organic product.

Vanessa Bell-LaSota, 1610 Howard Street, St. Charles: What is a PPE? You said there are no employee PPEs necessary.

Dr. Clarke: Personal Protection Equipment.

Vanessa: You mentioned the classification of waste; how is that disposed of?

Dr. Clarke: If there is any waste, it is put in a steel drum and then put into a plastic sealed drum and transferred out to a certified plant that would accept it.

Vanessa: Regarding your green products – it used to be that us as residents would get a phone call that there was spraying going on. Is that no longer necessary because of the organic base of the products?

Dr. Clarke: We still offer that service, it depends on if the City wants it.

Stephanie Baumgard, 3205 Blackhawk Trail, St. Charles: Could you talk about how products will be tested for the air and what sort of ventilation there is?

Dr. Clarke: If there are ones tested for air, we actually put a microscopic drop on that mosquito and keep it in a cage to test. There aren't any vapors being sprayed, and if we think we have a viable candidate then we would take it to a field location.

Mayor Rogina: Thank you for your professionalism and presentation.

Dr. Clarke: I invite and welcome any of the councilmen or public to come and view our laboratories.

LICENSE AGREEMENT

THIS AGREEMENT, made and entered into this 6th day of August, 2012, by and between the City of St. Charles, Kane and DuPage Counties, Illinois, an Illinois municipal corporation (the "Licensor" or "City"), and the Downtown St. Charles Partnership, an Illinois not-for-profit corporation (the "Licensee");

WITNESSETH

WHEREAS, the Licensor is the owner of the St. Charles City Hall/Municipal Center located at 2 East Main Street, St. Charles, Illinois (the "Property"); and,

WHEREAS, there is certain vacant office space located on the Property that the Licensor does not currently utilize, as more specifically described on Exhibit "A" attached hereto and incorporated herein (the "Office Space"), as well as certain office equipment that the City does not currently utilize, as listed on Exhibit "B" attached hereto and incorporated herein ("Equipment"); and

WHEREAS, the Licensee was organized for the purpose of promoting the downtown area of the City with the goal of enhancing the economic, social, and cultural environment in the City; and,

WHEREAS, Licensee requires office space and equipment in order to conduct its activities; and,

WHEREAS, Licensor is desirous of granting a license to Licensee, and Licensee is desirous of being granted a license from Licensor, for Licensee to utilize the Office Space and Equipment, pursuant to the terms and conditions contained herein.

NOW, THEREFORE, in consideration of the foregoing recitals and of the terms and conditions hereinafter contained, the sum of One Dollar (\$1.00), and other good and valuable considerations, the adequacy and sufficiency of which the parties hereto hereby acknowledge the parties hereto hereby agree as follows:

- Section 1. <u>Incorporation of Recitals</u>. The preambles set forth hereinabove are incorporated herein as substantive provisions of this Agreement as if fully set out in this Section 1.
- Section 2. Grant. Licensor agrees to grant, and does hereby grant, to Licensee, a license to use the Office Space and Equipment for the term of this Agreement for the purpose of conducting its activities as contemplated by its Articles of Incorporation.
- Section 3. Exclusive Grant. The privilege granted herein is exclusive; provided, however, that Licensor reserves the right at any time to enter upon the Office Space.
- Section 4. Liens. Licensee, its officers, agents, contractors, volunteers and/or employees, shall not suffer to permit any mechanic's lien, judgment lien or other lien of any nature whatsoever to attach or be against the Property, the Office Space, or the Equipment or any portion thereof. Should any such lien be filed, the Licensor shall have the right to contest same.

Section 5. Condition and Upkeep: Use. Licensee has examined and knows the condition of the Office Space and Equipment and has received the same in good order and repair, and acknowledges that no representations as to the condition and repair thereof have been made by Licensor prior to all the execution of this Agreement that are not herein expressed; Licensee will keep the Office Space and Equipment in good repair, normal wear and tear excepted; and upon the termination of this Agreement, in any way, will yield up the Office Space and Equipment to Licensor, in good condition and repair, ordinary wear excepted and will deliver the keys therefor at the Property.

Licensee will not allow the Office Space or Equipment to be used for any purpose that will increase the rate of insurance thereon, nor for any purpose other than that hereinbefore specified, and will not permit the Office Space or Equipment for any unlawful purpose, or for any purpose that will increase the fire hazard of the Property. The Licensee will not permit any alteration of the Office Space except by written consent of the Licensor; all alterations to the Office Space shall remain for the benefit of the Licensor unless otherwise provided in said consent.

Section 6. Access. Licensee, its officers, contractors, agents, volunteers and/or employees, shall at all times have the right of access to the Office Space and such other areas of the Property as are necessary to access the Office Space. The Licensee, its officers, contractors, agents, volunteers and/or employees shall also have access to other areas of the Property as follows: (a) conference and meeting rooms shall be available during normal business hours provided that said rooms are not in use by, or needed by, the City, and (b) use of conference and meeting rooms during non-business hours shall be available on the same basis as the City makes such rooms available to other non-City users, by scheduling in advance and pursuant to the City's policy.

<u>Section 7.</u> <u>Assignment.</u> Licensee shall not assign or otherwise transfer its right in whole or in part under this Agreement without the express written consent of Licensor.

Section 8. Insurance. Licensee shall procure and maintain at its sole and exclusive expense, comprehensive personal injury, workman's compensation and property damage insurance in such amounts as Licensee deems necessary and Licensor deems satisfactory to adequately cover all operation under the exercise of the privileges herein granted. Evidence of insurance shall be provided by Licensee to Licensor.

Section 9. Hold Harmless and Indemnification. Licensee hereby indemnifies, releases and holds Licensor harmless, and agrees to defend Licensor from any and all liability, causes of action, suits, damages or demands of whatever nature arising out of the conduct of Licensee, its officers, contractors, agents, volunteers and/or employees under the exercise of the privileges herein granted. This indemnity is intended as a full and complete general indemnity and shall include Licensee's responsibility for any attorney's fees incurred by Licensor in defense of any claims or actions brought by third parties against Licensor as a result of the privileges granted to Licensee herein.

Licensor hereby indemnifies, releases and holds Licensee harmless, and agrees to defend Licensee from any and all liability, causes of action, suits, damages or demands of whatever

nature arising out of the conduct of Licensor, its officers, agents and/or employees regarding the License Area. This indemnity is intended as a full and complete general indemnity and shall include Licensor's responsibility for any attorney's fees incurred by Licensee in defense of any claims or actions brought by third parties against Licensee as a result of the privileges granted to Licensor herein.

Section 10. Financial Responsibility/No Third-Party Beneficiaries. Licensor shall have no financial responsibility or obligation to Licensee or any third party as a result of Licensor's granting the privileges described herein to Licensee. This Agreement creates no rights, title or interest in any person or entity whatsoever (whether under a third party beneficiary theory or otherwise) other than the Licensee and the Licensor.

Section 11. No Lease or Easement. Licensee expressly acknowledges that nothing herein is intended to create a corporal or possessory interest of Licensee and, accordingly, this Agreement shall not be construed as a lease, easement or any other interest running with the land. Neither this Agreement nor any summary or memorandum thereof shall be recorded with any public authority.

Section 12. Relationship of the Parties. Under no circumstances shall this Agreement be construed to create a relationship of agency, partnership, joint venture, or employment between the Licenser and the Licensee.

Section 13. Term. Unless otherwise terminated pursuant to Section 14, this Agreement shall remain in effect until April 30, 2013; provided, however, upon mutual agreement of the parties hereto, this Agreement may be renewed for up to two (2) consecutive one-year periods.

Section 14. Termination. If the Licensee breaches any of the provisions of this Agreement, or abandons or vacates the Office Space, the Licensor may declare this Agreement terminated upon thirty (30) days written notice to the Licensee. In addition, the Licensor may, for any reason and in its sole discretion, declare this Agreement terminated upon one hundred twenty (120) days written notice to the Licensee.

Section 15. Damage and Destruction. Licensor and its officers, contractors, agents and/or employees shall not be liable or responsible to Licensee for any loss or damage to any property or person occasioned by theft, fire, act of God, public enemy, injunction, riot, strike, insurrection, war, or court order, or for any damage or inconvenience which may arise from this Agreement.

Licensor and its officers, contractors, agents and/or employees shall not be liable for any damage occasioned by failure to keep the Office Space or Equipment in good repair, nor for any damage done or occasioned by or from plumbing, electricity, gas, water, sprinkler, steam or other pipes or sewerage of the bursting, leaking or running of any pipes, tank or plumbing fixtures, in, above, upon or about Property or Office Space nor for any damage occasioned by water, snow or ice being upon or coming through the roof, windows or otherwise.

Section 16. Miscellaneous. This Agreement sets forth the entire understanding of the parties, and may only be amended, modified or terminated by a written instrument signed by the

parties unless herein otherwise provided. Either party's waiver of any breach of failure to enforce any of the terms or conditions of this Agreement, at any time, shall not in any way affect, limit or waive that party's right thereafter to enforce or compel strict compliance with every term and condition hereof.

Section 17. Effective Date. This Agreement shall become effective upon execution by both parties hereto.

Section 18. Governing Law. This Agreement shall be interpreted and construed in accordance with the laws of the State of Illinois.

Section 19. Notices. All notices hereunder shall be in writing and must be served either personally or by registered or certified mail to:

B. Licensee at:

City of St. Charles 2 E. Main Street St. Charles, Illinois 60174 Attn: City Administrator

C. To such other person or place with either party hereto by its written notice shall designate for notice to it from the other party hereto.

Section 20. Counterparts. This Agreement may be executed in multiple counterparts, each of which shall be deemed to be and shall constitute one and the same instrument.

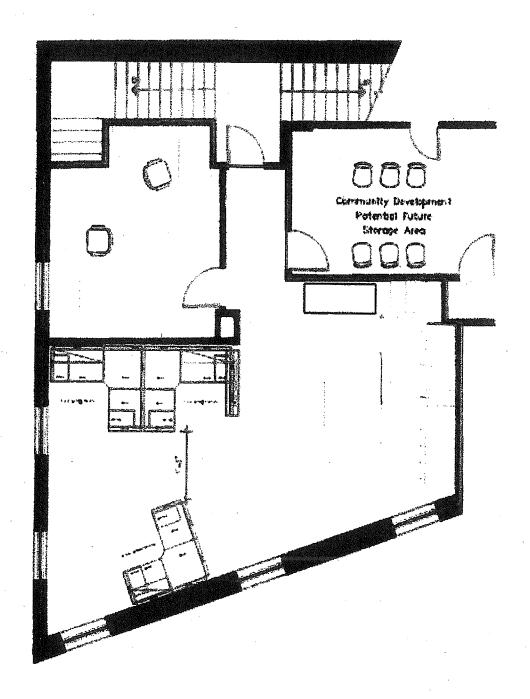

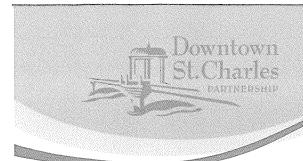

4. Finance Department

a. Recommendation to approve funding requests for St. Charles 708 Mental Health Board for FY13/14.

Chris Minick: For a number of years the City has set aside a portion of its tax levy on an annual basis to provide mental health support to agencies that support St. Charles residents. The mental health levy is 4 cents per \$100 of EAV that was approved by referendum many years ago and funding allocations are recommended on an annual basis by the Mental Health Board. Proceeds from the levy are to support the activities and functions of agencies that provide mental health support services regardless of their ability to pay. Enclosed tonight is a proposed funding allocation for FY13/14 in an amount of \$584,100. City policy requires that any outside agency who receives \$25K or more in funding from the City make a presentation on an annual basis updating the committee on its activities as well as any future plans for funding. Six agencies on the allocation schedule meet that threshold and representatives of these agencies will be making presentations this evening. At the conclusion of the presentations, staff will request a recommendation of approval of the funding allocation schedule in the amount of \$584,100. Tonight Barb Gacic is here, a member of the 708 Mental Health Board as well.

Chrmn. Turner: So anyone who receives over \$25K makes a short presentation tonight.

Association for Individual Development - Lynn O'Shea, President/CEO: We've been serving the St. Charles community since 1961 and we celebrated our 50th anniversary two years ago and are very pleased to be able to continue service to St. Charles. We started as a school for children who weren't eligible for public school services because of their disabilities which didn't change until 1975. As the school was phased out we began serving adults in our shelter work program, employment programs, and also started housing residential services because parents were afraid their children wouldn't have good alternatives when they weren't around anymore to care for them. The past 52 years we have grown from a small one room school to a very large organization serving all of Kane County. Last year we served over 5,000 children and adults with disabilities. St. Charles has always had a very active group of families who take advantage of the services through AID and this past year we served 101 individuals from St. Charles in a variety of programs. We began live-in house services in addition to our development disability services back in 1982. So we do provide some behavior outpatient services, as well as supported living house services with drop in support for individuals with serious mental illness. We continue to have a children's program and provide therapy both onsite and interim in families' homes and have a full extensive at home support program for youngsters who need help and whose parents want help in supporting their children at home. We also provide crisis intervention. By large our most expensive program is our housing program. Over half of our operation budget is for housing and we do have housing right here in St. Charles. In addition we have home based therapy for young adults. Those families want to keep them at home. Graduates form our job training placement in addition to the shelter work programs are being given jobs at Jewel and Walgreens. Services to St. Charles residents last year cost AID just under \$1.5M. Of the 101 individuals we serve we have 10 individuals who had no funding and they are supported by the funds of your 708 Board and for that I know their families are very grateful. The sad fact that even though we have over 100 people that we are serving, the waiting list is pretty substantial. As of yesterday there are 125 St. Charles families waiting for service. The needs are great and St. Charles has been terrific in your support and very much appreciate everything you do.

Ald. Bessner: How long are these folks or individual families waiting?

Lynn: The average wait time is about 10 years. The way people get approved for funding is through a lottery system. The last lottery draw was about a month ago and of the 15 names drawn, two had already passed away. Situations are very dire and St. Charles has stepped up and has gotten 10 people off of the waiting through your funding.

Chrmn. Turner: It's good that you are getting people out in jobs. I have seen several of them. Good work.

Ecker Center for Mental Health – Karen Beyer, Executive Director: Ecker Center has been serving this area for 58 years and we provide a number of services for people with mental illnesses. We have a psychiatric emergency program that is available 24/7 for people of all ages. It's located at Sherman Hospital. For adults we have a Crisis Residential Program that helps

people to avoid hospitalization if at all possible. We have psychiatry and nursing services, case management, traditional talk therapy, rehabilitation services and a number of residential options, 24-hour supervise residences, and residences that are only supervised during the day. Our specialty is working with people with severe mental illnesses who tend to need medication and tend to have an illness for the most part life-long. It usually develops in adolescence or early adulthood.

During this last year we've served 279 St. Charles residences which is 22% more than we have served in the previous year. We also provided 2,529 hours of service which was a big increase (50%) over the previous year. In this last year we have done a number of things. We've partnered with the VNA Healthcare to provide primary healthcare at our facility in Elgin for our clients and have partnered with a private pharmacy at our location in Elgin to provide pharmacy services for the people who come to us. We have continued to partner with Lazarus House and we do have an office here in St. Charles which we share with the Renz Center. Once again thank you for the support you have given us over the years.

Chrmn. Turner: So we are seeing an increase in demand for your services now in St. Charles?

Karen: Yes there is an increase.

Fox Valley Volunteer Hospice, Greg Weider, Executive Director: Thank you for your past support. We are grateful for your partnership as we strive to provide the best compassionate services to those that are dealing with a death lost and life threatening illnesses. For more than 32 years we have provided services to individuals and families. We work to alleviate the suffering and isolation associated with dying and grieving. We served more than 19,000 individuals since 1981 and all those services we provide are free of charge to those in the community. The funds we receive from the City of St. Charles are used to support our Hospice programs, our youth and adults bereavement programs, and many others all of which were spelled out in our application. Last year Fox Valley Volunteer Hospice served 201 clients from St. Charles, providing 2,756 days of hospice care and 1,845 direct service hours of bereavement care. Additional services we provide to the community are free equipment loans, community learning library, community education and continuous education in-services, and volunteer training programs. Fox Valley Volunteer Hospice receives no Federal or State funding. Medicaid or insurance payments. We are able to provide our important services to the community due to the generous support of individuals, businesses, foundations, and entities like the City of St. Charles 708 Mental Health Board.

Lazarus House, Liz Eakins, Executive Director: As the other partnering agencies has all said we couldn't be more grateful than we are to the City of St. Charles and this extends more than just the 708 funding we receive. Every time we have an opportunity to tell our story we are always telling people what a great privilege it is to be located in the heart of downtown St. Charles where we know we have the support and admiration of our entire community; and that is exhibited through our relationships with City Council, the Fire and Police Departments and the list goes on and on.

Told a story of a family with a myriad of needs that the City of St. Charles has impacted with the City's funding. Had she not come through the doors of Lazarus House she would not of known what kinds of help and support she was able to received. There is no greater pride and privilege than Lazarus House watching this evolution that occurs over time and that would not happen without the support and funding that the City provides us.

Chrmn. Turner: You do a great job in the City and do a lot of your education teaching after school also.

Renz Addiction Counseling Center, Jerry Skogma, Executive Director: Renz Center, like AID, has been celebrating 52 years of service incorporated in 1961 and we've had an office in St. Charles for 33 years. We provide to the city residents individual and group family counseling, outpatient program and intensive outpatient programing which is programing for up to 12 hours a week for those that are severely addicted. To give you a snapshot of the type of people who come to us from the City, we saw 177 residents, 126 males, 51 females, 75 of those were seen for primarily alcohol abuse, 47 for marijuana abuse, 17 each for heroin and cocaine use, and various other categories. As far as age we are seeing an older population. Forty-six of the 177 were over age 50, 97 between 21-49, and 34 under the age of 20. 90% of the people we see have family incomes under \$21,000, so the support from the City is really very critical for us.

TriCity Family Services, Jim Otepka, Director: I too, like my colleagues, want to thank the City Council for its sustaining support of services and want to commend the Mental Health Board for their efforts. They are wonderful stewards of the mental health tax dollars that they distribute. We were founded in 1967. TriCity Family Services is known by most as a counseling agency that provides a range of family centered psychotherapy counseling services to individuals on a sliding scale fee base to residents of the TriCities and four townships to our west and south. Annually over 3,000 individuals are served across our programs, more than a third who are residents of St. Charles. Counseling and psychotherapy, case management, consultation, client advocacy, and social work that supports much of our clinical work continues to be the cornerstone of the agency accounting about 2/3 of our service delivery. We deal with all ages and work with issues that span the family life cycle from post pardon depression, anxiety, marital conflict, a wide range of child/adolescent focused issues such as acting out behaviors in school and community, and more to problems related to aging and loss within the family, to challenges of grandparents raising grandchildren. Approximately 80% seek help with three or more presenting issues and many of our families have been affected with issues of substance abuse and domestic violence. We provide a range of support counseling and prevention programs, early intervention, and youth crisis intervention services to residents of the TriCity area and surrounding communities.

For our last full fiscal year June 30, 2012, we served 1,359 St. Charles residents which compare to 907 served the previous year. We were very active in the community and with the schools doing health fairs which is one factor. The growth factor is still spreading into this year. At the midpoint of the year (12/31) we show a 41% increase for residents of St. Charles all across our programs as the same time last year. We are seeing a 77% increase in our counseling program and we attribute that from school referrals. This is good, strong support from the school district.

Counseling is the cornerstone of our work and many other counseling services are integrated together. We don't bill for these services and we couldn't provide them if not for organizations like yours. Many are still dealing with residual affections of the recession. Last year 49% of the families reported of living on less the \$30K a year which is tough to do in the tri-city area. We see the continuing effect of the depression with increasing numbers of Medicaid eligible families that are coming to us for services. Reimbursements from the State fall 6-12 months behind.

As we look ahead into 2014 we are excited about further developing a new initiative. It is a family based outpatient program for the treatment of eating disorders. It is the first of its kind in this area, in fact the only program like it exists in Chicago. Untreated eating disorders have the highest mortality rate among all major mental illnesses.

As always our highest priority remains in finding ways to address our waiting lists. At times they exist 6 to 8 weeks which is too long for making that initial call. In order for us to continue on our mission in the future we will need the continue support of grand base funders like our mental health boards to assist those that may have given up hope of being able to attain mental health services. We also need your help in changing attitudes and misconceptions of mental health in helping our community to embrace the belief of ensuring that our fellow citizens have good affordable mental health care which is not only the humane and moral thing to do but given the very real cost of not providing that care it makes great economic sense to do so.

Chrmn. Turner: It is very pleasing that a lot of your groups work together, share and recommend your services to each other. It just multiplies the money we do give you.

b. Recommendation to approve funding allocation schedule of the Visitors Cultural Commission for FY13/14 and the related funding agreements.

Ald. Stellato: Two of the groups listed on here, the company that employs me does donate some portion of their space so I will be abstaining from voting on this.

Chris Minick: Annually a portion of the hotel/motel tax revenue stream is set aside for the promotion of arts and culture within the City of St. Charles. The Cultural Commission recommends allocation of this funding on an annual basis. The Cultural Commission goes through a process where they receive applications from groups who would like to receive funding to help promote arts and culture within the City. They have presentations from these groups at their meetings and then they recommend an allocation of funding to the City Council. Enclosed in your packets is the proposed allocation for FY13/14 in \$89,400. This is a consistent level of the same amount that was allocated and expended FY12/13. This amount is budgeted. Some of the highlights of this year funding is that the Heritage Center was removed from the

Cultural Commission allocation and are being funded separately through a motion and agreement that was approved at the Council meeting earlier tonight. The Norris Center for Cultural Arts did not apply for funding this year, and the Cultural Commission received two new allocations for funding: one from Water Street Studios and the other from St. Charles Arts Council. Dr. Anne Becker is here to make a brief presentation along with Jim Kirkoff from Water Street Studios. We will be seeking a recommendation at the conclusion of this presentation for approval of the funding allocation for FY13/14 in the amount of \$89,400.

Dr. Anne Becker, Chairperson of Cultural Commission: Thank you so much for continuing to support the arts in St. Charles, that adds to all the well-being of our community. Thank you for your commitment to the Heritage Center. This museum has provided a lot of wonderful historical information for our students and the community and thanks to Chris for serving on our committee. He has a grounded sense of finance that guides us and we do appreciate him. Tonight I am introducing Jim Kirkoff who will talk about an art venue that will be taking place in St. Charles called the Print Lab.

Jim Kirkoff, Co-founder of Water Street Studios and Board President, 117 W Main Street:

You are being handed examples of some of the work that is going to be done at the Print Lab facility. When you hear print some think of a Kinko's or some commercial printing center, but what we've done through our projects is received a great deal of funding for different types of equipment to produce fine art prints that are etchings. We are making this facility available to members at a very low cost so that they can use professional equipment, do fine art printing, and we also have space there to set up classes. Right now we are just getting off the ground with this facility. We currently have eight members who come from DeKalb, Batavia, Naperville, and North Aurora and right now students come from Carol Stream and St. Charles for Relief Print classes and Linoleum Print classes. We are also going to be using this facility for special events. Every Sunday we'll be doing a free family art activity called "Awesome Art Afternoon" between 1:00 – 3:00 p.m. which will be a variety of different types of artistic media not just print making. During Riverfest we made many different types of prints for handouts. On November 18 we are working with the Wayne Art League to put on some demonstrations and bring some of their members in to look at this type of technology. Another big thing we want to do with this program is to use the center as a way to draw people downtown, not just through the arts but also in collaborative efforts. Part of our outreach art flow is working monthly at Lazarus House doing art activities with some of the residents. We are working to put on a program this year with TriCity Family Services doing ceramics and welding programs for students at the Water Street location in Batavia. We are also looking forward in working with the other art groups in this community to come up with programming that we can work on together and better increase the visibility of St. Charles in this region as an artistic center.

Chrmn. Turner: I am very pleased to see that you are here and Anne I think it's great to bring on two new cultural additions to the City. The St. Charles Arts Council has been around for a few years and they are eligible for funding but I am also very pleased that you increased the funding for the other groups as well.

Motion by Ald. Bancroft, second by Krieger to recommend approval of the funding allocation schedule of the Visitors Cultural Commission for FY13/14 and the related funding agreements.

4.a Presentation to provide Update on IL Route 64 Projects – Information only.

James Bernahl presented. Regarding the west contract; crews continue to work on the installation of retaining wall 2 and retaining wall 3. Retaining wall 2 is near Cedar Avenue and retaining wall 3 is near Hunt Club Drive; this work is expected to be completed in very quick fashion. Crews are continuing to close up the remaining storm sewer work, specifically to North 8th Avenue. There is a section of the culvert that needs repair and that should be completed by the end of this week, and that will allow the contractor to close up the last section between 7th and 8th Avenue.

The contractor is also working on the last piece of water main across from 1615 and 1715 East Main Street on the north side; there is a section that as the road was widened, additional installation of water main was required. That will be the last piece of City utility work that the contractor will be working on.

Crews have started placement of asphalt material near the intersection of Dunham Road heading east. The base will continue to be put down and the roadway will be ground from 11th Avenue east.

Regarding the east job, crews are finishing the middle section by the entrance to Pheasant Run. That work is expected to be completed in the next week and a half. Crews will then move west to the intersection of Smith / Kautz and will keep east/west traffic moving as best they can. The contractor has also primarily completed the bridge at Powis Road. The only items missing are the approach slabs on the east and west side. The contractor is working on that now; once complete that will allow the intersection of Powis Road to be opened to the general public.

You may have noticed a lot of concrete has been put down; the batch plant has been working overtime and they are installing the asphalt sub-base of those roads and placing concrete main line, which will get traffic back to four lanes shortly.

Regarding the construction schedule; the west project, which is primarily from 7th Avenue heading east to Kirk Road is going to be completed by August 30. This will exclude minor restoration and ancillary work; things that may require daily lane closures, but the roads will be opened back up at night. The schedule is based on the State of Illinois Standards for installing grass and vegetation. The east project has a substantial completion date of October 1. The ancillary work won't be as critical on that section because we will be past the IDOT Vegetation Restoration deadline.

Aldr. Turner: Where does the asphalt start and where does the concrete start between 7th Avenue and Kirk Road?

Mr. Bernahl: It goes up to just west of Cedar; that's where it terminates and becomes asphalt from that point east until Kautz/Smith and then it's all concrete.

Aldr. Silkaitis: They are doing asphalt and putting concrete on top, correct? Did they do that when they did Main Street downtown? Is this something new?

Mr. Bernahl: Yes, this is something new the State is doing; it's called a 30 Year Life Design. Most of the roads you see now are based on a 20 year useful life. IDOT did testing and determined if asphalt is used as a sub-base and then build the concrete road on top of it, the roadway will last much longer; you will get an extra 10 years.

Aldr. Stellato: Jim, I know this isn't in our community, but we had an event last week and some Chamber Businesses asked about the Rt. 38 / Kautz Road intersection construction. Do you know anything about when that might end?

Mr. Bernahl: I do not. The City of St. Charles has not been invited to the weekly meetings.

No further discussion.

4.b. Recommendation to Prepare an Ordinance approving street name change for Charter One Avenue.

Mark Koenen presented. This is a request from US Bank to change the street name of Charter One Avenue to King Edward Avenue. US Bank is the new tenant of the former Charter One building; they obviously didn't like the marketing that brought to their building and they asked if we would consider a street name change. This is not something we have done frequently in St. Charles, but there are no tenants which have addressing on Charter One Avenue, so it seems like a convenient time to make the name change. Also, from a motorists' perspective, it would be nice to have a continuous roadway name between Smith Road and the residential area to the north.

Staff recommends directing staff to prepare an Ordinance.

No further discussion.

Motioned by Aldr. Lemke, seconded by Aldr. Turner. Approved unanimously by voice vote. **Motion carried**

4.c. Recommendation to approve Design Engineering Services for the IL Rt. 25 Watermain Replacement Extension.

James Bernahl presented. Staff is requesting professional design services for the replacement of the existing water main on North Avenue from North Avenue all the way to Q Center. Staff requested nine proposals; we received eight back. Staff has reviewed the proposals as part of an RFQ/RFP process. Of the eight proposals received, Trotter & Associates provided the best overall scope for the project and understanding of the principals. Based on that, Trotter provided a design price of \$93,876. This is within the

budgeted amount; staff recommends approving a contract with Trotter & Associates for an amount not to exceed \$93,876.

Aldr. Krieger: When will the actual construction take place, and how much of the roadway will it affect?

Mr. Bernahl: The construction is anticipated to begin in April/May, 2014. The design will determine how much construction activity might interfere with traffic on North 5th Street. Our goal is to not close the road at all by working in the parkway areas. However, once we get into the design we can see what obstacles we are facing that might prevent that.

They have been particularly helpful in processing Red Gate Bridge requests as well as IL Rt. 64 requests. The extension of this contract would take us through the end of the fiscal year, which should get us through the bulk of the billing period for the Red Gate Bridge and IL Rt. 64 projects.

Staff recommends approval.

4.e. Recommendation to approve a budget addition for electric utility work related to the McDonalds Rebuild at 1915 West Main Street.

Thomas Bruhl presented. As part of the work for the McDonalds rebuild at 1915 West Main Street, we are going to have to do work on their behalf as they move the restaurant to the west. We do not budget new business projects, we wait until we get a new building permit. At that point, we can estimate the job, know exactly what it's going to cost and come to you for a budget addition.

100% of the funds for the budget addition would be offset when the customer pays the building permit. Although this project has been deferred to spring, in March they want to have the building permit ready to go.

Staff recommends approval of a budget addition to the electric utility for the McDonalds rebuild in the amount of \$25,000.

4.g. Recommendation to approve Contractual Services for Storm Sewer Catch Basin Cleaning Services.

Peter Suhr presented. City staff solicited vendors to assist with storm sewer catch basin cleaning. An RFP was issued to five separate contractors at that time. This is the third year of a four year commitment of preventative maintenance cleaning of our storm sewer structures in the central core of our City. Last year we focused on the east quadrants, this year we begin on the west. United Septic was the most cost competitive and are the most qualified per the RFP. The contract will not exceed the \$65,000 that has been budgeted.

Staff recommends approval of the contractual services for storm sewer catch basin cleaning.

Aldr. Lemke: Do you have an engineers' estimate of where you thought this might come in at?

Mr. Suhr: It is not in your packet, but yes, we do prepare an estimate. Again, it was prepared two years ago and it did come in within budget at the time.

No further discussion.

4.h. Recommendation to approve Contractual Services for Stormwater Televising and Cleaning Services.

Peter Suhr presented. City staff also solicited vendors to assist with storm water televising and cleaning services. A request for proposal for these services was issued to six separate contractors. This is the third year of a four year commitment to investigating storm water mains in the central core of our city. These services provide us detailed televised information of each Stormwater main which will be used by staff to analyze and prioritize repairs and capital projects in the future.

Visu-Sewer of Illinois was awarded the original contract. The contract will not exceed the \$65,000 budgeted amount.

Staff recommends approving contractual services for Stormwater televising and cleaning.

No further discussion.

4.i. Recommendation to approve Asphalt Parking Lot Construction Project.

Peter Suhr presented. The Public Services Division is recommending asphalt binding, resurfacing and striping to the City parking lot that is leased from the Baker Methodist Church which is located on the corner of Main Street and North Third Avenue. Plote Construction was awarded the 2013 Street Rehabilitation Project this year. They completed this work and honored their competitive pricing. As noted in your packet, this work was already completed. Unfortunately last week, without Council authorization, we had a process error within our department, and we apologize for that mistake.

I want to reassure you this project was in our original budget and is scheduled to be completed this summer. The total project cost of \$35,690 was under that budgeted amount.

Staff recommends approval of the asphalt parking lot construction project.

Aldr. Krieger: I would like to say this looks very nice and was well worth the money.

4.j. Recommendation to waive the formal bid process and approve purchase of a Trailer Pump from Xylem/Godwin for the Sanitary Sewer Division.

John Lamb presented. This is a recommendation to waive the formal bid process and approve the purchase of a trailer pump for the Sanitary Sewer Division. We currently have six of these pumps that are used in emergency and maintenance situations. Staff contacted three vendors and received two quotes.

Staff recommends waiving the formal bid process since we requested proposals and approve purchase to the lowest bidder, Xylem/Godwin for a trailer pump.

Aldr. Silkaitis: What happens to the old pumps? Do we sell them on the City auction site?

Mr. Lamb: We are standardizing the pumps, so we will salvage whatever parts we can for future use.

John Lamb presented. We have seven items for a Change Order in the amount of \$21,726. This amount will be taken out of our project contingency fund and will be included in our low interest loan for that project.

Staff recommends approval of Change Order No. 4.

No further discussion.

Motioned by Aldr. Stellato, seconded by Aldr. Silkaitis. Approved unanimously by voice vote. **Motion carried.**

4.l. Recommendation to approve Refuse Ordinance Authorizing Amendment of Title 8 "Health and Safety" Chapter 8.24, "Garbage and Refuse", Section 8.24.040 "Charges and Bills" of the St. Charles Municipal Code.

John Lamb presented. Council approved the Solid Waste Disposal Contract in July. This language needs to be incorporated into the Ordinance under Title 8. We have listed the three items that need to be changed with the new contract.

Staff recommends approval of the Refuse Ordinance and authorizing amendment of Title 8, "Health and Safety".

Aldr. Silkaitis: Can you explain, under the single family rates, it says a 65 gallon recycling toter is no charge, and an optional 65 gallon recycling toter is \$1.20 per month?

Mr. Lamb: Correct; residents will receive one free toter, but if they want an additional toter, it's \$1.20 per month.

Chairman Martin: Kristi, please call a roll.

4.m. Recommendation to approve Renewal of Land Lease and Biosolids Application Agreement.

John Lamb presented. Our treatment plant generates about 4,000 cubic yards of Biosolids annually, which is then applied on 40 acres, as well as on land across the road from the Westside Treatment Plant. This land lease is with Bill and Roger Mangers, and we've had it for a number of years.

Staff recommends waiving the formal bid process and renewal of this agreement with Bill and Roger Mangers.

No further discussion.

Motioned by Aldr. Turner, seconded by Aldr. Stellato. Approved unanimously by voice vote. **Motion carried.**

4.n. Recommendation to approve VFW Parking Lot Construction Agreement.

Mark Koenen and James Bernahl presented. I'm here tonight to share information about where we are with the VFW Parking Lot project in terms of budget and schedule.

On the screen in front of us tonight is a picture of the project as it was originally designed; we will refer to this as Exhibit A. This plan was put together to be consistent with the Zoning Code as we have in place today. The budget for this entire project was \$200,000. We went out to receive quotations to build this parking lot and we came in about \$50,000 above that budgeted value. That budgeted value was to include demolition, construction of the lot and also any environmental remediation. Between demolition and environmental remediation, we spent about \$80,000, leaving \$120,000 in the budget. The bid that came in for building Exhibit A was \$170,000, which is over budget by approximately \$50,000.

We went back to the drawing board to see how we could redesign this project to get closer to the \$200,000 budget. Please look at Exhibit B in your packet. Plan B has a scope where we are leaving the existing lot on the south and grinding and resurfacing it. Everything else remains the same. The lot to the north, where the building was, is a new parking facility that meets the 2013 Zoning requirements. If we were to build the project this way, we would be approximately \$26,000 over budget.

The difference between the original budget and reality is that the demolition of the building was budgeted at \$25,000, but the actual cost was \$75,000. The primary difference between these two designs is there is a broader green space along the west side of the new lot in Exhibit B, which is necessary to satisfy the existing Zoning and Code requirements. If you were driving through the lot you would see a "kink" in the aisle as you drive through the lot, but it is not going to be a safety hazard. You have great sight visibility; the lot will be lit in the evening hours, so there shouldn't be any safety issues. But there will be approximately a four foot disconnect with the offset, and it will be the same case on the other side of the lot.

We have three options; 1) build Exhibit A and amend the budget by approximately \$50,000 2) build Exhibit B and amend the budget by approximately \$26,000 c) go back to the drawing board and see if we can cut the project back any further and/or delay the project and rebudget for it in Fiscal Year 14/15. As you may recall, this was being paid for by the Red Gate Bridge levy where we have money. I have spoken with the Finance Department and verified that we do have sufficient funds to cover the additional \$25,000

to \$50,000. If we chose to move ahead, we can have this project constructed in time for Scarecrow Festival.

If we chose to delay the project; we will still have the parking on the south for Scarecrow Festival, just as we have every year, but now it will be a City owned facility as opposed to a VFW owned facility. American Demolition Company is in the process of demolishing the VFW building and will be completed by July 26. It would then be backfilled and safe as an open area for the time being until we complete it in the future.

Aldr. Bessner: If we chose Option B, will the life of the south lot mirror the life of the north lot?

Mr. Koenen: We will have to do additional maintenance on the south lot, but I don't think it will be a financial burden we should be afraid of. We do have a Street Department in Public Works and they can fill pot holes and make curb repairs.

Aldr. Bessner: I'm just trying to figure out if we should spend all the money now or utilize Option B if it's going to save us money?

Mr. Koenen: We have always called this a temporary parking facility. There is a larger plan ten years down the road where this parking lot will change to a different configuration.

Aldr. Stellato: We are also talking about image. Having the green strip on the west side continue all the way to Cedar has a positive impact on the entire neighborhood and I would prefer to see the green strip. I also think the ten year plan for the deck or anything else that might happen in that area someday is more like 20 years, just based on market conditions. I would like to go with a permanent fix; do it right the first time and be done with it.

Chairman Martin: I concur; do it once and do it right.

Aldr. Silkaitis: As much as I hate to spend the money, I want to do it right the first time. I know you are going to grind and overlay the south lot, but it's going to shift and it's not going to look good. I agree with Dan; 10 years is pretty optimistic. I would rather do it right the first time. It's worth the money to keep the image and make it functional for a long time. I vote for Option A.

Aldr. Krieger: I want to put my support behind Option A. I think it would be better to do it and have it look nice because I agree, 10 years is pretty optimistic. I would rather have it all look the same and have the green space and bushes match so the neighborhood feels we are doing them a service.

Ron Johnson: I'm Ron Johnson, I live at 316 West Cedar Street. Are they going to keep the landscaping on the west side of the parking lot?

Mr. Bernahl: Yes, with Option A, there is a nine foot green space with trees and the existing retaining wall is going to stay. We will enhance the green space to meet City Code, and we will also enhance the landscaping along North Third Street.

Mr. Johnson: How many extra parking spaces are we going to get there?

Mr. Bernahl: I don't have that information with me.

Mr. Johnson: Are they are going to redo the lighting?

Mr. Bernahl: Yes.

Tom Anderson: Tom Anderson, 712 Horne Street. I had the privilege of being the owner across Third Street since 1917. We have seen a lot of changes. The biggest concern about the existing parking lot to the south is the lack of landscaping on Third and on Cedar. You are showing landscaping on Option A, but on Option B, you wouldn't be changing any landscaping. I think we are missing a crucial point of improving downtown by not having landscaped parking lots.

I will agree this is probably short term, but we have been hearing about multi-deck lots for a long time. Until the City finishes First Street and a few other things, this is going to be a long way off. I would like to have some landscaping that I can see screen the cars in my life time.

Aldr. Stellato: I make a motion to go with Option A.

Chairman Martin: Kristi, please call a roll.

5.a. Recommendation to approve IDOT Resolutions for the Closure of 2nd St. (Route 31) at Illinois Street for Two High School Homecoming Parades.

Chief Lamkin presented. Staff is asking for approval of an IDOT Resolutions for each High School Homecoming Parade, both on different dates. During the special events process, we met with both of the schools. In the past we held the parades on Illinois. North High School indicated they were okay with it on Illinois. East High School indicated they would be happy with either Main Street or Illinois; but preferred Main Street. We talked about the construction schedule and we know there will be some sections of Main Street complete, but there are still going to be back-ups.

Also, to move the parades back on to Main Street on a Friday afternoon would incur several hundred dollars in Police overtime, but the larger problem is that the long semis have trouble navigating the detour route onto Illinois. Having the parades on Main Street is something that we can revisit next year, but for this year we are recommending to keep the Homecoming Parades on Illinois.

No further discussion.

Motioned by Aldr. Turner, seconded by Aldr. Bancroft. Approved unanimously by voice vote. **Motion carried.**

5.b. Recommendation to approve Street and Parking Lot Closures and Amplification for the 2013 Scarecrow Festival.

Chief Lamkin presented. We had a Special Events meeting and went through the original request that was made by the Convention and Visitors Bureau. They have a different coordinator this year, Ravenswood Event Services; and they were present at the meeting. Everything listed in the Executive Summary is similar to last year. They have requested to use the VFW lot so we have left that open in terms of the construction schedule that was discussed tonight.

The other area we had significant discussion about is the closure of Cedar. It was requested to close Cedar and we advised that we didn't want a complete closure there. We have to keep a fire lane open and we have made that very clear. We have recommended a soft closure, meaning North Third and Cedar would be closed during the day, but late at night we would allow opening for access to cars. We are aware of the concern from Mr. Johnson of Johnson's Statuary and we share his concern. He does a significant amount of business as he has a driveway on Cedar. Last year, with the use of barricades, we allowed vehicles to access off of Fourth Street so cars were able to get to his driveway to make pick-ups. That is included in the plan again this year. Amy Egolf is here tonight in the event you have any questions.

Ron Johnson: I own the property on Cedar Street. It's my residence, plus the home of Johnson's Statuary. April started our 40th year there. There was only one time they closed that street about three or four years ago and it just about put me out of business for that weekend. If they can't leave the street open all the way, I feel you should close it all the way because it's too dangerous for people coming off Fourth Street to come as far as my business and have to back all the way up.

All of the people who own property downtown pay thousands of dollars every year on our tax bill for the parking lots. The parking lots were made for customers, not for private individuals to use them. I think if any money is made off the parking lots, it should go toward SSA1 for parking, not to the individual group or organization. When they first created SSA1, they didn't say they were going to close the parking lot they said it was parking for customers. We've been paying that for 30 years on our tax bills every year.

Aldr. Martin: Chief, do you have an answer?

Chief Lamkin: I'm not able to answer the tax question; that is not something I would normally be involved with. Our concern regarding the street closure is that with the volume of pedestrian traffic that we get during the festival, mixing cars with pedestrians is not a good mix for us.

Mr. Johnson: This festival has been going on for 30 years and we have never had an ambulance on the street during the festival.

Chief Lamkin: I can't answer for what we've had previously, but I have to plan for what could happen so we have to have the appropriate contingencies in place in the event someone does need to get through. We require that there is at least a 12 foot lane in the event there needs to be accessibility for emergency vehicles. In other words, they cannot position something there that can't be moved, because they have to be able to get emergency vehicles through there. That is a requirement we have always had in place.

Aldr. Payleitner: Chief, who is on the Special Events Committee?

Chief Lamkin: Representatives from Code Enforcement, which is where the application starts. We generally have someone from Public Works, Electric, Fire and Finance.

Aldr. Payleitner: I ask because previously when we have had closures of streets and parking lots, it was required that they contact the businesses in the area.

Chief Lamkin: We do require that; I can let Amy speak to that.

Amy Egolf: Amy Egolf, 311 North Second Street. We have reached out to the business owners in the area. There are two that I have not yet contacted, those being Isacco's and Mr. Simpson from Alibi, but we have contacted all the other businesses in the area.

Aldr. Payleitner: So you have heard Mr. Johnson's issues already.

Ms. Egolf: Yes, I talked to him about five weeks ago and he expressed the same concerns that he has expressed this evening. Our position, if you will, is that the closing we are suggesting is the same closing we did last year. We understand and appreciate the whole reason we have the festival is to call attention to the businesses in town and so that contradicts, if you will, the fact that we are bringing a festival in and can hurt a business certainly goes against what our goal is, but at the same time, it's a lot of people. Two years ago we have three days of pristine weather and we had between 150,000 and 180,000 people.

Aldr. Lemke: I would only ask if there is an ability to have an 11 foot lane for emergency vehicles, can that be used for a truck delivery as suggested by Mr. Johnson?

Mr. Johnson: They are going to do the same closing as last year; last year the street wasn't closed. It was open.

No further discussion.

Motioned by Aldr. Stellato, seconded by Aldr. Bancroft. Approved unanimously by voice vote. **Motion carried.**

3. MAYOR'S OFFICE

a. Recommendation to approve a Class B2 Liquor License for Puebla Modern Mexican, LLC, 51 S. 1st Street, St. Charles (former Wild Monk).

Mayor Rogina said Mr. Tony Alfonso, who also owns Pizzeria Neo located at 31 S. 1st Street, has submitted all paperwork including liquor license, background check, site plan and a menu. He said this is a cornerstone business to the plaza and to the 1st St. development and he highly recommends approval for the license. He noted that Mr. Alfonso was there to answer any questions.

Aldr. Lewis asked for the hours. Mayor Rogina said Monday-closed, Tues-Thurs.-Noon till 10pm, and Friday, Saturday and Sunday-Noon till 11pm, and in looking at the B2 license, it is predominantly food with a holding bar.

Aldr. Turner made a motion to approve a Class B2 Liquor License for Puebla Modern Mexican, LLC, 51 S. 1st Street, St. Charles (former Wild Monk). Motion was seconded.

4. ECONOMIC DEVELOPMENT

a. Recommendation to approve a Resolution authorizing the Mayor and City Clerk to execute amendment to an Economic Development Incentive Agreement between City of St. Charles and St. Charles Chrysler Dodge Jeep, Inc. (1611 East Main St.).

Mr. Aiston said in August 2012 the Council approved a Sales Tax Reimbursement Agreement between the City and St. Charles Chrysler Dodge Jeep. He said the agreement was for the property owner to make certain improvements to the existing dealership, and to also purchase property across the street at Tyler lots 1 and 2, which has been accomplished. He said the agreement committed through an exhibit was that the dealership expansion allow for fleet sales to be placed on lot 1, but since the agreement, the owner has determined that he would rather it be on lot 2, because it's a less viable commercial property in terms of exposure, and he wants to retain lot 1 for a better use such as commercial or office. He said staff feels the change is preferable with respect to the impact on the local economy and it still accomplishes the objective of the reimbursement. He said plans have been submitted and are under review and if Council approves the exhibit amendment the dealership would be responsible to construct the lot according to approval of plans.

Chairman Stellato clarified that nothing would change for lot A and B and it's just simply switching lot 1 and 2. Mr. Aiston said correct, the ownership stays the same, it's just the use for lot 1 and 2 that is switching.

Aldr. Payleitner made a motion to approve a Resolution authorizing the Mayor and City Clerk to execute amendment to an Economic Development Incentive Agreement between City of St. Charles and St. Charles Chrysler Dodge Jeep, Inc. (1611 East Main St.). Motion was seconded. No additional discussion. Approved unanimously by voice vote. Motion carried.

b. Recommendation to create a "Knowledge Based Employment Incentive Pilot Program" and utilizing such pilot program to secure The Clarke Group's Headquarters and Research and Development facilities.

Mr. Aiston said staff has designed a new program designed with The Clarke Environmental Group to incentivize the company to locate in St. Charles for an expansion and consolidation of their use. He said they are currently located in Schaumburg and Roselle and Dr. Lyle Clarke, who is the Chairman and CEO of the Company, was there to show a presentation.

Dr. Lyle Clark stated he was a resident of St. Charles for 28 years but currently resides in Princeton, IL. He said he has controlled mosquitos for St. Charles for a number of years and today Clarke is a global environmental product and service company who specializes in mosquito control and the management of aquatic habitat. He said their mission is to help communities around the world become more livable, safe and comfortable, and their products and services reach about 300 million people in 40 countries, but their vision is to reach 660 million people with their products and services.

Dr. Clarke gave a brief history of the private and family operated company whose future is driven by 3 passions: innovation, community and sustainability. He said they have created a new innovative product created for mosquito control from 1-150 days which is all organic, is OMRI certified, and won the Presidential Green Chemistry Challenge Award in 2010. He said their 2014 goal is to have 20% of their energy coming from renewable resources, reduce their carbon footprint by 25%, reduce their waste stream by 50% and give back to the communities they live and work in. He said in regard to aquatic services they have developed a precision application technology where it pinpoints where the weeds are and reduces the amount of herbicide by over 50%. He said he believes there is quite a bit of expansion internationally and they currently have distribution companies and offices in Mexico, Australia, Brazil and their next venture is for the public health market. He said the company's management team has won many awards but they are very proud that last year they received a \$3 million grant from the Bill and Melinda Gates Foundation to create a new control strategy for Malaria in Africa and all other places it's found, and also in 2012 they won the Illinois Governor Sustainability Award.

Dr. Clarke said the property they are looking at is 675 Sidwell Ct. and they are using a local architect and they want the building to reflect their culture, which will have a corporate office, extensive R&D, a knowledge center and an extremely green facility shooting for LEED certification. He said the outside will also reflect the culture with onsite renewable energy production and the use of ecological restoration for rain gardens and native plant species with a lot of outdoor gathering and meeting spaces and will be very attractive to the community.

Dr. Clarke explained the many benefits for the city for attracting a knowledge-based employer, including: creating 10-15 new jobs favoring residents by putting them on the city's website; a building project will be financed locally by using local contractors; and recruiting at East and North High Schools for summer jobs/science internships. He said it's a knowledge-based company with an average wage of \$80,000, with a healthy benefits program. He said the business will also bring in tourism due to vendors, suppliers, customers and visitors from all over the world and it will become an educational resource for students and a catalyst to attract other knowledge based companies to the city.

Mr. Aiston showed a PowerPoint presentation explaining the proposed knowledge-based employment incentive program. He said the purpose is to incentivize The Clarke Group to select St. Charles over Ames, Iowa, and the funding authority under Illinois law is that the city may appropriate and expend funds for economic development purposes including incentive grants directly to private business enterprises. He said the reason for creating the program would be to create opportunities for new employment, develop the local economy and provide incentives for business enterprises to locate in the city. He said according to an economic impact study done by NIU, the value of Clarke business activities to the area economy for existing operations is

\$28.1 million and the planned expansion would be \$7.7 million in economic activity. He said Clarke's capital cost to acquire and occupy the facility would be \$4 million, which would include a building renovation of \$600,000, and would be an economic impact of \$4 million over a 2-year project. He said the targeted business and employment types would be environmental research and development laboratories or services for management, professional, administrative and technical positions. He said for employment at occupancy, the direct would be 71 jobs at \$6.14 million, and indirect would be 84 jobs at \$4.1 million, and after 2-years, would be direct at 15 additional jobs at \$0.9 million and indirect at 16 additional jobs at \$0.8 million.

Mr. Aiston said Staff recommends providing employment incentive grant funds directly to Clarke for each employee (both existing, relocated employees, and new hires at proposed St. Charles facility) with a minimum annual salary of \$50,000, with additional grant funds available for new intern hires. He said additional bonus payouts are included for each such employee and intern that resides in or near the City of St. Charles. He said the maximum amount the City will pay the company in a given year is as follows: Year 1: \$80,000; Year 2: \$65,000; Year 3: \$50,000; Year 4: \$50,000; and Year 5: \$50,000. Further, the maximum amount the City will pay to Clarke over five years shall be \$275,000.

Chairman Stellato asked for clarification regarding any payment made being made at the end of the year. Mr. Aiston said yes, they will have to prove up their employment based on the addresses of the employees.

Aldr. Martin made a motion to create a "Knowledge Based Employment Incentive Pilot Program" and utilizing such pilot program to secure The Clarke Group's Headquarters and Research and Development facilities. Motion was seconded by Aldr. Turner. No additional discussion. Approved unanimously by voice vote. Motion carried.

5. COMMUNITY DEVELOPMENT

a. Discussion regarding the establishment of a Special Service Area (SSA) to fund proposed improvements in the Oaks of St. Charles Subdivision.

Mr. Tiedt said representatives from the Oaks HOA have approached the city to establish an SSA to fund rehabilitation and improvement of privately owned streets and infrastructure. He said some of the improvement being contemplated includes installation of storm sewer and stormwater detention to alleviate existing drainage problems. He said one of the basins is in the northeast corner and two are on the interior parcel, with storm sewer scattered throughout the site. He said another item is the installation of retaining walls and landscaping to help alleviate existing erosion control issues, which are located on the east side of the property where hills are steep, as well as the north side. He said they also plan to resurface the privately owned streets throughout the subdivision, which will entail reconstruction of some portions and also narrowing to add green space and reduce impervious surface. They also intend to bring some of the primary sidewalks up to ADA compliance. He said legal counsel has advised staff that the establishment of an SSA to fund these private improvements is feasible with the granting of certain easements and city costs associated would also be covered through the SSA.

Chairman Stellato commented that the letter prepared by the association was very well done, and he asked if every time an SSA is established, if the understanding is that there has to be more

than 50% of the homeowners to agree. Mr. Tiedt said correct, and the association has submitted a signed petition from the residents within the community which identifies that there is more than 51%. Chairman Stellato asked if they understand the costs borne by them paid through their tax bills going for however long it take to pay it off. Mr. Tiedt said yes, that is his understanding, but the HOA is here if they had anything to add.

Aldr. Bessner asked what the length of the SSA is and if it could be reverted at some point. Mr. Tiedt said at a conceptual level, initially the thought would be to have the SSA cover the expenditures of the improvements, which were estimated at between \$1.2-1.4 million. He said there have been some preliminary discussions with some of the members of the HOA to keep the SSA going in perpetuity to provide funds to maintain the improvements as well.

Aldr. Bessner asked how the city would be protected from an SSA reverting back 10-15 years from now. Mr. Minick said once it's established, and if it were to go into perpetuity, he doesn't believe there is a right for an SSA to revert back to the city, so the adopting Ordinance would have to be structured that way.

Aldr. Martin said he has had the opportunity to observe the procedures that the HOA has gone through to achieve this goal and he thinks it's a win/win situation for the city and he very highly recommends it.

Aldr. Turner asked if once the roads are rebuilt, they will become city property. Mr. Tiedt said no, the intention is to keep the roads private and maintained by the association, and legal counsel has advised that an easement be retained or the HOA grant easements over those improvements that would give the public the right of access to them.

Aldr. Lewis said she commends the job done by the HOA and staff and it's a win/win situation and she feels they have really done their homework and have presented a good project.

Aldr. Lemke asked if it becomes a covenant running with the land so that future purchasers are automatically covered. Mr. Minick said a perpetual SSA would actually be recorded against the individual parcel numbers within the development, which is the mechanism by which that right to tax would stay with the property.

Charles Radovich-Geneva, IL-Attorney for the HOA-said he has had many discussions with the city attorneys regarding the process and he had a couple points of clarification. There is a statutory process to establish an SSA and the first step would be to propose the establishment and set a public hearing date, after that there is a 60-day period in which objectors may file a petition. He said that is where the 51% comes into play, if there is 51% of the property owners and 51% of the electors in the conjunctive objecting to the formation then it cannot be established. He said the association has taken the reverse tact at the suggestion of staff to show there is support and the petition has been signed by the unit owners. The concept is to have a funding mechanism to do the initial improvements and then to perpetuate the repair and maintenance on an ongoing basis through the SSA.

Chairman Stellato asked if there was a vote to be taken, or if staff was looking for any objections. Mr. Radovich said the association would love to have a direction to authorize staff

and city attorney to participate with himself to create the necessary ordinances to get to the next step. Chairman Stellato said that sounds like a motion.

Aldr. Silkaitis said since its being done backwards, is the petition a legal document. Mr. Radovich said the association has conducted several informational meetings with their members and provided information sheets to them, and what's been done in the past is assessments through the HOA, which are difficult because there is not this much of an assessment to do this type of large capital improvement.

Aldr. Bancroft said 57 of the 75 units were represented, and 52 out of 57 signed the petition, and from the association's organizational documents, will they be in the position to grant easements and property rights. Mr. Rabchuk said yes, they had a required meeting of the unit owners authorizing the board to establish the easement documents with the city and under the base declaration they have somewhat authority as well, already.

Aldr. Martin made a motion to direct staff to proceed with the SSA. Motion was seconded by Aldr. Lemke.

b. Recommendation to approve a General Amendment to Title 17 of the City Code (Zoning Ordinance) regarding residential driveways.

Mr. Colby said the General Amendment application initiated by staff was to modify the Zoning Ordinance requirements for residential driveways. He said the rules were enacted in 2006 and prior to that the city did not regulate the size of residential driveways on private property, and staff is proposing to loosen the restrictions somewhat. He said over the past few years staff, has encountered situations where homeowners are unable to replace their driveway at a similar size as to what existed when their house was originally constructed. He said it has occurred in some neighborhoods where the driveway they were proposing to replace were very common and similar to the ones constructed when the neighborhood was built. He said staff went through a process of researching existing conditions of driveways in town and is proposing 3 changes; 1) Clarify that two access points are allowed for circular driveways, each up to 18 ft. The extent of the driveway on the lot itself will continue to be regulated based on the percentage of front yard pavement coverage. This will enable existing circular driveways in larger lot residential zoning districts to be reconstructed similar to what is common today in areas such as Woods of Fox Glen, Persimmon Woods, and Royal Fox. 2) Provide that all residential properties are at least entitled to a driveway width of 18 ft. (instead of 16 ft.). This is a more reasonable width to accommodate two cars parked next to each other. 3) Increase the allowable front yard pavement coverage for three-car front loaded garages to 33% to reflect existing conditions in neighborhoods where three-car front loaded garages are common. He said Staff along with Plan Commission, recommend approval. The Plan Commission did discuss limiting where 3-car garage driveways would be allowed, but it was not included in their recommendation.

Aldr. Lemke said it's not clear to him that existing driveways are being grandfathered in, and he wants it to be clearer and state that existing driveways are grandfathered and even if they need to be ground and resurfaced, that there is no need to narrow the driveways according to going forward regulations. Mr. Colby said that is not specifically the proposal, but it could be added. Chairman Stellato asked for clarification. Aldr. Lemke suggested having a date going forward where future reconstructions would be brought under conformance.

Aldr. Krieger asked how corner houses with driveways on the side would be affected. Mr. Colby said the percentages of lot coverage that currently exist, for the front yard, is allowed to cover 25%, the side yard is still 25%, so if it's a corner site and it's longer on the side, there is more percentage and pavement to work with.

Chairman Stellato clarified the comment by Aldr. Lemke, that if someone is working on a driveway now, or before the end of 2013, would they comply with the new ordinance if it's more to their benefit, or they would be grandfathered in as of a certain date in 2014. Mr. Colby said staff would bring it to Council and clarify the date in the Ordinance.

Aldr. Lemke made a motion to approve a General Amendment to Title 17 of the City Code (Zoning Ordinance) regarding residential driveways. Motion was seconded by Aldr. Martin. No additional discussion. Approved unanimously by voice vote. Motion carried.

c. Recommendation to approve a General Amendment to Title 17 of the City Code (Zoning Ordinance) regarding amortization of nonconforming signs.

Mr. O'Rourke said back at the June P&D meeting staff presented this item as a heads up that amortization of nonconforming signs would end Oct. 16, 2013, and given that IDOT construction will be ongoing through the season, it was stated by Committee to extend the amortization period for 1-year.

Aldr. Krieger said given the fact that they will still be doing landscaping and clean-up next year, will the extension be enough time. Mr. O'Rourke said he does not know when IDOT has landscaping scheduled, but this extension will give basically the whole construction season of next year, minus maybe November, so he thinks IDOT would be wrapping up sometime around there, but he couldn't verify that. Aldr. Krieger said she was in an IDOT construction area that afternoon that was scheduled to be finished December 15th and it is still torn up, so she is not very optimistic and she wants to be sure if there is a problem the city would not be fined or penalized. Ms. Tungare said it could always be revisited.

Aldr. Silkaitis made a motion to approve a General Amendment to Title 17 of the City Code (Zoning Ordinance) regarding amortization of nonconforming signs. Motion was seconded. No additional discussion. Approved unanimously by voice vote. Motion carried.

Chairman Stellato recused himself at 7:45pm and turned the meeting over to Vice Chair Bessner.

d. Recommendation to approve the 2013 Comprehensive Plan

Vice Chairman Bessner explained that Committee would be going over the 12 discussion points from the previous Planning & Development meeting on June 10, 2013. He said he would like to entertain a motion after each talking point so there is formal direction for staff to move forward. He said after that process, his goal would be for the Comprehensive Plan move on to City Council with a formal recommendation. He said once the plan is sent to Council, there would be a public hearing where public comment could be heard.

Ms. Penny asked if there would be general comment allowed. Vice Chairman Bessner said tonight they are looking for further discussion from the Committee, but that Task Force members present were more than welcome to comment.

Numbered items below reference the Planning and Development Committee Discussion Points and Recommendations Table included in the meeting packet.

1. On 6/10/13, P&D Committee approved a motion: p. 22- remove "Prairie Street east to Adams Avenue" as an example of a logical gap to complete. p. 52- remove "Extend Prairie Street/Adams Avenue to connect the river crossing to IL 25".

Aldr. Martin made a motion to approve the revision as presented in the table. Seconded by Aldr. Krieger.

The roadway along the railroad right-of-way (Tyler to 13th Ave.) was proposed primarily to improve access to commercial and industrial properties east of 13 Ave. The connection to Illinois Ave. is not necessary to meet this purpose; however, the connection can remain in as an option requiring further study.

Aldr. Lemke made a motion to approve the revision as presented in the table. Motion seconded by Aldr. Bancroft.

3. Add a repositioning alternative to p. 84 for the Charlestowne Mall that keeps the outer shell of the mall intact but repositions the outward façade.

Aldr. Krieger asked if in using this statement, would the city be limiting itself to the possibility of redevelopment. Mr. Colby said what is being proposed to be modified is the repositioning alternatives, which is the 3 already shown, but add a 4th option to show the entire footprint of the mall intact, with some discussion about ways to modify the exterior of the building. He said it

would change the outward appearance and show how the property is developed around the mall, but leave the mall structure intact.

Aldr. Lemke said the theatre and Kohl's are already expanded and they are architecturally similar in construction. He thinks if Neil Johnson were here, he may say some of the things that might look well and improve attractiveness and the business prospects would maybe be outlots or changes to the current façade that would equate to outlots.

Aldr. Turner clarified that all that is being added is a 4th option, so any potential buyer could take the roof off if they so desired. Mr. Colby said yes, if they wanted to present a proposal, there are options that are there to provide some direction.

Ms. Penny said she thinks that the 3 options should be left and add 1.

Mr. Rabchuk said this conversation was had many times during the Task Force meetings and what needs to be kept in mind is that the plan is just to show some ideas to say "we are open to more ideas"; it is not to be too specific, it just is to say this site is welcome to development. He said it's to say to developers "bring us a proposal", because Council has final say over it anyway. He said the Task Force thought the 3 options were enough, but certainly if the Committee needs more to feel comfortable that is fine, but the idea is to not put too many restrictions, or bound them in and tie them down. Aldr. Payleitner said or they could leave the mall as is to make it work.

Aldr. Payleitner made a motion to add a repositioning alternative that keeps the outer shell of the mall intact but repositions the outward façade, adding a 4th option on p. 84. Motion seconded by Aldr. Krieger.

Mr. Colby said staff is recommending that closing Riverside Ave. be removed from the plan based on analysis done by the Fire Dept.

Aldr. Martin made a motion to follow staff recommendation to not close Riverside Ave. (Downtown Catalyst Site Q on p. 68) per the table. Motion seconded by Aldr. Turner.

Aldr. Lemke made a suggestion to use an illustration of Meijer with the pond in front and Lowes next door. Aldr. Lewis thinks that would be positive and maybe a collage coming in from all different ways to the Gateway could be used. Aldr. Lemke said he would defer to that.

Aldr. Lewis made a motion to change the picture for the West Gateway cover on p. 71. Seconded by Aldr. Krieger.

7. Constructing a Fox River bridge near Division Street is not a direct recommendation of the plan, rather the plan identifies an opportunity exists for a bridge in this general location and recommends the issue be studied and considered at some point in the future. The Committee approved a motion to remove the text from p. 22.

Mr. Armstrong said it was not the Task Force's intent to force anything regarding bridges, and given the amount of interest that a bridge would generate and without significant public input, it is probably not a good thing to add into the plan. Vice Chairman said as far as discussion point 7, we are looking to remove it from the plan, but leave the option for at least discussion in some particular area. Mr. Colby said the text that is shown in the comments on page 53 notes that an opportunity exists, and the Committee recommended to take out the text on page 22 under Goals and Objectives.

Aldr. Krieger made a motion to remove the text from p 22. Seconded by Aldr. Silkaitis.

8. The term *Town Center* is used in the three locations, and it would be changed to an alternate term that describes the same type of development:

p. 76 Former St. Charles Mall Redevelopment Alternative- *Local Town Center* change to *West Neighborhood Center*

- p. 76 Concept Legend- Town Center Mixed Use change to Mixed Use
- p. 84 Charlestowne Mall repositioning alternatives- *Town Center East* change to *East Town Square*.

Aldr. Lemke said he doesn't know how p. 84 got in here because it causes great confusion, because we are talking about a west side parcel and not renaming Charlestowne Mall in any way Towne Center. Vice Chairman Bessner said he is thinking it's a vague description of what could be Town Center east versus Town Center west. Mr. Colby said the repositioning alterative shown on p. 84 is called *Town Center East*, and it's being proposed to change the name to *East Town Square* since it's based on the square being the center of the development. Aldr. Lemke asked why it can't just be called Charlestowne Mall because it's a fair representation for that area. Ms. Tungare suggested an alternative of calling them options A, B, C. Aldr. Lewis mentioned that during a study recently done it was suggested that the name be changed. Mr. Rabchuk suggested wording it as "the existing Charlestowne Mall", and that way a developer knows they can change the name if they want.

Ms. Penny said the whole idea of the plan is to have flexibility, and she agrees with Ms. Tungare to call it A, B, C and not get into semantics, because we are trying to encourage future people that might have some interest in helping us economically to come in and do something. She said the last thing we want to do is for them to think we will lock them into a name or anything else. Ms. Tungare said the names are just to identify and differentiate between the different concepts; it's not about renaming the mall. Vice Chairman noted that there would also be an Option D for the 4th alternative.

Motion was made by Aldr. Lemke to redefine the alternatives as A, B, C, and to also add a 4^{th} which will be D. Seconded by Silkaitis.

9. Regarding Downtown parking and the catalyst sites on p. 68, additional parking structures are contemplated at Site C (NW quadrant) and Site P (SE quadrant), and the need to accommodate some parking is noted for other sites. However, a general note can be added noting the need to address parking as each site is considered for development and reference back to the text discussing the issue on p. 67 and 54.

Aldr. Martin made a motion to approve the revision as presented in the table. Seconded by Aldr. Krieger.

- 10. Regarding the West Gateway former St. Charles Mall redevelopment alternatives on p. 76, this area includes catalyst sites H (Jewel), I (Tri-City Center) and J (St. Charles Mall site). At a minimum, the following changes to Redevelopment Alternatives on p.76 would be necessary:
 - #1 Regional Repositioning: No changes.
 - #2 Local Town Center: Change definition of "mixed use" to exclude all residential uses of any type. ("Multi-family/Single Family Attached" is located on Site I- this could remain or be changed to another land use.)
 - #3 Comprehensive Mixed Use Center: Change definition of "mixed use" to exclude all residential uses; remove references to residential in the "Considerations" section.

Other changes to consider:

- P. 76- Broaden the "mixed use" definition to include other uses. Educational and medical uses were suggested.
- P. 34, 36, 40: These pages reference "potential mixed use" for Sites H, I and J, but recognize the future land use designation of the site is "Corridor/Regional Commercial". This can remain as is or be removed to eliminate any reference to mixed use at this site.

Mr. Colby showed a marked up slide of what would be changed on p. 76

Aldr. Lemke said the use of "Towne Center" was a concern and needed another name and he doesn't have any preferences but wanted to call it to attention. Mr. Colby said that was in item 8, the *Local Town Center* would be *West Neighborhood Center* throughout the plan and in the legend where it says *Town Center mixed use*, it would just state *mixed use*.

Aldr. Turner said he thinks saying "no residential" is very short sighted and very regressive to the development of the west side, especially considering the area south of Rt. 38 where Geneva already has residential housing. He said he doesn't think it will do anybody any good in the long run and if we keep on the route of "no residential" on the site, we may as well keep the vacant picture on the West Gateway because that's what it will look like. Aldr. Martin asked Aldr. Turner how he knows that, and stated that he did not agree.

Aldr. Krieger said she would like to consider changing the part under "other changes" to consider broadening the mixed use definition because she would not want to eliminate the possibility of education or medical uses, and in considering residential, who is to say a residential rehab center would not be turned away because of it. She said she knows it's a vision, but she would hate to see possibilities eliminated.

Aldr. Payleitner asked to break it down square by square (each of the three alternatives) and have a discussion and a vote for each. Vice Chairman Bessner agreed.

Mr. Rabchuk asked the Committee to consider that the main purpose is to give flexibility and vision, and once restrictions are put in, it's cutting that down. He said if someone is trying to sell their house, the more restrictions put on the ability to sell it, the opportunity is lessened. Aldr. Martin said he has an option to get in there what he wants instead of some pie in the sky thing that somebody dreamed up. Mr. Rabchuk said it has to be kept in mind that the Council has final say on any plan being proposed and that if all these type of restrictions are added at this point, we are telling developers "we don't even want to talk to you". He said the impact of that type of thinking for this site financially, had it been developed, could have decreased taxes for residents \$1,000 per year and per household, and somebody at some time is going to come before Council to want them to deal with their tax issues. He said the city has done a great job at controlling cost and providing services, but at some point in time these type of sites need to develop and produce income for the city. Aldr. Martin said this site is one of the remaining sites on the west side available for retail and that's what he wants it to be and he stands by that. He said he doesn't want to see apartments or hotels, just commercial retail. Mr. Rabchuk said and the Council controls that, but let developers make a proposal, for example, maybe something like \$3 million townhomes come in that are all sold already generating \$3 million a year in extra tax and 90% of the site will be retail, would Aldr. Martin accept that. Aldr. Martin said no, he would not accept \$3 million townhomes on the property. He said in terms of flexibility of the plan, he has sat up on Council long enough to know that once the plan is approved the staff and everyone else uses it as a guide and to make changes to the plan is very difficult, so why not avoid that to begin with. Mr. Rabchuk said the City used a very top notch urban planning firm to guide us through the process, they know what developers are doing, what other towns are doing to compete with St. Charles, and we are ignoring their advice and the city paid a lot of money for that. Aldr. Martin said that's a matter of opinion and he voted no on it. Mr. Rabchuk said the result is, in looking back at previous plans where urban planners were not used, they are a mess and provided poor or no guidance whatsoever. He said in using professionals to guide us along with the hundreds of people that contributed comments, that the City had an excellent process of gathering input, sorted it all out and came up with what is in front of us. He said to arbitrarily deny that and to say that someone knows more than these experts, that the city paid lots of money for, in his opinion he feels is a poor decision.

Aldr. Payleitner asked Aldr. Martin if he is recommending that there only be plan #1, not the other 2 options. Aldr. Martin said if that is the one that was come up with at the last meeting. Vice Chairman Bessner said he thinks the discussion ended up that there would be 3 options on the table and residential and or mixed use was pulled out of all of them. Mr. Rabchuk said the definition of mixed use was changed to specifically exclude residential. Aldr. Payleitner said options 2 & 3 do not have retail only and she needs clarification from Aldr. Martin. Vice Chairman Bessner noted that even in option 1 there is a small portion that has mixed use. Mr. Rabchuk said the professionals said that the type of retail that would go on the site, because it's not a Randall Rd. site, would have to be supported by some level of residential, but that it doesn't mean it has to be, but it's highly recommended. He mentioned the Towne Center proposal and how Whole Foods was going to build across the street, but they said if the site didn't develop with residential or were to stay an empty space, they would go someplace else, and that's what happened. Aldr. Martin said his opinion is that Rt. 38 is an extremely viable frontage road for any commercial. Mr. Rabchuk said the developers have told us they don't think so and he hopes Aldr. Martin has the funds to develop it.

Aldr. Lemke said there are two corners on the west side where Randall Rd. fronts state highways Rt. 38 and Rt. 64 and in terms of massing and folks driving to Randall Rd. it is because they want to shop at more than one place. He said we were criticized for putting in the Amli parcel, not because Amli people shopped at Jewel, but because it cut out the ability to have retail mass on the east side, and he thinks the same damage would be done if it were assumed that more residential would make the retail development pay off. Mr. Rabchuk said but wouldn't you rather have the option to look at it, and then say no, than to say no upfront and we don't even want to talk about it. Aldr. Lemke said the city has made a decision that the land north of Rt. 38 be retail and good money was spent to allow additional uses in retail. He said the developer knew that when he took money to allow additional retail uses and when he took full interest in the parcel, he knew it was retail, and it was the city's opportunity to have a retail cluster on Randall Rd. and Rt. 38.

Aldr. Lewis asked if the zoning stays the same for the site, because changing it has not been mentioned. Mr. Colby said yes, the property is zoned for commercial use, so for developments to be constructed, particularly options 2 & 3, there would need to be a review process and public hearing process for zoning changes. He said the plan does recommend that a PUD be considered on the site due to its size and complexity. Aldr. Lewis said that last month she asked some questions and also read through some minutes again that there is very strong language that an 8story complex is not what we are looking for. She said residential over a business was talked about, but not a stand-alone residential building. Mr. Colby said correct, and that is the language highlighted in the mixed use option 3. Aldr. Lewis said she personally feels the hands of the Council, Mayor and Plan Commission, both current and future, should not be tied for developments to come forward, and she feels by not leaving all 3 plans in, they will be doing just that. Aldr. Payleitner suggested more broadened verbiage, maybe multifamily/single family attached in the brown area sounds too restrictive, maybe add other options. Vice Chairman Bessner said the Task Force struggled with that. Mr. Armstrong said one of the things looked at was "what could be legally regulated and what could not" and one thing that could not be was the type of ownership, that's why definitions were not used referring to apartment versus condominiums. He said they did use language that gave direction that showed the type of units that promote home ownership and in the mixed use section we are looking for the flexibility to allow some type of residential use over a commercial or office use on a 2nd or 3rd floor. He said in looking at the mixed use Town Center on the photograph, it's an example of commercial use on the 1st floor but a residential use over it.

Aldr. Payleitner said in looking at the map it says multi family, and Bickford is multifamily, so she is looking for more definition clarity or expansion. Vice Chair Bessner said going through the process he didn't feel their role was to decide what kind of residential product would be there, the closest they got was to look at density levels for the Corporate Reserve property. Aldr. Payleitner said but it does get specific at some points, and she wondered if some examples could be put in there to keep developer options open. Vice Chair Bessner said there would be a number of residential uses out there going from senior housing to the possibility of apartments, but he feels Committee should not promote any particular one, just trying to leave the option open, because there are not developers lining up for these sites and we are not sure if the economy will ever get back to what it was 5-6 years ago. Aldr. Payleitner said we are changing the definition of mixed use according to the recommendation, to exclude residential, and she is

asking if in option 2 if the definition could be added to not limit it. Mr. Armstrong said yes, the Council can define it how the Council sees fit, but he would caution that a consistent definition be used throughout the document, so it does not vary from page to page. Aldr. Payleitner said she agreed, because mixed use is mixed use, and she asked if there is a definition for mixed use anywhere in the plan.

Aldr. Silkaitis said back in the early 2000's when he was on Council, before the housing was on the West Gateway, it was said then that when all that housing was built, it would bring commercial and that did not happen. He said he will not limit the last piece of commercial property on the west side to residential, and he thinks it should be commercial or office. He said he if fine with residential on Bricher, but prime commercial should be all that's allowed for this site.

Aldr. Bancroft said to characterize the site as a prime commercial area is aggressive, and he had no history of the plan so read the plan all weekend long to understand pieces of it. He said on page 6, the final point, and he does respect Aldr. Martin's observation of how it is used historically, states that the plan serves as an important marketing tool to promote the city's unique assets and advantages. He said under purpose, it states that at the most basic level, the plan is intended to direct orderly growth and change as well as maintain and enhance the livability of the city. He said in his opinion, attempting to forego residential in both mall areas is a mistake, and there is a definition of mixed use on p. 29 and he thinks the definition needs to maintain its current flexibility. He thinks if we want to encourage the best and brightest to bring ideas for these troubled areas, the last thing we want to do, by virtue of something that is supposed to be aspirational, is limit their choices. Aldr. Payleitner said she thinks by limiting our choices based on something that happened 20-years ago is short sided and it needs to be realized that there is a totally different ballgame with the upcoming generation and those options need to be kept open.

Ms. Penny said she supports what some of the Committee is saying and that she was around for the '96 Comprehensive Plan, and yes, residential was supposed to bring commercial, but Geneva got it. She said the last thing we want to do is lock ourselves in, and she feels we were fortunate to have professionals help with the plan for the future, but that it needs to be kept in mind that it's a Comprehensive Plan, not a Zoning Ordinance. She said she feels nothing good comes from fear, and we should not allow ourselves to be afraid of possibilities for the future, because things change and if we shut down the options, we are shutting down viability and possibilities for St. Charles.

Aldr. Lewis said her parents bought a house in St. Charles in 1946 on 11th Ave. and if her parents had said back then they were happy with the way things were and wanted no more residents, most people in the room would not be living here at this time. She said we are not saying we want residential, we are saying this is something we will take a look at, and here is 3 ideas, 3 plans, and she feels that is all it is saying.

Kim Malay-526 S. 16th St.-said if we are going to open it up to any alternative then why was the money spent to do the Comprehensive Plan. She said in all fairness, Aldr. Martin is right, the plan is supposed to give guidance and help staff cut through the proposals that will not go through the Council, and to have a plan that says it will accept just anything to come forward,

what good is it. Aldr. Payleitner said that's not true. Ms. Malay said it leaves the door open to quite a bit and once it's in the plan, and yes the zoning is in place, it was in place back in 2004-2005, but Shodeen came in and did an amendment to the Comprehensive Plan and suddenly residential was an option, and 2 ½ years fighting the project, and the developer was frustrated spending hundreds of thousands of dollars on a project the community didn't want. She said if a project is viable and it's not in the plan, the plan can be amended, but once those 3 options are in the plan it's leading the developers on. Aldr. Payleitner said these are 3 very different ideas. Ms. Malay said exactly, but it's in there so developers are thinking we're open to it, and the City already has the reputation of being hard to deal with, and if residential is what is wanted, then be up front and just say in the plan that we are open to all of it. Aldr. Payleitner said but we are not. Ms. Malay said but you are because once you start with some residential then the doors open. Aldr. Lewis said in looking back at early minutes of the Task Force, there were comments that Ms. Malay was open to some residential. Ms. Malay said the residents did not want residential but she was trying to compromise. Aldr. Lewis said which residents. Ms. Malay said a good majority of them, she had over 300 people. She said there were a lot of people in attendance here and people keep saying that there were hundreds of people saying that we are hard to deal with and that they want residential, and she would like to see that.

Aldr. Payleitner made a suggestion to keep discussion to Committee because there will be an opportunity at the public hearing for residents, and now Committee is just getting distracted. Ms. Malay said she agrees with Aldr. Martin that we are better off to narrow it down and let them come in with an amendment, and the residents are open to everything else but residential. Vice Chair Bessner added that if a developer does come that has a viable idea, that it is a big process to get that turned around in a timely manner. Ms. Malay said it would be a lot quicker than what went on with Shodeen. Vice Chair Bessner said that was a whole different story, the reason it didn't pass had nothing to do with retail or residential, it had to do with the fact that that the Plan Commission came up with a number of units right around 300, he himself suggested 150 units, and there was no meeting in the middle on Shodeen's part, and that's why it didn't pass. He said it was a very viable plan but had height and density issues. Ms. Malay said but it was competing with downtown as well. Vice Chair Bessner said nobody gave him a false sense of allowing him to build 1,000 units. Ms. Malay said that's not what she was told. Vice Chair Bessner said well he was part of the process, so he was there.

Mr. Doyle-member of the Task Force and Plan Commission-said he would like to affirm what Aldr. Martin and Ms. Malay said about clarity in the plan. He said it's important and is a key part of providing fair certainty to developers, that what we say our vision is, we mean it, and we are open to those kinds of developments. He said he thinks that while it is clear to say "no residential" on the property, it's so restrictive and he doesn't think it's the right mission for the city. He said he feels there are some reasons why residential should be included. He said consensus heard at Plan Commission from the public was that big box or strip mall is not what is wanted for this site because it is a catalyst site and he was glad to hear Aldr. Bancroft draw out the part of mixed use pertaining to focus and walkability, because that is the proposition of mixed use development, to have a vibrant lifestyle center where people get out of their cars and shop where they live. He said its transit oriented and is a destination that has character. He said there needs to be limit, so he feels the plan should be clear in terms of the limits, how dense, the ratios, all these things are very important, with some citizen input and the desires of the community, and the Task Force and Plan Commission are both citizen panels whose interests are

not greater and no less than any other member of the community that provides testimony. He said in 2010 the Plan Commission made a unanimous recommendation to establish a mixed use district on this parcel, but the PUD was split because of density issues. He said that recommendation has been upheld by the Task Force and the Comprehensive Plan and supported by workshops, consultants, and paid staff, so he is asking that Committee pay close attention to the aspects of the vision that is being recommended in the plan and understand what the value of the proposition is. He asked that Committee consider it sincerely as it moves to Council.

Aldr. Turner asked if in making a motion it would be to keep the plan as is, or vote on multiple changes. Vice Chair Bessner said he thinks there is an option to vote for discussion point 10 with whatever direction, either keep mixed use as it, to include residential or not to, or as Aldr. Payleitner said, to address each particular alternative.

Aldr. Krieger asked if item 10 is disregarded, will that eliminate any future educational or medical uses there. She doesn't want to throw out those possibilities. Mr. Colby said it would not specifically be excluded, but if the Committee wanted that identified here, it could be identified as a part of mixed use. Aldr. Krieger thinks that's important. Vice Chair Bessner said that should be stated now that medical and educational remain part of mixed use. Aldr. Payleitner clarified that the change would be in the definition for mixed use on p. 29. Aldr. Martin said given the discussion had, that to make that type of motion as opposed to his position, to solid commercial, is unproductive and is going to result in some negative reactions. He said he supposes it's time to compromise and he thinks to give the commercial retail site vision an opportunity to produce and if not go to plan B (2nd alternative) and he would also like to add that any construction is limited to 3-stories. Vice Chair Bessner asked if that number is currently at 6. Ms. Tungare said she did not think there was a number included in the plan. Aldr. Lemke said he would be in support of that because the problems in the past were the high elevations proposed, but he doesn't understand where it's decided that option A hasn't worked. Aldr. Turner said he cannot accept Aldr. Martin's compromise because we don't know when it starts, ends, and what if B comes first.

Vice Chair Bessner said if the height were to be added into the motion, it would need to be discussed as a Committee. Aldr. Lewis suggested not using the word limit, but maybe a suggested or preferred height. Ms. Tungare said the plan will not regulate height, it's going to give direction, and the zoning will regulate the height. She said either "prefer" or "limit" would work, it just gives direction to then translate into zoning regulations. Vice Chair Bessner asked if "height to not exceed what's currently in the city" would work. Aldr. Bancroft said he goes back again to the mixed use definition which states that the areas be characterized by uses and development patterns that provide a vibrant, safe, attractive and walkable pedestrian environment. He said in adding a reference to height, he doesn't think it should be specific; it should just be of a character in height consistent with making it walkable. Vice Chair Bessner suggest saying something like "conscious of height".

Aldr. Turner made a motion to disregard item 10 in the table, broaden the mixed use definition on p. 29 to include educational and medical, and also state to be "conscious of height". Motion seconded by Aldr. Bancroft.

11. Regarding the Charlestowne Mall framework plan on p. 83:

At a minimum, the following changes to the Framework Plan on p. 83 would be necessary: "Single Family Residential" will be removed from the plan on p. 83. Stormwater basins on the north side of the mall site will be shown on the plan. The screening buffer north of the Mall can be shifted further north to the Mall property line. The northwest section of the Oliver-Hoffmann site will be shown as "Outlot Commercial, Retail and Office Development", consistent with the other sites around the mall building.

Change to citywide Land Use Plan on p. 30: Revise the Land Use Plan to match the revisions to the Charlestowne Mall Framework Plan.

Other change to consider: P. 34, 36, 40: These pages reference "potential mixed use" for the Charlestowne Mall site, but recognize the future land use designation of the site is "Corridor/Regional Commercial." This can remain as is or be removed to eliminate any reference to mixed use at this site.

Mr. Colby showed a diagram depicting the changes to the land uses on the framework plan.

Aldr. Krieger asked if by adding the medical and educational to p. 29, would that now be included here as well, because if not she would like to see that added. Mr. Colby said it could be added under the outlot commercial and retail development category or it could also be indicated for the mall building. Aldr. Martin asked if in regard to the medical/education, if they would pay taxes. Vice Chair Bessner said it would probably vary based on the size of the institution or the property being discussed versus commercial retail. Aldr. Martin said what if a college wants to take the whole site. Vice Chair Bessner said that would be something to consider. Aldr. Martin said that's a big consideration. Aldr. Turner said it could be a private school too, they pay taxes. Aldr. Lewis said her opinion would maybe be to open an option to take a small portion of the property and there probably would not be tax dollars if it were a state type of educational facility, but employees would be spending money in the surrounding retail and get tax dollars that way, but she doesn't think anyone was thinking the whole parcel would be a college. Aldr. Martin said it's a possibility.

Aldr. Lemke made a motion to take the point as presented in the table with the exclusion of city land use from the Charlestowne Mall plan and mixed use. There was no second.

Aldr. Turner said so remove all residential. Aldr. Lemke said yes, he thought that was decided last time. Aldr. Turner said he can see removing the single family homes but other than that he would leave the residential and mixed use in for the same reasons here as the west side. Aldr. Lemke said it would remove the detention and the berms and he is not sure what the benefit of that is. Aldr. Turner said we would keep the removal of the single family residential and maintain Oliver Hoffman, and he thinks mixed use should stay on the parcel as well. Aldr. Lemke clarified that the extent of residential would be Oliver Hoffman only. Vice Chair Bessner asked if the option of mixed use would be left in. Aldr. Turner said he would leave it in. Aldr. Lemke said there should be a vote. Aldr. Payleitner asked where the mixed use would be. Mr. Colby said it's on the main land use plan, it's not detailed in the framework plan. He said this

page is an excerpt from the commercial area framework plan which shows both mall sites as a future land use of Corridor/Regional Commercial and was identified as Potential Mixed Use.

Aldr. Turner made a motion to remove single family residential (p. 83), residential for Oliver Hoffman consent decree stays (p. 83), maintain mixed use with a medical and education component (p. 34, 36, 40). Seconded by Aldr. Bancroft.

Aldr. Martin made a motion to amend the motion to remove medical and educational from the motion.

Aldr. Payleitner said wait, we have already changed the definition for mixed use throughout the plan, which now has education and medical use in it.

Mayor Rogina noted that the amended motion needed to be voted on first, before the original motion.

Aldr. Lemke amended the motion to exclude mixed use. Seconded by Aldr. Martin.

Aldr. Lewis said she personally would like to see an updated plan at the Public Hearing.

Vice Chairman Bessner asked if there would be a chance that there would be more modifications after the Public Hearing. Mr. Colby said it's possible. Aldr. Krieger said if there will be more changes, it would be best to go off of the tables rather than printing the plan twice. Ms. Tungare added it's an additional cost as well. Aldr. Lewis said she was fine with the tables.

Vice Chairman Bessner asked Committee for any last changes. None were stated.
