Therefore we are presenting all the special service areas in public hearings tonight.

Regarding SSA1A is located generally in the downtown area. It was established for the provision and maintenance of parking downtown. Currently the proceeds are spent on the maintenance and operation of the parking decks, parking lots and on street parking spaces within the downtown area. The 2012 levy extension for SSA1A was \$79,826. We do expect a slight increase for 2013 that levy request would be \$80,000. Currently, SSA1A is levied at the maximum tax levy of \$.40/\$100 of EAV or taxable value. With that, I can answer any comments.

Special Service area 21 is generally at the Northeast corner of Kirk Road and Route 64. It does exclude the mall property but it does have its eastern boundary is the western property line of the of Charlestown mall. It does include the commercial property north to Foxfield. With this particular SSA, debt of \$3.7 million was issued for improvements related to the development that would normally taken care of and paid for by he developer. Particularly, streetscape, landscape, sidewalks, intersections, boulevards, curb and gutter, utility service and detention area were all paid for out of this debt issue. The bond proceeds have now been expended in there entirely and project is complete. The SSA levy pays the debt service on an annual basis. The 2012 levy was \$236,226 or \$4.34/\$100 EAV. The 2013 proposed levy is \$230,244 resulting in a rate of \$4.23/\$100 EAV. If the City Council will recall, approximately a year ago, we called \$875,000 of principal of this particular bond issue, resulted in an annual savings of about \$58,000. Had we not taken that action last year, the levy request for 2013 would be \$58,000 higher. That was a good action for that particular service area.

Is there a sinking fund for retiring some of these?

There is not, we had \$875,000, approximately, in bond proceeds and collections because there are still some vacant areas within this SSA. However there are no projects pending. We wanted to take advantage of \$58,000 of savings back to individual tenants. And at some point we will start running afoul of expenditure regulations for SSA debt related to the bonds. Not having a project and being able to take advantage of \$58,000 of savings seemed like a no brainer.

This public hearing concerns the City's proposed 2013 property tax levy. A notice of this public hearing was posted in the Kane County Chronicle on November 20, 2013.

o Chris Minnick

The 2013 tax levy will be collected during calendar year 2014. Notice was published, according to State Statue. At the conclusion of today's hearing, all of the statutory requirements to pass this tax levy will have been met. During the during government operations meeting later on we will be requesting an approval of 2013 tax levy and recommend be placed on the December 16, 2013 City Council meeting for final action and ultimate approval.

The 2013 tax levy request is in the amount of \$21.8 million approximately a 6.4 % decline over the 2012 levy. The operating levy has been frozen for five years since 2009. We anticipate we will also a fifth year of decrease in the citywide EAV or taxable value of property in the City. This would be at 4.5%. These two factors/bullets, by freezing the operating levy and having a decrease in the tax base of the City, has an impact of raising the tax rate while keeping the amount of dollars paid by tax payers the same year over year.

Consistent with past practice and Council direction, we anticipate we will abate the debt service portion of the levy. Despite all the challenges talked about on this particular slide, we are able to maintain prudent pension funding with the actuarial recommended levels of approximately \$4.7 million for the next fiscal year.

We are anticipating another decline in the EAV or taxable value of the City. We do anticipate that it will decrease about 4.5 % that equates to \$61.8

million. Taking the EAV of the City to the level \$1.31 billion. EAV is estimated to be one third of the market value of the property in the City. That means that market value of the properties in the City is slightly less than \$4 billion dollars. Breaking down the 2013 tax levy into the individual components. We have the operating component being held consistent at \$12,055,117. This is the area which the City Council has the most discretion. It is part of the levy that operations, primarily the General Fund, and it is being held consistent at \$12 million. The debt service levy is declining from to \$9.3 million from \$10.8 million. This is due to the refinancing that the City did in February 2013 primarily for the First Street development. And the special service area levies are increasing slightly to \$435,000. The total is \$21.8 million, as compared to \$23.3 million for 2012.

We will be abating the debt service portion of the levies. We will be removing those from the property tax levies via a series of resolutions that will pass early in 2014. However, we need to include the debt services portions of the levies in these annual totals.

We are keeping the operating levy consistent. The operating levy has not changed since 2009. So for the fifth consecutive year we will be holding the operating levy at that level. This has provided a very significant tax savings over that period. For instance, an owner of property of \$300,000 in 2009 has saved \$112 over that five-year period.

The next couple of slides look at the distribution of the 2012 levy. Up to this point, we have been talking about the City of St. Charles portion of the levy. This is roughly 10.5%. The majority goes to the school district, roughly 64%, which is comparable to other municipalities. The smaller amounts paid to various others.

The next slide goes through and breaks down what a property tax bill looked like for 2012 collected in 2013 for a \$300,000 market value property. A \$300,000 market value property paid approximately, a little less than, \$8,700 in property taxes in 2012 levy year. Majority went to District 303.

I mentioned the interplay of between the EAV and the rate. This slide goes through and demonstrates what happens and how those two factors interrelate. We look at value of the property for 2012-levy year, which would be calendar year 2013. If you have a \$200,000 market value you paid approximately \$585 in property taxes for the 2012 levy. For 2013, we are holding the amount of the operating levy consistent, we expect about a 4.5% decrease in the tax base of the City. If that \$200,000 property experienced that 4.5% decline in its value, it would have a market value of \$191,000. Even though the tax rate would increase by 4.5% in this scenario, the taxable value of the property would also decrease by a corresponding 4.5% and there would be no change in amount of property taxes paid to the City by that

property. This is all an average. As in individual property owner experience varies, so will that individual property owners tax bill. It is possible that a person could experience an increase in their value or a decline, which may be not as great as 4.5% that we anticipate for the tax base of the City. On average, the City's portion of the tax bill should remain about the same between 2012 and 2013 levies.

To recap:

4.a Recommendation to approve a Resolution Approving a License Agreement By and Between the City of St. Charles and St. Charles Arts Council (January 1 – December 31, 2014)

Peter Suhr presented. On January 18, 2011, City Council approved a two year License Agreement authorizing the St. Charles Arts Council to utilize office space in the Municipal Center. This agreement expires on December 31, 2013, but does allow for up to two annual renewal periods. Power Point presentation by Tom Bruhl and John Lamb.

Mayor Rogina: I, along with Aldr. Stellato had an opportunity to attend a roundtable meeting at BEMA, a business in our industrial park. BEMA wants to investigate the use of Geothermal application. I don't know if this will come to pass or not, but I was most impressed with our staff and their level of conversation because they were interrogated about whether or not this Green Initiative should take place at this property.

Aldr. Stellato: I echo those comments. The St. Charles Chamber of Commerce Industrial Council for Industry put on this forum, and it was held on site where they want to use a Geothermal application to help reduce energy costs. They flew someone over from England to give us a seminar on how to apply Geothermal Energy usage in an industrial application. There was a very well attended seminar in the morning and an open house in the afternoon; it was a very educational day.

No further discussion.

4.d. Recommendation to approve Electric Distribution Maintenance Budget Addition.

Tom Bruhl presented. In the first half of FY 13/14, we have had three events that have depleted our Distribution Maintenance Fund. Our philosophy is that we budget for the average, not taking a worst case scenario into consideration in order, to keep the budget in line. If necessary, we will come to Council to ask for a budget addition if we have unforeseen circumstances.

The first incident was at Tyler and Main Street. Martam caused our duct to collapse, which was an \$8,000 repair that has been billed to Martam and their insurance company.

The second incident was related to East Main at Pheasant Run. They had cable under Kautz Road. To help facilitate that project getting done in a timely fashion, we were able to sell them material out of our storeroom so we knew they were getting high quality material that was readily available. The cost was \$21,000 which has been billed to Thorne Electric who is submitting that to IDOT for our reimbursement.

The final incident was on Tyler Road for the culvert project. Without doing exploratory digging and shutting down a lane, we couldn't tell whether the duct was going to be in conflict with the box culvert and it turned out that it was. As such, we had to move the cable and the duct.

The total of all these projects is \$40,000; I am here today to ask for a budget addition for these. Two of them will be offset with revenue for the damage from Thorne Electric. The other was an unforeseen project that we didn't budget.

Aldr. Stellato: It looks like the box culvert is going to help take care of the water situation. I know it's not done yet, but is it far enough along to be useful now if we have a rain event?

Mr. Bernahl: It is about 80% done right now. They are forming the last wing wall component on the east side. Once that is completed, they will remove the temporary dam that we have at the far east end that will allow the detention facility to start to flow normally and utilize that ditch. Everything is completed on the west side; the patch work in the road is done.

Lootens is working on the removal of the railroad tracks; that will be completed by the end of this year. We are anticipating by next week the wing wall will be completed and the temporary dam will be down and it will be 100% open.

No further discussion.

4.e. Recommendation to Authorize the Mayor and City Clerk to Execute an Agreement with Verizon for Placement of Mini-Cell Sites on City Owned Poles.

Tom Bruhl presented. Verizon contacted the City to install mini-sites on City owned poles. It's an attachment on top of a wood pole, so it's on an existing structure. This is not a major cell tower, just a small extension on an existing 30 foot pole. The agreement offers for the City to receive \$250 per pole, per month. They are currently looking at five or six locations; it's not on every pole, just areas where Verizon has less than adequate coverage. These have become standard on electric poles; our agreement was crafted from Naperville, who has a similar agreement with Verizon. The agreement has been reviewed and approved by John McGuirk.

Staff recommends authorization for the Mayor and City Clerk to execute an agreement with Verizon for the placement of the mini-cells on City of St. Charles poles.

Aldr. Silkaitis: Are these self-powered, or are they metered?

Mr. Bruhl: They do require power, and they are metered. Verizon will pay for the power, so we will receive \$250 per pole, plus the energy they use.

Aldr. Lewis: In the photo, there are boxes located lower down on the pole. What are they?

Mr. Bruhl: Those are the power boxes, which will be at the base of the pole. We will not allow them on the pole.

Aldr. Lewis: So in addition to what's on top, there will also be two boxes?

Mr. Bruhl: Unlike the photo, it will be one bigger box at the base of the pole.

Aldr. Lewis: Do they make a humming noise?

Mr. Bruhl: No; it's just a communication cabinet. It takes in power and transmits the signal to the antenna.

No further discussion.

4.f. Presentation of Emerald Ash Borer (EAB) Program Update.

Chris Adesso presented. Tonight I would like to speak to you about the City's Emerald Ash Borer Program. Because we are drawing near the completion of the program, we felt it was important to provide a brief overview and status.

For the purpose of tonight's update, I have broken down the program into three distinct, but related topics of discussion. First, a program snapshot, including a brief history of the program, the processes executed during the program and where we are at today with a glimpse into the future.

Following the program snapshot, I would like to provide information relating to the Finances behind this program and share some preliminary thoughts on where we will be in the future.

Finally, an introduction to the concept of a diversified urban forest and some recommended next steps will close the presentation.

Power Point presentation by Chris Adesso.

Aldr. Lemke: Do we have a list of anticipated species with enough choices that none of them will become the leader?

Mr. Adesso: We are working to ensure that we do not end up in a situation like we have right now. Unfortunately, we do have a far and away leader currently in our inventory, but we are taking steps to have diverse plantings. Last fall, we offered approximately 30 different species of trees.

Aldr. Lemke: Going forward, the list of 30 gives us more diversity for the new trees?

Mr. Adesso: That is correct.

Aldr. Lewis: I have concerns about the trees along the bike path in front of St. Mary's Park along IL Rt. 31. All summer long I noticed two or three huge, dead ash trees. Are they our responsibility to remove, or the Park District?

Mr. Adesso: I believe those trees are the Park Districts; I have had a conversation with the Park District about that area and they have asked us for help, so we did trim some of those trees away from the right-of-way along Rt. 31. I will follow-up with them regarding removal.

Aldr. Lewis: Besides not looking nice, I don't think it is safe for them to be standing in such a public location.

Mayor Rogina: I had a chance to go to a Tree Commission meeting a while ago and I was introduced to the diversity issue. Between our staff and the Tree Commission, they are working very diligently to put together a plan to avoid this issue we have had with the Emerald Ash Borer.

Aldr. Lewis, to your point about the dead trees, I received an e-mail over the weekend about a problem on the bike path and I sent an e-mail to Peter Suhr and it was taken care of. Our staff deserves all the credit.

Mr. Adesso: The tree that Mayor Rogina is talking about actually fell from someone else's property, and we did help with that.

4.g. Recommendation to approve Change Order No. 5 for Biosolids Building Construction Project.

John Lamb presented. This is a recommendation to approve Change Order No. 5 for the Biosolids Construction Project. This is in the amount of approximately \$36,000. This Change Order amount will be taken out of the project contingency plan and will go into the low interest loan for the project.

Staff, along with local electrical contractors took time to trouble shoot this prior to approaching Layne Western, who is the local expert. It has been determined that this is related to the pump motor that is 800 feet down in the ground. There is also a VFD on a booster pump that also failed and needs to be repaired. These items are quite costly and we did not budget for this type of repair.

Staff recommends approval of a budget addition in the amount of \$250,000, which is hopefully a worst case scenario; we are not anticipating needing to spend the total amount of money to make the repair.

Peter Suhr presented. We are back this evening to discuss the parking lot on the southwest corner of IL Rt. 64 and IL Rt. 31. As you will recall, the section of parking lot highlighted in your packet is being sold from the current owners, the Petersons, and

purchased by Mr. Tim Allen. The City is currently leasing those 11 parking stalls for public parking from the Peterson's for \$750 per month.

At the October Government Services Committee Meeting, Staff was directed to continue negotiations with Mr. Allen and to include a credit on the lease agreement as part of the Right of First Refusal Clause in the contract. As directed, Staff did prepare that new agreement for Mr. Allen's consideration, but he did not agree to the terms as suggested, and will not provide any credit back for the lease. In addition, his counter offer also included \$1,000 per month in lieu of \$750 per month. Mr. Allen will extend the right of first refusal only for the first five years or the first term of the agreement, but in year six, that clause will lapse. There are also some small administrative type issues that he was requesting in the agreement as well.

A representative for Mr. Allen is here if you have any questions for him.

Aldr. Stellato: If we decide to move forward and approve this, the wording is here and that is one option we could take. If we decide to take no action tonight, that is another option. If we decide to take no action, do you want a motion to deny this request?

Mr. Suhr: Yes, we are seeking a motion. At this point in time, this has gone on three months with five or six revisions of the agreement, so I'm looking for guidance one way or the other tonight.

Aldr. Bancroft: If we vote no, what happens to the current status quo?

Mr. Suhr: The current status quo continues, unless the Petersons, who are the current owners, come to us for some change in the agreement that we have had with them over the past 25 years.

Aldr. Silkaitis: Looking at the contract, I do not find these terms favorable to the City at all. Unless something changes, I will be voting no to this contract.

Aldr. Lewis: How would we end the deal all together?

Mr. Suhr: That is a motion that can be offered.

Aldr. Lewis: So we would have to make a motion to be in favor of, or against this and then make another motion to either continue or discontinue?

Mr. Suhr: That is certainly something we can consider tonight.

Executive Summary:

The City's Building and Code Enforcement Division offsets its operating cost through construction permit fees. Approximately every three to four years, staff reviews the City's current fee structure and services that the Division provides to determine if any adjustments are necessary to offset costs incurred and to continue to provide a high level of service. The last increase to the permit fee schedule in Title 15 of the City code took place in January of 2009.

The majority of permit fees are based on movements, or the number of inspections a particular project has and the time it takes to conduct these inspections. The Building and Code Enforcement Office provides various courtesy services such as Special Event Coordination's, Code Enforcement, and Chapter 34 Reviews at no cost to the customer, along with other non-construction services. Our practice has historically been to try and cover 60 to 70 percent of the building inspection services, based on construction activity.

The City's current permit fee structure is based upon a specific project, square footage, or cost. Building permit fees for commercial projects include Fire Department inspection services. This type of fee structure provides the customer with a simple comprehensive fee structure for budgeting.

Based on a recent 12-month operating time frame from September 1, 2012 to August 31, 2013, the collected revenue permit fee covered approximately 47-percent of operating costs related to building permitting activity. With a modest increase in permit fees and proposed construction activity, we are expecting to close this percentage shortfall.

Planning and Development Committee Review

The Planning and Development Committee reviewed the proposal on 12/09/13. Alderman Lemke expressed concern about including de minimis standards for certain permit types and differentiating between decorative landscape vs security fences. Staff has reviewed the provisions in Title 15 and we have added language for clarification of when a fence permit is required. The Planning and Development Committee recommended approval of the amendment on 12/09/2013. The vote was 8-aye to 1-nay.

An Ordinance Amending Title 15 "Building and Construction" Section 15.101.150 "Permit and Inspection Fees" of the St. Charles Municipal Code

WHEREAS, the City Council of the City of St. Charles hereby finds that it is in the City's best interest to establish permit fees that correspond to the cost of providing permit related services; and

WHEREAS, the City has analyzed the costs related to providing plan reviews, inspections, and other services in relation to building permits, which are reflected in the proposed fees contained herein;

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ST. CHARLES, KANE AND DUPAGE COUNTIES, ILLINOIS AS FOLLOWS:

1. That Title 15, "Building and Construction", Chapter 15.101 "Administration, Enforcement, Fees, and Penalties" of the St. Charles Municipal Code by and is hereby amended by deleting the provisions of Section 15.101.150 "Permit and Inspection Fees" and by substituting the following therefore:

"15.101.150 Permit and Inspection Fees.

A. Payment of Fees. All base fees shall be paid at the time of submittal of the permit application and plans. Other fees calculated from square footage, estimated cost, and other unit measures shall be paid prior to issuance of a permit. Additional fees and reimbursements that are incurred after issuance of a permit shall be paid prior to issuance of a certificate of occupancy. All permit fees are non-refundable.

B. Building Permit Fees. Permit fees for construction, alteration, demolition, installation, and other work as listed herein are established as follows:

- 1. New residential buildings:
 - a. Single family detached dwellings.
 - i. Base fee: one hundred twenty five (\$125.00) dollars. (Due at the time of submittal)
 - ii. \$0.28 cents per square foot of each level of buildings including basement, garage, crawl space.
 - b. Single family attached dwellings townhouse/duplex.
 - i. Base fee: one hundred twenty five (\$125.00) dollars. (Due at the time of submittal)
 - ii. \$0.28 cents per square foot of each level of building including basement, garage, and crawl space.

- c. Multi-family buildings-apartments/condominiums/mix use.
 - i. Base fee: three hundred seventy (\$370.00) dollars for the entire building. (Due at the time of submittal
 - ii. \$0.44 cents per square foot for the first 10,000 square feet.
 - iii. From 10,001 square foot and above \$0.16 cents per square foot.
- 2. New industrial, business, commercial or other non-residential buildings:
 - i. Base fee: three hundred seventy (\$370.00) dollars for the entire building. (Due at the time of submittal)
 - ii. \$0.44 cents per square foot for the first 10,000 square feet.
 - iii. From 10,001 square foot and above \$0.15 cents per square foot.
- 3. Additions to existing buildings:
 - Residential.
 - i. Base fee: one hundred twenty five (\$125.00) dollars (Due at the time of submittal)
 - ii. \$0.28 cents per square foot of each level of building -including basement, garage, and crawl space.
 - b. Industrial, business, commercial, or other non-residential buildings.
 - i. Base fee of three hundred seventy (\$370.00) dollars. (Due at the time of submittal)
 - ii. \$0.44 cents per square foot for the first 10,000 square feet.
 - iii. From 10,001 square feet and above \$0.16 cents per square foot.
- 4. Alterations to existing buildings:
 - a. Residential.
 - i. Base fee: one hundred twenty five (\$125.00) dollars. (Due at the time of submittal)
 - ii. For estimated cost of up to four thousand dollars, no additional fee.
 - iii. For estimated cost from four thousand dollars to twenty-four thousand dollars, six dollars and seventy-five cents (\$6.75) for each one thousand dollars or fraction thereof.
 - iv. For estimated cost in excess of twenty-four thousand dollars, three dollars and ten cents (\$3.10) for each thousand dollars or fraction thereof.
 - b. Industrial, business, commercial, or other non-residential buildings.
 - i. Base fee: three hundred seventy (\$370.00) dollars. (Due at the time of submittal)
