An Ordinance Amending Title 2 Administration and Personnel, Chapter 2.24 Fire and Police Commissioners of the St. Charles Municipal Code

BE IT ORDAINED BY THE CITY COUCNIL OF THE CITY OF ST. CHARLES, KANE AND DUPAGE COUNTIES ILLINOIS, AS FOLLOWS:

WHEREAS, the City of St. Charles (the "City") is a home rule municipality duly organized and existing pursuant to the Illinois Constitution of 1970 and the laws of the State of Illinois; and,

WHEREAS, the City has provided for a Board of Fire and Police Commissioners pursuant to the City's statutory and home rule authorities; and,

WHEREAS, the City finds that it is necessary and desirable to increase the number of Fire and Police Commission members; and,

WHEREAS, the City finds that said increase pertains to the government and affairs of the City, and is otherwise in the public interest.

<u>SECTION ONE.</u> Recitals. The foregoing recitals are hereby adopted as part of this Ordinance.

<u>SECTION TWO.</u> That Section 2.24.010 of the St. Charles Municipal Code is hereby deleted in its entirety and the following language is inserted in lieu thereof:

"2.24.010 Created- Composition.

There is hereby created a board of fire and police commissioners consisting of five (5) members. They shall be officers of the municipality, as provided by statute."

<u>SECTION THREE.</u> That Section 2.24.020 of the St. Charles Municipal Code is hereby deleted in its entirety and the following language is inserted in lieu thereof:

"2.24.020 Members- Appointment- Terms.

The Board of Fire and Police Commissioners shall be appointed by the Mayor of the City

by and with the consent of the City Council. Each member of the Board of Fire and Police Commissioners shall serve for a term of three (3) years beginning on the date of appointment thereof and until their respective successors shall be appointed and qualified. The terms of office shall be staggered so that all members shall not be up for re-appointment at the same time. No such appointments shall be made by the Mayor within thirty- (30) days before the expiration of his term of office."


SECTION FOUR. SEVERABILITY - If any provision of this Ordinance, or the application of any provision of this Ordinance, is held unconstitutional or otherwise invalid, such occurrence shall not affect other provisions of this Ordinance, or their application, that can be given effect without the unconstitutional or invalid provision or its application. Each unconstitutional or invalid provision, or application of such provision, is severable, unless otherwise provided by this Ordinance."

SECTION FIVE. That all ordinances and resolutions, or parts thereof, in conflict with the provisions of this Ordinance are, to the extent of such conflict. expressly repealed.

SECTION SIX. That this Ordinance shall be in full force and effect from and after its passage and approval as provided by law.

5. Police Department

a. Recommendation to approve an Ordinance Amending Title 5 "Business Licenses and Recommendations", Chapter 5.08 Alcoholic Beverages" of the St. Charles Municipal Code.

Chief Lamkin: Over the past several months we've had many discussions on some proposed changes that we could make to the liquor code outlining the difference of the normal time that deals primarily with B and C license holders that would close at midnight and then have the option of applying for a late night permit which could be until 1:00 a.m. or 2:00 a.m. We drafted some language and there are four points on the summary I've given you. Items A and B, with the input from our city attorney are clarification issues in terms of what the role of the City Council is in relation to the approval of the permits as they come in front of you. So those two items are to clarify the language itself. Item C outlines the hours of operation and as you'll see we've discussed 12:00 midnight seven days a week and then there was discussion allowing the annual New Year's Eve so those license holders could have an exemption to stay open until 2:00 a.m. on January 1. Lastly the license fees are outlined going forward with the late night permits fees for 1:00 a.m. and 2:00 a.m. We put this together based on input from the Liquor Control Commission and all of you and I'll open it up for discussion.

Chrmn. Turner: Members of the Liquor Commission can make their comments first, followed by Council for discussion and then the public.

Ald. Lewis: We've discussed it at length over the last few months and we're all on the same page with what we wanted to see. We want to give this a try and move forward with it and see how it will work. To my knowledge I have not heard any information from anyone that this will affect with exception of one letter that their business wasn't even located downtown.

Mayor Rogina: I've received the same letter you are referencing but I received no input to date, but not to suggest that it still couldn't happen.

Ald. Lewis: As a Commission we are all in favor of this in recommending it to Council.

Mayor Rogina: The document speaks for itself and would like to speak to Chief Lamkin, Mark Koenen, City Administrator, to my colleagues on the Liquor Commission, and Counsel McGuirk putting all this input together. This is an end to a long road that we discussed way back in the spring trying to do some reshaping of the language in our ordinances that may have some input on affecting some of the behaviors downtown. We are going to give it go and see what happens.

Ald. Payleitner: Just to tack onto what Maureen said, I have two points. One is the incentive for the early closing which was something as a group we talked about and secondly it is so hard in trying to define restaurant vs. taverns, vs. bar, vs. pub. This way they'll take care of that by whatever license they seek. They'll define it.

Ald. Lemke: I'm curious if one were to select a 1:00 a.m. permit vs. a 2:00 a.m. permit; are those additive or 2:00 a.m. is what you pay? The fact you're doing two hours is what you're paying for oppose to I want 1:00 a.m. and then if I want 2:00 a.m. I'll have to pay for 2:00 a.m. also.

Chief Lamkin: The intent is if you want to stay open until 2:00 a.m. you pay for 2:00 a.m. fee. You don't have to pay 1:00 a.m. and 2:00 a.m. fee.

Ald. Lewis: Also we put those figures down for a base but they are certainly open for discussion if someone may think it should be higher.

Chrmn. Turner: If members of the Council want changes to the fee they'll get back to us and the Liquor Commission.

Mayor Rogina: One comment regarding the fees, if there's a subtle hint in the fee structure as to the fact we're saying why don't you take a look at closing at 1:00 a.m.? You're going to save \$600 over your previous 2:00 a.m. closing from the year before. If that subtle hint is there I would say maybe it's not so much of a hint; but if you want to stay open until 2:00 a.m. the price is there as noted.

Motion by Ald. Martin, second by Krieger to recommend approval of an Ordinance Amending Title 5 "Business Licenses and Recommendations", Chapter 5.08 Alcoholic Beverages" of the St. Charles Municipal Code.

6. Finance Department

a. Recommendation to accept the Comprehensive Annual Financial Plan for the fiscal year 2013/14.

Chris Minick: We are going to take a look back historically at the Comprehensive Annual Financial Report (CAFR) for FY2013/14 or commonly known as the audit of the City. State statues require the City to have the City contain an annual audit of the City's financial statements. Currently we have contracted with Sikich, LLP out of Naperville, IL who have been our auditors for several years. We prepare this CAFR so that we can participate in the Government Finance Officers Association Certificate of Achievement of Excellence Financial Reporting Program. That's the premier program for audits and financial reports for governmental entities to receive based on their audits.

The April 30, 2012 CAFR was submitted for the Certificate of Achievement and was awarded to the City early spring of 2013. This represents the 27th consecutive year that the City has won this prestigious award. We have submitted the April 30, 2013 CAFR for review through the Certificate of Achievement Program and are hopeful that we will attain the Certification of Achievement again next year and should have that news in early 2014.

With regard to the April 30, 2013 CAFR it was previously distributed to the City Council and it's posted on the City's website. Chris briefly reviewed the highlights of the CAFR for the committee.

Pages 1-3 are the only part of the CAFR that belongs to the auditor. The remaining pages are the responsibilities of the City, city management, staff, and Finance Department.

Pages 21-22 Balance Sheets – the City is still in compliance with holding 25% reserves.

Pages 24 & 26 Statement of Revenues/Expenditures a.k.a. Income Statement and Balance Sheet for individual utility funds.

Page 27 Operating Funds.

Page 78 Actuarial Study of Supplemental Information.

Pages 80-83 Breakout of IMRF, Police Pension, Firefighter Pension.

This concludes my presentation on some of the highlights. Overall the audit contains very good financial performance news for the City's four main operating funds.

Chrmn. Turner: With the Electric Fund being in a negative situation, it will eventually, over time, Pay back the General Fund?

Chris: We do track that and yes it is intended that it will repay the General Fund.

Ald. Lemke: On page 27 regarding the Electric Fund we show some non-operating gain/loss of sales of fixed assets, gain/sale of property; was that any one item? The number is \$307K.

Chris: I am going to guess that some of that is primarily due to related disposal of obsolete inventory just based on the technology and transformers, etc. I don't remember a specific large item in that area.

Ald. Lewis: On the revenue slide there is miscellaneous for \$700K. What would be some examples of that? That seems like a lot of money to just lump in.

Chris: It's related to those items that are deemed significant enough to be broken out. I'm not sure what that might be at this moment but will get you an answer.

Mayor Rogina: Director Minick reports a \$1.463M surplus and as Mayor I would like to say to the elected officials that's the result of some of the policies you invoked into the course of this year and to the staff that's a net result of due diligence by staff. I am very proud of this figure.

Motion by Ald. Lemke, second by Bessner to recommend accepting the Comprehensive Annual Financial Plan for the fiscal year 2013/14.

Voice Vote: Ayes: Unanimous; Nays: None. Chrmn. Turner did not vote as chair. Motion carried.

b. Presentation of monthly update regarding City's Financial Results for October 2013 – Information Only.

Chris: In accordance with the discussion that we had a month ago we are now presenting the financial reports on a quarterly basis. We'll still prepare the monthly reports and post them on the City's website, however formal presentations to the committee will be done on a quarterly basis.

October 31, 2013 represents the halfway point of the City's fiscal year and it's good time to review the trends and see how they are holding.

General Fund – we are forecasting \$40.2M of revenue and \$40.5M of expenditures and if those trends hold that will result in a \$300K deficit for the General Fund. That is not a tremendous concern when you combine it and take a look at the fact that we just had a \$1.4M surplus for the previous fiscal year. The item most concerning in the General Fund continues to be the sales tax revenues. They are trending 4-1/2% below budget at this point in time. I believe we may be having some good news. We just received the December disbursement for sales tax which represents sales activity that took place in August. That represents roughly the time that Rt. 64 on the east end of town reopened. That particular month's receipts were \$75K over where they were for 2012. Hopefully we are seeing those shopping patterns re-emerge and get re-established on the Rt. 64 east corridor.

Regarding the expenses, it's all good in terms of comparison to budget. We're anticipating that we'll end the year approximately \$1.9M under budget; 4-1/2% in terms of total expenditure for the General Fund. Good new with regard to our financial management practices.

Electric Fund – we are projecting \$55.8M in revenue as compared to \$57.9M in expense on a cash basis. If those trends hold that would result in a \$2M cash basis lost for the Electric Fund for 2013. One of the phenomenons is two-fold within the confines of the Electric Fund. 1) We have \$3.5M of capital expenses. Some of those revenues were received in prior years so they are not going to show and reflect on the cash basis. 2) Wholesale power costs that are increased due to the cooler weather summer that we had in 2013 as compared to 2012. Our user charges – rate revenue is exactly in line with budget. We are projecting that we would end the year within \$20K of where we had budgeted for the Electric Fund and will continue to monitor this fund as we go forward. Again we are seeing reflected a little bit more of a historically less favorable environment in terms of the weather conditions from 2013 for the Electric Fund.

Water Fund – this is a victim of some of those tiny and different circumstances that I referred to in the Electric Fund. If you look at the cash basis numbers, we would experience a \$4.4M lost in this fund. However, if you take out the one time revenues and one time capital expenses, a significant portion of those capital expenses have been funded in prior years. We're looking at \$4.8M of revenue and \$5,650,000 of expense that would result in a \$262K operating loss. There's a bit of a phenomenon happening with regards to the expenditure for some of the projects lagging the receipt of financing for several of the projects.

Wastewater Fund – we see a similar phenomenon in this fund as well. There's a \$2.5M cash basis lost but if you blow out the one time revenues and capital expenditures we're looking at \$168K operating lost.

Overall I would say FY13/14 is not quite as positive as FY12/13, but certainly not an area for a tremendous amount of concern at this point.

Ald. Bessner: Are you seeing trends or markers that are showing the economy going back to where it was in 07/08. Looks like we're stopping/rising/stopping – are we still moving forward?

Chris: We are increasing but very slowly. In terms of the history we experienced prior to 2008/09, the increase is more goal driven in pace then perhaps previously experienced. The goal trends in the revenues are going to be fairly flat. There will be an increase overall but it's not going to be a significant increase that we might of seen pre-recession.

Ald. Bessner: So we're not going backwards.

Chris: I don't foresee us going backwards unless something unexpected was to happen.

Ald. Lemke: We talked about the wastewater fund and the \$10.3M of capital, does that then become amortized over time?

Chris: Yes, we do not convert to a gap basis for the interim for the interest statements. The Enterprise Funds (electric, water, wastewater) are all presented on a cash basis but your are correct that the interim majority of the \$10.3M will be capitalized and then appreciated over its useful life. That represents the building on Deveraux Way for that renovation project.

7. City Administrator's Office

a. Presentation of request from Pride of the Fox Riverfest Committee for the City to be the Presenting (Title) Sponsor.

Mark Koenen: We have had a request from the Riverfest Committee to consider being a title sponsor for the fest. We did that last summer 2013. Tonight this is being brought to you to consider this request and if your consideration is positive it will begin to start the budget process for FY14/15. So the Festival Committee can depend on that with the approval of the budget this coming April, but it also becomes an issue of them to being able to plan accordingly. There's information in your packet that details how we handled it last year and what our contribution was to be a title sponsor. It also deals with what our contribution was for operational services. I also provided information with other activities that the City has been involved in either directly or indirectly for other users to provide activity in our downtown area. Julie Farris is here tonight representing Riverfest and can answer questions as well.

Chrmn. Turner: You are asking for the approval of the funding tonight?

Mark: Yes, we need that for budget preparation and Riverfest needs to know that for their planning.

Julie Farris: Walked through a slide presentation showing the City the benefits of being a title sponsor for the Pride of the Fox Riverfest. I met with Mark Koenen and went through line item by line item of our contract and showed him how we delivered on our contract and also how I over delivered on our contract with benefits to our title sponsor the City of St. Charles. Because we do such a great job I am back again to ask you to please support our non-for-profit and community festival.

Went through the activities of what Riverfest gives to the City and the history of Riverfest which started in 1982. Riverfest is the longest running festival in St. Charles and the only festival that is produced by the community for the community. We get between 30K to 50K visitors who attend our 3-day festival, we offer seven venues of entertainment and showcase our downtown, community parks, showcase the Fox River and Riverwalk, provide an event for the community businesses to showcase their organizations, and other various activities. In 2013 we had 71 businesses that sponsored our event with 60 of them being from St. Charles. We have goals and visions for our team for 2014: 1) 20 year anniversary for the sand sculpture event, 2) creating a Native American Pow-Wow (nationally recognized event), and will be partnering our Hospitality Tent with Blue Goose which will be officially named The Blue Goose Hospitality Tent. We have new partnerships and have created a non-profit group volunteer program. With this program we'll be able to help three non-for-profits each year. They'll provide the manpower for our beer garden and we'll provide them a percentage of our sales.

Some of the benefits for title sponsorship is you're branded as the title sponsor on all media, have exclusive seating to the VIP tent for food, drink, and concerts, your name actually goes before Riverfest and it becomes the City of St. Charles Riverfest, your listed on our website and banner program and also announced at the venues. A lot of volunteers, residents and business owners have helped to put on this event. Two new events in the planning for 2014 are a Special Needs Night and Bachelor Auction.

Motion by Ald. Stellato, second by Bancroft to approve the request from Pride of the Fox Riverfest Committee for the City to be the Presenting (Title) Sponsor.

1. CALL TO ORDER

The meeting was convened by Chairman Stellato at 7:00 P.M.

2. ROLL CALLED

3. CITY ADMINISTRATION

a. Recommendation to approve an Ordinance Amending Title 2 Administration and Personnel, Chapter 2.10 "Appointive Officers" of the City Municipal Code.

Mr. Koenen said a decision was reached in regard to the Economic Development Dept. He said when the fiscal year began in May of this year there were 3 people in the dept. and since then the director chose to retire, and the manager chose to resign for an opportunity closer to home, both within about 6-weeks of each other, which left one person in the dept. He said since then they have taken some time to look at the future of Economic Development and how to best match the City's needs. He said the recommendation from staff is to merge what was a standalone Economic Development Dept. with the existing Community Development Dept. into a new work group referred to as the Dept. of Community & Economic Development, with leadership being under Rita Tungare who has 15+ years of service. He said Ms. Tungare is up to the task of expanding her scope and he feels she will do a great job for the community.

Mr. Koenen stated that Economic Development is a relatively new dept. in the community since 1998 and through the years it has sometimes been standalone and sometimes under Community Development. He said that has vacillated through the years pending the leadership available at the time and also the disposition of the City Administration and Council.

Mr. Koenen then shared the 3 models used to figure out what the municipal industry does to address Economic Development:

- 1) Standalone Economic Development Dept.-which is used in Geneva.
- 2) Farming out Economic Development out of house-which is practiced in Batavia.
- 3) Economic Development being housed as a component of Community Development-which is practiced in Arlington Heights, Wheaton, Schaumburg etc.

Mr. Koenen said what is being proposed is not particularly novel but has some history in the community which seemed to be successful. He said the purposes for Economic Development as seen by Staff, feedback from Council and also the community at large are:

- Business retention-Corporate clients need to be appreciated for being in the community, they are valuable and make us stronger, they provide a workforce, employment and reinvest in the community, and they need to be supported and their needs met.
- The Dept. will occasionally seek business and be the recipient for answering questions to
 work with high profile customers when it comes to negotiating incentive agreements, or
 to find them locations in the community to best fit their needs.
- Economic Development is a marketer and one of the first faces seen by a new business coming to St. Charles.

Mr. Koenen gave some analysis behind merging the two departments:

- It makes financial sense-in the past when it were two standalone departments, there was a certain degree of some duplicated business of running the machinery of a department, and it also meant two department directors. He said merging them will combine that energy and synergy with one leadership.
- Those looking to locate their business in St. Charles will only talk to one department, which makes it not only more convenient, but more friendly for new businesses.
- Cross Training-which will create not only back-up during vacation/sick time, but also synergy where information can be shared between a very talented Community Development staff and Economic Development.

Mr. Koenen asked that Council consider the formal Ordinance to create the department of Community & Economic Development.

Chairman Stellato thanked Mr. Koenen and said it was very well put and that he can hear the confidence Mr. Koenen has, along with the Council, in Ms. Tungare.

Mr. Lemke said the most common issue will be how this looks to the outside community and his feeling is that if it is not implicit here, that there is one dept. they can go to and there is not questions going back and forth. Mr. Koenen agreed that it should be simple.

Chairman Stellato asked Mr. Koenen how he would like to proceed. Mr. Koenen said a motion to proceed to the full Council on Monday, December 16, 2013 to approve the Ordinance.

Aldr. Martin made a motion to approve an Ordinance Amending Title 2 Administration and Personnel, Chapter 2.10 "Appointive Officers" of the City Municipal Code. Seconded by Aldr. Krieger. No additional discussion. Approved unanimously by voice vote. Motion carried.

Ms. Tungare thanked the Council stating that she is honored by the support and confidence demonstrated by the Mayor and Council. She said as Mr. Koenen indicated Community Development has a very talented and committed staff, and she is confident that by merging the two areas and bringing in new Economic Development expertise to work side-by-side with existing staff will allow for further improved coordination and enhance Economic Development efforts.

4. COMMUNITY DEVELOPMENT

a. Recommendation to approve an Amendment to Title 15 of the City code for Building Permit Fees.

Mr. Vann said the Building and Code Enforcement Division uses building permit fees to offset operating costs for conducting construction inspections and approximately every 3-4 years staff reviews the city's permit fee structures and services to see if any adjustments are necessary. He said the last permit fee increase was in January 2009, and staff reviews those fees based on the number of movements a project has and the time it takes to conduct inspections. He said historically the city's practice has been to try to cover 60-70% of staff's inspections services, and the permit fee structure is based upon a specific project, square footage or cost of the project. He said building permit fees for commercial include Fire Dept. inspection services as well, and that type of fee process provides a simple, but comprehensive fee structure for customer budgeting. He said based on a recent 12-month review of operational costs, starting in September 2012, the collected revenue permit fee covered approximately 47% of the operational cost of the building inspection operations. He said a modest increase in permit fees, with the anticipated increase in construction activity, will close the short fall.

Mr. Vann then showed a PowerPoint presentation showing the proposed adjustments for building permit fees. He stated that Building Division staff performs 16 or more inspections on a single-family detached house with approximately 11 movements per project at a minimum. He then shared the current fees as well as proposed fees for single-family detached homes with examples from Regency Estates, in-fill lots, and The Reserve, as well as a comparison of residential permit fees for Geneva, Batavia and St. Charles.

Mr. Vann then showed the current fees, allocations and proposed commercial permit fee increases, along with the new or expanded fee types for: appliance permits, as-built permits, parking lots and consultation for permitted projects.

Aldr. Lewis asked if the 47% of operating costs has anything to do with less construction going on. Mr. Vann said it does a little bit and that is why the time frame they took was from September 2012 through September 2013. He said they felt permits were going up at that time and it was a fair analysis of that time frame. He said right now at the end of year they are looking at about 40 new single-family residential homes, and what is typically seen after a recession will be commercial projects, which they are starting to see right now. Aldr. Lewis asked if they would be back up to the 60%-70% operating cost if the fees were not increased. Mr. Vann said he did not think so because the fees have not been adjusted since 2009, and 1 ½ years ago when they looked at them, the economy was not where they wanted it to be and inspections were down. He said it would be reviewed in about a year to see if they are up at

about 60%-70%, which he thinks they will be. Ms. Tungare said if a large scale development is seen such as Charlestowne Mall or First St. it would probably inch up closer to about 60%, but just average construction activities will take at least 2 or 3 incremental revisions to get to that 60%-70%. She said at this point the changes being proposed are fairly modest because we cannot predict where the city will be in 12-months from now, but it was thought making some incremental adjustments made sense and is fair to the development community and the city. She said in maybe 12-18 months another look could be taken and if adjustments are warranted some future adjustments could be made.

Aldr. Lemke said the increases do look modest considering \$5 over 5-years in looking at something like elevators lifts or fences, but in looking at the peers, and he doesn't think it's been changed, but in the past there was a de minimis. He gave an example of putting in a window air conditioner and then taking it out, that type of thing he feels should be known, but he doesn't know what it should be. He said he would like to see what other communities do in that instance, and at that point he would be willing to support this, but he thinks it's time for the city to review the de minimis because everything has gone up many times over since those levels were set. Mr. Vann said there is no permit needed for a window air conditioner. Aldr. Lemke said there used to be a de minimis, he does not see it now, but in looking at it in the past it probably hadn't been changed in 20-years. Mr. Vann said he did not recall that. Chairman Stellato said he did not either. Aldr. Lemke said he remembers it and suggested looking into staff records and that if necessary he would see if he could find something as well. Mr. Vann said the fees being proposed would just cover the work and reviews done by staff, he gave an example of a detached garage and then taking it down, and asked Aldr. Lemke if that's what he meant. Aldr. Lemke said how about a railing around a patio, does that qualify as a fence where he spends \$50 and in turn then owes the city \$55. Mr. Vann said no, there are 2-types of fences, a security fence around property needs a permit, but a little landscape type arbor fence does not require a permit because it is not going into an easement. Aldr. Lemke said he thinks what would solve that is "when does this arbor become a fence" to set some de minimis and he rests his case on that.

Aldr. Turner said he supports the increase because the city's fees are still much cheaper than the surrounding communities.

Aldr. Silkaitis asked if the as-built permits applies to furnaces. Mr. Vann said they do not look around for furnaces, but typically as-builts apply when someone is selling a property that has a brand new furnace and the proposed buyer says "I want to see all your permits". Aldr. Silkaitis said what if a neighbor calls and says they did not get a permit, would that apply. Mr. Vann said it would not because on a furnace they can see everything; an as-built is more for a basement where walls are hidden.

Aldr. Silkaitits asked if a shed is 23 sq. ft. and under do you not need a permit, and he thinks that is something new. Mr. Vann said they put that in the last fee change request which was more based on small Rubbermaid types that go against houses; they are more looking for sheds that go over easements where electrical lines are more an issue.

Aldr. Turner made a motion to approve an Amendment to Title 15 of the City Code for Building Permit Fees. Motion seconded by Aldr. Krieger.

b. Recommendation to approve an Ordinance Amending Title 8, "Health and Safety" Section 8.30.50 "Tree conservation Areas" of the St. Charles Municipal Code.

Mr. Tiedt said this section identifies specific procedures that property owners must follow when proposing to encroach into a Tree Conservation Area, but does not identify the procedure when an unauthorized encroachment has already been made within the conservation area. He said the proposed amendment to this section requires that unauthorized encroachments be removed, but also gives the property owner the option to formally request by writing a letter to the Director of Community Development to allow the encroachment to remain, as well as identify certain criteria to be considered for each request and allow for an administrative approval of the request. He gave the example of a recent request where a homeowner came in to request a fence around their pool, but unbeknownst to the city, two homeowners prior installed a basketball court in the conservation area, and staff discovered there is a great impact in the tree conservation easement. He said the proposed amendment is a process to try to address those types of situations. He said the proposed amendment language was reviewed by the City Attorney and staff recommends approval.

Aldr. Silkaitis asked if staff has ever gone out to check for encroachments on tree conservation areas and suggested taking an inventory next year, because if this has happened in two sales before, he wonders if there may be other issues out there. He said he remembers setting up the conservation areas a long time ago in the subdivisions but if they are not being kept track of then we don't know what is happening back there. Mr. Tiedt said the conservation areas are currently not being inspected, and things that have been brought to our attention have been addressed on a case by case basis, such as trampolines and swing sets, we ask the owners to remove them. He said something like a basketball court is not something that can be moved so easily which is why staff is moving forward with the amendment, but staff could certainly look into taking an inventory. Aldr. Silkaitis said he doesn't think every year is necessary but it should be done, if possible. Ms. Tungare said that's a good suggestion, but one issue is trespassing on private property without the consent of the property owner, but that staff could attempt to see what they can from the public right of way as much as possible. Aldr. Silkaitis said that is a valid point, but he would like staff to do the best they can to not have problems in the future. Aldr. Lemke said sometimes to get to the easement you have to shortcut and his sense is that this is well thought out. He said his only comment is more of an incremental; there once was a case where Keim presented to move the utilities through the conservation areas, which does not help the root structure of the trees, and he thinks something should be stated to make very clear that utilities do not go through these areas.

Aldr. Krieger made a motion to approve an Ordinance Amending Title 8, "Health and Safety" Section 8.30.50 "Tree conservation Areas" of the St. Charles Municipal Code. Motion seconded by Aldr. Bessner. No additional discussion. Approved unanimously by voice vote. Motion carried.

c. Update on First Street Phase 3-Information only.

Mr. Colby gave a brief update and stated that First St. LLC has filed a concept plan application which will go before P&D committee in January 2014, following its review by Historic Preservation and the Plan Commission. He said although it is not listed on the table in the packet, SMN Development made staff aware that they are working on obtaining cost estimates for the construction of the building, and are also working on putting together a market analysis. He said they intend to have information to present to committee in January 2014. Aldr. Silkaitis asked why the developer was a day late with their submittal, and he is concerned they have already missed the first deadline.

5. ADDITIONAL BUSINESS-None.

Aldr. Silkaitis made a motion to adjourn at 7:35PM. Seconded by Aldr. Bancroft. No additional discussion. Approved unanimously by voice vote. Motion carried.
