The owner of 11 N. 3rd St. has requested a Façade Improvement Grant to assist with funding the following exterior improvements to the four-unit building known as Old St. Charles Place:

- Replace all wood trim with cedar (including fascia board, vertical trim, and block accents).
- Replace all 10 vinyl windows on the south elevation with aluminum frame windows.
- Replace three steel doors on the north elevation.
- Replace the "Old St. Charles Place" plywood sign on the east elevation.
- Replace the four raised sign panels on the south elevation.
- Re-roof the west half of the building.

The cost of work is estimated at \$45,050. The grant would cover up to \$20,000.

EXTERIOR REPAIRS AND PAINTING AT OLD SAINT CHARLES.

Metal flashings and drip edges are to be saved to re-use if still in fair condition. 1x12 Cedar is to be pre-primed and installed for all fascia/freeze board, verticals and red blocks.
