Executive Summary:

Formal bids for Ready Mix for Fiscal Year 2015/2016 were solicited but none were submitted. The City did receive a quote from Ozinga Ready Mix. Last year, Ozinga Ready Mix acquired Meyer Material, which the City has used for the last nine years. They have provided the City with enhanced service, and are located in South Elgin providing for more efficient deliveries. They charge us a minimum load charge, waiting time, and a weekday overtime charge. Estimated expenditure is \$35,000.
