Executive Summary:

The Camp Kane Heritage Foundation has prepared a Conceptual Site Plan for utilization of the Camp Kane site within Langum Park.

The property is City owned. To utilize the property, the Camp Kane Heritage Foundation would need to enter into an agreement with the City. This agreement has not yet been drafted.

The plan is being presented at an early stage to obtain feedback regarding the potential use of the property.

The Camp Kane property and the Jones Law Office are designated historic landmarks. The plan will be presented to the Historic Preservation Commission for feedback on Oct. 7.

The Concept Site Plan shows perpendicular parking extended along the north side of Devereaux Way. The other two alternate layouts incorporate a vehicle turn around.

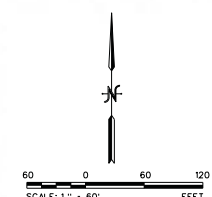

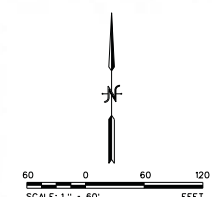

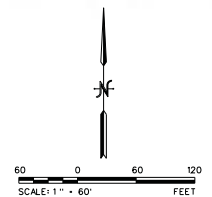
