MINUTES CITY OF ST. CHARLES TREE COMMISSION MEETING RON ZIEGLER, CHAIRMAN MAY 14, 2015

1. Call to Order & Pledge of Allegiance

The meeting was convened by Chair. Ron Ziegler at 7:03 p.m.

2. Roll Call

3. Introductions of Visitors

A. City's America in Bloom Initiative

Chair. Ziegler introduced Aldr. Maureen Lewis. Aldr. Lewis currently represents the 5th Ward, located on the southwest quadrant of city, and she stated how much she appreciated all the effort the Tree Commissioners put towards protecting the City's trees.

Aldr. Lewis attended this meeting to discuss the City's new initiative America in Bloom, also referred to "AIB". AIB is a national awards program which promotes nationwide beautification through education and community involvement by encouraging the use of flowers, plants and trees and making other environmental and lifestyle enhancements thus fostering a better quality of life through the community. The winner of the recognition award will be announced in September.

From July 12-14, two program judges will be in St. Charles touring and judging the city on in several different categories: floral displays, landscaped areas, heritage preservation, urban forestry, environmental efforts, in addition to the overall community impression. Aldr. Lewis, Steve Amatangelo and Diane Cullen are the Steering Committee members of this project and they have recruited several representatives from the community to volunteer in this effort.

Aldr. Lewis was present to encourage the Tree Commissioners to participate in this effort:

- Volunteer: The AIB Committee needs the expertise of the Tree Commissioners regarding the city's urban forest, wooded areas, urban forestry volunteer programs, the City's tree diversity program and the efforts being placed on creating the Urban Forestry Management Plan. Some of this information has been included in the Urban Forestry section of the <u>St. Charles in Bloom</u> <u>Community Profile</u> that was written and submitted to AIB. This document may be found on the City's website.
- 2. Recommendations: If any of the commissioners had any suggestions or recommendations of unique urban forestry programs or areas located here in the city, please contact Chris Adesso or Aldr. Lewis.
- 3. Assist in Beautifying the City: Pink, purple, white and yellow have been chosen as the colors for the program's plantings. Consider these colors as you plant your spring flowers and be a part of the effort.

4. Spread the AIB Word: Speak to your neighbors and friends that live in St. Charles. Plant a container of flowers in the AIB palette, assist with tidying up your yards and streets, assist in making the entire city looking beautiful.

The commissioners offered a few items the AIB Committee may want to consider in the Urban Forestry tour:

- 1. Several wooded areas can be included in the tour: Norris Woods, Delnor Woods, Hickory Knolls Woods, and Lee Roy Oaks.
- 2. Large oak trees located in the city:
 - a. 1230 Ash Street on the corner of Fellows and Ash Street. The oak is estimated to be approximately 400 years old.
 - b. St. Mary's Park also has a grand oak tree that can be pointed out.
- 3. Frank Saupp would be great resource regarding the trees in the city.

4. Minutes Review and Approval

5. Old Business

A. Urban Forest Management Plan Update

AJ Reineking, Public Works Manager, met with Graf Tree Care and reviewed the Urban Forestry Management Plan (hereinafter referred to as "UFMP") outline, which was discussed at the last meeting. A draft of the plan will be reviewed by Public Works and presented to the Tree Commissioners at the July Tree Commission meeting. A purchase order has been written for Phase 3 of the Urban Forestry Management Plan; therefore the plan will continue to move forward in FY15/16.

B. Reorganization of the Tree Commission

Due to the time constraints of the meeting, Chris Adesso recommended this agenda item be postponed to the July meeting. Commissioners agreed and moved to the next agenda item.

6. New Business

A. News and Concerns from Public Works

Chris Adesso invited the Tree Commissioners to an upcoming St. Charles Active River Project meeting, Wednesday, May 20 from 7:00 to 9:00 p.m. at Hickory Knolls Discovery Center located at 3795 Campton Hills Road. The River Corridor Foundation of St. Charles has created a task force and is requesting the community to participate in a workshop to share their thoughts and suggestions regarding improvements along the Fox River Corridor in St. Charles

The <u>River Corridor Foundation of St. Charles</u> commissioned a team of experts to engage the community and update the 2002 River Corridor Plan. The intent is to identify potential infrastructure and program changes within and adjacent to the Fox River that may leverage the river as an active community asset, by improving the recreational, ecological and economic impact of the river. Per Chris Adesso, having the presence of the Tree Commission at the meeting would be an asset at the meeting and the community. He hoped that some of the commissioners would be able to attend.

Tree Trimming Update: The Public Services Urban Forestry crews are focusing on trimming trees in the southwest quadrant of town. DeMar Tree & Landscape Services will be focusing on trimming parkway trees along the electrical lines and Skyline Tree Service and Landscaping will focus all other parkway trees. For the next week both contractors will be working from S. 7th to 13th Avenue raising

the canopy of the trees. Once this has been completed, the contractors will be moving to the southwest quadrant of town.

Chair. Ziegler asked if Public Works had consulted with Phil Graf regarding the optimal time to trim. Mr. Reineking stated that EAB has put the staff behind on the trimming schedule and the staff is very sensitive to proper seasonal trimming. The staff however is currently receiving 20-30 requests from residents per week. Mr. Adesso mentioned that a position was open for a Public Services Crew Leader; they hope to hire or promote someone with a forestry background. The department anticipates developing this person as the City Arborist in the future.

Spring Tree Planting Update: There are approximately 170 trees in the ground and the program will be wrapping up soon. The trees were purchased, by Pedersen, within the radius required around the city; the trees purchased focused on the tree diversity recommendations made by Graf Tree Care.

B. Morton Arboretum Study

Comm. Blaine found the attached article and requested that it be shared with the Tree Commissioners. This study conducted by the Morton Arboretum revealed how concerned Chicagoland residents feel now that its trees are under threat and likely to be destroyed by the emerald ash borer beetle. There were several key findings to the study e.g., "a green neighborhood is an ideal neighborhood", "tree loss has an emotional impact", and "the benefits of trees and the importance of 'tree diversity'". It also included five easy ways residents can champion trees in their city. These include watering trees along the street or parkway, protecting the tree bark, watching out for roots, correct mulching and choosing the right tree for the right location. Comm. Blaine found the article very interesting and reflective of the St. Charles community.

C. Annual Nominations for Chair and Election of Chairman

Chair. Ziegler announced that he was resigning as chair, but would continue as a member of the committee moving forward. He has enjoyed his tenure as Chair and hoped his position made a positive impact on the committee. Chair. Ziegler opened the floor for nominations.

Motion was made by Comm. Myers, second by Comm. Otto to nominate Ralph Grathoff as chairman of the Tree Commission for Fiscal Year 2015-2016.

Comm. Grathoff was voted as Chair of the Tree Commission at 7:56 p.m. and continued the meeting as Chair of the Tree Commission

Comm. Myers asked for an update on the books ordered back in February, "Why Would Anyone Cut a Tree Down?" by Roberta Burzynski. Ms. Soderlind was unable to call again this past month, but will follow up on the status of the order by the next meeting.

C. Arbor Day

The Commissioners felt this year's Arbor Day went well. The event had approximately 50 to 75 people in attendance due largely to the participation of Mrs. Tieche 4th grade students from Munhall School and St. Charles Boy Scout Troop #500.

Area to Improve on Next Year:

- Comm. Blaine suggested an announcement be made regarding all the children's activities being offered at the event. This can include: the leaf rubbing activity, counting the tree rings, tree climbing activity, cookies, etc.
- Announcement thanking all those that participated and donated items for the event e.g., Mrs. Tieche for the children's program, Pedersen for the donation of the Arbor Day tree, Midwest Groundcovers for donating perennials, etc.
- Consider moving the Arbor Day event to a different park every year. The program agenda can include the significance of each park. Locations to consider in the future St. Mary's Park & Belgium Town Park located on N. 9th Street, north of Dean Street could be considered in the future.

Comm. Otto: Voiced her concern regarding all the volcano mulching that is occurring throughout the community. It appears this is a very sensitive issue for those who aware of improper mulching technique. She recently published an article on mulching and received numerous positive comments from the community championing her awareness effort. Comm. Otto requested the Tree Commission rally with other communities, other organizations, etc., publicizing the perils of volcano mulching. It was recommended that this topic be discussed in further detail and placed on the agenda at a future meeting.

Comm. Ziegler: Thanked the Commission for their support the last couple of years. He felt the Commission will be in good hands with Ralph Grathoff as the newly appointed Chair of the Committee.

Comm. Blaine: None

Comm. Wilfong: Thanked Comm. Myers for speaking to three classes at Davis School during Arbor Day.

Chair. Grathoff: Mentioned that the improper "volcano" mulching word has started to spread. One of his customers was making sure that his crews would not be "volcano" mulching his trees.

B. City Staff:

Chris Adesso: Mr. Adesso made the commissioners aware of a recent planting issue on Winners Cup Circle where an ash tree was removed last fall. The resident requested a new tree be planted on the same site as the ash tree. Due to the proximity of the driveway, the placement of an existing young maple tree near the site and the underground utility infrastructure in the parkway, this site was determined to be an "unsuitable" for a re-planting. The area was inspected by several

managers; all agreed that the planting of a tree in this area was not viable. The homeowners living adjacent to the site were contesting the decision not to replant. The residents were invited to attend today's Tree Commission meeting to voice their concerns and request the support of the Tree Commission. Since they were not in attendance, staff outlined the situation on their behalf.

Upon further explanation and discussion, the Tree Commission realized the Public Works department made the most suitable choice not to replant; with time the maple tree on the parkway would fill in the area in the parkway. As Mr. Adesso explained, in the future, these types of "best practice" policies will be documented in writing in the UFMP; City policies will be clearly stated for all.

NEW STUDY FROM THE MORTON ARBORETUM REVEALS CHICAGOANS' TAKE ON TREES

- As Chicago-area tree canopy shrinks, new survey finds majority of Chicagoans concerned about region's tree loss,

yet unsure how to help trees in their neighborhoods -

LISLE, Illinois (April 28, 2015) – Chicago and its seven surrounding counties have more than 150 million trees–trees that make our communities healthier, more sustainable and more beautiful. Yet Chicago-area trees are under threat, with one of every five[i]<file:///Y:/Media%20Relations/Press%20Releases/Sent%20Releases%202015/ARBOR%2 0DAY%202015%20press%20materials/Tree%20Poll%20Release%20FINAL.docx#_edn1> parkway trees likely to soon be destroyed by the emerald ash borer beetle.

At this tree "tipping point," Chicago-area residents are concerned, as evidenced by a new survey commissioned by The Morton Arboretum. The Lisle-based tree-focused institution's Talking Trees survey reveals just how much Chicago-area residents care about our trees and the future of our urban forest-the trees that live alongside people in our city and suburbs.

Key findings include:

* A green neighborhood is an ideal neighborhood. Two-thirds of those surveyed place top importance on trees when deciding where they want to live, saying they would "never live in a neighborhood without trees."

* Tree loss has an emotional impact. 60% of Chicago-area residents say they are concerned with the loss of trees in their city, while nearly half are specifically aware of the emerald ash borer beetle.

* We know our cities' trees need human help to thrive, yet aren't sure how to help them. Eight of 10 Chicagoans believe that our trees need human help to thrive, which is especially true in our populated cities, where trees undergo extra stress living alongside people and cars, as well as in smaller spaces. Yet, while 65% agree that the trees where they live need to be checked regularly for pests and diseases, only 41% know that our area's trees need help getting enough water, and even fewer (36%) are aware that trees need mulch to thrive in cities.

* Chicago-area residents understand some of the benefits of trees. Most Chicagoans know that trees clean our air (86%), and "make me healthier" (66%). But only about half know that they have an impact on flooding (49%), and only slightly more know that trees increase a home's value (56%), and protect against climate change (57%).

* We understand the concept of "tree diversity" and its importance in the future of our cities.

The best defense against future tree pests is to plant a wide variety of trees—and nearly threefourths of those surveyed agree! According to the Arboretum's experts, the best defense against major tree loss is to plant a varied selection of trees.

Trees Under Threat

An estimated 10,000 tree species are threatened worldwide, trees that support ecosystems around the world. Yet, compared to threatened animals like the panda bear or bald eagle, trees receive much less awareness. In fact, only 3 in 10 Chicagoans can name an endangered or threatened tree, while nearly 6 of 10 Chicagoans can name an endangered animal.

Chicago's Trees Need Champions

Now more than ever, every tree needs a champion, especially those that live in urban areas. Facing compacted soils, artificial surfaces, summer heat, and physical damage to limbs and roots, our urban trees need human intervention to live. Meanwhile, people–quite literally–cannot live without trees and the myriad benefits they provide. This why the Chicago region's urban forest needs planning, management and care.

The Morton Arboretum's arborists, horticulturists, researchers and teams of volunteers work diligently to protect and conserve the trees that make our cities so beautiful, dealing daily with issues like the emerald ash borer and fungal diseases that are decimating much of the Chicagoarea treescape. But every Chicagoan can do his or her part to help our area's trees thrive.

Here are five easy ways residents can champion trees in their city:

1. Water trees along the street. Trees near the street add hugely to the beauty and character of your neighborhood and increase your property values. Trees like long, slow drinks so leave the hose, barely dribbling, at the base of the tree for an hour or more. Or use a soaker hose.

2. Protect tree bark. A tree's outer and inner bark help guard against damage by weather, insects, animals, and organisms that can cause disease. Their bark is easily hurt if it is struck by lawnmowers and string trimmers. Be careful not to damage them when mowing and edging. Don't chain bikes to trees or drill to hang swings.

3. Watch out for roots. In confined areas, some trees' roots are forced to the surface of the soil. Avoid mowing over those roots; damaging them can cut off the flow of water and nutrients.

4. Mulch right. Mulch, wood chips or shredded bark placed over a tree's roots, does a lot to help trees, keeping tree roots cooler and healthier in summer and preventing water from evaporating so tree roots can use it. Spread mulch in a wide, even, flat layer about 3 to 4 inches deep around the base of a tree. Don't pile it against the trunk in the shape of a volcano; it can trap moisture that causes rot or harbors insects and diseases.

NON-EXCLUSIVE LICENSE AGREEMENT

THIS AGREEMENT, made and entered into this 3rd day of August, 2015, by and between the City of St. Charles, Kane and DuPage Counties, Illinois, an Illinois municipal corporation (the "Licensor"), and Camp Kane Heritage Foundation, an Illinois not-for-profit corporation (the "Licensee");

<u>WITNESSETH</u>

WHEREAS, the Licensor is the owner of the Jones Law Office parcel 0934426001 located at 50 Devereaux Way, St. Charles, Illinois (the "Property"); and,

WHEREAS, the Licensee was organized for the purpose of educational, civic and other activities permitted to be exempt from taxation under Section 501(c) or 501(d) of the United States Internal Revenue Code; and,

WHEREAS, the Licensee, in consultation with the Preservation Partners, and the Elias Kent Kane Chapter of the National Society of Daughters of the American Revolution, desire to restore, maintain and promote the education of the history of the Jones Law Office and to preserve the historic value of the structure which is presently located at Camp Kane in Langum Park in St. Charles, Illinois; and,

WHEREAS, the Licensee intends to maintain, operate, and promote the historical education regarding the Jones Law Office and make decisions with respect to furnishing, decorating, landscaping, light, displays and exterior improvements at the Jones Law Office building; and,

WHEREAS, the Licensor and the Licensee believe that the maintenance and the promotion of the Jones Law Office will enhance the tourism activities in the City of St. Charles; and,

WHEREAS, the Licensee intends to seek and secure funding, grants and support all activities regarding the Jones Law Office.

NOW, THEREFORE, in consideration of the foregoing recitals and of the terms and conditions hereinafter contained, the adequacy and sufficiency of which the parties hereto hereby acknowledge, the parties hereto hereby agree as follows:

<u>Section 1</u>. <u>Incorporation of Recitals</u>. The preambles set forth hereinabove are incorporated herein as substantive provisions of this Agreement as if fully set out in this Section 1.

Section 2. Grant. Licensor agrees to grant, and does hereby grant, to Licensee, a license to use that portion of the Property depicted on Exhibit "A", attached hereto and incorporated herein, (the "Licensed Area").

Section 3. <u>Non-Exclusive Grant</u>. The privilege granted herein is not exclusive and Licensor reserves the right at any time to grant other or similar privileges to use or occupy the Property and/or the License Area.

Section 4. Liens. Licensee, its agents, independent contractors and/or employees, shall not suffer or permit any mechanic's lien, judgment lien or other lien of any nature whatsoever to attach or be against the Property or the License Area, or any portion thereof. The Licensee shall promptly pay all contractors, sub-contractors or material men providing work or materials for the Improvements and shall not suffer or permit the filing of any mechanics lien on behalf of said parties against the Licensor with respect to the Property or the License Area. Should any such lien be filed, the Licensee shall have the right to contest same.

Section 5. Improvements and Maintenance. Any Improvements or Maintenance of the Licensed Area shall be performed by the Licensee upon prior consent by the Licensor. All permanent maintenance, reconstruction or construction improvements that will require a building permit from the City of St. Charles (if applicable) and, be subject to review by the City St. Charles Historical Commission and approved by the St. Charles City Council before any work is

commenced. Exterior Improvements include but are not limited to repair or replacement of roof shingles, masonry, exterior siding, soffits and fascias on the windows and doors, foundation, painting/staining and lighting. Interior Improvements shall include repair or replacement of wall materials, ceilings, flooring, trim and painting/staining.

Section 6. <u>Non-Structure Improvements.</u> All non-permanent Improvements (interior and exterior) may be completed by the Licensee. Non-structural Improvements include and are not limited to landscaping, decorating, signage banners, holiday decorations and nonpermanent lighting. Any and all non-structure Improvements must be approved by the City staff prior to commencing.

<u>Section 7.</u> <u>Access</u>. Licensee shall have complete access to the facility at all times and will be allowed to utilize the facility for repair or educational purposes in accordance with the City of St. Charles Municipal Code.

<u>Section 8</u>. <u>Assignment</u>. Licensee shall not assign or otherwise transfer its right in whole or in part under this Agreement without the express written consent of Licensor.

Section 9. Hold Harmless and Indemnification. Licensee hereby indemnifies, releases and holds Licensor harmless, and agrees to defend Licensor from any and all liability, causes of action, suits, damages or demands of whatever nature arising out of the conduct of Licensee, its officers, contractors, agents and/or employees under the exercise of the privileges herein granted. This indemnity is intended as a full and complete general indemnity and shall include Licensee's responsibility for any attorney's fees incurred by Licensor in defense of any claims or actions brought by third parties against Licensor as a result of the privileges granted to Licensee herein.

Licensor hereby indemnifies releases and holds Licensee harmless, and agrees to defend Licensee from any and all liability, causes of action, suits, damages or demands of whatever nature arising out of the conduct of Licensor, its officers, agents and/or employees regarding the License Area. This indemnity is intended as a full and complete general indemnity and shall include Licensor's responsibility for any attorney's fees incurred by Licensee in defense of any claims or actions brought by third parties against Licensee as a result of the privileges granted to Licensor herein.

Section 10. Financial Responsibility/No Third-Party Beneficiaries. Licensor shall have no financial responsibility or obligation to Licensee or any third party as a result of Licensor's granting the privileges described herein to Licensee. This Agreement creates no rights, title or interest in any person or entity whatsoever (whether under a third party beneficiary theory or otherwise) other than the Licensee and the Licensor.

Section 11. No Lease or Easement. Licensee expressly acknowledges that nothing herein is intended to create a corporal or possessory interest of Licensee and, accordingly, this Agreement shall not be construed as a lease, easement or any other interest running with the land. Neither this Agreement nor any summary or memorandum thereof shall be recorded with any public authority.

Section 12. <u>Relationship of the Parties</u>. Under no circumstances shall this Agreement be construed to create a relationship of agency, partnership, joint venture, or employment between the Licensor and the Licensee.

<u>Section 13</u>. <u>Waste</u>. In the exercise of the privileges herein granted, Licensee will conduct all of its operations in a careful and proper manner, and will not commit any waste or damage to the Property or License Area or permit any nuisance upon or at the Property or the License Area.

<u>Section 14</u>. <u>Term</u>. This Agreement shall remain in effect until August 03, 2016. This License Agreement shall automatically be extended on the same terms and conditions set forth herein for successive periods of one (1) year unless either party provides written notice to the other

of its intension to terminate this License Agreement no less than ninety (90) days before the end of the then current term.

Section 15. Damage and Destruction. Licensor and its officers, contractors, agents and/or employees shall not be liable or responsible to Licensee for any loss or damage to any property or person occasioned by theft, fire, act of God, public enemy, injunction, riot, strike, insurrection, war, or court order, or for any damage or inconvenience which may arise from this Agreement, other than that caused by its own officers, agents and/or employees.

Licensee and its officers, contractors, agents and/or employees shall not be liable or responsible to Licensor for any loss or damage to any property or person occasioned by theft, fire, act of God, public enemy, injunction, riot, strike, insurrection, war, court order, or for any damage or inconvenience which may arise from this Agreement, other than that caused by its own officers, contractors, agents and/or employees.

<u>Section 16</u>. <u>Miscellaneous</u>. This Agreement sets forth the entire understanding of the parties, and may only be amended, modified or terminated by a written instrument signed by the parties unless herein otherwise provided. Either party's waiver of any breach of failure to enforce any of the terms or conditions of this Agreement, at any time, shall not in any way affect, limit or waive that party's right thereafter to enforce or compel strict compliance with every term and condition hereof.

Section 17. Effective Date. This Agreement shall become effective upon execution by both parties hereto.

<u>Section 18</u>. <u>Governing Law</u>. This Agreement shall be interpreted and construed in accordance with the laws of the State of Illinois.



- A. Bids shall be submitted in a sealed envelope, inserted in a larger sealed envelope. Both envelopes shall be clearly marked with the word "Bid", and the name of the project or subject of the bid. 



THE E-VERIFY MEMORANDUM OF UNDERSTANDING FOR EMPLOYERS

ARTICLE I PURPOSE AND AUTHORITY



Storm Sewer Point Repair Contractor

St. Charles Public Works Department is seeking a point repair contractor to perform repairs to the City's storm sewer system throughout the duration of the 2015/2016 fiscal year, ending April 30, 2016. This work will be contracted on a time and materials basis.

Proposals for Point Repair Contractor, as described in the accompanying technical scope, shall be received before **10:00a.m**, **Thursday**, **June 25**, **2015** at the City of St. Charles City Hall, Two East Main Street, St. Charles, IL 60174, Council Chambers, Attention: Purchasing. Proposals will be read aloud at this time. Any proposal received subsequent to the time specified will be promptly returned to the Contractor unopened.

Proposals shall be in a sealed envelope labeled with "Sealed Bid – Storm Sewer Point Repair Contractor".

Any questions shall be submitted to AJ Reineking via e-mail to the following e-mail addresses:

areineking@stcharlesil.gov

Upon receipt of questions prior to **June 17, 2015**, the Contractor shall receive a reply e-mail acknowledging the receipt of the question. Response to the question shall be as soon as practical. Should the question result in a clarification that requires addenda, such addenda will be issued via website update as soon as practical.

Questions submitted after 3PM, June 17, 2015 shall not be acknowledged or answered. Contractors shall take all necessary steps to propose questions prior to June 17.

City reserves the right to extend the due date. Should an extension be necessary, communication of such shall be e-mailed to all registered Contractors.

Scope:

The work shall be performed on storm sewers throughout the City, in areas identified by staff or through the City's contracted cleaning and televising program. The cleaning and televising program will focus primarily on Zone 4 of the City's storm sewer system, which is bound roughly by IL Route 64 to the North, the Fox River to the East, Prairie Street to the South, and Randall Road to the West. Storm sewers in this area lie under pavement as well as in utility easements.

All work performed shall be in compliance with the City's design and inspection policy manual for storm sewers, an excerpt of which is provided herein these specifications.

General Conditions

Contractor should have experience with underground infrastructure work, with storm sewer repair work seen as a bonus.

The work schedule shall be coordinated by the City and the successful bidder. All work shall be completed an invoiced by April 30, 2016.

The Contractor may not start work before 7AM weekdays, and must be completed for the day by 3PM weekdays. Additional hours must be approved in advance to coordinate inspection. Note that the contractor may be restricted with respect to work hours each day depending on special events in the area and weather. Weekend hours must be approved by the City in advanced, and generally will not be permitted.

Once the work starts on a site, the City expects, within reason, the work to proceed without delay to completion.

The Contractor shall provide a Safety Officer contact for the City Inspector to address any safety related concerns that arise on the job. The Safety Officer shall have the ability to respond and address the concern in a timely fashion.

Job show up. The City Public Works facility, upon request, can be used for a job show up location. Utility trucks and private cars can be parked within our fenced in yard. The City reserves the right to revoke this privilege. The yard is open weekdays from 6AM to 5:30PM and locked at all other times.

Contractor is required to abide by the Illinois Prevailing Wage Act and must submit certified payroll records with all pay requests. Pay request without certified payroll will not be processed by the City Accounts Payable Dept.

Technical Specifications & Requirements

A: Design Requirements:

- 1) <u>Catch Basins:</u> Catch basins shall consist of four (4) foot minimum interior diameter reinforced concrete structures with a 3' sump (refer to restrictor structure detail).
- 2) <u>Cover Depth</u>: All storm sewer and sump lines must have a <u>minimum</u> cover of two (2) feet.
- 3) <u>Disconnection of Existing Services:</u> Where necessary for the purposes of completing a repair, existing services shall be disconnected by means of cutting out existing "wye" or tee and replacing with a straight piece of equal size pipe and making the final connection with "non-shear" mission couplings. Disconnection of all services must be performed prior to the demolition of an existing structure.

- 4) <u>Flared End Sections:</u> All flared end sections greater than or equal to 12 inches, which will receive or discharge storm water, shall have a removable grate system to prevent entry. This grate system shall be made from steel stock that is hot-dipped galvanized after fabrication.
- 5) <u>Connecting to an Existing Sewer:</u> When connecting to an existing sewer main by means other than an existing "Y", "T", or an existing manhole, one of the following methods shall be used:
 - a. Using pipe cutter, neatly and accurately cut out desired length of pipe for insertion of proper fittings. Use "band-seal" couplings or similar couplings, <u>and shear rings and clamps</u> to fasten the inserted fittings and hold it firmly in place. Mission couplings shall have the length of boot approximately equal to the pipe diameter. Follow manufacturer's recommendations for the installation. No cut-in connection, made by breaking or cutting a hole in the main and inserting the spigot end of an ordinary sewer pipe shall be permitted.
 - b. Circular, saw-cut of sewer main with proper tools ("Shewer-tap" machine or similar) and proper installation of hub-"Y" saddle or hub-"T" saddle, in accordance with manufacturer's recommendations. This method shall only be allowed for pipe sizes over 12 inches in diameter. All must be encased in concrete flowable fill.
- 6) <u>Frame & Grate:</u> Frames and grates shall be provided as appropriate for the structure location (i.e.: depressed curb, barrier curb, overflow route, rear yard...). All grates to be located near a paved surface shall be "bicycle safe". Calculations may be required to demonstrate that the proposed grates allow for an inflow that does not exceed the design capacity for the downstream pipe (refer to standard details).
- 7) <u>Inlets:</u> Inlets shall consist of a two (2) foot minimum interior diameter reinforced concrete structure. Inlets shall be placed at the sag of vertical curves in roadways, at low points in parking areas, and at other locations as necessary to minimize stormwater ponding and/or flow across roadways or intersections. Storm sewer inlets shall be placed not more than 500' apart in pavement and shall not exceed 250' in grassy areas.
- 8) <u>Release Structure / Restrictor</u>: The release structure shall be of a weir wall orifice design (refer to overflow weir structure detail) or as approved by the City of St. Charles.
- 9) <u>Separation Requirements:</u> A minimum ten (10) foot horizontal separation shall be established between the sewer and any proposed or existing water distribution facility, or the invert of the water main shall lie a minimum of 18" above the top of the sewer pipe. Where neither of the above conditions can be met, the water main shall be encased for the duration of the horizontal conflict (10' on each side of a perpendicular conflict), or the sewer shall be constructed of water main quality materials the duration of the conflict (10' on each side of a perpendicular conflict (10' on each side of a perpendicular conflict).

- 10) <u>Sewer Pipe, Minimum Size:</u> Public sewer shall have a minimum diameter of 10" for the first "run" of pipe, 12" minimum for all other. Replacement sizing for all point repairs should be consistent with the size of the section removed.
- 11) <u>Slope:</u> Slope shall be adequate to provide a minimum flow velocity of 3 fps and maximum acceptable velocity is 10 fps.
- 12) <u>Structure Sizing</u>: Manholes and catch basins shall have a minimum inside diameter of four (4) feet for sewer pipe 18" or less in diameter, five (5) feet for sewer pipe 21" to 48" in diameter. Pipes larger than 48" in diameter will require a special design (refer to standard manhole and catch basin details)

13) <u>Structure Spacing:</u> Manholes / Catch basins shall be provided at:

- 400' minimum intervals.
- Change in pipe diameter.
- Change in pipe material.
- Change in vertical alignment.
- Change in horizontal alignment.
- 14) <u>Sump Lines:</u> Domestic sump services shall be constructed of PVC SDR 26 with a minimum diameter of 4". All domestic services shall connect to the public sewer by removing a section of main and installing a new "wye" fitting for pipes less than 15" in diameter, "Kor-N-Tee" Boots for pipes 15" and larger, or at a structure (refer to connection detail).
- 15) <u>Trench Backfill:</u> All utility and service trenches within (3) feet of paved surfaces, or at a distance specified by the Engineer, shall be backfilled with CA-7 (Virgin Crushed Limestone). In other unpaved locations, CA-7 material shall be used within 12' of the pipe on all sides, and the excavated material may be replaced in the hole from that point. All Backfill material shall be properly compacted unless otherwise directed by the appropriate City staff. Backfill under existing pavements, where an open cut of the pavement has been approved, shall be Flowable Fill that meets the IDOT standards of Controlled Low Strength Material (CLSM) Mixture #1. No fly ash will be permitted in this mix (refer to City pipe trench detail).
- 16) <u>Underdrains</u>: Underdrains will be required under curbs at the bottom of all roadway sags. Underdrains shall extend 50 feet on each side of the inlet. Underdrains shall be perforated polyethylene pipe. The underdrain shall be encased in gravel trench with no fines, and a geotextile fabric shall be used to limit sedimentation in the pipe (refer to standard "Pipe Underdrain" detail). Where an underdrain is removed for a point repair, it shall be restored to its original condition and function.
- 17) <u>Culverts:</u> Culvert pipe designs shall be in accordance with the Illinois Department of Transportation "Standard Specification for road and Bridge Construction" latest edition. Publicly owned culver pipes shall be PVC for pipes less than 15" in diameter or RCP for pipes equal to 15" or larger in diameter.

B: Materials:

- 1) <u>Casing</u>: Where water main protection is required, encasement shall consist of PVC SDR 26, or steel casing with "*Cascade type CCR-STD*" spacers or approved equal.

3) <u>Manhole:</u> Manholes shall be reinforced concrete with steps provided 16" on-center. All manholes shall have a minimum inside diameter which conform to the following:

•	18" storm sewer and smaller -	four (4) foot inside diameter
٠	21" to 48" storm sewer -	five (5) foot inside diameter
٠	Larger than 48" storm sewer -	special design required

- 4) <u>Sewer Pipe, Materials</u>: Main line storm sewer shall be constructed of one of the following:
 - a. Pre-cast reinforced concrete pipe, with "O-ring" joints;
 - b. PVC pipe, rigid, (Min. SDR 26, push-on gasket joints);
 - c. All joints shall conform to ANSI 21.11 for ductile iron pipe.
 - d. Ductile iron pipe, (Class 52), minimum;
 - e. HDPE pipe, (Rigid with corrugated exterior and smooth interior meeting AASHTO M-294, Type S. Pipe sections shall be joined with PVC double bell couplers installed on the pipe with O-ring gaskets. Ex-filtration standards shall meet or exceed that of PVC SDR 26 with push-on-joints.) FOR PRIVATE USE ONLY. NOT TO BE USED WITHIN PUBLIC RIGHT-OF-WAY OR FOR PUBLICY OWNED AND MAINTAINED STORM SEWER
 - f. The type of pipe material will be dependent upon the depth of bury, soil conditions, and pipe criteria, and as approved by the City of St. Charles.
 - g. For RCP/CSP pipe, lifting holes shall not be allowed on pipes less than 84" in diameter.
 - h. All storm sewer smaller than 15-inches in diameter that will be publicly owned and maintained shall be PVC pipe, rigid, (Min. SDR 26, push-on gasket joints).
- 5) <u>Flared End Section</u>: Flared end sections and subsequent riprap material shall be designed and specified per the Illinois Department of Transportation "Standard Specification for Road

and Bridge Construction" latest edition. Flared end sections shall be constructed of a concrete material only or approved by the appropriate Engineering Division.

C: Traffic Control:

The Contractor is responsible for all traffic control and protection. Work in IDOT ROW requires traffic control and protection measures that meet IDOT standards for such. A City inspector will be making spot checks and any deficiencies must be addressed immediately. The City will secure an IDOT permit for any work on state roadways; however, the Contractor is responsible for reviewing the jobsite and quantifying the need for flaggers.

D: Erosion Control:

The Contractor shall be responsible to establish silt screens on the downstream end of any dewatering discharge.

D: Restoration:

- 1) <u>Non-Paved Surfaces:</u> In the parkway and other non-paved surfaces, a minimum of 4" of topsoil must be used for all landscaped restoration areas. Contractor is responsible for leveling and seeding all parkway excavations and installing erosion blankets.
- 2) <u>Paved Surfaces:</u> Excavations in the pavement shall be backfilled with the above specified materials up to existing surface depth. All existing pavement depths must be matched with like surface material, or asphalt may be used to complete depth of existing surface material. Asphalt lifts must be completed at 2" intervals.
- 3) <u>Temporary Restoration</u>: No excavations may be left open overnight or after the contractor has left the site. On paved surfaces, cold patch or plating is required as a temporary surface prior to completion of final surface on all arterial roadways <u>and</u> for all surfaces that will not see final surface material for more than 24 hours.
- 4) <u>Restoration of Private Property:</u> The Contractor shall notify the City <u>prior</u> to removal of any or part of a driveway apron or sidewalk section. These areas are not to be marked as part of the initial excavation.

Respect for resident and business property is very important. Where specialized equipment could be utilized to minimize private property damage, Contractor should consider such. Contractor shall make the City aware of any work on private property that may damage trees, landscaping, fences, sheds, or other property **prior to starting work**. Any abnormal damage, as deemed by the City Inspector, shall be the responsibility of the Contractor, without any additional payment by the City. The amount of forecast damage identified by the Contractor and communicated to/approved by the City, requiring advanced restoration,

shall be added to the evaluated price. To the extent that private property damage can be minimized, it is in the Contractor's best interest. Any driveways or sidewalks in the construction zone should be photographed by the Contractor prior to work starting to defend against resident claims that Contractor work cracked or damaged such. Contractor shall be responsible for defending and satisfying any claims for driveway or sidewalk damage. Pending resident claims against the Contractor could delay final invoice processing.

Loaded Crew Rate Pricing Request

The City is requesting contractors provide loaded hourly crew rates for storm sewer repair work, including emergency repairs.

For unplanned overtime work, the contractor needs to be prepared to work the amount of time that the City needs the crew for, which may be a short period, or may be an extended period. For emergency restoration work, the City expects the contractor to have the requested crews on site within 24 hours of notification.

8. ASSIGNMENT

Assignment of this contract or any part thereof, or any funds to be received thereunder by the bidder shall be subject to the approval of the City of St. Charles.

9. <u>DEFAULT</u>

The contract may be cancelled or annulled by the purchasing manager in whole or in part by written notice of default to the bidder upon nonperformance or violation of contract terms. An award may be made to the next lowest bidder, or articles specified may be purchased on the open market similar to those so terminated. 



Executive Summary								
Purchasing went out for bids and received six responses for a new substation transformer. This 25MVA transformer will replace a unit at Prairie Street Substation that is beyond normal life expectancy and failed a condition assessment test last year. CG Power Systems, which builds this size transformer at a plant in Washington, Missouri, has provided transformers to the City in past years, namely the units at RR Donnelley and at Red Gate Bridge. We have not had any maintenance or reliability issues with CG Power Systems, and they have a fine reputation in the industry. CG Power Systems met all bid requirements and their proposal offered the lowest life-of-unit cost of the bids received. There was one bid that was lower first cost by approximately \$1,500, but the unit was to be built in Mexico and our specification calls for transformers to be manufactured in the U.S. The CG proposal did offer the lowest total ownership when efficiency losses were evaluated.

<u>SECTION TWO</u>: That, after the adoption and approval hereof, this Ordinance shall (i) be printed or published in book or pamphlet form, published by the authority of the City Council of the City of St. Charles, or (ii) within thirty (30) days after the adoption and approval hereof, be published in a newspaper published in and with a general circulation within the City of St. Charles.

<u>SECTION THREE</u>: This Ordinance shall be in full force and effect ten (10) days from and after its passage by a vote of the majority of the corporate authorities now holding office, approval and publication in the manner provided by law.

Chief Keegan,

I was contacted via email a complaint about the traffic circle at S. 14th Street and S. 16th street being unsafe, and the right-of-way unclear for motorists. I studied the intersection, and worked closely with our cities engineering and public services departments to see if any improvements could be made.

Part of my investigation requires that I pull the crash data from the intersection and decipher if the intersection itself aided in a crash occurring. A review of the crash data indicated this was not an issue. The following data supports my statement.

Total Number of Crashes

- 2011 - 0 Crashes - 2012 - 0 Crashes

- 2013 1 Crash
- 2014 1 Crash

As you will recall, at the end of March, I submitted to you via email an extensive historical perspective complete with aerial photo maps to show the evolution of the roadway since the late 1960's. I have that email archived in the traffic file and available at any time if you wish to review it again.

The following recommendation comes direct from Karen Young's email in regards to what we (Karen, Chris Adesso, and myself) all agree is the proper actions to be taken next.

(Taken from Karen Young's email dated May 27th, 2015)

- Existing Stop Sign and Stop Bar: Remove the existing stop sign and stop bar that is currently in place for westbound S. 14th Street at 16th Street. This stop sign was never put into place with an ordinance; therefore it will not require any revisions to the City code to remove it.
- **Sign #1:** Install Yield signs at all three legs of the intersection. This is allowed and recommended in the MUTCD manual for this configuration. This will help notify all vehicles



entering the area to use caution and yield to oncoming traffic. An ordinance will need to be established for the installation of the yield signs. Rich Clark and I will work together to get this completed at an upcoming committee meeting. The new yield signs will include orange flags for a period of time to notify the motoring public of the change at the intersection.

- **Sign #2:** Replace the existing "Traffic Island Ahead" signs with Sign #2, which is a visual of a traffic circle along with the "Traffic Circle" verbiage.
- **Sign #3:** Replace the miscellaneous signs in the circle area with the chevron arrows directing traffic to the right.
- **Pavement Marking**: There is currently some existing pavement marking's out at the intersection which will be modified. The proposed pavement markings' are shown in yellow and will help direct traffic utilizing the current MUTCD standards. Shown in black hatching are the areas of pavement marking to be removed.

In summary, after extensive research and a collaborative effort with our city departments, I recommend the following addition be made to our existing ordinance as it applied to section 10.11.2100 Intersections Where Stop or Yield Required.

Under section **10.11.2100 (B)** The following streets in the city are *yield right-of-way streets*. I recommend adding:

11) On South 14th Street at its intersection with South 16th Street, so that westbound traffic at the traffic circle must yield to north and southbound traffic on South 16th Street.

12) On South 16th Street at its intersection with South 14th Street, so that north and southbound traffic at the traffic circle must yield to westbound traffic on S. 14th Street.

Please let me know if you have any questions or additional comments about our recommendation. If approved, I will supply Sara Cass with any additional information or clarification she may need to pursue this change.

Chief Keegan,

Since early spring, I was contacted by and spoke to numerous citizens who reside in the "Rivers Edge" subdivision near the St. Charles North high school. The residents wished to complain about an ongoing parking issue that they experience with students parking vehicles on the streets within the subdivision during school hours. Much of the subdivision is already ordinance "No Parking" on one side of the street; however, there is only one sign posted in the subdivision stating such. This one sign is on River Ridge Drive immediately after turning off of Red Gate Road and states, "Resident Parking Only On School Days 7am-4pm". There are no other signs within the vicinity other than one contradicting and un-ordinanced sign on River Ridge Drive near Prairie Crossing that reads, "Parking Permitted Beyond This Point". This particular sign makes enforcement difficult for officers who do not want to enforce the actual ordinance out of fairness to those who have parked here believing it is legal.

I am issuing this memo to you to explain how I have worked towards a solution to the problem, and it is one that the members of the subdivision and its association support. I propose to have the entire subdivision ordinanced "No Parking on School Days between 9am-1pm". This method of signage has been used throughout other areas of the city that are adjacent to high schools, and proves to be an effective method of limiting violations, while not disrupting the daily use of the city roadways. In order to understand how I came to recommendation, I will give you a brief summary of what steps I have taken.

1

Based upon my experience, I am aware that twice a year a portion of the school parking lot is closed for driver's education activities. When this occurs, an entire parking lot's worth of students come over and park on both sides of the roads within the Rivers Edge subdivision. Students recognize that all other surrounding subdivisions already have parking restrictions in place, and therefore come to Rivers Edge because they believe they can.

One side of the road is already ordinance "no parking" based upon the width of the roadway, however; there are no signs erected within the subdivision saying such. When students park on both sides of the road, it now creates a safety issue in which a fire truck or other emergency vehicle does not have proper access to maneuver within. I witnessed this predicament on several days.

To complicate matters, there is the city sign that I mentioned earlier in this memo that states, "Parking Permitted Beyond This Point". This sign is on the north side of River Ridge Drive nearest Prairie Crossing which is approximately 100 feet north of the T-intersection that leads into the subdivision. This un-ordinaced sign was erected sometime in the last 5 years without our department's traffic unit or our command staff's recommendation. We were never offered an opportunity to give our input or ask questions as to the necessity of the sign. Today, that sign continues to present a conflict to our officers trying to take proper enforcement action. Meanwhile, students continue to park here thinking it is ok, and the subdivisions residents continue to be aggravated with the mixed signals and lack of enforcement.

In accordance with my request to create resident only on street parking in Rivers Edge, I recommend the following addition be made to our city ordinance.

10.40.044 Residential Parking on School Days

16. Between the hours on 9:00 a.m. to 1:00 p.m. on all roadways within the Rivers Edge subdivision. Streets to include; River View Drive, River Ridge Drive, Prairie Crossing Drive, Meadow View Drive and North Meadow View Drive.

There are other signs that were placed within the subdivision a few years back that aided traffic flow during the construction of the Red Gate Bridge. With your approval of the recommendations within this memo, I will also have these obsolete signs removed as part of the full request that I would make to our Public Services Department. Those signs include:

- Change over the sign on Meadowview that states "Resident Parking Only on School Days 7-4", to the proposed "Resident Parking Only on School Days 9-1".

- Change over the sign on River Ridge Dr. that states, "Resident Parking Only on School Days 7-4", to the proposed "Resident Parking Only on School Days 9-1".
- Removal of signs at the entrance to the Reserve subdivision (north of Rivers Edge) off of Route 31 that prohibit vehicles from using River Ridge Drive (in Rivers Edge) on school days from 6:30-7:30 a.m.
- Removal of the sign on River Ridge Dr. that states "Parking Permitted From This Point On"
- Removal of the sign on River Ridge Dr. that states "Road Closed Monday Friday 630am-730am".

I believe these changes will give a have a positive impact on this subdivision adjacent to the high school. Please let me know if you have any questions or additional comments about this recommendation. If approved, I will supply Sara Cass with any additional information or clarification she may need to pursue this change.

Re:	Parking in the River Edge subdivision/School Days

As you are aware, an ordinance change is being recommended to address resident parking concerns north of St. Charles North HS (SCNHS) in the Rivers Edge subdivision. After receiving on-going complaints from area residents both administratively into the police department and inprogress via 911 calls, I directed staff to complete the attached investigation and subsequent recommendation.

Complaints were received about the following issues:

- Difficulty for residents of the single-family homes to pull in and out of their driveways.
- Car stacking just north of Red Gate Road on Meadow View Drive (across from the tennis courts).
- Sign confusion on various locations, including: River Ridge Drive and Reserve Drive.

This area in question was monitored by the Traffic Unit, Officer Rich Clark, and interaction was initiated with numerous area residents, staff from SCNHS and the homeowners association. The results of our investigation revealed several issues as outlined above. Specifically, sign confusion and students from the high school ignoring parking bans.

As a result of our observations and dialogue with area residents and the staff of St. Charles North HS, we are recommending a clear and concise alternative moving forward. Per Officer Clark's attached memorandum, we are requesting Ordinance 10.40.044 (Residential Parking on School Days) to be amended to now include item #16: "Between the hours of 9:00 am-1:00 pm, all roadways within the Rivers Edge subdivision".
